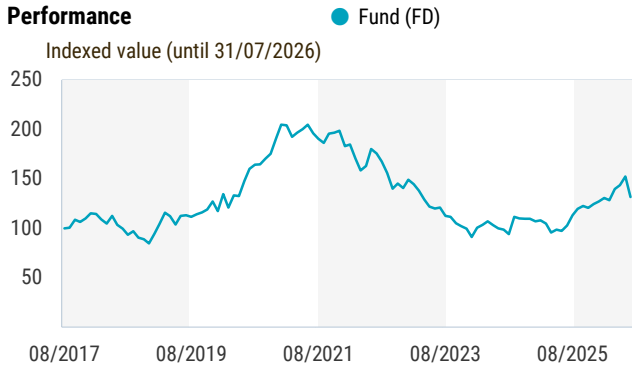

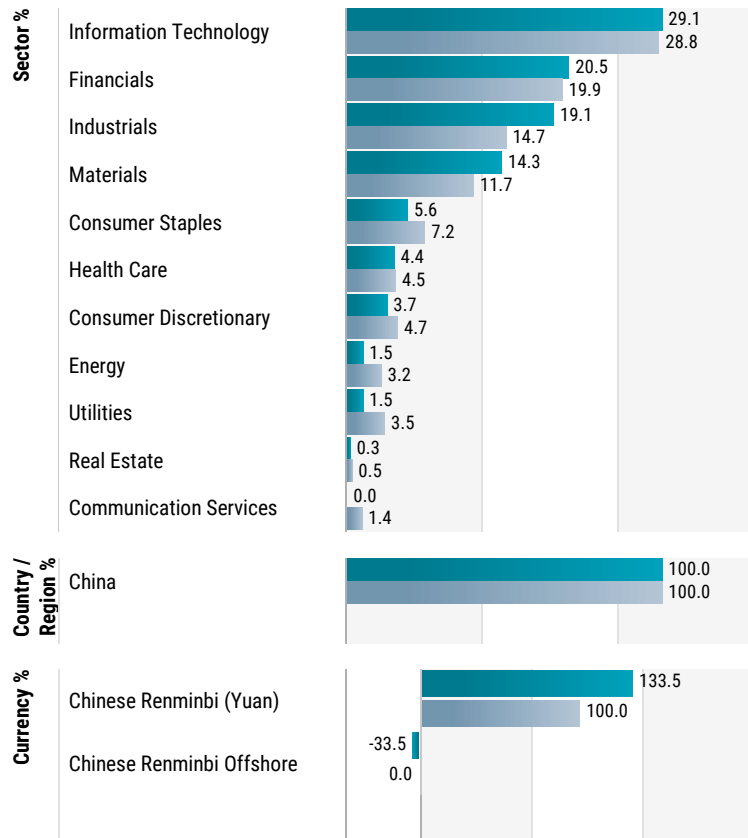

**Performance commentary**

Based on transaction prices, the fund's return was -13.56%.

Robeco Chinese A-share Equities underperformed in July. At the sector level, industrials, energy and information technology detracted. Financials contributed positively. At the stock level, the main detractors were Giga Device Semiconductor, L&K Engineering, and Jiangsu Zhongtian Technology. The top contributors were China Construction Bank, JCHX Mining Management Co., and Asia-Potash International Investment.

**Market development**

In July, China's onshore market faced heavy selling pressure as crowded tech positions unwound, prompting a massive rotation into lagging cyclical and defensive sectors. Global scrutiny over AI monetization timelines, hyperscaler cash flows, and capex sustainability triggered a de-risking event that quickly spilled into China's tech space, exacerbated by tight liquidity and Middle East tensions. This led to a severe plunge in information technology, dragging down adjacent materials and industrials. Consequently, capital rotated aggressively into defensive segments, driving strong outperformance in consumer staples, energy, and financials. Despite the onshore correction, we believe the most painful phase of deleveraging is likely behind us, with margin buying as a percentage of turnover dropping to a low level.

**Expectation of fund manager**

China enters 2026 following a strong equity market rally in 2025, driven by renewed confidence in innovation and a moderation in US-China trade tensions. Policymakers are now prioritizing stability, execution quality, and longer-term economic rebalancing rather than aggressive reflation. Against this backdrop, the equity market is transitioning from a valuation-led recovery to a more earnings-driven phase. China's National People's Congress (NPC) has set a 2026 GDP growth target of 4.5 to 5%, signaling a preference for incremental easing and calibrated support rather than large-scale stimulus. While fiscal and monetary tools remain available, they are being deployed more selectively, with greater emphasis on addressing domestic frictions such as overcapacity, weak pricing power, and inefficient competition, while advancing priorities including anti-involution, market unification, and innovation led upgrading.

**Top 10 largest holdings**

Contemporary Amperex Technology, a leading battery manufacturer and technology innovator, remained our largest holding during the month, followed by Zhongji Innolight, a key optical module producer. Kweichow Moutai, China's premier liquor brand, held the third spot. Financials maintained their stability, with China Construction Bank and China Merchants Bank holding steady in fourth and fifth place, respectively. Further down the list, Advanced Micro-Fabrication Equipment, a prominent semiconductor equipment manufacturer, advanced to sixth, while WuXi AppTec, a leading global CDMO provider, rose to seventh. Rounding out the top ten, Ping An Insurance declined to eighth, Cambricon, a leading GPU designer, dropped to ninth, and Luxshare slipped to the tenth position.

**Sector allocation**

The portfolio had an overweight in industrials, materials, financials, and information technology. It held an underweight in utilities, energy, consumer staples, communication services, consumer discretionary, real estate, and healthcare.

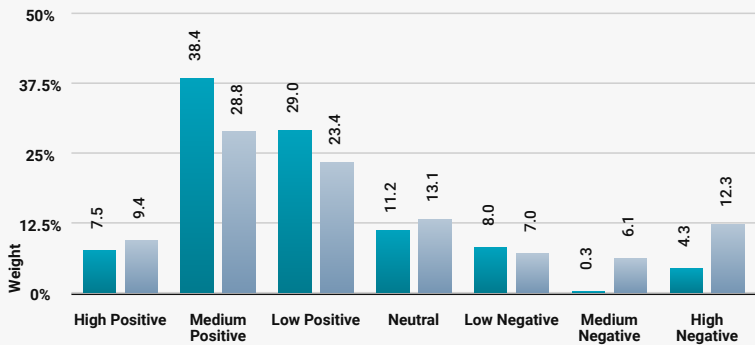

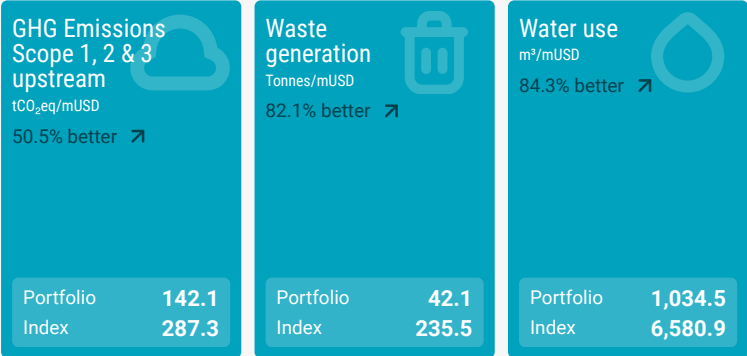
## SDG Impact Alignment <sup>1</sup>

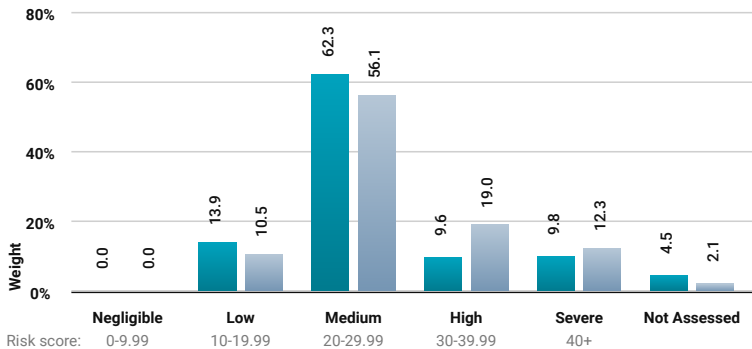

## Reference

### 1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

### 2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. ### 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
