## Performance commentary

Based on transaction prices, the fund's return was 8.99%.

Robeco Chinese A-share Equities outperformed in April. At the sector level, industrials made a strong positive contribution, while information technology, financials and healthcare also contributed. Materials and utilities detracted. At the stock level, the main contributors were Cambricon Technologies, Zhongji Innolight and Luxshare Precision Industry. The top detractors were ENN Natural Gas, Asia-Potash International Investment and Hygon Information Technology.

## Market development

China A-shares rebounded strongly in April 2026, as risk appetite returned and liquidity conditions improved both domestically and globally as markets looked past Middle East tensions and fund flows turned positive. IT, materials and real estate led the rally, supported by enthusiasm around AI infrastructure, strong lithium performance, and improved Tier-1 property data, while defensive sectors such as consumer staples, utilities, and healthcare lagged. Earnings momentum improved in 2026Q1, with A-share overall EPS returning to growth, and margins stabilizing, led by IT and materials.

## Expectation of fund manager

China enters 2026 following a strong equity market rally in 2025, driven by renewed confidence in innovation and a moderation in US-China trade tensions. Policymakers are now prioritizing stability, execution quality, and longer-term economic rebalancing rather than aggressive deflation. Against this backdrop, the equity market is transitioning from a valuation-led recovery to a more earnings-driven phase. China's National People's Congress (NPC) has set a 2026 GDP growth target of 4.5-5%, signaling a preference for incremental easing and calibrated support rather than large-scale stimulus. While fiscal and monetary tools remain available, they are being deployed more selectively, with greater emphasis on addressing domestic frictions such as overcapacity, weak pricing power, and inefficient competition, while advancing priorities including anti-involution, market unification, and innovation led upgrading.

## Top 10 largest holdings

Contemporary Amperex Technology, a leading battery manufacturer and technology innovator, remained our largest holding during the month, followed by Kweichow Moutai, China's premier liquor brand. Zhongji Innolight, a key optical module producer, rose to third place. China Construction Bank, one of the country's major state-owned lenders, advanced to fourth, while China Merchants Bank slipped to fifth. Cambricon, a leading Chinese GPU designer, entered the top ten in sixth position, as Ping An Insurance fell to seventh. Advanced Micro-Fabrication Equipment, a prominent semiconductor equipment manufacturer, climbed to eighth. WuXi AppTec, a leading global CDMO provider, declined to ninth, and Luxshare, a major Chinese consumer electronics manufacturer, joined the top ten in tenth place.

## Sector allocation

The portfolio had an overweight in industrials, materials and healthcare. It held an underweight in information technology, energy, consumer discretionary, communication services, utilities, financials, consumer staples, and real estate.

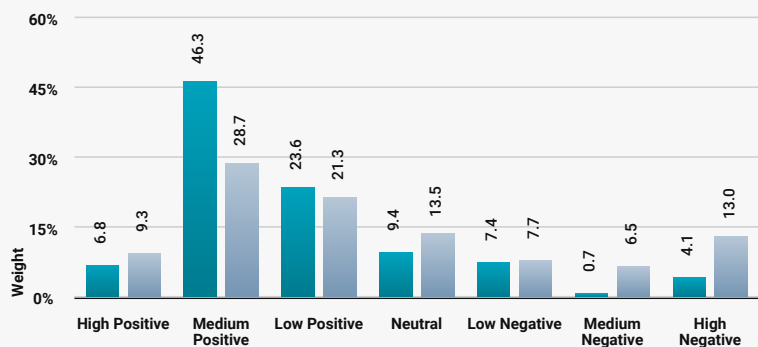

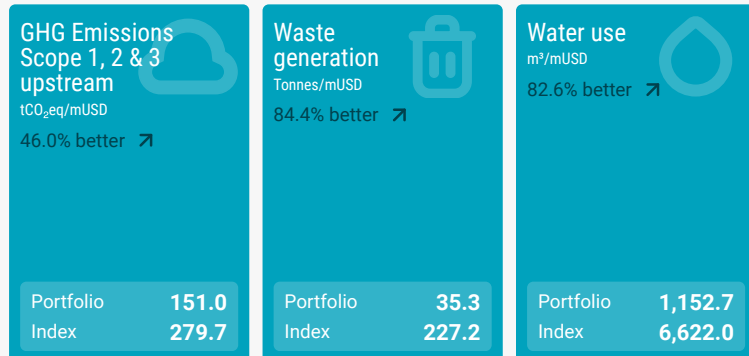
## SDG Impact Alignment <sup>1</sup>

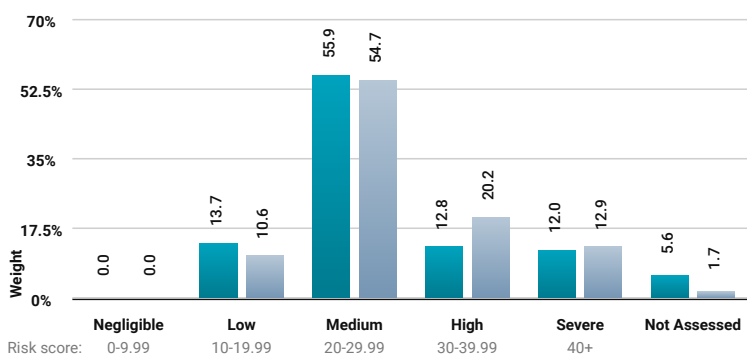

### 1. SDG Impact Alignment

The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

### 2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. ### 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

## Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund.
