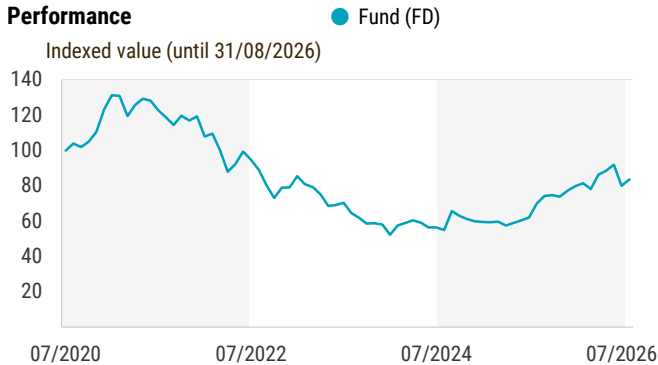

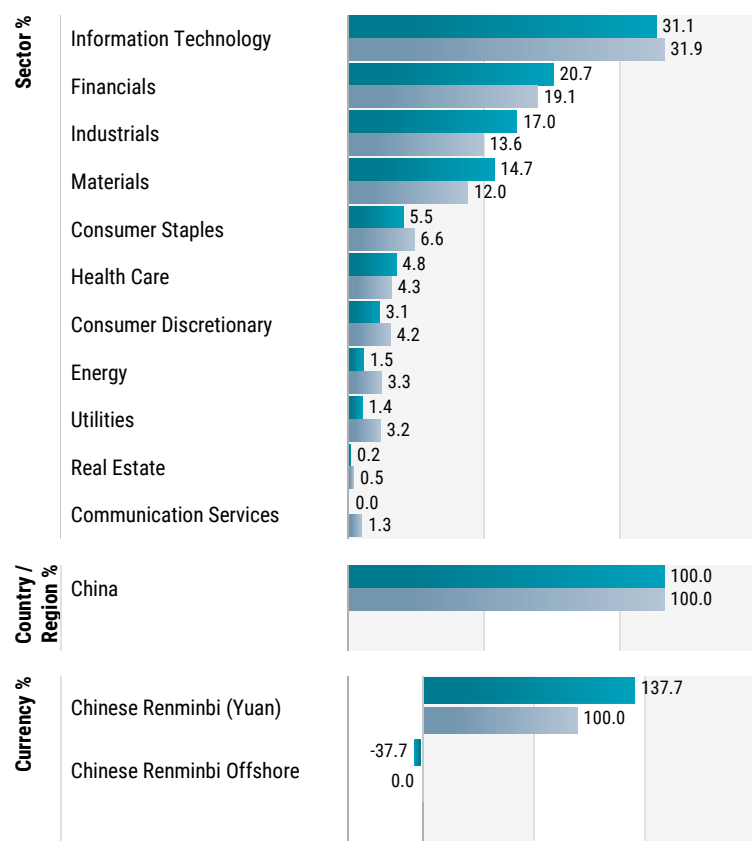

Performance commentary

Based on transaction prices, the fund's return was 4.63%.

Robeco Chinese A-share Equities outperformed in August. At the sector level, materials, healthcare, financials and consumer discretionary contributed positively. Information technology and energy detracted. At the stock level, the main contributors were WuXi AppTec, Shandong Gold Mining, and Shengyi Technology. The top detractors were Contemporary Amperex Technology, Asia-Potash International Investment (Guangzhou), and Sieyuan Electric.

Market development

In August, the NBS manufacturing PMI came in slightly above expectations, rising closer to the neutral threshold at 49.8 and recovering from July's softness. This mild improvement in industrial activity and demand conditions was driven by the major production and new orders components returning to expansionary territory, alongside a rebound in price indices that reflected higher commodity costs and partial pass-through. Conversely, the non-manufacturing PMI remained subdued, highlighted by a continued decline in the construction sector.

Expectation of fund manager

China enters 2026 following a strong equity market rally in 2025, driven by renewed confidence in innovation and a moderation in US-China trade tensions. Policymakers are now prioritizing stability, execution quality, and longer-term economic rebalancing rather than aggressive reflation. Against this backdrop, the equity market is transitioning from a valuation-led recovery to a more earnings-driven phase. China's National People's Congress (NPC) has set a 2026 GDP growth target of 4.5 to 5%, signaling a preference for incremental easing and calibrated support rather than large-scale stimulus. While fiscal and monetary tools remain available, they are being deployed more selectively, with greater emphasis on addressing domestic frictions such as overcapacity, weak pricing power, and inefficient competition, while advancing priorities including anti-involution, market unification, and innovation led upgrading.

Top 10 largest holdings

Contemporary Amperex Technology, a leading battery manufacturer and technology innovator, maintained its position as our largest holding, closely followed by China Construction Bank. Kweichow Moutai, China's premier liquor brand, retained the third spot. WuXi AppTec, a leading global CDMO provider, advanced to fourth, while China Merchants Bank held steady in fifth place. Further down the top ten, Advanced Micro-Fabrication Equipment, a prominent semiconductor equipment manufacturer, remained in sixth place, and Ping An Insurance moved up to seventh. Zhongji Innolight, a leading optical module producer, shifted down to eighth, and Cambricon, a premier GPU designer, maintained its ninth-place position. Bank of Jiangsu, a regional bank, entered the top ten to round out the list at the tenth position.

Sector allocation

The portfolio had an overweight in industrials, materials, financials and healthcare. It held an underweight in utilities, energy, communication services, consumer discretionary, consumer staples, information technology and real estate.

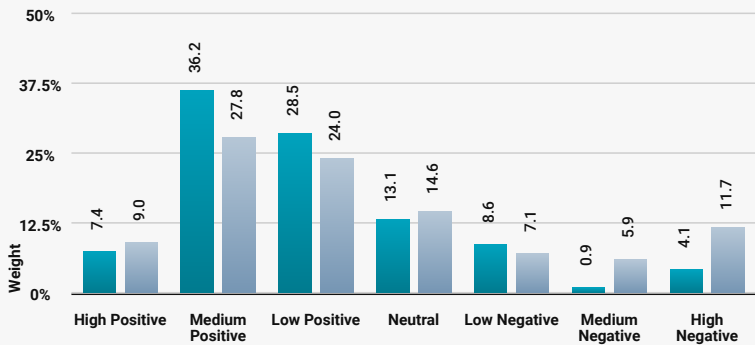

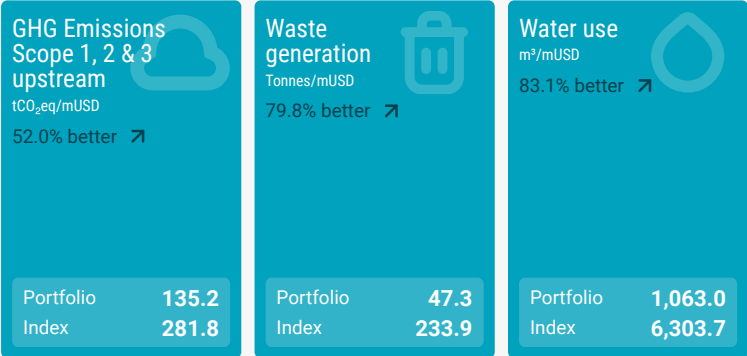
SDG Impact Alignment ¹

Environmental Footprint ²

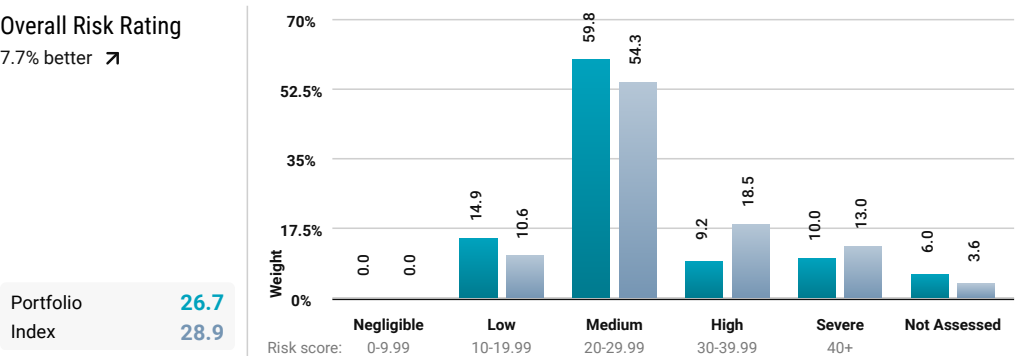

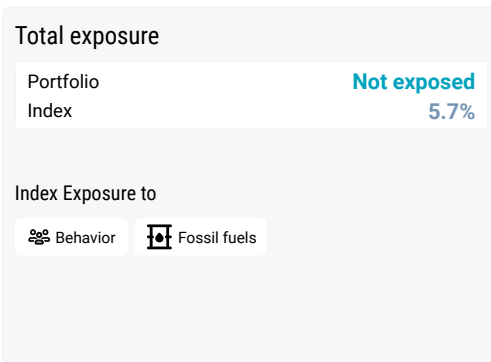

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
