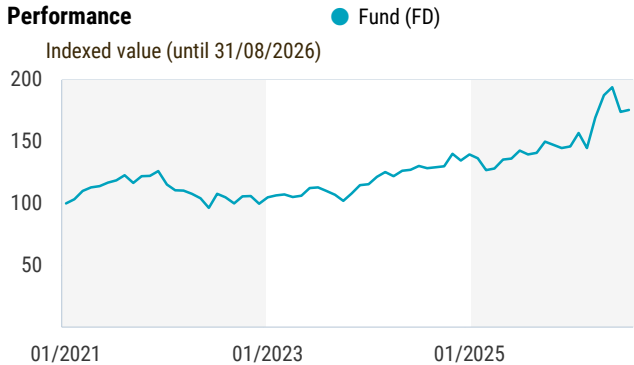

The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 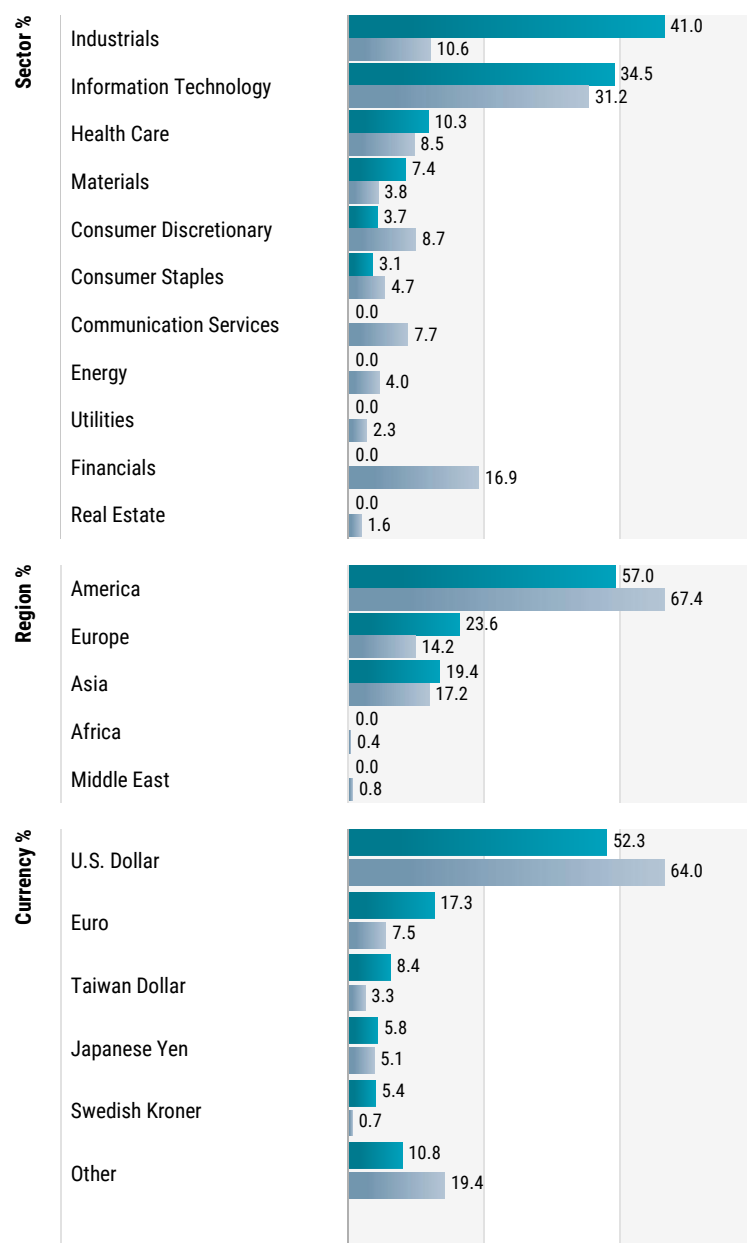

Performance commentary

Based on transaction prices, the fund's return was 0.79%.

In August, the fund delivered a positive absolute return, but a number of strong headwinds resulted in a weaker month in relative terms. Over time, the strategy has been able to compensate for its natural underweights, but over shorter periods these can be either a tailwind or a headwind. This August, they were clearly a headwind. Our natural underweights in mega caps, metals, pharma and energy detracted from the relative performance versus the MSCI World. The very strong performance of the software cohort was another headwind. Many of the key detractors in August were technology and industrial companies, where share price weakness appeared to reflect the broader risk-off move rather than a deterioration in underlying demand. The fund also underperformed versus its internal benchmark in August. Following the sharp technology drawdown in July, US technology stocks rebounded more strongly than their Asian peers, creating a relative headwind for the fund. Our underweight exposure to software was another negative contributor. Seeking more balanced exposure continues to be an important part of how we position the fund.

Market development

After the large tech de-grossing in July, August started with an attempt to re-risk. That attempt largely failed, and the de-risking impulse resumed in the second half of the month. August also marked the return of the software trade. Some software companies can now show genuine growth re-acceleration, and their stock prices are being rewarded. Others benefited more broadly from the whole software cohort bouncing off likely oversold levels. Most software companies, however, spoke with great enthusiasm on their earnings calls about AI agents and other AI products. Going forward, several factors could dampen the mood in the short term: energy prices, inflation and yields, a historically weak September, the pre-midterm period in the US, and the anti-data-center narrative gaining pace in the US. However, in the glass-half-full camp, we see good – and even accelerating – earnings in the non-AI cohort. The strategy's high degree of flexibility has historically allowed it to adjust. We believe this feature particularly valuable in the current uncertain environment.

Expectation of fund manager

The discrepancy between technology companies' enthusiasm about underlying demand and investors' cautiousness is a striking feature of today's market. Both investors and companies largely agree that this cycle will probably not be different from previous ones. Where they seem to disagree is on its longevity. Concerns that today's heavy spenders on AI infrastructure will eventually pause their spending are, of course, not without merit. As these companies increasingly tap the debt market, the sensitivity of the current capex wave to macro factors rises. What seems to keep hyperscalers going is the still significant positive spread between their ROIC and cost of capital. What we find even more interesting, however, is that regular non-AI companies are starting to talk about the returns they are getting on their AI investments. Underlying demand is therefore likely to remain strong. What investors seem more cautious about is what happens when supply eventually catches up with demand. Having balanced exposure – to AI and non-AI – is, in our view, particularly important in an environment as uncertain as today's.

Top 10 largest holdings

The fund maintains relatively even weights across its high-conviction holdings. In August, the fund fully exited Elite Materials and Eoptolink. Both companies belong to the fast-growing AI enablers cohort and, in our view, are approaching fair valuations. The fund also initiated new positions in Okta, Samsara and Novonesis. Okta's digital identity and AI security platform shows strong demand. We believe its platform offering puts Okta in an advantageous position. Samsara has been expanding from vehicle telematics and video-based safety into connected operations and maintenance, opening up a significantly larger addressable market. Novonesis has been on a transformation journey, moving away from more volatile ethanol exposure toward an efficiency-driven enzyme offering capable, in our view, of delivering more consistent mid to high-single-digit sales growth. Within the top ten holdings, Infineon re-entered the list in August, replacing SK hynix.

Sector allocation

The fund invests in four distinct investment clusters, with the following exposure per end of February. 'Redesign Inputs': 33%; 'Enabling Technologies': 19%; 'Circular Use': 30%; and 'Loop Resources': 18%. As a result, the portfolio is invested mostly in the industrials, information technology, materials, consumer discretionary, consumer staples and healthcare sectors.

Regional allocation

The country allocation of the fund is purely the result of the bottom-up stock selection process of companies exposed to the shift to a circular economy. Consequently, the fund is currently overweight in Western Europe and underweight in North America compared to the MSCI World.

Currency allocation

The fund has no currency hedges in place. The currency allocation of the fund is purely a result of the bottom-up stock selection process. Internal investment guidelines limit currency deviations versus the investable universe to a maximum of 10%.

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. 2. Sustainability ESG Risk Rating

The chart displays the portfolio's Sustainability ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainability ESG Risk Rating by its respective portfolio weight. The distribution across Sustainability ESG Risk levels chart shows the portfolio allocations broken into Sustainability's five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
