Robeco Climate Global Credits is an actively managed fund that invests mainly in nongovernment bonds all around the world. The selection of these bonds is based on fundamental analysis. Performance drivers are the top-down beta positioning as well as bottom-up issuer selection. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The fund aims to reduce the carbon footprint of the portfolio and thereby contribute towards the goals of the Paris agreement to keep the maximum global temperature rise well below 2°C. The carbon footprint reduction objective will be aligned with the Solactive Paris Aligned Global Corporate Benchmark. The portfolio is broadly diversified and has the ability to invest off Benchmark in high yield (primarily BB-rated) and Emerging Credits. Performance drivers are the top-down beta positioning as well as bottom-up issuer selection. The fund's objective is also to provide long term capital growth.

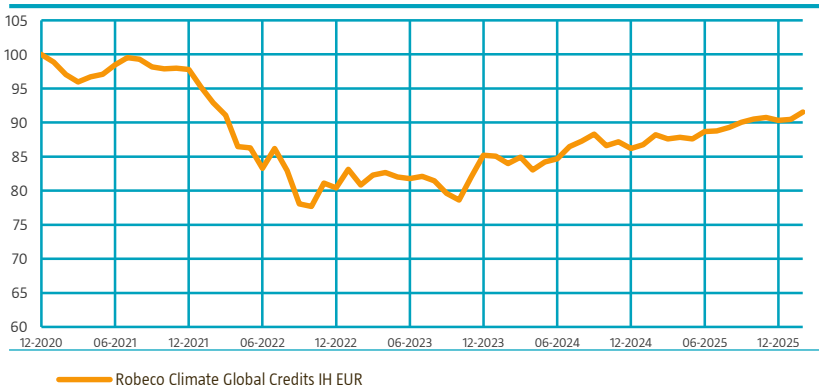

Performance

Based on transaction prices, the fund's return was 1.18%.

The Paris-Aligned Global Corporate Index returned 0.18% (hedged to EUR) in January. Credit spreads widened to 81 bps over government bonds, driven by geopolitical developments and relatively higher supply. Both global IG and EUR IG markets ended the month wider, although the rally in USD government bonds partially offset the negative excess return at index level. Against this backdrop, we continue to prioritize improved liquidity while maintaining additional spread carry versus the index, given ongoing macro volatility. The portfolio delivered a positive performance with a gross total return of 1.19% (hedged to EUR). Outperformance of the benchmark before fees. Beta impact was negative, as we carried a small overweight position. Issuer selection posted a positive performance for the month. The top contributors were Cellnex, NextEra, Volkswagen, and Vesteda.

Market development

Credit markets delivered a strong performance over February, supported primarily by the rally in government bonds, although credit spreads weakened modestly toward month-end amid rising macro, geopolitical, and idiosyncratic risks. Equity leadership broadened, with Europe recording an eighth consecutive monthly gain and Japan reaching new record highs, while US equities lagged as technology and software stocks sold off sharply. A key theme was growing concern around AI monetization and disruption, intensified by the release of new AI tools and a widely circulated Citirini Research memo highlighting potential labor market risks. These dynamics weighed on software and spilled over into credit sentiment, alongside renewed scrutiny of BDC loan books. Elsewhere, gold extended its strong run, while escalating Middle East tensions pushed oil prices to multi-month highs. Overall, February marked a shift toward broader market participation and greater selectivity amid rising structural and geopolitical uncertainty.

Expectation of fund manager

Credit markets enter 2026 on a resilient macro footing, but confidence is fragile. Global growth looks solid, supported by AI-driven capex, easier policy, and reduced tariff risk, though dispersion is widening. US momentum continues, but labor softness and political pressure on the Fed cloud visibility. Europe remains steadier with benign inflation, strong balance sheets, and loose policy. EM are robust, but China's uncertain stimulus and tight valuations call for careful selection. Valuations offer little cushion as spreads sit near historic tight, and an expected supply wave – from hyperscalers to M&A – may challenge strong technicals. Demand remains firm, but conditions could be peaking as issuance competes for limited risk budgets. We stay disciplined: we favor higher-quality IG, shorter spread duration, and conservative beta. We avoid long-dated USD credit and are selective in sectors with stretched fundamentals, especially AI-heavy tech. In high yield, we focus on BB/B names, avoid distressed areas, and seek idiosyncratic carry. We maintain a constructive stance on European credit and bank capital, while approaching EM selectively.

Top 10 largest positions

The most prominent issuer risk positions are a reflection of spread x duration. We consider the requirements of the Paris-aligned benchmark in combination with attractive valuations. These companies already have a low carbon intensity or credible plans to reduce GHG emissions going forward. This helps to meet the two Paris-aligned decarbonization targets of the fund: 1) At least 50% less carbon intensive than the broad market 2) At least 7% year-on-year reduction of the portfolio carbon intensity going forward.

Currency denomination allocation

Our currency positioning is primarily based on top-down beta positioning and bottom-up positioning, considering regional valuation differences. We seek arbitrage opportunities in currency mismatches from issuers when they arise, reflecting attractive risk-adjusted return profiles. All currency exposure is fully hedged to match the Paris-Aligned Global Investment Grade Corporate Bond Index.

Subordinated bank debt can be BB-rated, and the fund is also active in BB-rated rising stars, corporate hybrids and emerging market corporates.

Subordination allocation

Sustainability

The fund's sustainable investment objective is to contribute to keeping global temperature rise well-below 2°C by reducing the carbon footprint of the fund. Climate change and sustainability considerations are incorporated in the investment process via exclusions, ESG integration, a minimum allocation to ESG-labeled bonds and a carbon footprint target. The fund does not invest in companies that are in breach of international norms and applies the activity-based exclusions of Article 12 of the EU regulation on Climate Transition Benchmarks, EU Paris-aligned Benchmarks and sustainability-related disclosures for benchmarks as per Robeco's exclusion policy. ESG factors, including climate change, are integrated in the bottom-up security analysis to assess the decarbonization potential and the impact of financially material ESG risks on the issuer's fundamental credit quality. Furthermore, the fund invests at least 5% in green, social, sustainable, and/or sustainability-linked bonds. In the portfolio construction the fund targets a carbon footprint at least equal to or better than the Solactive Paris Aligned Global Corporate Index. This is to ensure the fund is aligned with the desired decarbonization trajectory of an average 7% year on year.

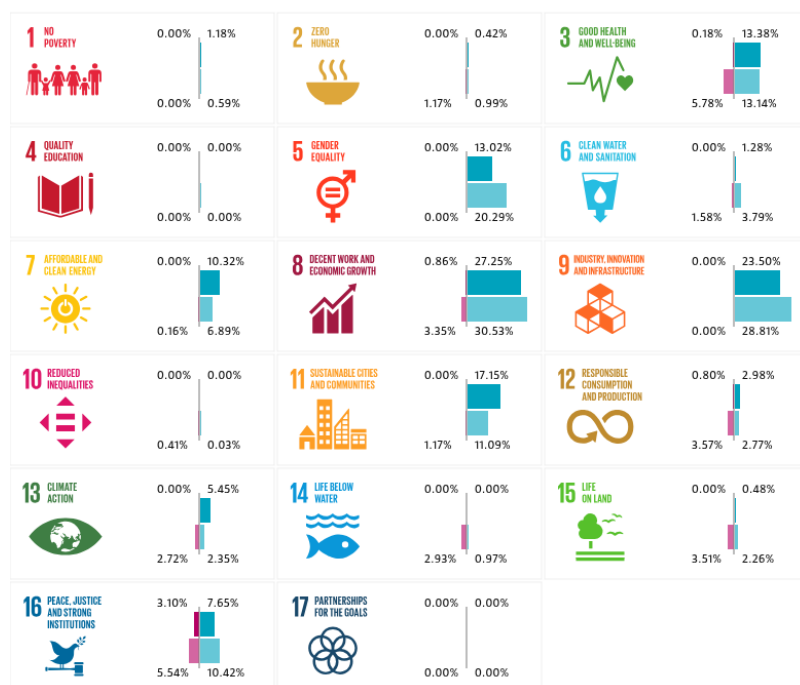
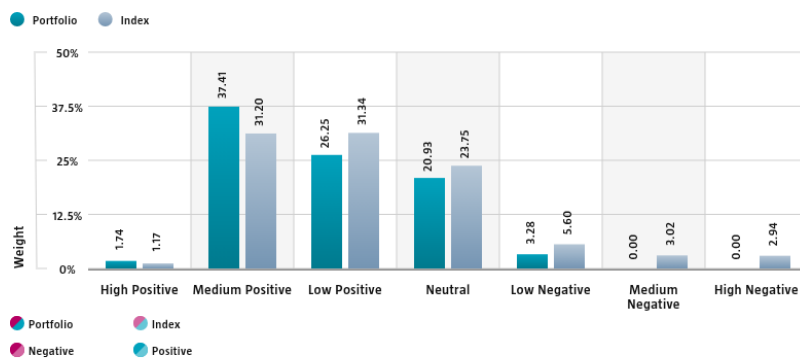

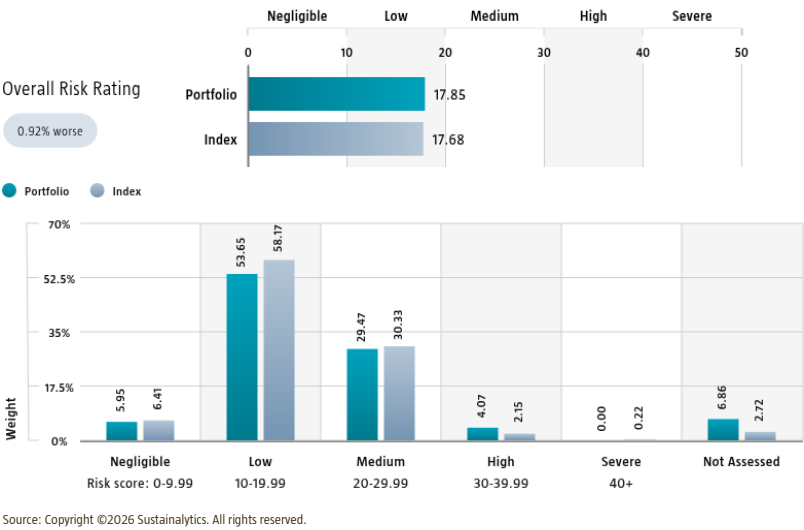

Sustainalytics ESG Risk Rating

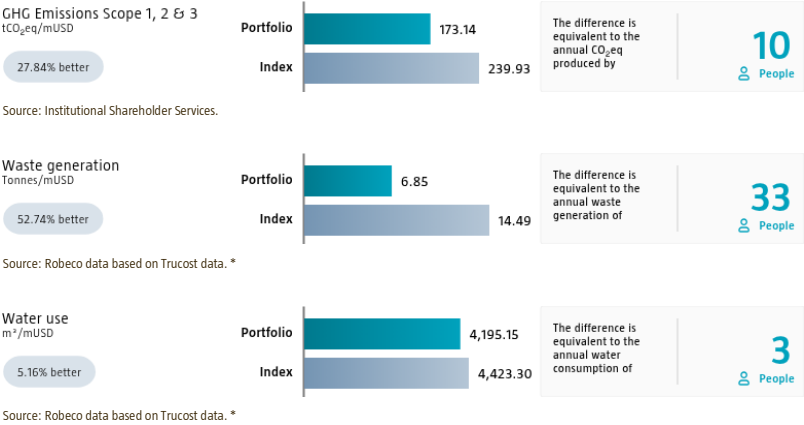

Environmental Footprint

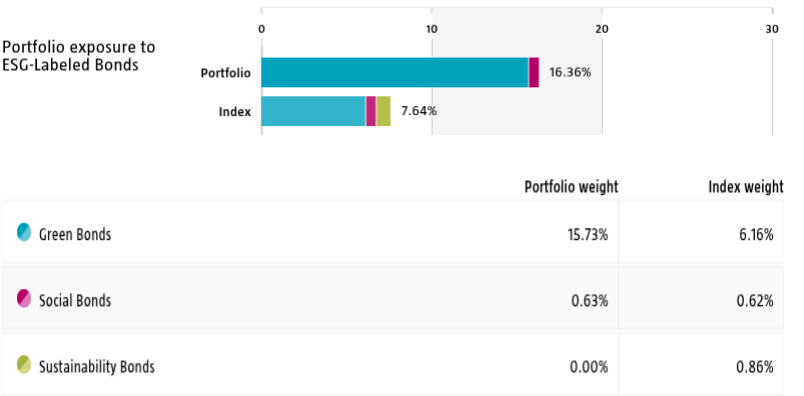
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

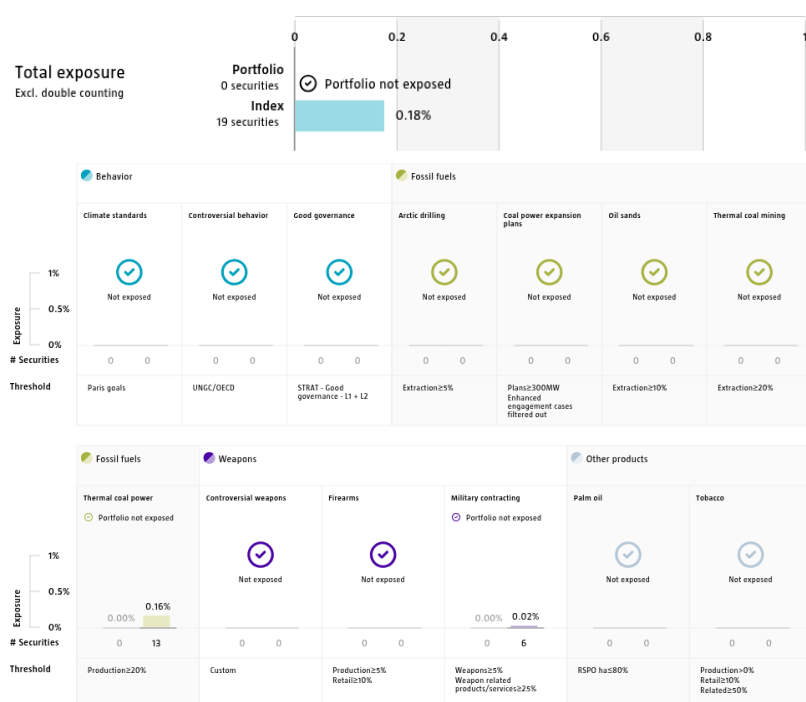
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The portfolio managers are responsible for the construction and management of the credit portfolios, whereas the analysts cover the team's fundamental research. Our analysts have long term experience in their respective sectors which they cover globally. Each analyst covers both investment grade and high yield, providing them an information advantage and benefiting from inefficiencies that traditionally exist between the two segmented markets. Furthermore, the credit team is supported by dedicated quantitative researchers and fixed income traders. On average, the members of the credit team have an experience in the asset management industry of seventeen years, of which eight years with Robeco.
