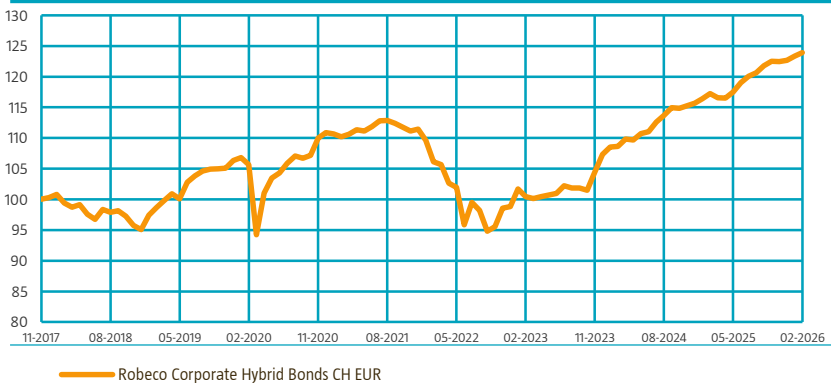

Performance

Based on transaction prices, the fund's return was 0.46%.

The Bloomberg Global Corporate Hybrids Index returned 0.57% in February on a EUR-hedged basis. Average spreads widened by 10 basis points to 152 basis points over government bonds, resulting in credit excess returns of -0.43%. Government bond yields were mixed, with the 10-year US Treasury rising 7 bps to 4.24% and the 10-year Bund easing 2 bps to 2.84%. Total returns were therefore supported primarily by underlying rates, while credit excess returns were negative for the month. The portfolio underperformed versus its benchmark before fees. Beta detracted, as average beta remained above one over the period, while issuer selection was supportive and partly offset the drag. Notable single-name contributors included NextEra Energy, MTR Corp, AerCap Holdings, Corp Andina de Fomento and Verizon Communications.

Market development

February was constructive for credit, with total returns driven largely by the rally in core rates, as resilient macro data underpinned sentiment despite persistent headline volatility. US activity indicators remained firm, though stickier inflation tempered expectations for near-term Fed easing. Credit spreads were broadly stable but softened modestly into month-end amid rising geopolitical and policy uncertainty. Equity performance was mixed, with Europe extending its rally and Japan reaching fresh highs, while US equities lagged on a sharp correction in software and broader mega-cap technology, reflecting evolving AI narratives and more cautious positioning. Trade developments also resurfaced following a US Supreme Court ruling overturning prior tariffs, prompting renewed policy action and uncertainty. Meanwhile, escalating Middle East tensions lifted energy prices late in the month, though market closures limited the immediate impact on asset prices. Overall, supportive fundamentals and resilient demand continued to anchor credit markets despite episodic volatility.

Expectation of fund manager

Credit markets enter 2026 supported by solid macro fundamentals, but tight valuations make the setup fragile. Global growth remains constructive on AI capex and gradual policy easing. The US still has momentum, yet softer labor data and political noise around the Fed add uncertainty. Europe looks steadier, with benign inflation, healthy balance sheets and supportive policy. EM are resilient, although China's uncertain stimulus and rich pricing call for selectivity. Spreads are near historic tight, so there is limited cushion if data disappoints or event risk rises. A larger supply pipeline, from hyperscalers to M&A financing, will test technicals and risk budgets even if demand stays firm. We stay disciplined: we favor higher-quality IG, shorter spread duration, and maintain conservative beta. We limit long-dated USD credit and are selective in tech linked to heavy AI spend. In high yield, we focus on BB/B quality, avoid distressed pockets and target idiosyncratic carry. We prefer European credit and bank capital, and keep EM selective and valuation-aware. The bottom line: a solid fundamental and technical backdrop remains in place, but tight spreads leave little margin for error – patience remains essential.

Top 10 largest positions

The largest overweight positions in DTS terms are NextEra Energy, Volkswagen, Alliant Energy, Enbridge and Verizon Communications. We like the high yields on these bonds, relative to the market average.

The portfolio's largest sector overweights remain consumer cyclicals, energy and communications. Financials account for approximately 6% of the portfolio. We continue to manage this allocation tactically, actively rotating positions to capture relative value.

From a risk positioning standpoint, the fund maintained a modest overweight in EU-denominated hybrids and a neutral to slightly underweight allocation to USD-denominated hybrids, while GBP exposure remained limited given its relatively small weight in both the benchmark and the portfolio.

Rating allocation

The portfolio remains primarily invested in BBB-rated bonds. Approximately 3% is allocated to BB-rated bonds, representing a modest overweight from a risk perspective. The BB exposure consists mainly of corporate hybrids issued by companies with investment grade issuer ratings.

Subordination allocation

The fund predominantly invests in corporate hybrids, which offer high yields for investment grade ratings. Corporate hybrids are subordinated bonds issued by high-quality, non-financial issuers. The fund can also invest in the hybrid capital of banks and insurers, and in the senior debt of non-financial corporates. These bonds can offer an attractive risk/return profile relative to the corporate hybrid market.

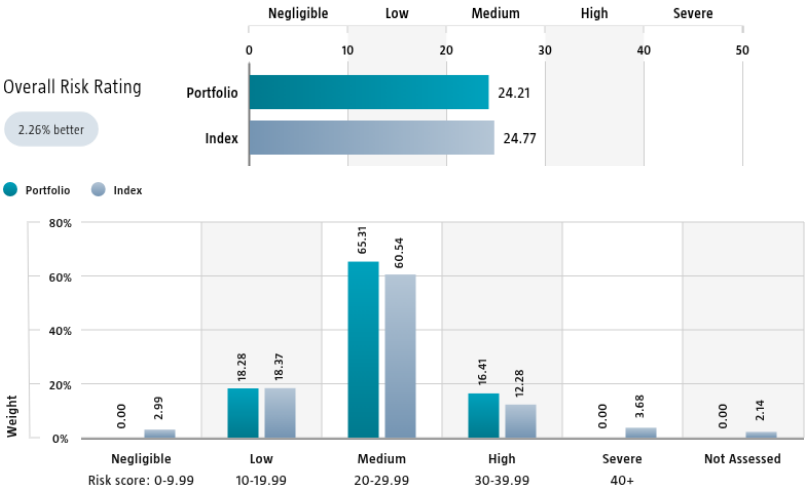

Sustainability

The fund incorporates sustainability in the investment process via exclusions, ESG integration, a minimum allocation to ESG-labeled bonds, and engagement. The fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. In the credit selection the fund limits exposure to issuers with an elevated sustainability risk profile. Furthermore, the fund invests at least 5% in green, social, sustainable, and/or sustainability-linked bonds. Lastly, where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Sustainalytics ESG Risk Rating

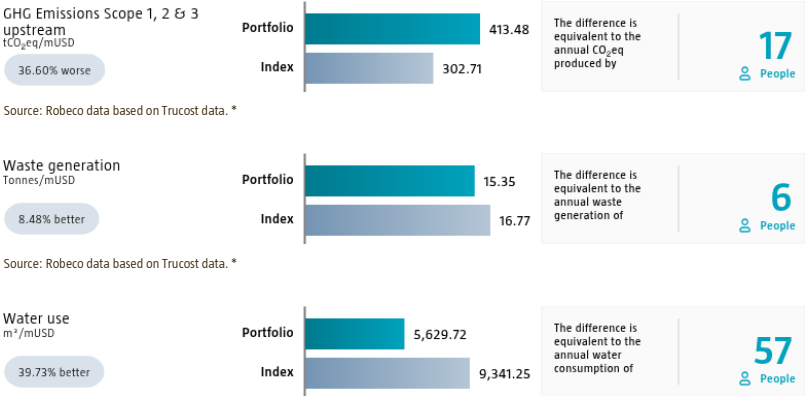

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

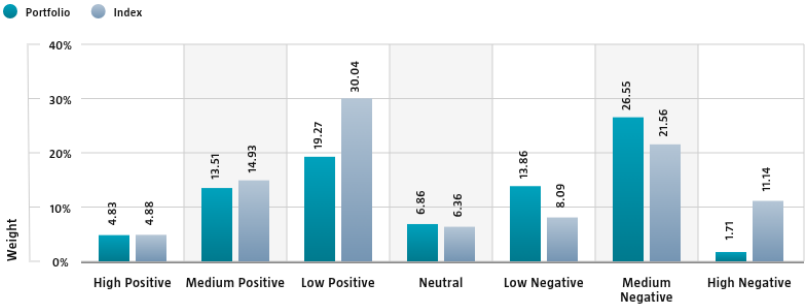

SDG Impact Alignment

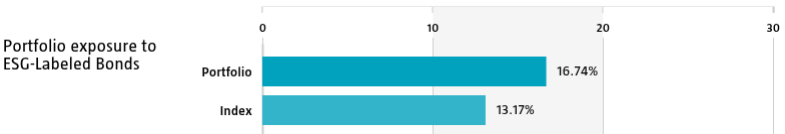

Engagement

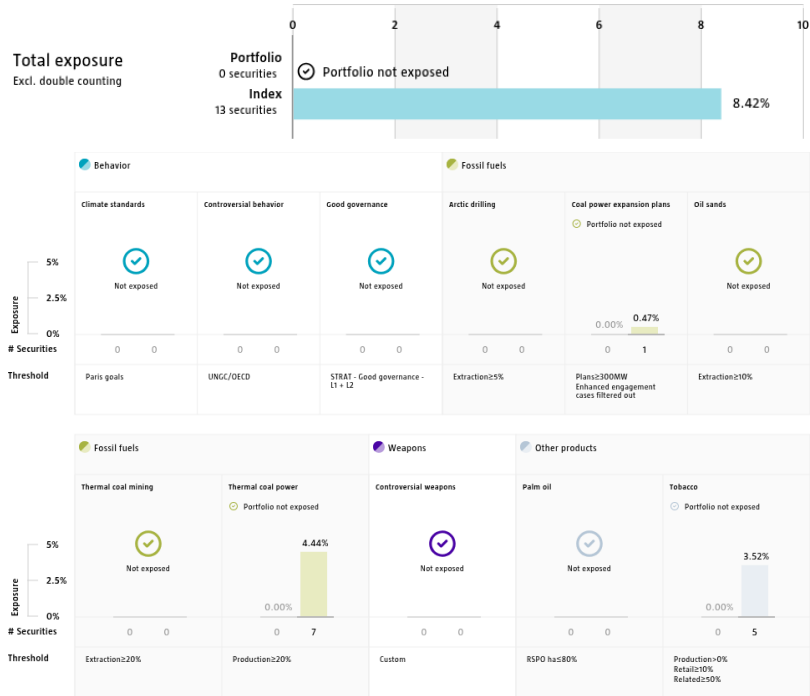
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund's objective is to provide long-term capital growth. Corporate hybrids are deeply subordinated bonds with equity-like features. The bonds are mainly issued by investment grade issuers. The fund selects the best-in-class hybrid bonds, with the best risk-return characteristics.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.

Key risks

He started his career in the industry in 1999 at APG, where he held several positions including Portfolio Manager of global insurance portfolio pan-European financials portfolios. Jan Willem holds a Master's in Business Economics from the University of Groningen and he is a CFA® Charterholder.

Team info

The Robeco Corporate Hybrid Bonds fund is managed within Robeco's credit team, which consists of nine portfolio managers and twenty-three credit analysts. The portfolio managers are responsible for the construction and management of the credit portfolios, whereas the analysts cover the team's fundamental research. Our analysts have long term experience in their respective sectors which they cover globally. Each analyst covers both investment grade and high yield, providing them an information advantage and benefiting from inefficiencies that traditionally exist between the two segmented markets. Furthermore, the credit team is supported by three dedicated quantitative researchers and four fixed income traders. On average, the members of the credit team have an experience in the asset management industry of seventeen years, of which eight years with Robeco.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
