Performance commentary

Based on transaction prices, the fund's return was 0.88%.

The Bloomberg Global Corporate Hybrids Index returned 0.98% in April (hedged to EUR). Credit spreads tightened meaningfully over the month, with average index spreads compressing 17 bps to 146 bps. Government bond yields moved modestly higher, with the 10-year US Treasury yield rising 5 bps to 4.37% and the 10-year German Bund yield increasing 4 bps to 3.04%. As a result, positive total returns were primarily driven by spread tightening and strong credit excess returns. The portfolio underperformed its benchmark, gross of fees. Contribution from beta positioning was strongly positive, as portfolio beta remained well above one during a period of strong credit excess returns. However, this was more than offset by weaker issuer selection. Elevated EUR-denominated hybrid issuance continued to pressure EUR hybrid spreads relative to USD hybrids, where issuance remained limited. In addition, USD hybrids benefited from higher underlying US government bond yields given their greater price and yield sensitivity. Around 65% of the issuer selection drag was driven by currency allocation. The main detractors included Volkswagen, NextEra Energy, and General Mills.

Market development

April remained dominated by the Iran conflict and persistent stagflation concerns. Oil prices stayed volatile but elevated overall, with Brent briefly trading above USD 120/bbl intraday before ending the month around USD 114/bbl. Markets oscillated between fears of escalation around the Strait of Hormuz and hopes for a negotiated settlement, driving sharp moves across rates, commodities, and risk assets. Sovereign yields reached multi-year highs in several markets, with Germany's 10-year Bund yield rising above 3.1%, its highest since 2011, while US Treasury yields ended at 4.37%. Central banks maintained a cautious stance amid rising inflation risks. The Fed left rates unchanged, but the meeting highlighted growing divisions within the FOMC, with four dissents, the highest number since the early 1990s. The ECB also kept rates unchanged while signaling that a June hike remains possible should energy-driven inflation pressures persist. Credit markets remained resilient despite the volatile macro backdrop. Both US and EUR IG spreads tightened, with EUR IG outperforming as it retraced part of its earlier underperformance amid improving expectations for de-escalation in the Middle East.

Expectation of fund manager

The macro backdrop entering Q2 is shaped by a stagflationary impulse not fully priced in by markets. With Brent near USD 100/bbl, the inflation-growth trade-off has deteriorated sharply, particularly in Europe and Asia where energy dependence is highest. The Fed retains an easing bias but rate cuts are largely priced out for 2026, while the ECB faces a tougher trade-off, with hikes a tail risk if disruption proves persistent. Against this backdrop, credit spreads remain tight and offer limited compensation for a multi-month Hormuz disruption, rising private credit stress, and AI-driven business model pressure in software. We keep portfolio beta close to neutral and do not chase spreads. Alpha is driven by issuer selection: we favor HALO exposures in energy infrastructure, metals, and critical networks, and remain constructive on well-capitalized European banks. We avoid BDCs and private-credit-linked insurers, stay underweight in software in high yield, and prefer BB over B in EM as dispersion widens.

Top 10 largest holdings

The largest overweight positions in DTS terms are General Mills, NextEra Energy, Volkswagen, Repsol and Alliant Energy. We like the high yields on these bonds, relative to the market average.

Sector allocation

The portfolio's largest sector overweights remain consumer cyclicals, energy and communications. Financials account for approximately 4% of the portfolio. We continue to manage this allocation tactically, actively rotating positions to capture relative value.

Currency denomination allocation

From a risk positioning standpoint, the fund maintained a large overweight in EUR-denominated hybrids and an underweight allocation to USD-denominated hybrids, while GBP exposure remained limited given its relatively small weight in both the benchmark and the portfolio.

Duration allocation

The fund's interest-rate sensitivity tracks the duration of the index. Interest rate futures can be used to maintain this neutral duration position.

Rating allocation

The portfolio remains primarily invested in BBB-rated bonds. Approximately 7% is allocated to BB-rated bonds, representing a modest overweight from a risk perspective. The BB exposure consists mainly of corporate hybrids issued by companies with investment grade issuer ratings.

Subordination allocation

The fund predominantly invests in corporate hybrids, which offer high yields for investment grade ratings. Corporate hybrids are subordinated bonds issued by high-quality, non-financial issuers. The fund can also invest in the hybrid capital of banks and insurers, and in the senior debt of non-financial corporates. These bonds can offer an attractive risk/return profile relative to the corporate hybrid market.

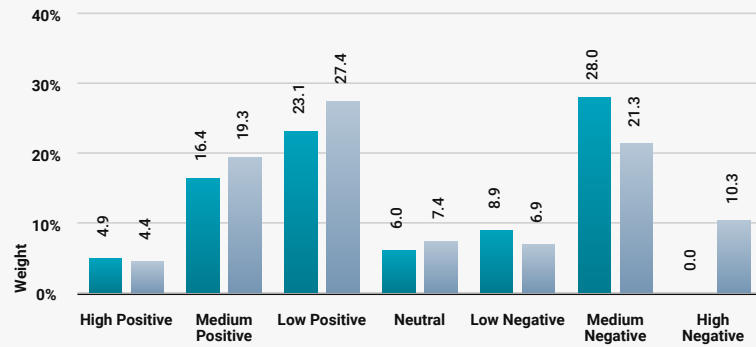

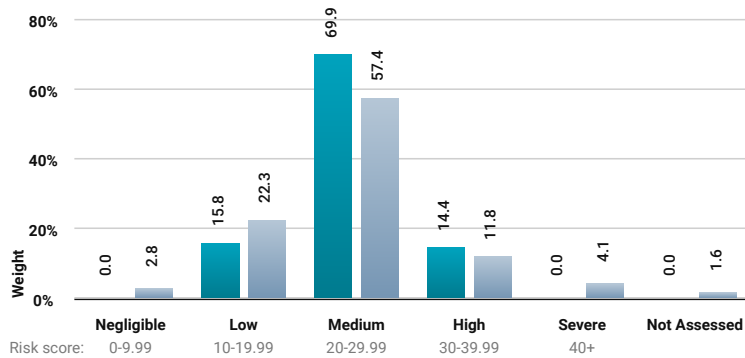
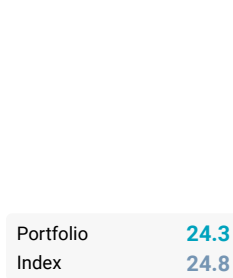

1. SDG Impact Alignment

The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment
