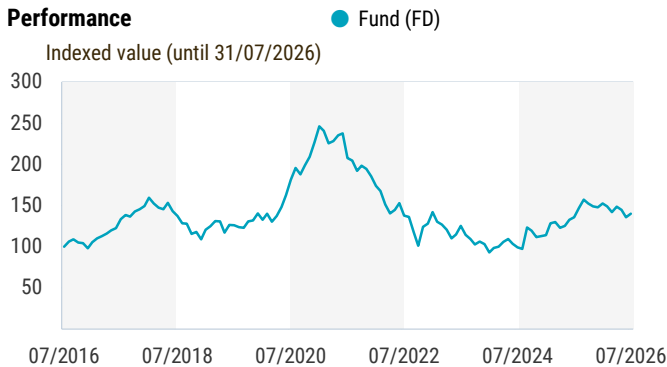

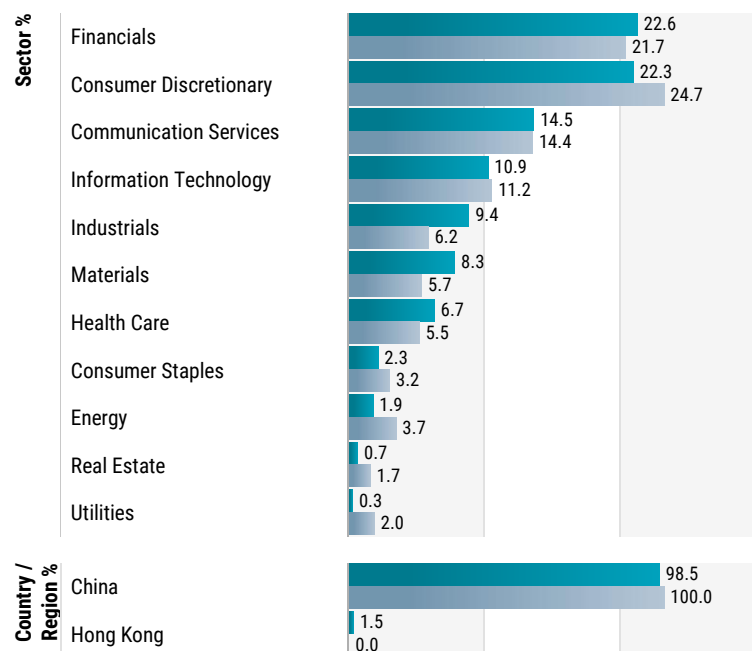

Performance commentary

Based on transaction prices, the fund's return was 3.04%.

Robeco Chinese Equities underperformed versus the benchmark in July. At the sector level, information technology, industrials, materials, and energy detracted. Financials contributed positively. At the stock level, the main detractors were Giga Device Semiconductor, Zhongji Innolight, and Cambricon Technologies. The top contributors were Kingboard Laminates, Hua Hong Grace Semiconductor, and China Construction Bank.

Market development

In July, China's market witnessed a sharp narrowing of the AI versus non-AI performance gap as crowded tech positions unwound, prompting a massive rotation into lagging cyclical and defensive sectors. Global scrutiny over AI monetization timelines, hyperscaler cash flows, and capex sustainability triggered a de-risking event that quickly spilled into China's tech space, exacerbated by tight global liquidity and Middle East tensions. Consequently, AI-heavy onshore indices plummeted, while offshore markets surged as capital rotated into consumer, financials, and real estate. However, looking into August, we expect the AI trade to reassert leadership as forced selling appears largely exhausted.

Expectation of fund manager

China enters 2026 following a strong equity market rally in 2025, driven by renewed confidence in innovation and a moderation in US-China trade tensions. Policymakers are now prioritizing stability, execution quality, and longer-term economic rebalancing rather than aggressive reflation. Against this backdrop, the equity market is transitioning from a valuation-led recovery to a more earnings-driven phase. China's National People's Congress (NPC) has set a 2026 GDP growth target of 4.5 to 5%, signaling a preference for incremental easing and calibrated support rather than large-scale stimulus. While fiscal and monetary tools remain available, they are being deployed more selectively, with greater emphasis on addressing domestic frictions such as overcapacity, weak pricing power, and inefficient competition, while advancing priorities including anti-involution, market unification, and innovation led upgrading.

Top 10 largest holdings

We maintain a meaningful exposure to high-quality internet platforms within our top ten holdings, including Tencent, Alibaba, PDD, NetEase, and Meituan. Against the backdrop of declining government bond yields in China, high-dividend names have become increasingly attractive, reflected in our positions in China Construction Bank and the Industrial and Commercial Bank of China. The portfolio also includes Contemporary Amperex Technology, a global leader in battery manufacturing and innovation; WuXi AppTec, a leading Chinese CDMO provider; Ping An Insurance, one of China's premier insurance groups; and BYD, China's top automaker.

Sector allocation

The portfolio had an overall overweight in industrials, materials, healthcare, financials, and communication services. It was underweight in consumer discretionary, energy, utilities, consumer staples, real estate, and information technology.

Environmental Footprint ²

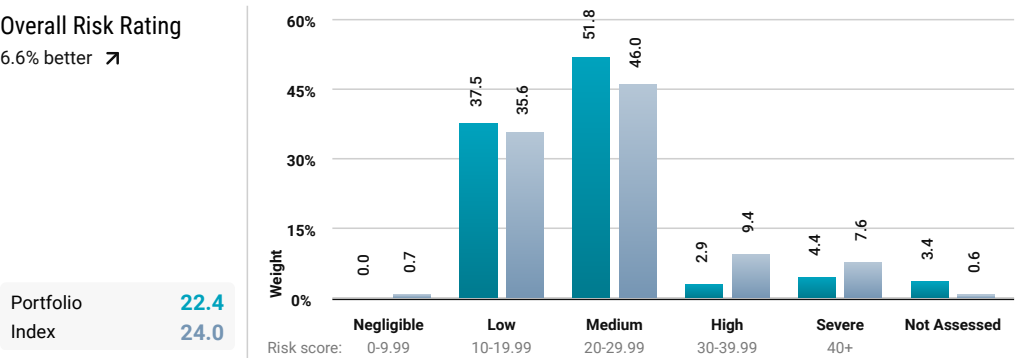

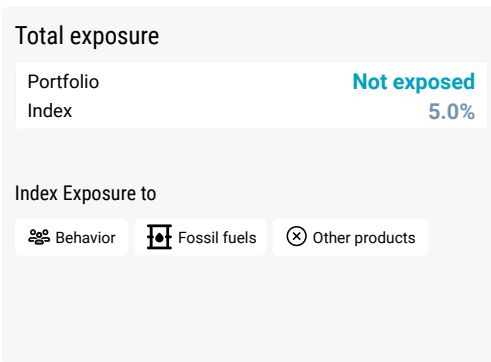

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Active. Risk management systems continually monitor the portfolio's divergence from the benchmark. In this way, extreme positions are avoided.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund.
