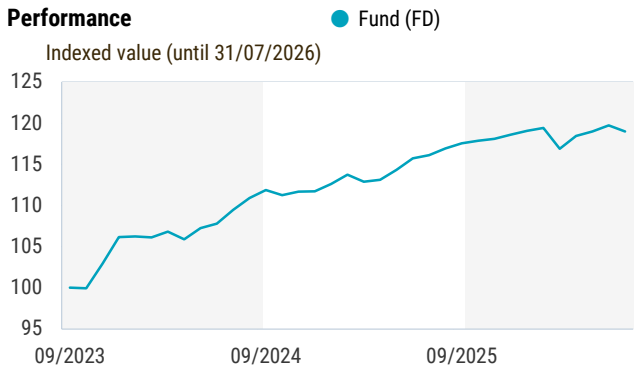

About the fund

Robeco Climate Global High Yield Bonds is an actively managed fund that invests predominantly in bonds with a sub-investment grade rating. The selection of these bonds is based on fundamental analysis. The fund's sustainable investment objective is to contribute to keeping global temperature rise well-below 2°C by reducing the carbon footprint of the fund. The fund's objective is also to provide long term capital growth. The portfolio is broadly diversified, with a structural bias towards the higher rated part in high yield (BB/B). Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.

Performance commentary

Based on transaction prices, the fund's return was -0.64%.

Both negative excess returns and underlying rates widening contributed to the negative total return over the month, as the 5-year US yield settled 20 bps wider at 4.45%. The benchmark returned -0.48% over the month, while the portfolio outperformed by 14 bps. Issuer selection was positive, adding 13 bps to performance, while beta positioning contribution was 1 bps. Euro-denominated bonds outperformed on a risk adjusted basis, particularly the higher quality segment, benefiting the portfolio. From a sector perspective, underweight in the communications and the consumer non-cyclical sectors added 8 and 6 bps, respectively, whereas underweight in the technology and finance sectors detracted 2 and 2 bps, respectively. Underweight in Virgin Media added 5 bps, as concerns were increasing over the highly leveraged capital structure without a clear deleveraging path. Underweight in Gray Media detracted 2 bps, as the company improved its balance sheet from a bondholder's perspective, repaying the preferred stock and doing accretive acquisitions.

Market development

In July, high yield OAS widened by 10 bps to 286, and YTW widened 30 bps to 7.11%. The Iran ceasefire collapsed in early July as renewed US-Iran strikes forced tankers to turn around in the Strait of Hormuz, sending Brent crude surging more than 20% over the month to settle near USD 88/bbl – erasing much of June's relief. The US labor market softened further, with June payrolls at just +57k (vs 110k consensus) and prior months revised down a combined 74k, though unemployment ticked down to 4.2% on a falling participation rate. The FOMC held rates at 3.50–3.75% with three dissents in favor of a hike, and rates volatility was meaningful through the month as markets repriced the path of policy in both directions. In Europe, the ECB held at 2.25% after June's hike but Lagarde signaled that a September increase was likely; the July flash CPI ticked up to 2.9% (from 2.8%) with core rising to 2.5%, reinforcing the case for further tightening. Gross new issuance (USD) totaled USD 18 bn over the month, while the HY bonds default rate ticked up to 2.77%.

Expectation of fund manager

Global high yield enters 2026Q3 with valuations still tight, despite an increasingly complex macro backdrop. The Iran ceasefire and falling oil prices, together with signs of a cooling US labor market, should help contain inflation and reduce the need for further hikes from both the Fed and ECB. Geopolitical risk hasn't disappeared, however. While the immediate Gulf threat has diminished, the Russia-Ukraine conflict has entered a more unpredictable phase, and although markets have largely shrugged this off, it raises the risk of tail events and volatility spikes. Meanwhile, the AI investment cycle continues unabated, driving strong issuance across credit markets, including a growing number of data center-related HY transactions, with investor demand comfortably absorbing supply so far. Dispersion remains elevated: most issuers trade well inside long-term averages, while a smaller group widens materially on company-specific concerns, refinancing risk or structural disruption. We remain cautious, emphasizing quality, resilience and downside protection, while avoiding areas where spreads offer insufficient compensation for the macro and geopolitical risks at hand.

Top 10 largest holdings

Our largest positions are concentrated in communications, healthcare and financials, alongside select exposures in utilities, capital goods and consumer products. In communications, Charter Communications and Telefónica represent key holdings. Within healthcare, we hold sizeable positions in Teva and Davita. Financial exposure is driven by insurance, financial companies and banking positions. We also maintain allocations to regulated electric utilities, capital goods through United Rentals, and consumer products.

Sector allocation

The fund maintains overweights in capital goods, with a particular focus on packaging and paper, alongside a pronounced overweight in financials. Telecommunications also contributes positively within communications. On the other hand, we remain underweight in consumer cyclicals and consumer defensives, as well as technology and industrials, with underweights spanning media, retail, healthcare and broader industrial exposures.

Country / Region allocation

Country risk analysis is incorporated in our proprietary credit research, but we do not implement any specific top-down country policy in the portfolio. We have a slight preference for Europe versus the United States based on valuations.

Currency denomination allocation

All currency risks are hedged to the currency of the share class. The currency denomination allocation shows the currency distribution of the portfolio before hedging.

Duration allocation

Robeco Climate High Yield Bonds does not pursue an active duration policy. HY bonds tend to have a limited effective sensitivity to underlying moves in government bond yields. In our 0-duration share classes, the underlying rate risk is hedged to 0 to 6-month duration.

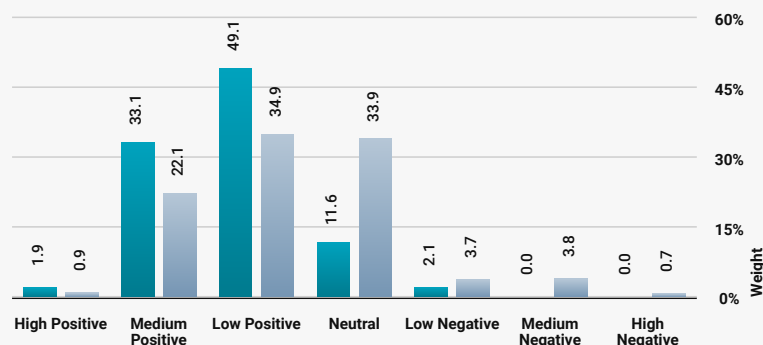
Rating allocation

Most exposure is in Ba and B issuers. The fund has a large underweight in the categories Caa and below. We have an allocation to BBBs, consisting of former rising stars that still trade at attractive spread levels and some EM issuers with IG ratings.

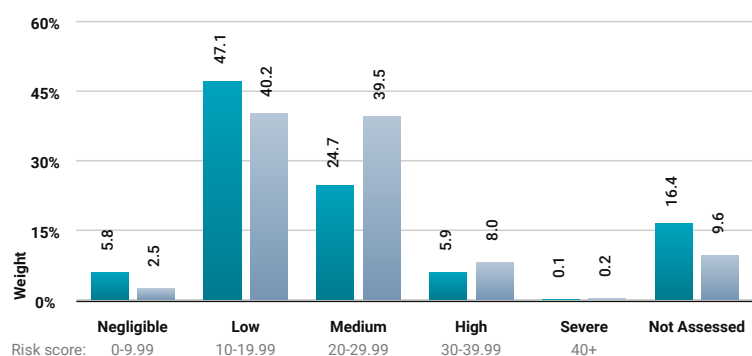
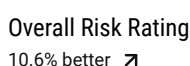

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

3. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment
