Robeco Climate Global High Yield Bonds is an actively managed fund that invests predominantly in bonds with a sub-investment grade rating. The selection of these bonds is based on fundamental analysis. The fund's sustainable investment objective is to contribute to keeping global temperature rise well-below 2°C by reducing the carbon footprint of the fund. The fund's objective is also to provide long term capital growth. The portfolio is broadly diversified, with a structural bias towards the higher rated part in high yield (BB/B). Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.

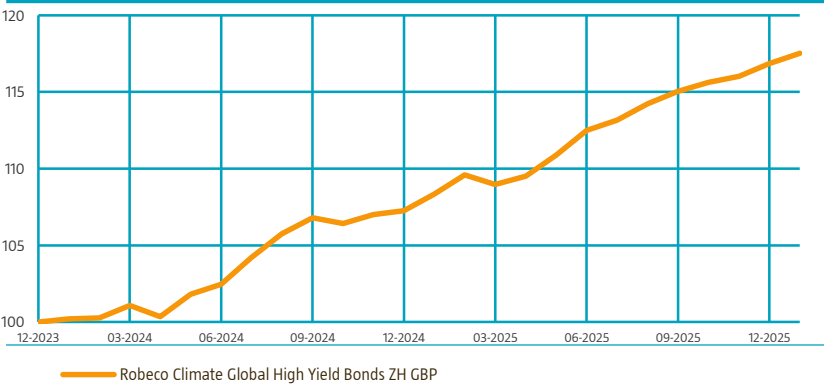

Performance

Based on transaction prices, the fund's return was 0.57%.

In January, the high yield market had a total return of 0.37%. Credit excess returns were positive, but underlying government rates detracted, as the US 10-year yield settled higher at 4.23%. The portfolio outperformed by 5 bps this month, as issuer selection contributed 11 bps and underweight beta positioning detracted 6 bps. As mentioned, the month was characterized by strong returns in the lower-rated credits in both currencies, with a slight outperformance of USD, where BBs posted the best risk-adjusted returns. Our allocation to higher-quality credits, mainly in the BB and BBB space, contributed meaningfully to performance. Overweight in the banking and overweight in the capital goods sectors added 6 and 6 bps, respectively, whereas overweight in the basic industry sector detracted 6 bps. The underweight position in Multi-Color contributed 7 bps, as the US labels company skipped a payment during the month and enters into negotiations with lenders to address its substantial maturities. The underweight in consolidated energy detracted 5 bps, as the bonds rebounded following the finalization of a litigation which will release significant working capital for the company.

Market development

In January, high yield spreads tightened by 4 bps to 269, while YTW widened by 1 bps to 6.26%. January data highlighted a growing disconnect between headline growth and underlying sentiment. While US GDP growth for 2025Q3 was confirmed at a strong 4.4% annualized pace, consumer confidence fell sharply, with the Conference Board index dropping to 84.5, its lowest level since 2014. The divergence reinforced the narrative of a bifurcated economy, where gains from a strong equity market are concentrated among higher-income households, while the broader population faces pressure from higher prices and a cooling labor market. The Federal Reserve kept rates on hold for the first time since July, with Chair Powell stressing there was no urgency to cut and that policy was no longer clearly restrictive. Markets continue to price the next rate cut no earlier than the summer. Meanwhile, risk sentiment recovered, with the S&P 500 climbing above 7,000 as equities rebounded from the Greenland-related sell-off. US HY new bond issuance totaled USD 28 bln in January.

Expectation of fund manager

The fourth quarter of 2025 ended positively for credit investors, with high yield delivering excess returns, though the lowest-rated credits underperformed, highlighting the need for selectivity. Looking to 2026, global growth prospects are strong. In the US, the average consumer remains resilient despite ongoing disparities, with lower-income groups and small businesses facing more challenges. The AI investment surge, reduced tariff uncertainty, and continued monetary easing are expected to support US economic growth, with consensus forecasting 2% real GDP growth. While the labor market poses some risks, recession fears have eased and a reacceleration is possible. US inflation is above target but manageable, aided by cooling services inflation and lower oil prices. The Fed must balance growth, inflation, and a potentially softer labor market. In Europe, rates support the economy, but growth is expected to be modest. Uncertainty from new AI sector supply and M&A activity clouds the 2026 outlook. Valuations are tight, so we remain conservative, focusing on quality and risk management.

Top 10 largest positions

Our largest overweightings are spread across a diverse set of sectors. In communications, Charter represents a key position, while in pharmaceuticals we maintain a significant allocation to Teva. Within utilities, Terna is a notable overweight, and in healthcare, we hold a meaningful position in IQVIA. We also maintain a substantial overweight in ASR Nederland within insurance, alongside exposure to Telefónica in telecommunications and Belden in cable manufacturing.

Sector allocation

The fund currently carries overweights in less cyclical industries such as basic industry and capital goods, with an emphasis on issuer selection within packaging, chemicals, and pharmaceuticals. Financials remain one of our largest sector allocations, complemented by additional overweights in food & beverage and telecommunications. On the other hand, our most pronounced underweights are in healthcare, gaming, retailers and media.

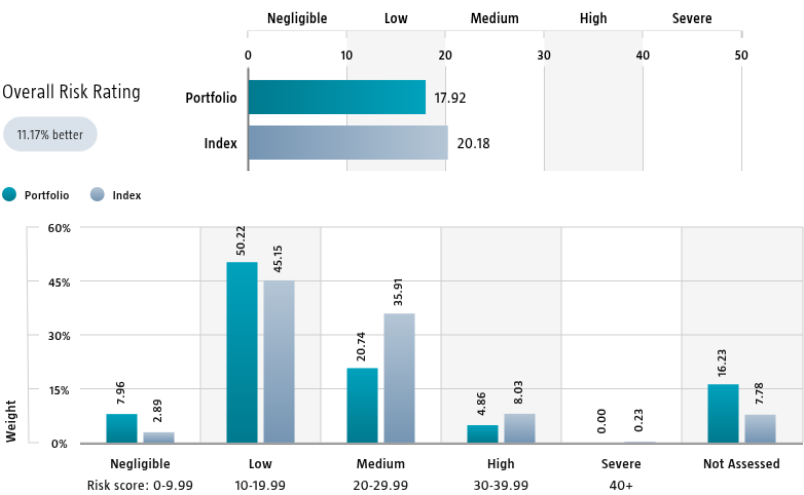

Sustainability

The fund's sustainable investment objective is to contribute to keeping global temperature rise well-below 2°C by reducing the carbon footprint of the fund. Climate change and sustainability considerations are incorporated in the investment process via exclusions, ESG integration, a minimum allocation to ESG-labeled bonds and a carbon footprint target. The fund does not invest in companies that are in breach of international norms and applies the activity-based exclusions of Article 12 of the EU regulation on Climate Transition Benchmarks, EU Paris-aligned Benchmarks and sustainability-related disclosures for benchmarks as per Robeco's exclusion policy. ESG factors, including climate change, are integrated in the bottom-up security analysis to assess the decarbonization potential and the impact of financially material ESG risks on the issuer's fundamental credit quality. Furthermore, the fund invests at least 2% in green, social, sustainable, and/or sustainability-linked bonds. In the portfolio construction the fund targets a carbon footprint at least equal to or better than the Solactive Paris Aligned Global Corporate Index. This is to ensure the fund is aligned with the desired decarbonization trajectory of an average 7% year on year. For more information please visit the sustainability-related disclosures. Sustainalytics ESG Risk Rating

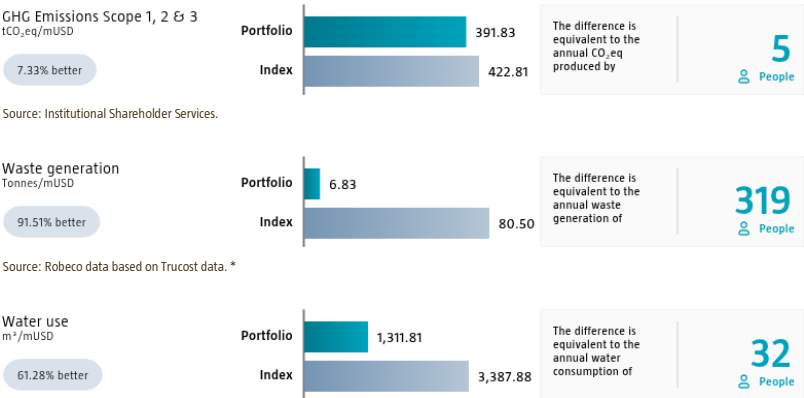

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

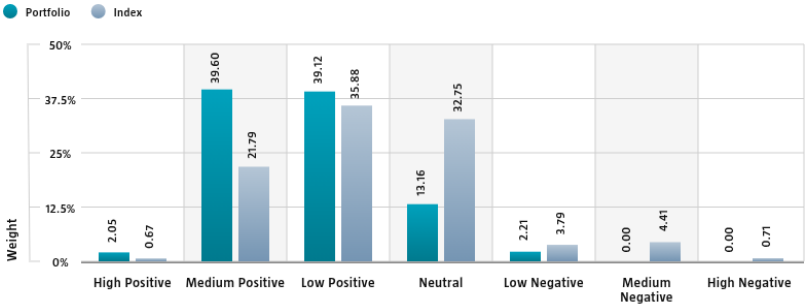

SDG Impact Alignment

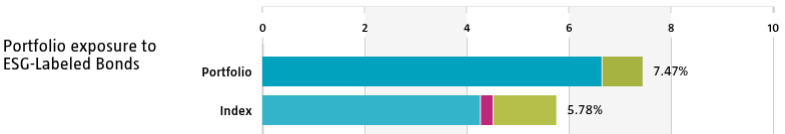

Engagement

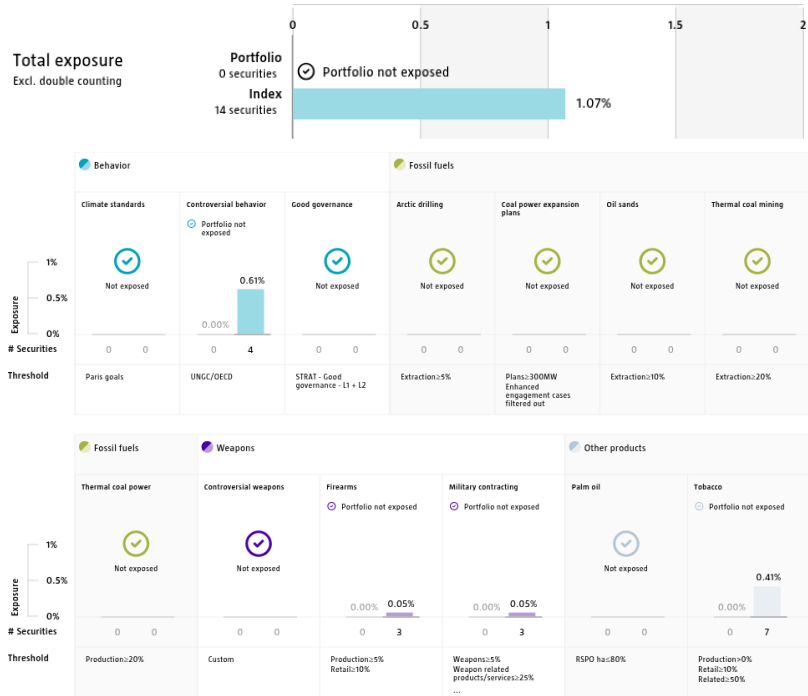
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.
