The selection of these bonds is based on fundamental analysis. Performance drivers are the top-down beta positioning as well as bottom-up issuer selection. 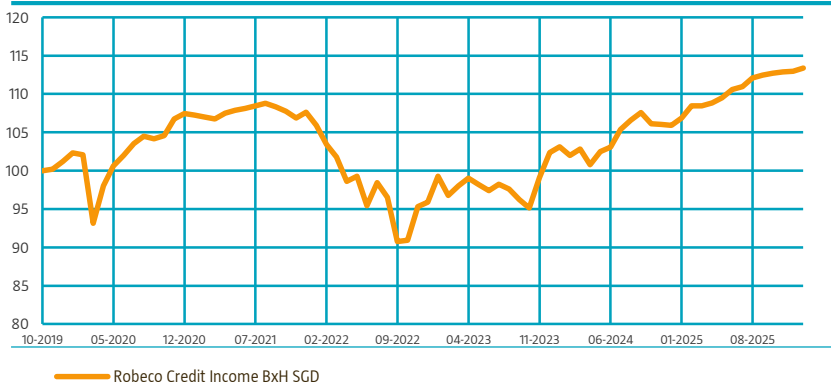

### Performance

Based on transaction prices, the fund's return was 0.37%.

The fund had a positive total return in January. Cash yields continued to make a positive contribution, but this was partially offset by a negative contribution from duration exposure. The total contribution from credit was positive in January. Positive contributors were Mexican chemical company Orbia, telecom company CAS Capital and Turkish soda ash producer WE Soda. There were negative contributions from mortgage servicer PennyMac, packaging company Crown Cork and sovereign bonds of Mexico.

### Market development

Markets began 2026 on a firm footing, supported by resilient macro data and improving risk appetite, with equities reaching fresh highs despite elevated cross asset volatility. Strong US activity indicators and softer European inflation reinforced expectations for eventual policy easing, helping credit spreads tighten. Geopolitical risks weighed early, as tensions around Greenland and renewed uncertainty in the Middle East and Latin America pushed energy prices higher and increased demand for hedges, before easing as tariff threats and annexation rhetoric faded, allowing risk assets to recover. While equities and commodities experienced notable swings, credit volatility remained comparatively subdued. High yield spreads were 8 bps tighter and closed at 283 bps, and investment grade spreads tightened 4 bps to 75 bps. Emerging market spreads tightened 13 bps to 224 bps. Treasury yields were slightly higher over the month; the 5-year yield rose 6 bps to 3.79%.

### Expectation of fund manager

Credit markets enter 2026 supported by solid macro fundamentals, but tight valuations make the setup fragile. Global growth remains constructive on AI capex and gradual policy easing. The US still has momentum, yet softer labor data and political noise around the Fed add uncertainty. Europe looks steadier, with benign inflation, healthy balance sheets and supportive policy. EM is resilient, though China's stimulus uncertainty and rich pricing call for selectivity. Spreads are near historic tights, so there is limited upside from further spread tightening. We continue to prefer shorter spread duration. Given the decent macro outlook, we are comfortable in adding carry via high yield and emerging markets. Although inflation moves in the right direction, there remain concerns that fiscal spending could revive inflation again. We remain therefore careful on the longer end of treasury curves and continue to favor short and intermediate maturities.

## Top 10 largest positions

The top ten positions mostly consist of high yield-rated corporates and holdings in subordinated financials. Our subordinated financials positions are mainly in Tier-2 securities. Our high yield holdings are to a large extent in subordinated financials.

### Subordination allocation

The fund holds a significant allocation to banking and insurance, mainly via subordinated bonds. In CoCo bonds, we prefer shorter dated calls with high reset spreads. With index spreads close to historical tights, selection should focus on instruments with limited extension risk. For instruments with lower reset spreads, we have a clear preference for the higher-quality higher-rated issuers. We also see some opportunities in corporate hybrids and have added some exposure.

## Sustainability

Sustainability is incorporated in the investment process by the means of a target universe, exclusions, ESG integration, and a minimum allocation to ESG-labeled bonds. The fund solely invests in credits issued by companies with a positive or neutral impact on the SDGs. The impact of issuers on the SDGs is determined by applying Robeco's internally developed three-step SDG Framework. The outcome is a quantified contribution expressed as an SDG score, considering both the contribution to the SDGs (positive, neutral or negative) and the extent of this contribution (high, medium or low). In addition, the fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. ESG factors are integrated in the bottom-up security analysis to assess the impact of financially material ESG risk on the issuer's fundamental credit quality. Furthermore, the fund invests at least 5% in green, social, sustainable, and/or sustainability-linked bonds. Lastly, where a credit issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion.

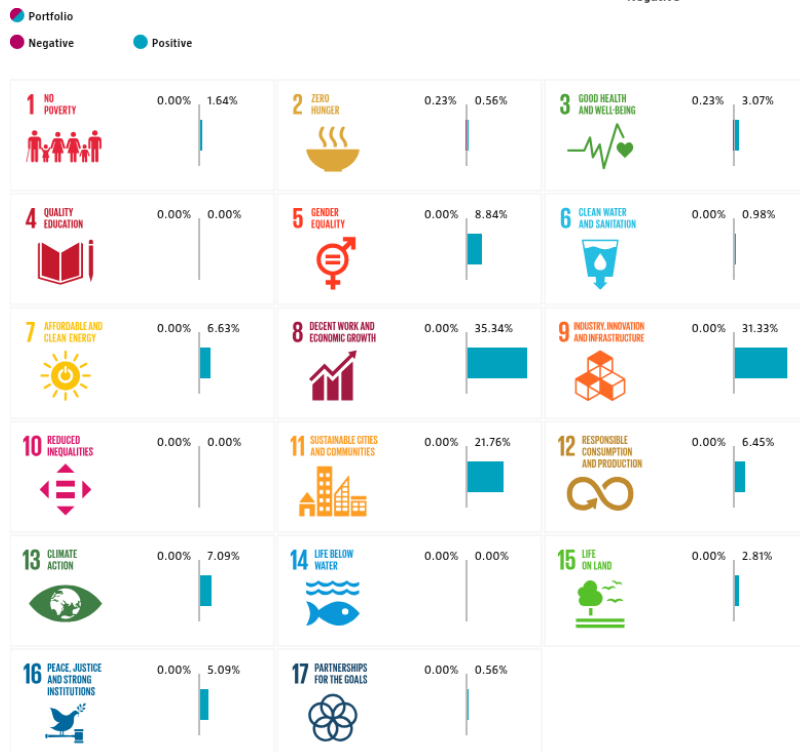

## SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. Sustainalytics ESG Risk Rating

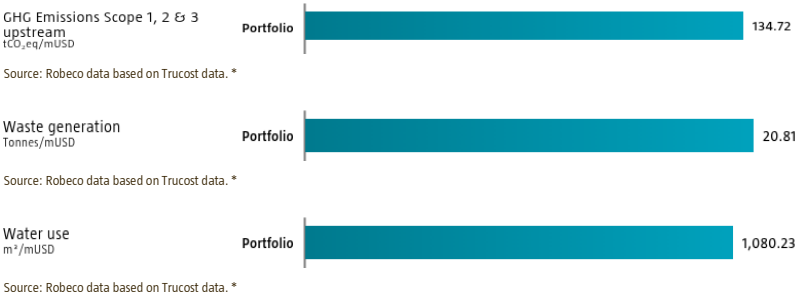

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

He has been active in the industry since 1997 and holds a Master's in Econometrics from Tilburg University. Jan Willem Knoll is Portfolio Manager Investment Grade in the Credit team. He joined the Credit team in 2016. Previously, Jan Willem headed the Financials Equity sell-side research team at ABN AMRO. He started his career in the industry in 1999 at APG, where he held several positions including Portfolio Manager of a global insurance portfolio and subsequently a pan-European financials portfolio. Jan Willem holds a Master's in Business Economics from the University of Groningen and he is a CFA® charterholder.
