Performance

Based on transaction prices, the fund's return was -0.95%.

Last month, our AI Revolution and Next Generation Consumer themes outperformed the market, while our Health & Hygiene and Experience Economy themes were the biggest laggards. Performance dispersion across themes was pronounced. In the AI Revolution cluster, MongoDB (+26%) delivered strong earnings with better than expected margins. Samsung Electronics (+19%) also contributed positively as memory prices continued to rise, reinforcing investor confidence in the cycle. Within the Experience Economy, Nintendo (-20%) declined due to concerns that surging memory costs could pressure margins for upcoming hardware, alongside softer-than-expected holiday gaming activity. Netflix (-13%) fell after announcing a nearly USD 100 billion bid for Warner Bros Discovery's assets, raising concerns about valuation, regulatory timelines, and the near-term earnings impact. In Health & Hygiene, EssilorLuxottica (-13%) weakened after Google revealed AI powered smart glasses. The market reacted to the competitive threat, although we continue to view EssilorLuxottica's brand strength and vertical integration as meaningful advantages.

Portfolio changes

Several selective adjustments were made during the month. A new position was initiated in Kering with Gucci as most important brand, re establishing exposure to the luxury segment. Gucci's recent underperformance and margin pressure have been notable, but the new design direction is expected to stabilize brand momentum. The position was funded by selling L'Oréal, where we see limited upside given stagnant 4-5% growth and a valuation that leaves little room for multiple expansion. We switched from Coinbase to Robinhood. While Coinbase remains the leading crypto focused platform, Robinhood offers broader retail market participation by combining equities, crypto, and prediction markets. A new holding was added in Royal Caribbean Cruises. The company benefits from structurally improved margins through its private island strategy. Destinations such as Perfect Day at CocoCay generate substantially higher per passenger spending and eliminate port-related fees, supporting sustained profitability.

Market development

US economic data in December surprised to the upside. GDP expanded at an annualized 4.3%, the strongest pace in two years, easing concerns about weakening consumer spending. Despite this resilience, the Federal Reserve cut interest rates by 25 basis points to 3.75%, driven largely by slowing job growth. Inflation remained a worry for investors, reflected in 10-year US Treasury yields holding above 4%. Global equity markets were mixed. The MSCI All Country World Index remained more or less flat, with currency effects continuing to weigh on euro-based investors due to the weaker US dollar. Emerging markets outperformed developed markets, led by South Korea and Taiwan. Sector dispersion remained wide. Financials was the best sector in December, while consumer staples lagged meaningfully.

Expectation of fund manager

We maintain our conviction in a quality growth approach, despite macro uncertainty. Companies with strong intangible assets, high margins, and durable competitive advantages remain central to the strategy. These businesses have historically delivered attractive returns with downside protection, especially in environments of shifting sector leadership. While several consumer-related themes faced headwinds in December, long-term structural drivers such as digital transformation, AI adoption, and premium brand resilience remain intact. Management believes valuations for high quality franchises continue to be supported by strong business fundamentals and healthy forward earnings prospects.

Sustainability

The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. The fund targets at least 20% lower carbon footprint compared to the reference index. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

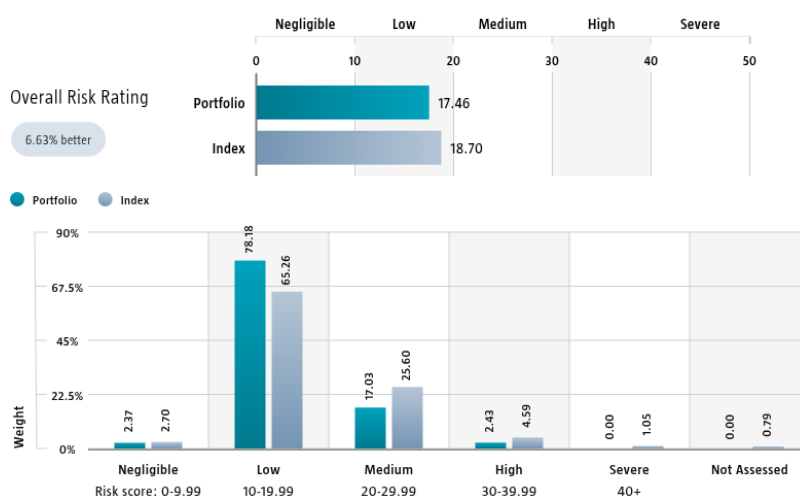

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. 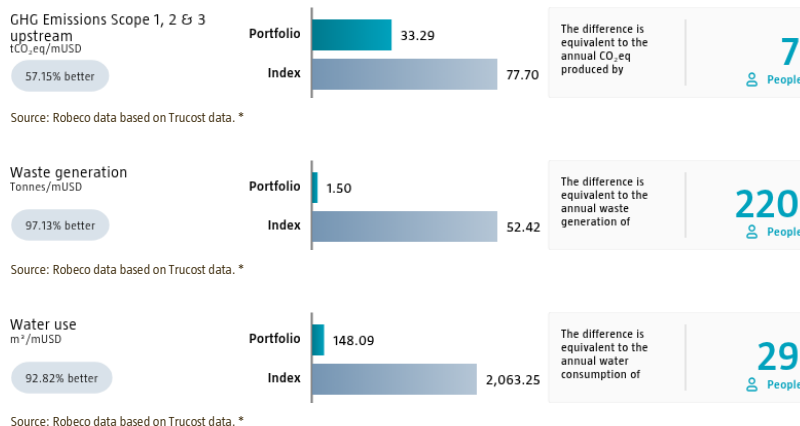

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

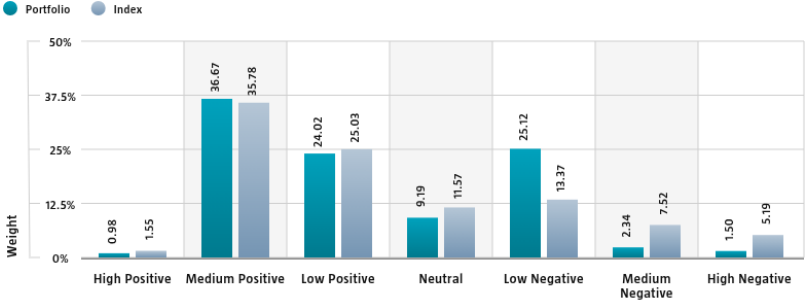

SDG Impact Alignment

Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund managers focus on selecting stocks of structural winners within these trends. The stock selection is based on fundamental analysis. The fund's objective is to achieve a better return than the broad equity index.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy.
