### Performance

Based on transaction prices, the fund's return was -0.59%.

The Next Generation Consumer theme acted as the primary detractor last month, whereas AI Revolution outperformed due to strong exposure to the semiconductor memory segment. Despite this strength, the investment narrative is shifting as concerns grow over the massive capital expenditures by hyperscalers, with quarterly spending for Microsoft (-9%) and Alphabet (-8%) reaching approximately USD 30 billion. A surge in data center construction has created a critical bottleneck in high-bandwidth memory, causing DRAM prices to skyrocket. This trend has significantly benefited the consolidated memory industry, particularly Samsung Electronics (+35%) and SK hynix (+18%). However, the parabolic nature of these recent gains leaves these stocks vulnerable to potential corrections. Meanwhile, Apple remains uniquely positioned, having avoided the aggressive capital expenditure increases seen among its technology peers.

### Portfolio changes

We reduced our exposure to Tencent Holdings, as the lackluster consumer spending sentiment in China continued, indicated by a rising promotional intensity across Lunar New Year. On top of that, investors are concerned that increased spending may be required by the tech giants for China's 'AI Plus' initiative. We also further trimmed our Magnificent Seven exposure by further reducing positions in Microsoft and Amazon, as concerns about the massive capital expenditures have risen. Finally, we increased our position in Danish freight forwarder DSV and Swedish streaming service Spotify. Both feel victim to an AI-based narrative that would disrupt their business. We fundamentally disagree here and have therefore used the sell-off in both shares to add to positions.

### Market development

US economic growth slowed sharply at the end of 2025, with output rising at a 1.4% annualized rate in the fourth quarter, down from 4.4% in the previous quarter. According to The Bureau of Economic Analysis, the prolonged government shutdown cut roughly one percentage point from growth. For the year as a whole, the economy expanded by 2.2%, its weakest annual performance since the pandemic-hit year of 2020. The dominant market narrative in 2026 centers on software's vulnerability to 'agentic' AI, which threatens traditional seat-based subscription models. While bears fear the commoditization of applications, bulls believe established firms will leverage proprietary data to adapt. This uncertainty triggered sharp sector sell-offs, contributing to Robeco Global Consumer Trends underperforming versus the broad index. Concurrently, a rotation toward 'hard assets' such as energy and materials intensified, fueled by geopolitical tensions in Iran and European gas shortages, leaving growth stocks trailing their value counterparts.

### Expectation of fund manager

Given the uncertain macro and geopolitical climate, our quality growth style seems well suited for the current investment climate. We believe long-term investors should focus on high quality businesses with valuable intangible assets, high margins, and superior returns on capital. Companies with these traits have historically delivered above average returns while offering downside protection. These firms are also poised to deliver healthy revenue and earnings growth, and we expect them to generate attractive long-term returns as a result. We believe premium valuations for these businesses are justified given the quality of their business models, the high levels of earnings growth and the sustainability of their franchises.

### Changes

The performance was achieved under circumstances that no longer apply. On 30 November 2009, the Robeco Consumer Goods Equities fund was converted from a sector fund into a trend fund Robeco Global Consumer Trends Equities. The fund can invest across regions and across sectors.

### Sector allocation

The fund invests in companies exposed to structural growth trends in consumer spending. As a result, the portfolio is invested mostly in the consumer discretionary, consumer staples, technology and communication services sectors. The fund may also invest in sectors that may appear to be not directly linked to consumption.

## Sustainability

The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. The fund targets at least 20% lower carbon footprint compared to the reference index. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

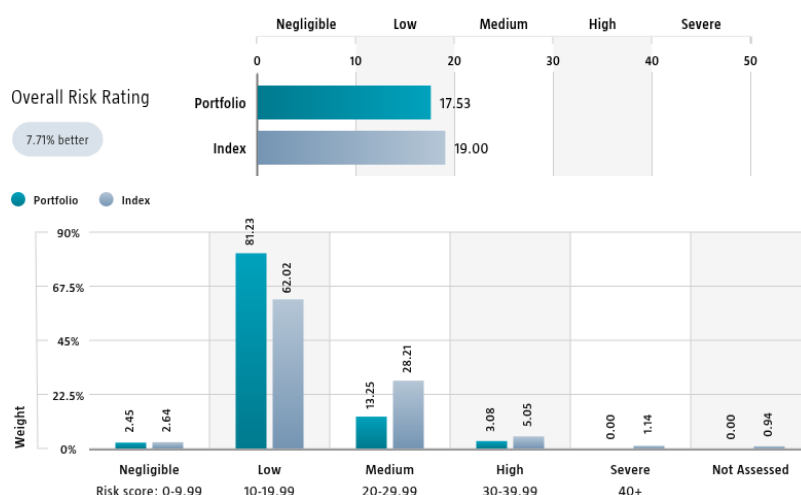

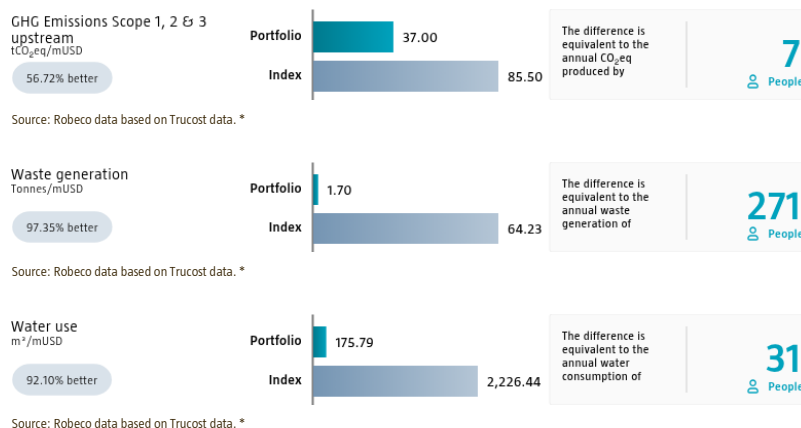

## Environmental Footprint

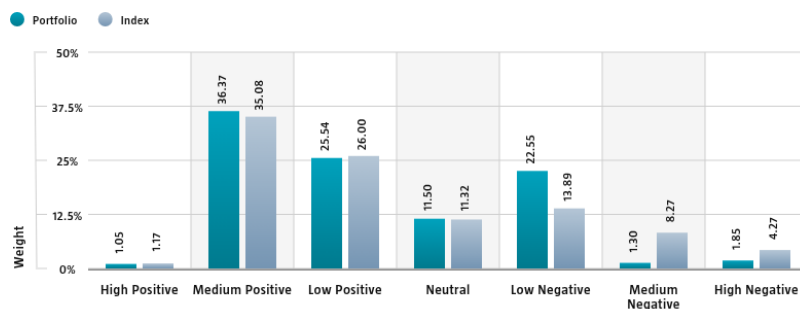
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. ## Engagement

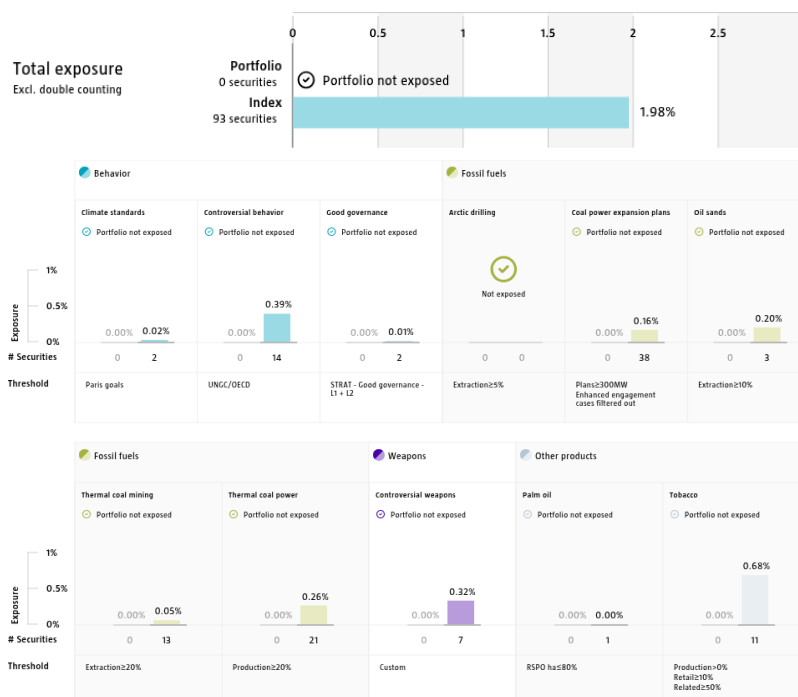
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund managers focus on selecting stocks of structural winners within these trends. The stock selection is based on fundamental analysis. The fund's objective is to achieve a better return than the broad equity index.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to normative, activity-based and region-based exclusions, proxy voting and engagement.

He has managed the strategy since December 2010. He joined Robeco as a Portfolio Manager European Equities in 2007. Previously, Richard was Portfolio Manager European Equities at Van Lanschot Asset Management and at Philips Investment Management. Richard holds a Master's in Business Economics and Finance from Maastricht University and is a CFA® Charterholder.
