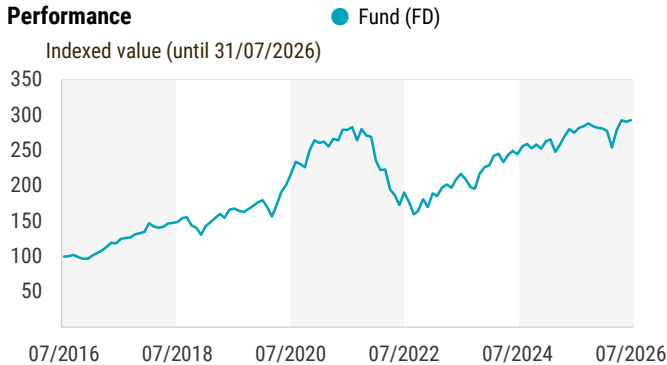

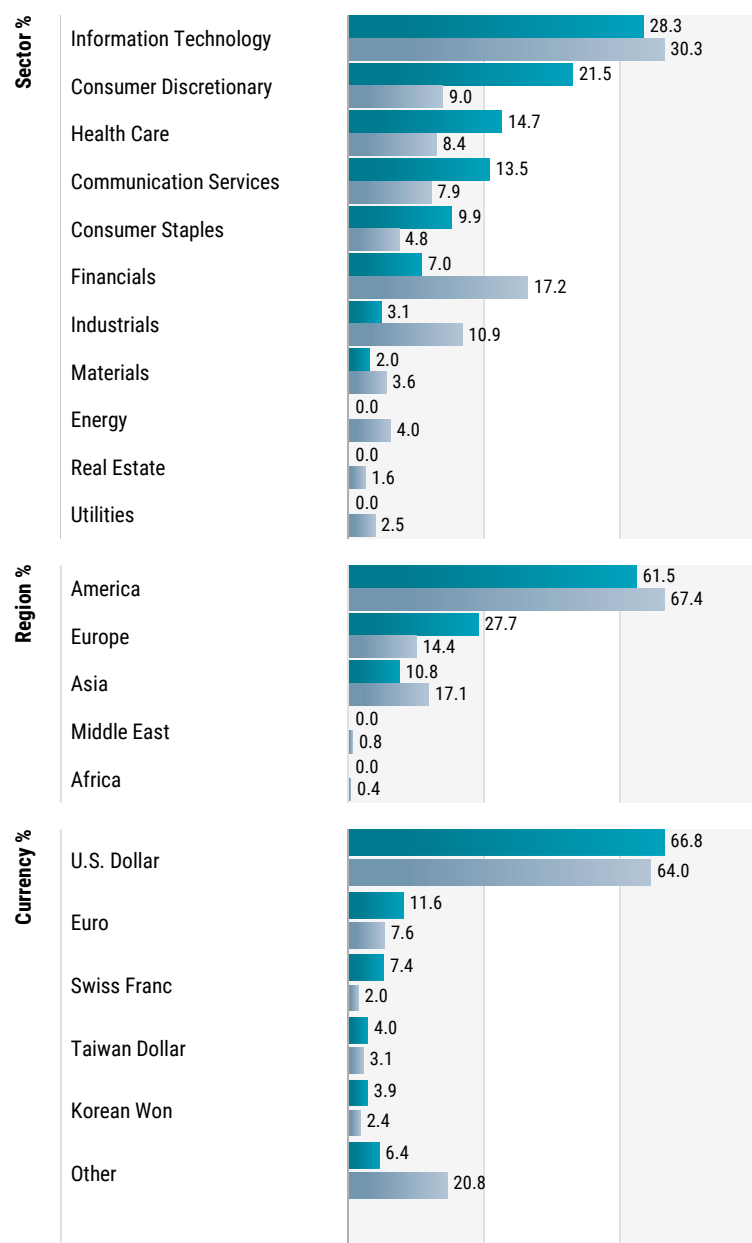

Performance commentary

Based on transaction prices, the fund's return was 0.75%.

Robeco Global Consumer Trends outperformed the MSCI All Country World Index in July for the third month in a row. Both theme allocation and stock selection contributed positively to relative performance. Next Generation Consumer was the strongest contributor during the month, supported by strong results from Amazon, continued momentum at discount retailer Action and improving sentiment toward luxury goods. The AI Revolution theme also contributed positively despite a challenging month for semiconductors, as gains in cloud and AI-related holdings outweighed weakness among several technology infrastructure names. Smart Living and Experience Economy delivered positive contributions, while Health & Hygiene was the largest detractor. Within the latter theme, weakness in Galderma, AstraZeneca and Eli Lilly more than offset positive contributions from IDEXX and Stryker. Personal Finance and Safety & Security also detracted modestly, although Mastercard remained among the strongest individual performers as resilient consumer spending continued to support payment volumes.

Portfolio changes

We increased the strategy's exposure to consumer, staples and healthcare companies through several new positions. We initiated investments in Eli Lilly, Compass Group, L'Oréal and Airbnb. Eli Lilly provides exposure to the fast-growing obesity and diabetes market, while Compass Group, L'Oréal and Airbnb offer attractive opportunities across foodservice, beauty and travel. We exited Danaher, BYD and Alibaba. Danaher was sold due to operational challenges and market share losses, while BYD and Alibaba were exited amid increasing competitive, regulatory and AI investment concerns. Furthermore, we reduced several technology-related positions, including NVIDIA and Tencent, while maintaining exposure where we continue to see long-term potential. We also trimmed Vertiv, Stryker and Galderma. Proceeds were redeployed into existing consumer-oriented holdings such as Anheuser-Busch InBev, Mastercard, Danone and 3i Group, reflecting our constructive view on consumer spending trends and improving company fundamentals.

Market development

Equity markets were volatile in July, following the strong rebound during the second quarter. Investor sentiment was initially supported by resilient economic data, easing geopolitical tensions and continued optimism around artificial intelligence. However, market leadership broadened as semiconductor stocks corrected sharply, reflecting investor concerns about earnings expectations and the prospective returns on significant AI-related capital expenditure. Macro developments were dominated by renewed tensions in the Middle East and the Federal Reserve meeting. Rising oil prices supported a strong recovery in energy stocks, while financials also performed well amid robust earnings results. At the same time, concerns that inflation may remain persistent pushed bond yields higher and reinforced expectations that monetary policy could remain restrictive for longer. Consumer spending trends remained resilient, supported by healthy labor market conditions and improving retail sales growth. The energy sector was the stand-out sector, followed by financials while IT was the laggard this month.

Expectation of fund manager

Given the uncertain macro and geopolitical climate, our quality growth style seems well suited for the current investment climate. We believe long-term investors should focus on high quality businesses with valuable intangible assets, high margins, and superior returns on capital. Companies with these traits have historically delivered above average returns while offering downside protection. These firms are also poised to deliver healthy revenue and earnings growth, and we expect them to generate attractive long-term returns as a result. We believe premium valuations for these businesses are justified given the quality of their business models, the high levels of earnings growth and the sustainability of their franchises.

Top 10 largest holdings

The top five largest positions for the month are NVIDIA, Alphabet, Amazon, Microsoft and TSMC.

Sector allocation

The fund invests in companies exposed to structural growth trends in consumer spending. As a result, the portfolio is invested mostly in the consumer discretionary, consumer staples, technology and communication services sectors. The fund may also invest in sectors that may appear to be not directly linked to consumption.

Regional allocation

The portfolio has direct exposure to emerging markets and Asia-Pacific, mostly to China, Japan, India, and Latin America. The fund's investments in Europe comprise approx. 25% of the fund, with the remainder invested in the US market.

Currency allocation

The portfolio itself does not use currency hedges. This means that for an unhedged share class, the currency allocation is a reflection of the investments of the portfolio. For a hedged share class, the currency allocation is the result of the currency hedge.

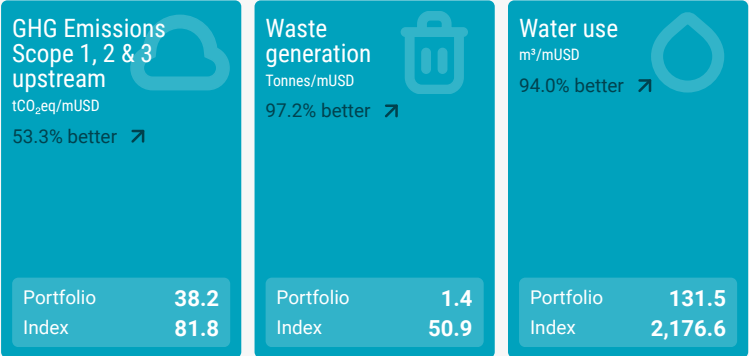
SDG Impact Alignment ¹

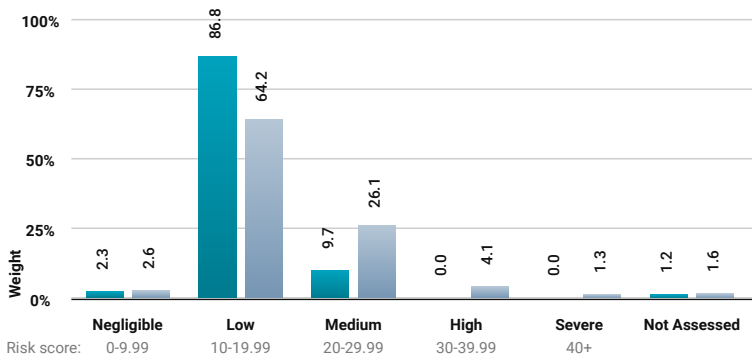

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
