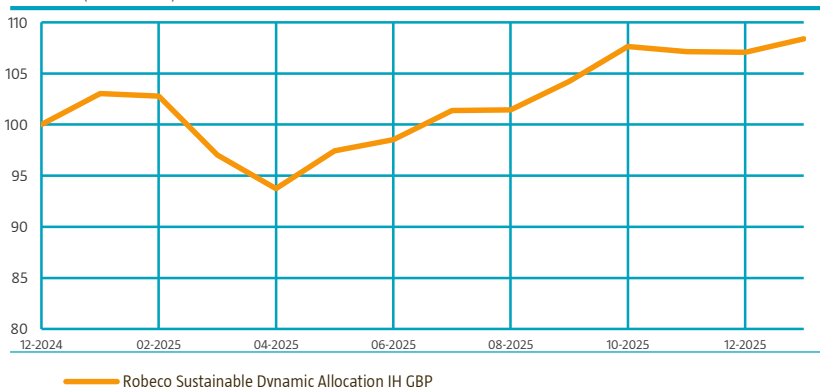

Performance

Based on transaction prices, the fund's return was 1.22%.

The Sustainable Dynamic Allocation Fund delivered a return of 1.2% for the month, broadly in line with its benchmark, with asset allocation supporting relative performance. The team maintained discipline amid short-term market volatility, and the decision to retain an overweight in equities contributed positively. The overweight allocation to emerging markets strengthened the portfolio's risk-on positioning. Active currency positioning added value, with an underweight in the US dollar against an overweight position in the Australian dollar. Despite late-month weakness, the tactical overweight in gold generated positive alpha. The short high-yield position detracted modestly. Security selection was mixed. In developed markets, the technology sell-off weighed on quantitative and fundamental strategies, with the mega trends allocation in particular experiencing a challenging period. Emerging market equity holdings performed more strongly. Within credit, the portfolio's high-quality tilt limited participation in spread tightening, although issuer selection contributed positively to returns during the reporting month.

Market development

January markets experienced heightened volatility, driven by shifting policy signals, early US dollar weakness, and strong commodity performance. Trade uncertainty resurfaced following the announcement of Greenland-related tariff measures, briefly weighing on risk sentiment and boosting demand for strategic resources before fading as monetary policy expectations shifted. In Japan, equities recorded solid gains after the government announced a new fiscal stimulus package and confirmed a snap general election, which investors viewed as strengthening the administration's policy mandate. As earnings season progressed, corporate results across major regions proved resilient, helping stabilize equity sentiment despite ongoing macroeconomic and geopolitical uncertainty. Emerging markets outperformed developed markets, supported by improving capital inflows and strength in commodity-exporting economies, while developed markets posted more modest gains. Precious metals reversed sharply late in the month, with gold and silver selling off after the appointment of a new Federal Reserve chair triggered a rebound in the US dollar.

Expectation of fund manager

Markets opened 2026 positively, with precious metals and emerging markets advancing and the US dollar weakening amid policy-driven volatility. Unexpected US policy announcements continue to shape market sentiment. Our investment stance remains unchanged. We favor equities across developed and emerging markets, supported by resilient earnings and a supportive macro backdrop. Monetary policy remains central, as economies show improving growth momentum while inflation remains elevated. In Australia, markets have begun to price potential rate hikes, though we view tightening as premature in most regions, with Japan the key exception. In the United States, uncertainty surrounding the successor to Chair Powell may add risk premiums to government bonds. We therefore maintain a neutral stance on sovereign debt, remain underweight in corporate bonds, and retain a constructive view on emerging market debt, supported by attractive carry and a weaker US dollar backdrop. While gold exposure was reduced, we continue to view it hedge against risk and currency debasement.

Sustainability

The Sub-fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, targets on investments in companies and countries based on ESG performance as well as engagement and a minimum allocation to ESG-labeled bonds. For government and government-related bonds, The Sub-fund complies with Robeco's exclusion policy for countries, excludes the 15% worst ranked countries following the World Governance Indicator 'Control of Corruption', and ensures investments have a minimum weighted average score of 6 following Robeco's proprietary Country Sustainability Ranking. The Country Sustainability Ranking scores countries on a scale from 1 (worst) to 10 (best) based on 40 environmental, social, and governance indicators. For corporate bonds, The Sub-fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. In the credit selection The Sub-fund limits exposure to issuers with an elevated sustainability risk profile as well as excludes companies with high or medium negative SDG scores following Robeco's internally developed three-step SDG framework. Where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion.

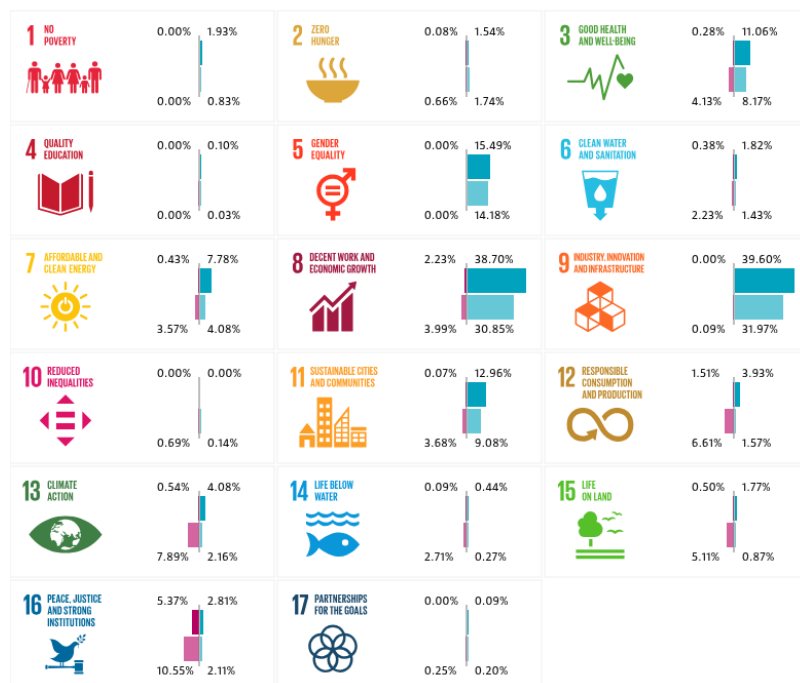
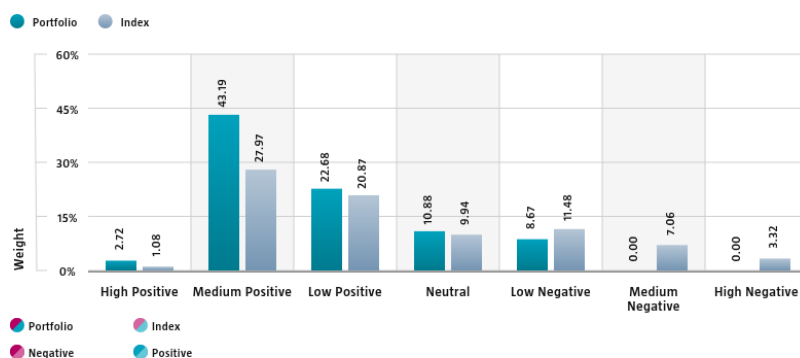

SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

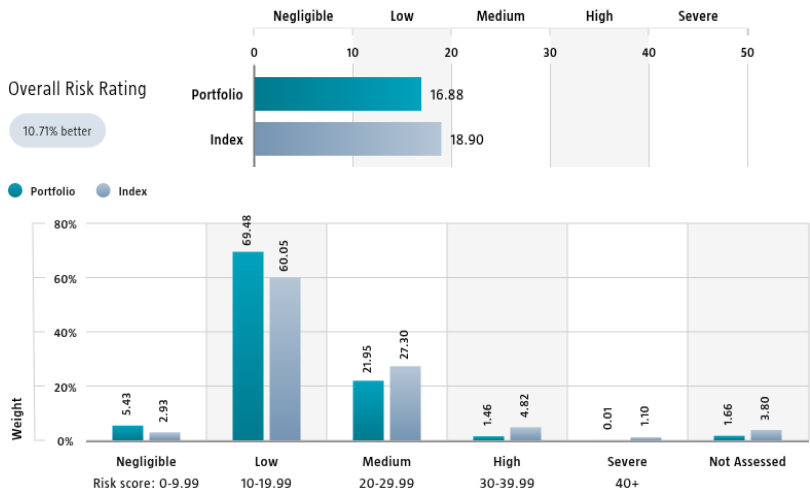

Sustainalytics ESG Risk Rating

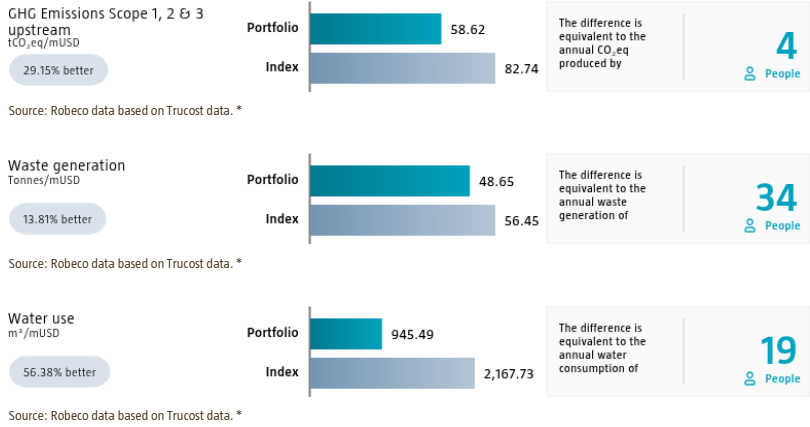
The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. Environmental Footprint

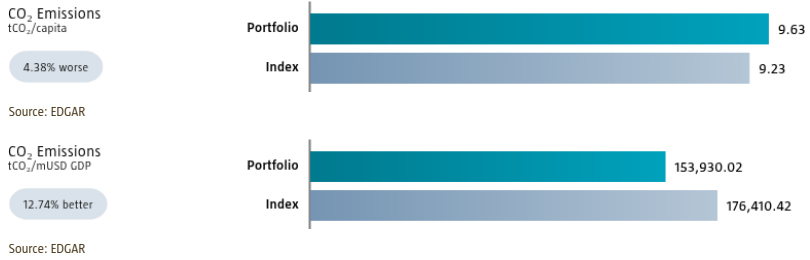
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

Environmental Intensity

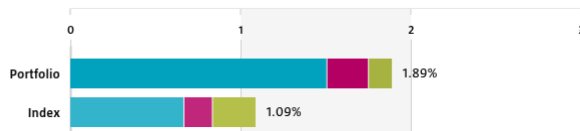
Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.



ESG Labeled Bonds

The ESG-labeled bond chart displays the portfolio's exposure to ESG-labeled bonds. Specifically, green bonds, social bonds, sustainability bonds, and sustainability-linked bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

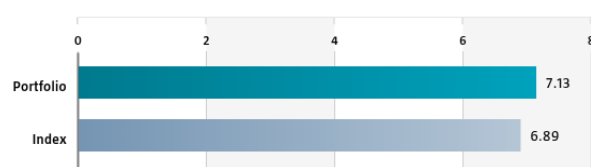

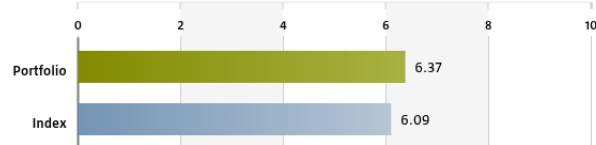

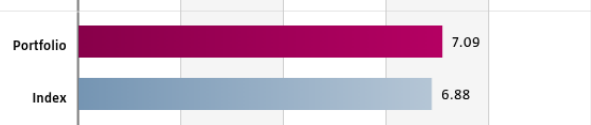

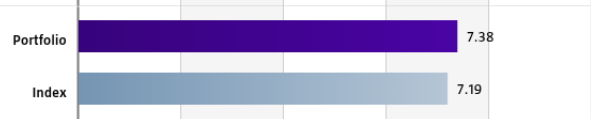

Engagement

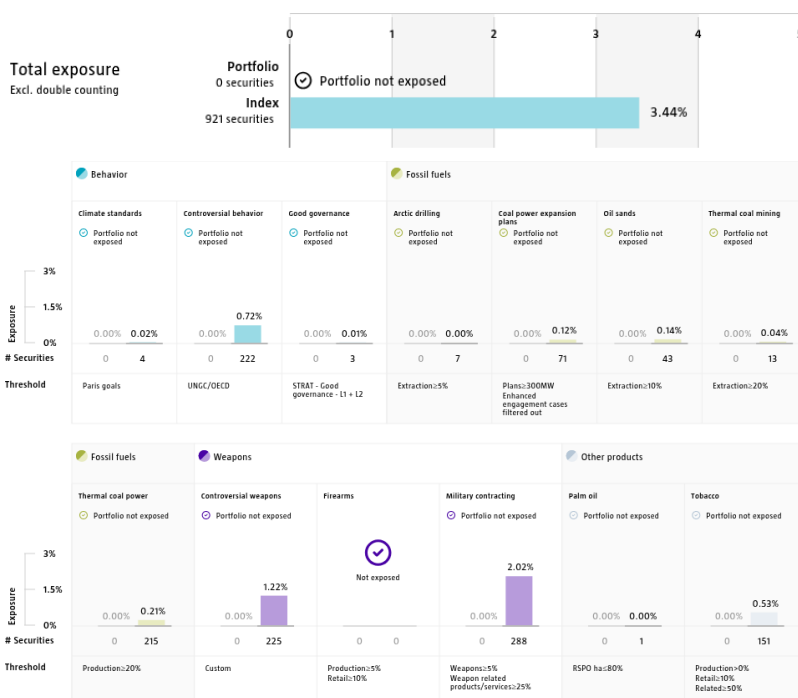
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
