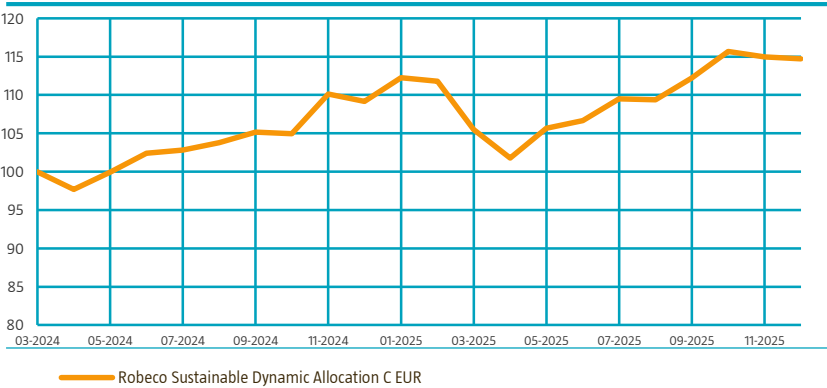

Performance

Based on transaction prices, the fund's return was -0.22%. The Sustainable Dynamic Allocation Fund declined by 0.1% in December, outperforming its benchmark by 0.1%. For the full year, the fund finished behind the benchmark, delivering a total return of 6.0% in euro terms and a relative return of -0.8%. Relative performance in December was supported by the overweight in equities, particularly emerging markets, where equities rallied sharply (1.8%) compared with declines in developed markets (-0.4%). Solid returns from European equities provided additional support. In fixed income, credit markets were broadly flat, although lower-rated bonds performed strongly, causing the fund's short position in high yield credit to detract. Given stretched valuations, the preference remains to take risk through equities amid a selective late-cycle environment. In alternatives, an overweight in gold added value. Selection effects were mixed: Global Developed Active and Credit Income were supportive, while the Impact strategy and Global Stars detracted as thematic and high-quality equities lagged broader markets.

Market development

The global economy ended 2025 in a stable but decelerating growth environment. While no broad signs of systemic stress emerged, economic momentum remained uneven across regions, reinforcing a cautious and orderly late-cycle backdrop rather than a shift toward renewed acceleration or outright downturn. Central banks broadly met market expectations in December, anchoring sentiment into year-end. The Federal Reserve delivered a widely anticipated rate cut, the European Central Bank maintained its policy stance, and the Bank of Japan continued gradual normalization. These decisions underscored policy continuity and incremental adjustment rather than abrupt shifts. Market behavior reflected late-cycle dynamics, with narrow and selective leadership prevailing over broad risk-on participation. Selective cyclical performed reasonably, while US technology delivered mixed results. Volatility in longer-dated bond markets persisted but failed to trigger sustained risk-off moves. Equity markets closed the year with mixed outcomes. Across other asset classes, commodities diverged, with subdued energy prices offset by firmer industrial metals, while credit markets remained resilient overall.

Expectation of fund manager

Financial markets delivered a strong year, with most major asset classes ending in positive territory. Global equities posted a third consecutive year of gains, while gold emerged as the standout performer. Looking ahead, the investment backdrop remains broadly supportive. Monetary policy is expected to remain accommodative, underpinning risk assets. Developed market equities remain overweight, supported by resilient earnings and improving revisions. In contrast, investment grade and high yield credit spreads remain tight and offer limited upside. In rates, government bonds are expected to be driven by supply and growth dynamics. 10-year US Treasury yields are expected to trade in a 4.0 and 4.5 percent range, with higher levels offering more attractive entry points. German Bunds appear more attractive above 3 percent, though volatility risks persist at the long end. Emerging market debt remains attractive, supported by advanced easing cycles, while emerging market equities remain appealing on a relative basis. Within commodities, oil is viewed cautiously, while copper offers better upside and gold remains preferred.

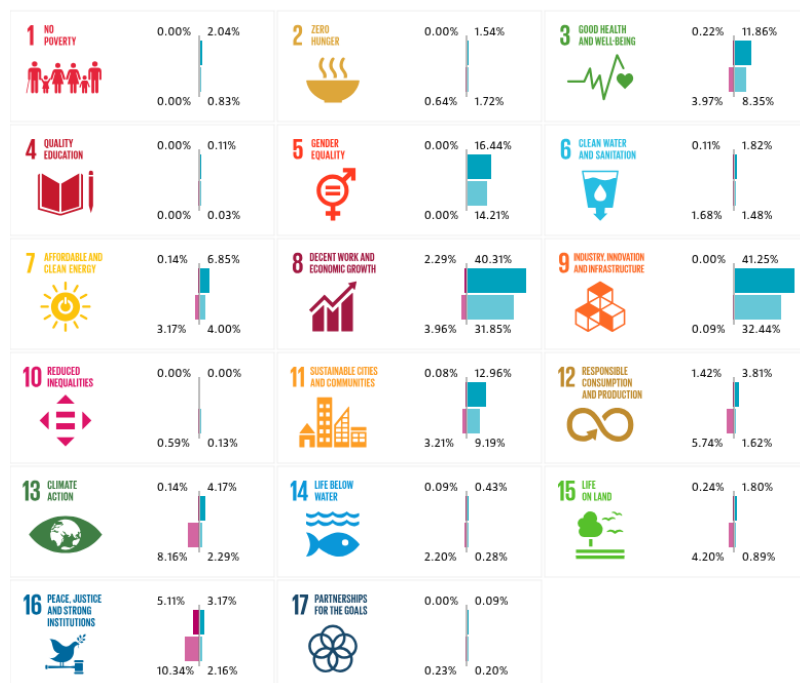
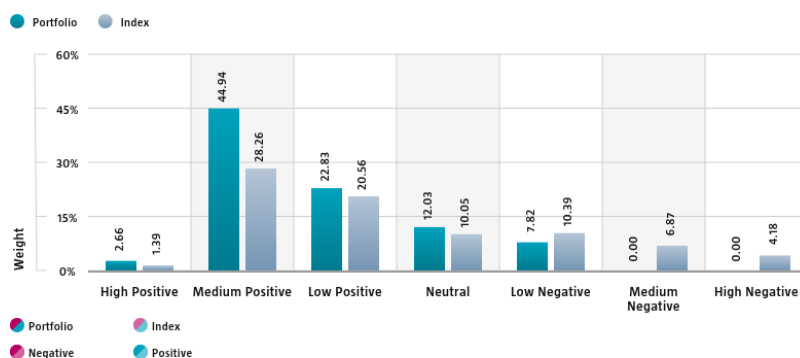
The Sub-fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, targets on investments in companies and countries based on ESG performance as well as engagement and a minimum allocation to ESG-labeled bonds. For government and government-related bonds, The Sub-fund complies with Robeco's exclusion policy for countries, excludes the 15% worst ranked countries following the World Governance Indicator 'Control of Corruption', and ensures investments have a minimum weighted average score of 6 following Robeco's proprietary Country Sustainability Ranking. The Country Sustainability Ranking scores countries on a scale from 1 (worst) to 10 (best) based on 40 environmental, social, and governance indicators. For corporate bonds, The Sub-fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. In the credit selection The Sub-fund limits exposure to issuers with an elevated sustainability risk profile as well as excludes companies with high or medium negative SDG scores following Robeco's internally developed three-step SDG framework. Where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

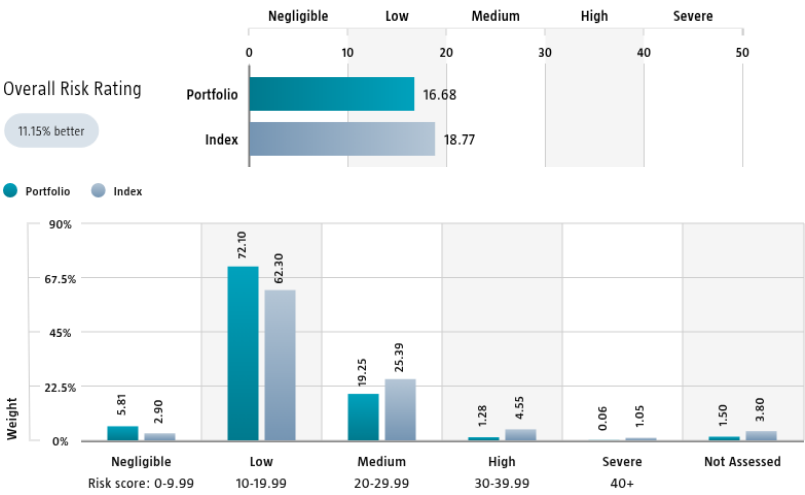

Sustainalytics ESG Risk Rating

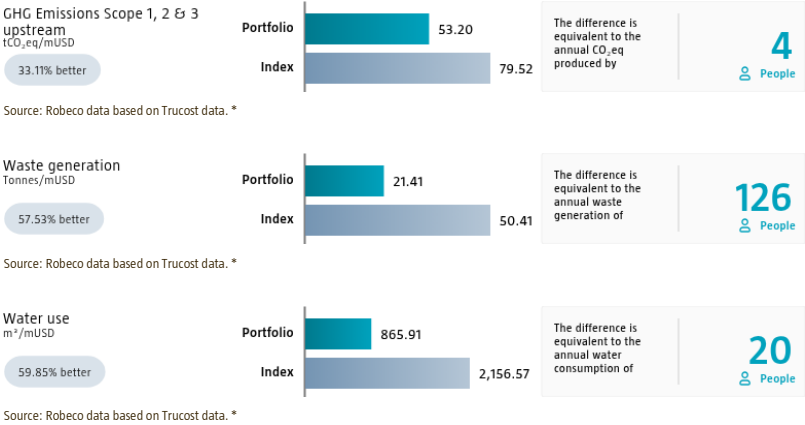
The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. Environmental Footprint

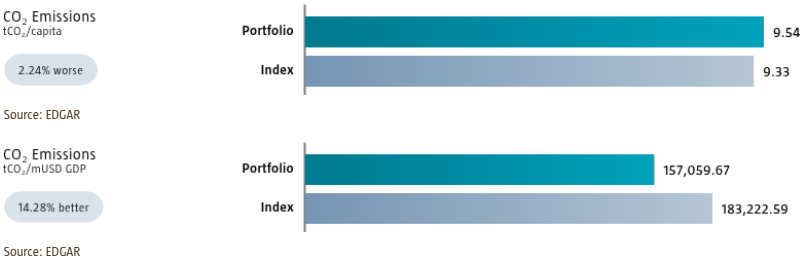
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

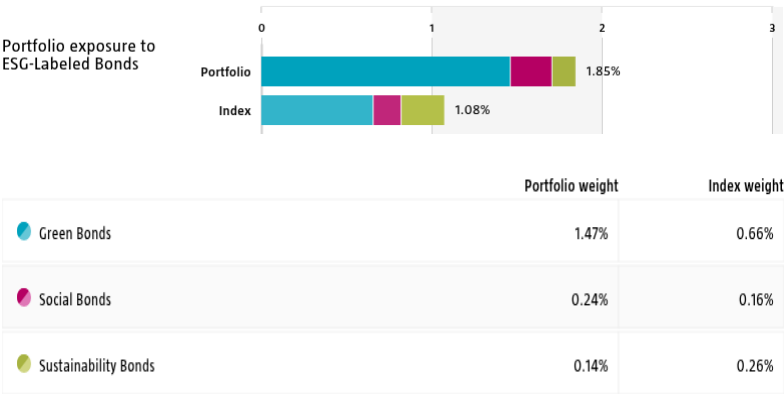
Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.



ESG Labeled Bonds

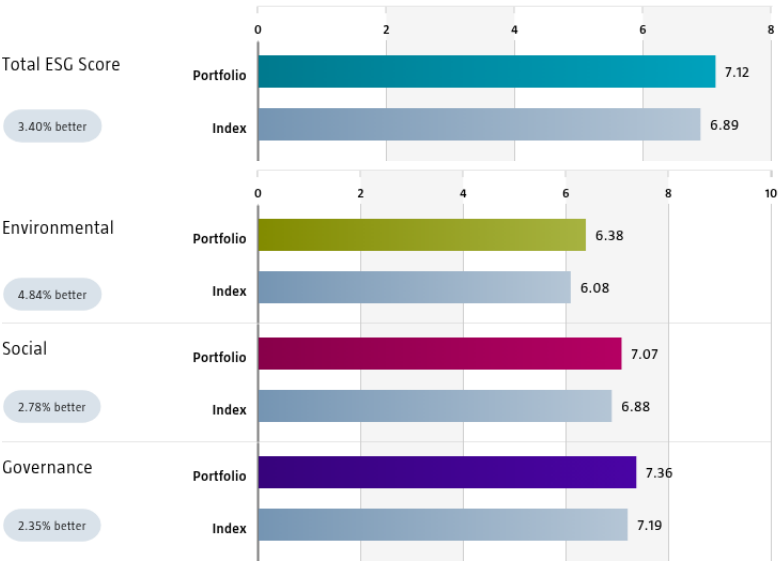
The ESG-labeled bond chart displays the portfolio's exposure to ESG-labeled bonds. Specifically, green bonds, social bonds, sustainability bonds, and sustainability-linked bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

Engagement

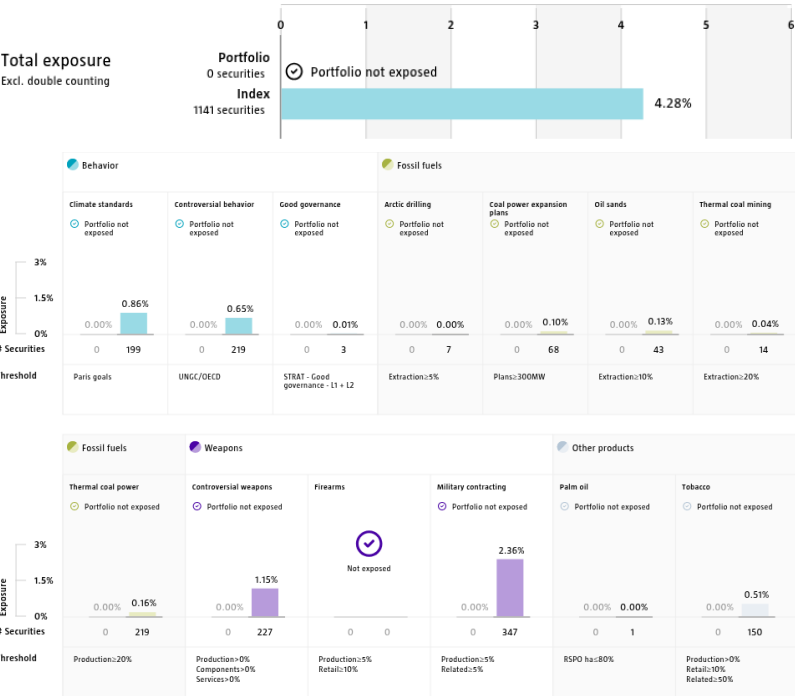
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The asset allocation strategy is subject to investments and volatility restrictions. The portfolio management team can also use other investment instruments to enhance the riskreturn profile of the fund. The Sub-fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The Sub-fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.

Fund manager's CV

Ernesto Sanichar is Portfolio Manager and member of the Sustainable Multi Asset team. He responsible for the Robeco Multi Asset funds, Robeco ONE and Defined contribution funds. His asset specialties are fixed income and FX. He has been part of Robeco's Investment Solutions department since 2005. Previously, he was Treasury Manager for four years. Prior to joining Robeco in 2001, Ernesto worked at ING Barings as a Product controller at the cash equities and derivatives desk for three years. Ernesto started his career in the investment industry in 1998. He holds a Master's in Financial Economics from Erasmus University Rotterdam. Mathieu van Roon is Portfolio Manager and member of the Sustainable Multi Asset team and is responsible for the Robeco Multi Asset funds, Robeco ONE and Defined contribution funds. He joined Robeco in 2011 within the Structured Investments department. Mathieu holds a Master's in both Business Economics and Econometrics (cum Laude) from Erasmus University Rotterdam and is a Financial Risk Manager (FRM) charterholder.

The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
