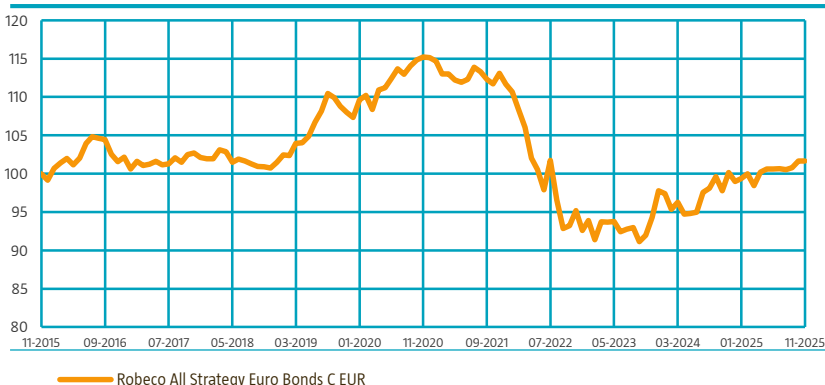

Performance

Based on transaction prices, the fund's return was -0.01%.

The fund posted a small positive return over the month, also above its index. While duration positioning slightly detracted, the yield curve steepener position added to performance. We think long end curve steepening will continue, as we expect more long-dated selling flows from Dutch pension funds and less investor interest in ultralong issuance next year. Country and credit positioning also slightly contributed. Close to month-end, we reduced exposure to Italian and French government bonds, while we closed the underweight in Belgium, as the Belgian government reached an agreement on the budget, while tough negotiations in France are ongoing. The overall risk in corporate bonds is close to the index level, but we continue to favor financials over industrials.

Market development

Government bond market returns were mixed over November. The 10-year US Treasury yield declined by 6 basis points to 4.01%, while German Bund yields increased by 6 basis points. The US government shutdown ended, allowing official economic statistics to resume publication. US labor market signals turned more cautious as WARN notices jumped, indicating large employers are preparing for increased layoffs. A dovish speech by regional Fed President Williams caused markets to raise the probability of a December Fed cut to 80%. Across the Atlantic, UK Chancellor Reeves presented the much-anticipated 2025 budget, which was well received by markets, while in France, tough budget negotiations remain ongoing. The ECB made it quite clear that it aims to keep rates on hold for a while, as inflation seems to be moving to target. Italian 10-year spreads tightened to 71 basis points, reflecting improved risk sentiment, while also receiving a rating notch upgrade to Baa2 by Moody's.

Expectation of fund manager

In Europe, the ECB's latest meeting reinforced its stance that policy rates are "in a good place". Risks to inflation seem quite balanced; if anything, the upside risks seem to be getting smaller. The continued moderation of wage growth adds to this trend, suggesting that the hurdle to hike is larger than the hurdle to cut rates. Curve steepening beyond 10 years remains likely, as rising issuance meets declining (pension fund) demand for ultra-long euro duration. Meanwhile, peripheral bond spreads over Germany continue to converge, supported by recent sovereign rating upgrades in Italy, Greece, and Portugal. France remains the exception. While the current Prime Minister Lecornu managed to survive a vote of confidence, the revenue side of his budget proposal was voted down. Risks that the 2025 budget will be rolled over into 2026 have risen; should this be the case, a deterioration in next year's fiscal outlook is likely.

Sector allocation

Around 36% of the fund is invested in treasury bonds, well below index. The overall beta of the portfolio including SSA, covered bonds and EM hard currency bonds is around 1.3, with the corporate beta around 1.1. The fund still has a small overweight position in both investment grade as high yield corporate bonds, which is partly hedged to the iTraxx Crossover. Within SSA, the fund has an overweight in long-dated EU bonds. The fund has a 15% allocation to green, social and sustainable bonds, predominantly consisting of government-related issuers.

Duration allocation

The overall duration of the fund is 6.5 years versus 6.3 years for the index. The fund holds a small long position in Europe and the UK, versus a short position in Japanese bond futures. Long positions are predominantly located in the belly of the curve. The fund is also positioned for a further normalization (steepening) of curves in Europe, the UK, Norway and the US.

Rating allocation

The fund is 21% invested in AAA bonds, comprising German and Dutch government bonds and high-quality government-related and covered bonds. The fund has a below-index exposure to France (A-rated) and Italy (BBB-rated), versus an overweight in Greece (BBB-rated) and Spain (A-rated). The fund has around 5% Bulgarian government bonds (BBB-rated), as the country will join the Eurozone per January 2026, with EGB index inclusion per March. Exposure to below-investment-grade bonds is slightly below 4%, as the fund took profit on its overweight in Romanian government bonds.

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, limits on investments in companies and countries based on ESG performance as well as engagement. For government and government-related bonds, the fund complies with Robeco's exclusion policy for countries, excludes the 15% worst ranked countries following the World Governance Indicator 'Control of Corruption', and ensures the fund has a minimum weighted average score of at least 6 following Robeco's proprietary Country Sustainability Ranking. The Country Sustainability Ranking scores countries on a scale from 1 (worst) to 10 (best) based on 40 environmental, social, and governance indicators. For corporate bonds, the fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. In the credit selection the fund limits exposure to issuers with an elevated sustainability risk profile. Lastly, where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement.

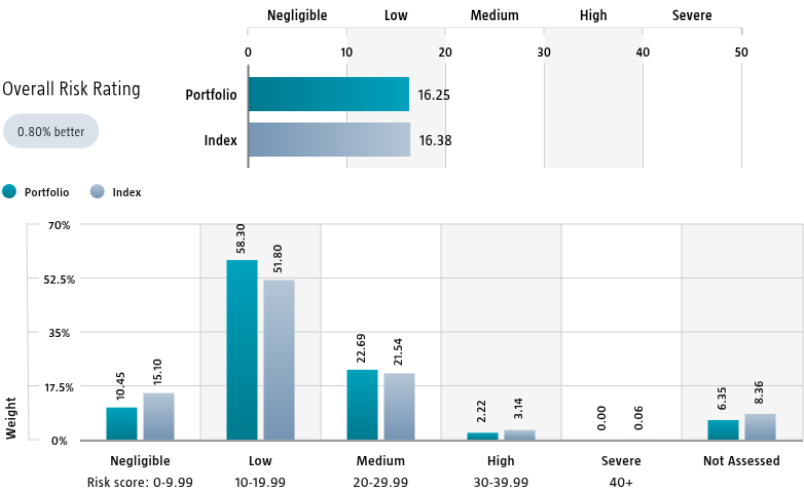

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. Environmental Intensity - Government bond allocation

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.

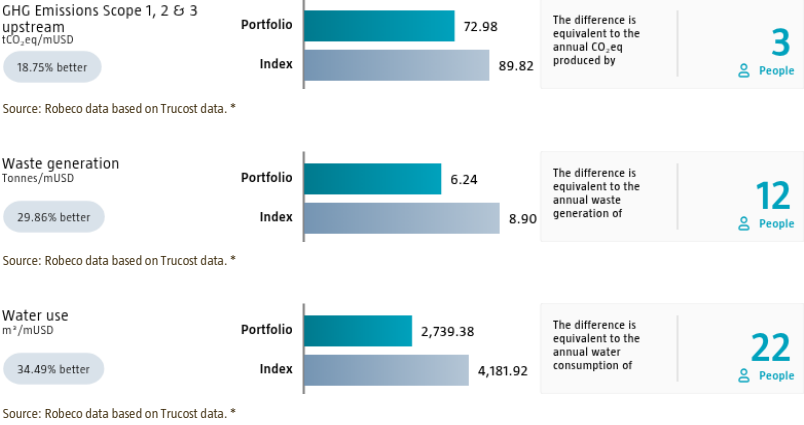

Environmental Footprint - Credit allocation

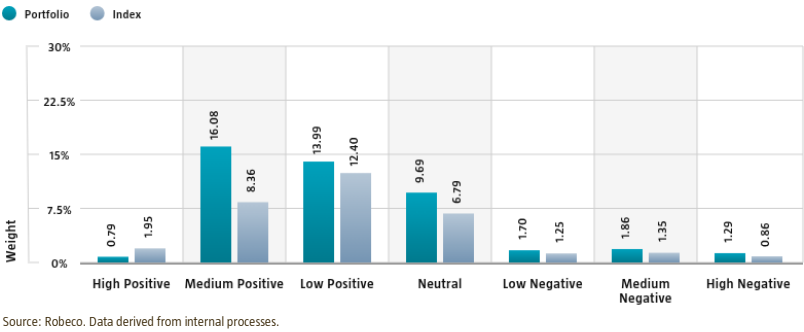
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

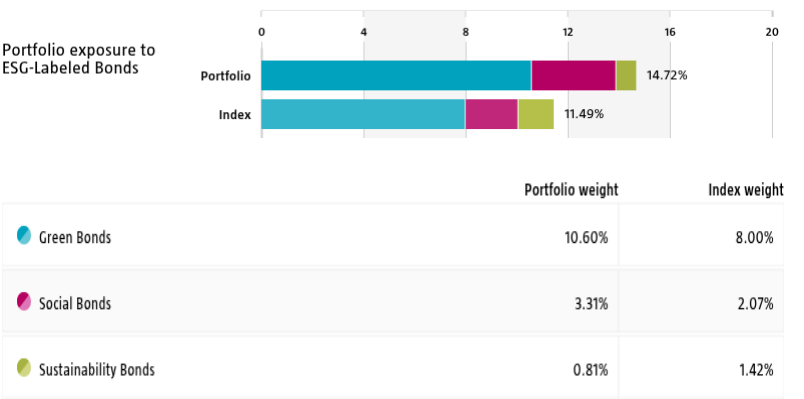
SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. 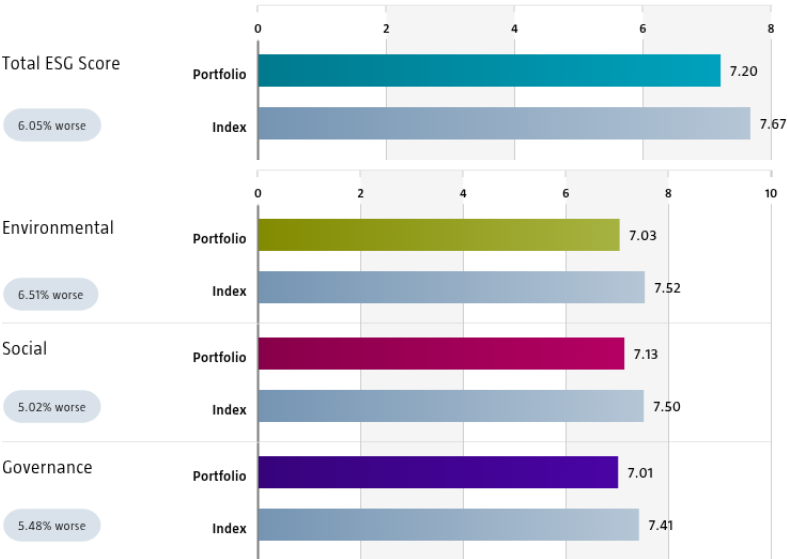
ESG Labeled Bonds

Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

Engagement

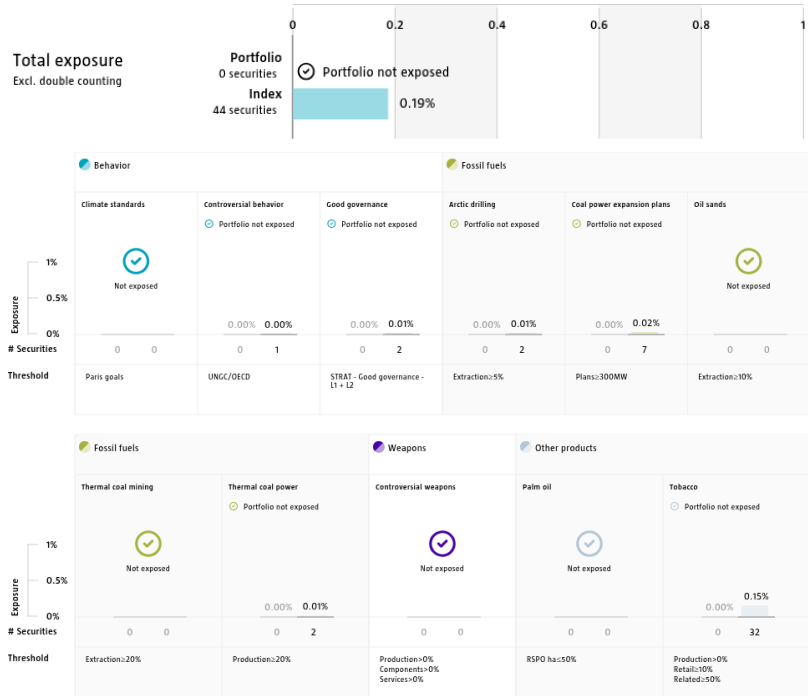
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes.
