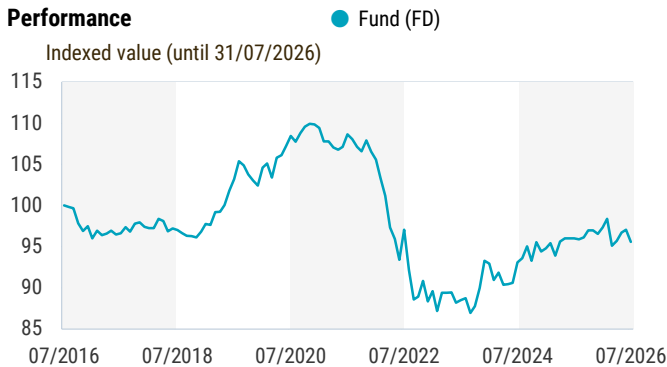

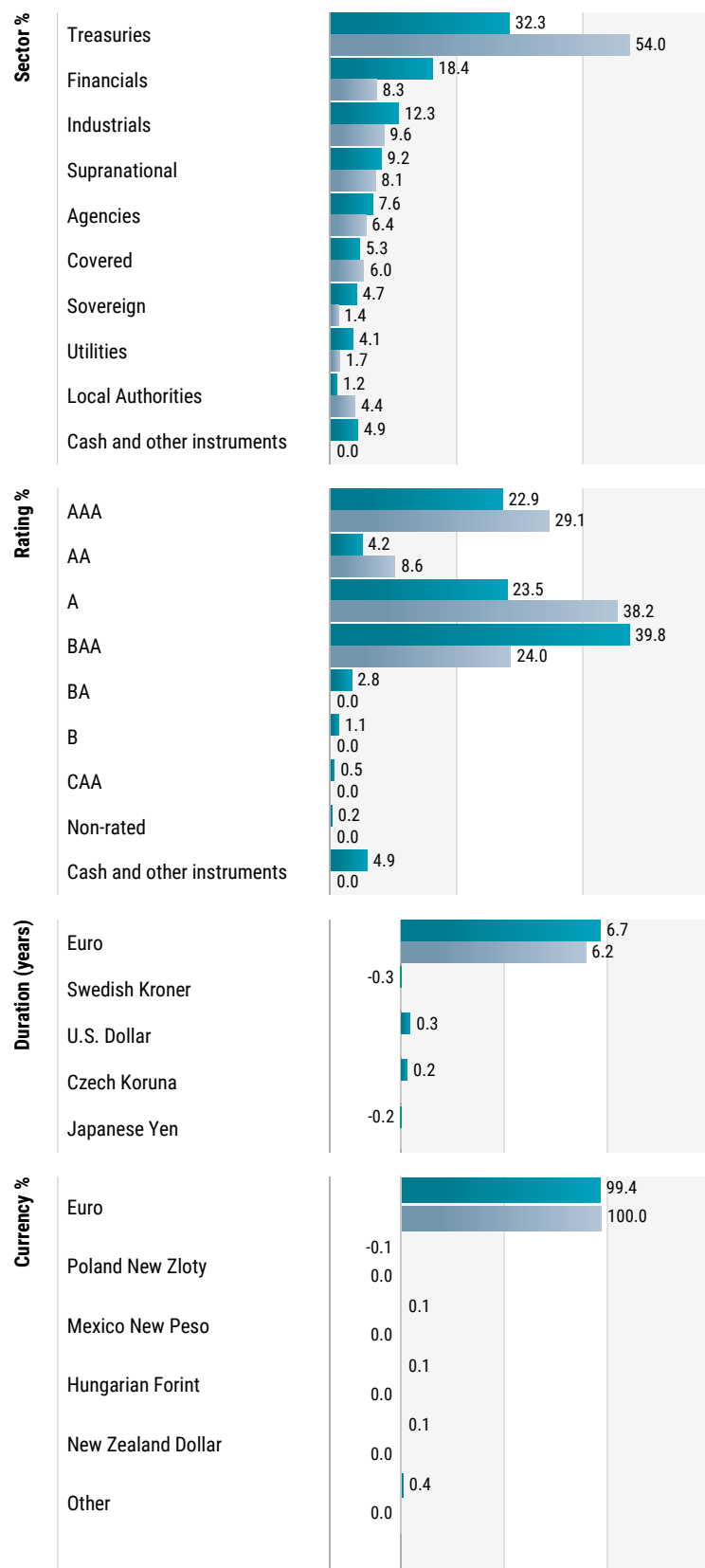

Performance commentary

Based on transaction prices, the fund's return was -1.53%.

The fund posted a negative return over the month, slightly below its index. In recent weeks we have used spikes in yields (which also led to front-end flattening) to gradually increase both the overall duration of the portfolio and to increase curve steepeners. Market pricing for the ECB is not that different from the end of March, when markets got spooked about the inflationary impact of prolonged oil disruptions. While a September hike seems likely, we would need to see more evidence of 2nd round effects to see them do more than that. As our base case remains that before year-end some sort of a solution has been found, and oil and gas prices will be lower than they are currently, we think current levels offer attractive entry points for both duration and curve steepeners. Around month-end we closed the underweight in Italy, while we remain cautious with regard to France. Volatility in credit spreads remains extremely low. We keep the credit beta somewhat above one and remain patient for opportunities to increase allocation when spreads widen.

Market development

Government bond returns were negative across the globe in July. 10-year US Treasuries rose 27 basis points to 4.73% while the 30-year bond reached its highest yield since 2007. The German Bund yield even rose by 35 basis points to 3.21%. Oil prices rose sharply again, driven by a renewed escalation of the US-Iran conflict, which fueled concerns about inflation and increased expectations for further monetary policy tightening. As widely anticipated, the ECB left its deposit rate unchanged at 2.25%. President Lagarde highlighted the downside risks to growth stemming from higher energy prices, while reiterating the ECB's data-dependent approach. In the US, labor market data continued to point to a 'low-hire, low-fire' environment. Although the unemployment rate declined, this was driven by a lower participation rate rather than stronger job creation. The Fed left rates unchanged at its July meeting, despite markets assigning some probability to a rate hike ahead of the decision. Peripheral Eurozone spreads widened marginally versus Bunds, as investors demanded a higher risk premium amid weaker risk sentiment and heightened geopolitical uncertainty.

Expectation of fund manager

The renewed escalation of the US-Iran conflict has led to upside risks to inflation and increased the scope for further monetary tightening. In the US, this raises chances that the Federal Reserve might raise its policy rate later this year. That said, a meaningful deterioration in labor market conditions or a sharp decline in oil prices could prevent the Fed from acting. We expect the ECB to hike rates by 25 bps at their September meeting if oil prices stay at current levels. After September, our base case is for a stable depo rate at 2.5%, but in our base scenario we expect more stable energy prices and a continued absence of second round effects on inflation. Within European sovereign spreads, we expect further divergence across countries. While Spain and Greece continue to benefit from a more favorable economic backdrop, French government bond spreads are likely to remain under widening pressure, as investor focus shifts toward upcoming presidential elections and fiscal developments.

Sector allocation

Around 32% of the fund is invested in treasury bonds, below index level. The corporate beta of the portfolio is somewhat above 1.0, with a preference for financials over industrials. The fund has an overweight position in both IG and HY corporate cash bonds, which is partly hedged with iTraxx Crossover and CDX EM indices. The fund holds positions in a broad basket of USD and EUR-denominated EM hard currency bonds. The fund maintained its sizeable overweight in long-dated EU bonds. The fund has a 21% allocation to green, social and sustainable bonds, predominantly consisting of government-related issuers.

Duration allocation

The overall duration of the fund is 6.6 years versus 6.2 years for the index. The fund has long positions in Europe, the US, the Czech Republic and Hungary versus underweight positions in Sweden, Poland and Japan. The fund is positioned for a steepening of the yield curve in Europe, the UK and Norway.

Rating allocation

The fund is 23% invested in AAA bonds, comprising German and Dutch government bonds and high-quality government-related and covered bonds. The fund has a below-index exposure to France (A-rated) and Spain (A-rated), versus an overweight in Greece (BBB-rated) and Bulgaria (BBB-rated). Exposure to below-investment-grade bonds is relatively cautious at around 5%.

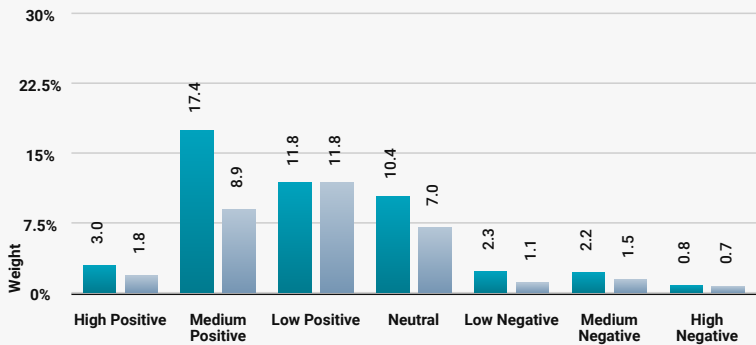

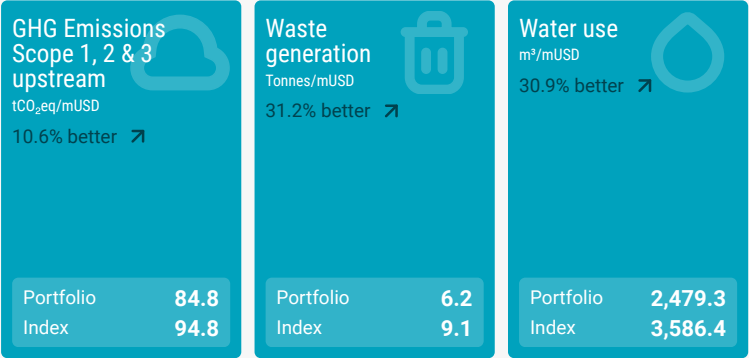

Environmental Footprint ²

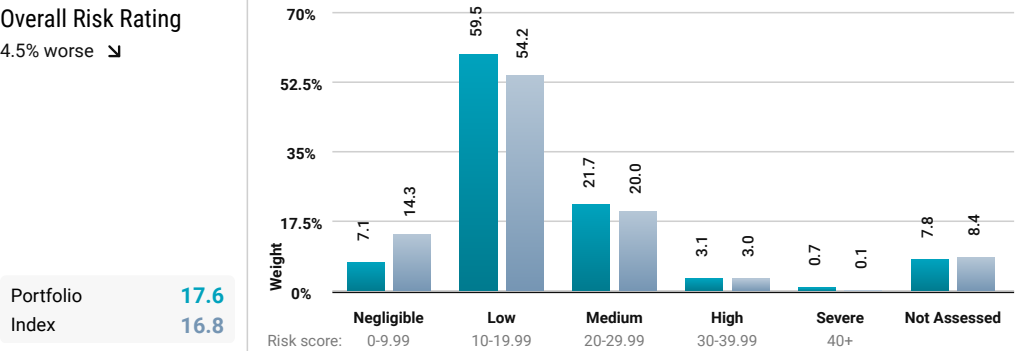

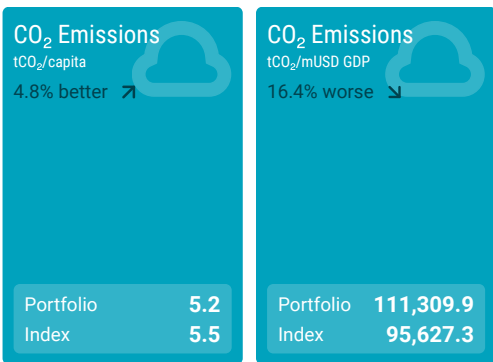

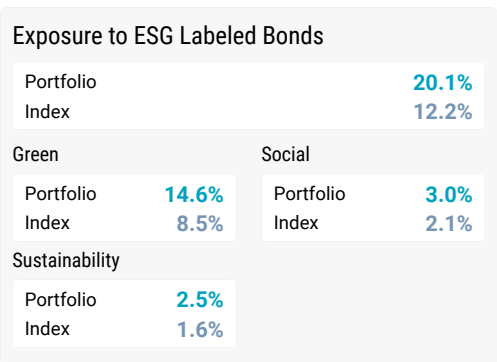

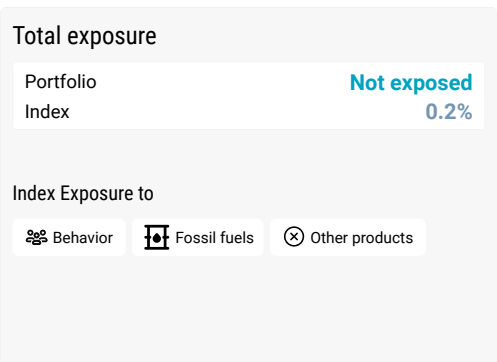
ESG Labeled Bonds ⁵

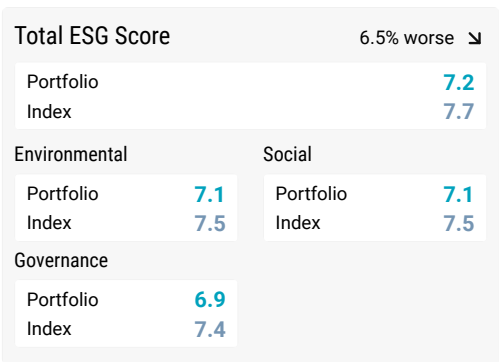

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

4. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Exclusions

7. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully embedded in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment
