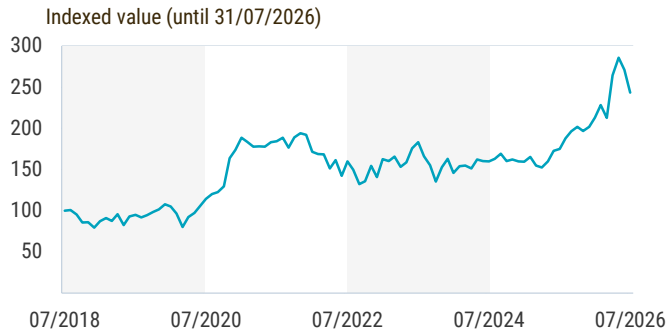

Robeco Smart Mobility is an actively managed fund that invests globally in companies involved in electric or fuel cell vehicle production including components and the entire value chain. The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 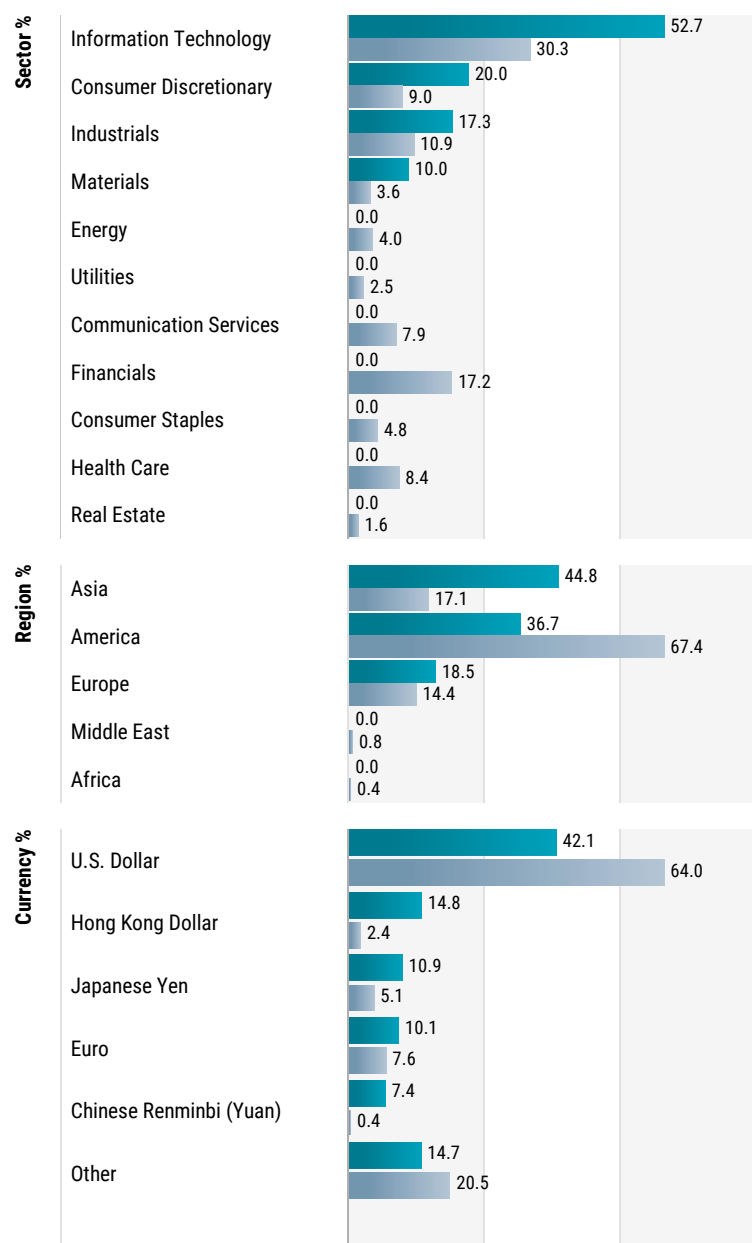
On the launch date, 29 October 2020, the fund absorbed Multipartner SICAV - Robeco Smart Mobility Fund. Performance prior to the launch date has been simulated on the basis of the past performance of the absorbed fund that had similar investment policy and applied higher or comparable charges. With effect from 16 July 2026, the benchmark has been changed from MSCI World Index to MSCI All Country World Index.

Performance commentary

Based on transaction prices, the fund's return was -10.09%.

July reversed the first-half AI trade as investors reassessed valuations, capital intensity and prospective returns, rotating toward previous laggards and Chinese equities. STMicroelectronics was the largest detractor, as its strong first-half re-rating unwound and its near-term outlook fell short of elevated expectations. Corning declined despite solid results, as slightly weaker guidance and optical-product capacity constraints disappointed. Infineon and Murata gave back earlier AI infrastructure gains, while Qualcomm weakened with the broader semiconductor rotation. Conversely, improving sentiment toward Chinese EV demand and manufacturers supported Xiaomi, BYD and Leapmotor. Xiaomi also benefited from June deliveries above 30,000 vehicles and enthusiasm for its model pipeline; BYD and Leapmotor benefited from overseas momentum. Fuyao Glass advanced with renewed interest in Chinese automotive suppliers. Shimano gained after first-half sales and net income exceeded forecasts, prompting higher full-year sales guidance. Overall, rotation was a dominant driver of July's performance.

Market development

Autonomous driving advanced toward broader commercial deployment in July, as robotaxi fleets expanded and regulation increasingly accommodated vehicles designed without human controls. Waymo was reported to operate approximately 4,000 robotaxis, while an IIHS study found its driverless vehicles had a 68% lower rate of police-reportable crashes per mile than human drivers across the markets studied. Tesla widened its US footprint, while Zoox received the first US commercial exemption for a purpose-built robotaxi without steering wheel or pedals. Electrification also broadened: China's passenger-vehicle NEV retail penetration reached approximately 66% in the first 26 days of July, while EV sales outside China, Europe and the US rose approximately 90% year-on-year in the first half of 2026.

Expectation of fund manager

The underlying fundamentals (as reflected by the core themes addressed by the strategy) are very robust. Technology companies with strong and sustainable moats remain the focus of the strategy's investments. These companies focus on the development of high-voltage electric, low-voltage electronic and software-managed solutions that enable electrification, connectivity and autonomous driving. Other key enabling technologies include battery management systems, power inverters and artificial intelligence (AI). The strategy will also continue to seek exposure to the EV market as well as to companies helping to develop EV infrastructure worldwide. Continued momentum in electrification, energy storage and autonomous driving should provide several independent but increasingly interconnected growth engines for Smart Mobility through the remainder of 2026.

Top 10 largest holdings

CATL - global leader in EV and energy-storage batteries, advancing cell chemistry, fast charging and battery services; STMicroelectronics - supplies power semiconductors, microcontrollers and sensors for vehicle electrification, driver assistance and adjacent infrastructure applications; Infineon - provides power semi devices for traction, charging, data centers and robotics; Texas Instruments - supplies analogue and embedded processors for motor control, battery management and in-vehicle connectivity; Analog Devices - delivers precision sensing, power management and connectivity solutions for fast charging, software-defined vehicle architectures and increasingly intelligent cabins.

Sector allocation

The fund invests in companies exposed to structural growth trends of the 'Smart Mobility' theme. As a consequence, the portfolio is particularly invested in companies in the technology sector, followed by the industrial and consumer discretionary sectors.

Regional allocation

The fund invests globally. Most exposure is to US-listed stocks, followed by China, Japan, the Eurozone, Switzerland, Taiwan, Chile and South Korea.

Currency allocation

The fund has no currency hedges in place. This means the currency allocation is a reflection of the investments of the fund.

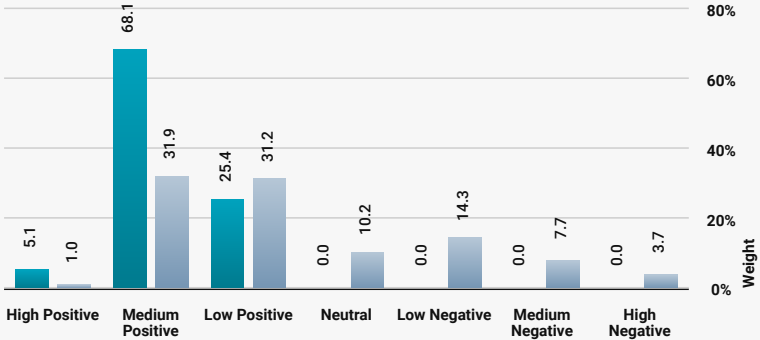

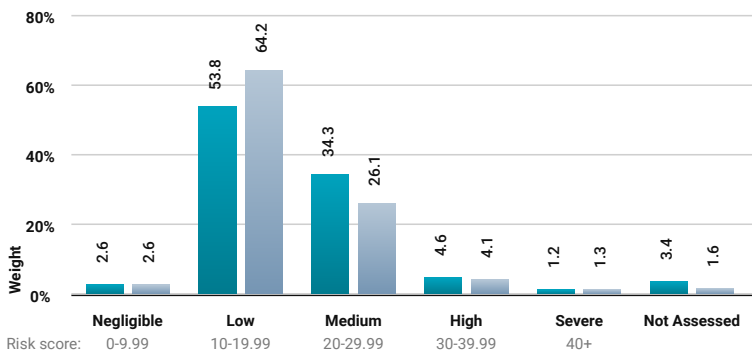

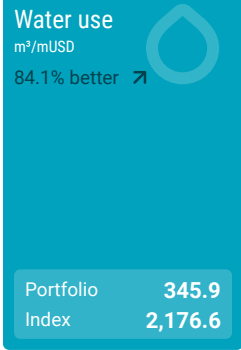

1. SDG Impact Alignment

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully integrated into the investment process to ensure that positions always meet the investment guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
