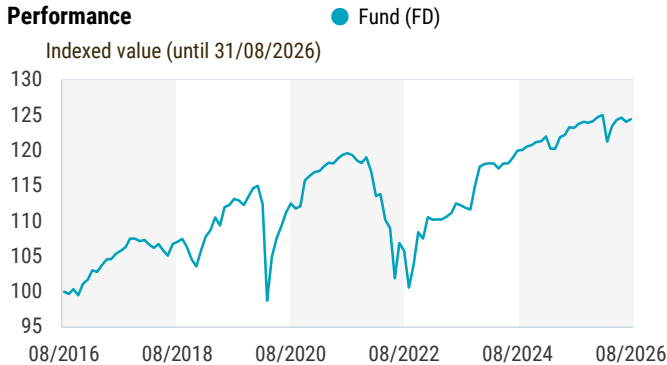

Robeco European High Yield Bonds is an actively managed fund that invests predominantly in bonds with a sub-investment grade rating, issued primarily by European issuers. The selection of these bonds is based on fundamental analysis. The fund's objective is to provide long-term capital growth. The portfolio is broadly diversified, with a structural bias towards the higher rated part in high yield (BB/B). Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.

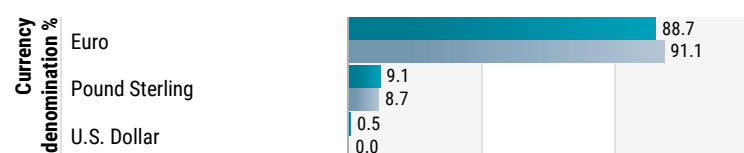
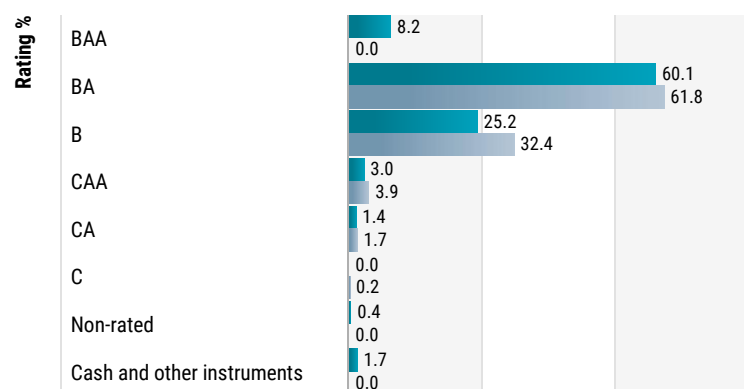
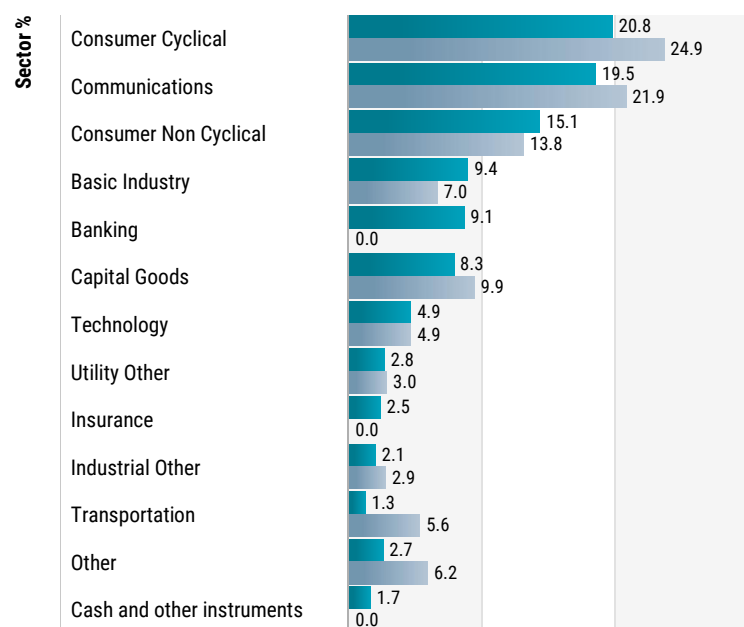

Performance commentary

Based on transaction prices, the fund's return was 0.32%.

Euro high yield performed strongly in August, with credit excess returns driving total returns. Rates volatility on the other hand detracted partly, with the German 10-year yield up 10 bps to 3.32%. The benchmark returned 0.55% over the month, while the portfolio outperformed by 3 bps. Issuer selection was positive, adding 8 bps to performance, while beta positioning contributed -5 bps. Single Bs had the best risk-adjusted performance, followed by BBs, while CCCs underperformed. From a sector perspective, underweight in the communications and underweight in the consumer cyclical sectors added 11 and 4 bps, whereas underweight in the consumer non-cyclical and underweight in the other industrial sectors detracted 2 and 2 bps. Altice remained the biggest contributor over the month, adding 4 bps as the bonds dropped further on LME developments. Multiversity, an online university in Italy, detracted 3 bps as new subscriptions slowed for two quarters in a row.

Market development

In August, euro high yield OAS tightened by 12 bps to 277, and YTW tightened 3 bps to 5.97%. TTF gas surged from EUR 45/MWh to nearly EUR 70 (the highest since January 2023), as renewed Hormuz disruption and low EU storage heading into winter raised serious supply concerns. Eurozone flash CPI jumped to 3.3% in August from 2.9% in July, with energy inflation accelerating to 14.3% YoY, though core held steady at 2.4%. The August composite PMI edged up to 52.1, a nine-month high, with manufacturing turning positive for the first time since early 2022, though the energy price spike cast doubt on the sustainability of the recovery. ECB member Schnabel's hawkish messaging through August reinforced the case for a September hike to 2.50%, which markets now price at near-certainty. In the UK, July CPI rose to 2.9% from 2.6%, and the BoE held at 3.75% on a 6-3 vote, with three members now voting for a hike, though Bailey pushed back. Gross new issuance (EUR) totaled EUR 1 bln over the month, while the pan-European HY bonds default rate ticked up to 0.8% for the last 12 months.

Expectation of fund manager

European high yield enters 2026Q3 with spreads still relatively tight, despite a complex backdrop. Gulf tensions have eased and oil prices retraced, which should temper inflation and reduce the case for further tightening from the ECB and Fed – reinforced by signs of a cooling US labor market. Geopolitical risk hasn't gone away, however: the Russia-Ukraine conflict has entered a more unpredictable phase, and while markets have largely shrugged this off, the risk of tail events and volatility spikes remains underappreciated. The AI investment cycle continues to drive demand for semiconductors, power and data infrastructure, creating pockets of strength but also adding to inflationary pressures. Dispersion remains elevated – most issuers trade well inside historical averages while a tail of credits widens on company-specific stress, refinancing risk or structural disruption, with AI-related business model challenges an important area of focus. We continue to emphasize resilient business models, solid balance sheets and careful risk selection, while avoiding areas where spreads offer insufficient compensation for Europe's macro and geopolitical risks.

Top 10 largest holdings

Our largest positions are concentrated in automotive and telecommunications. Automotive exposure is driven by holdings including ZF Friedrichshafen, Schaeffler and Forvia. In telecommunications, Telefónica and Fibercop represent key positions. We also maintain a meaningful allocation to Vodafone, which is one of the portfolio's larger active risk positions.

Sector allocation

The fund holds a strong overweight in financials, driven primarily by banking, alongside selective overweights in basic industry, particularly chemicals, metals & mining and paper. We also maintain positive exposure to packaging and insurance. On the other hand, we remain underweight in communications and consumer cyclicals, with underweights across media, gaming and consumer services, as well as in technology, transportation and utilities.

Currency denomination allocation

All currency risks are hedged to the currency of the share class. The currency denomination allocation shows the currency distribution of the portfolio before this FX hedging.

Rating allocation

The biggest investments are in BB and B bonds. The fund also has positions in a number of investment grade instruments that trade at attractive, high yield-like spreads.

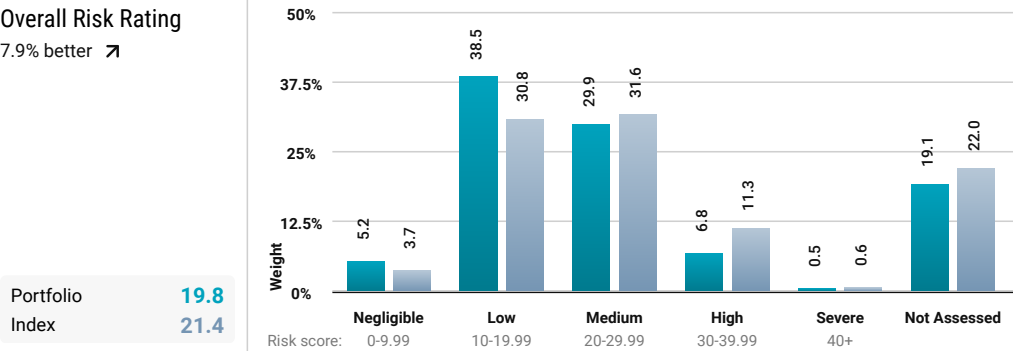

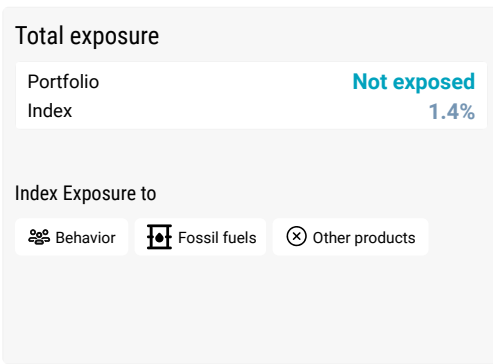

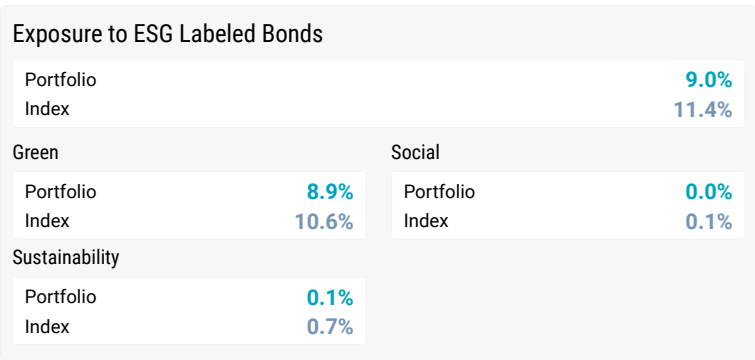

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 3. Sustainalytics ESG Risk Rating

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully embedded in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
