Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.

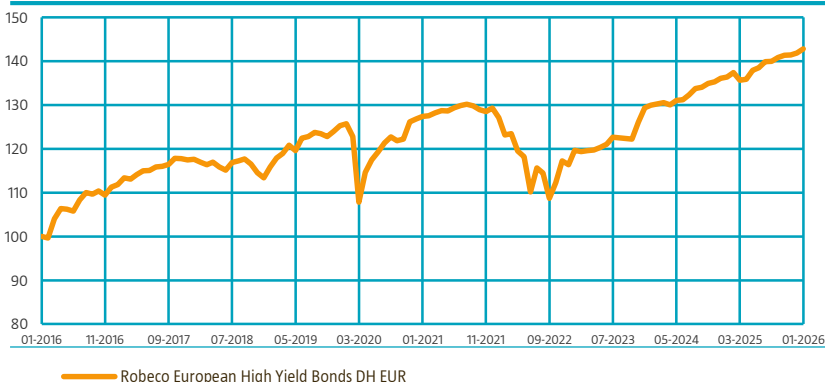

Performance

Based on transaction prices, the fund's return was 0.62%.

In January, the euro high yield market had a total return of 0.64%. Strong credit excess returns driven by a junk rally, as well as underlying interest rates movements, contributed to this total return, with the 10-year Germany yields ticking lower to 2.84%. The portfolio outperformed by 9 bps this month, as issuer selection contributed 10 bps and underweight beta positioning detracted 1 bps. Lower-rated bonds showed a strong performance over the month, with CCCs leading. This was partly compensated by our overweight in BBs and allocation to BBBs, which both had strong risk-adjusted returns. Overweight in the banking and underweight in the consumer cyclical sectors added 6 and 5 bps, respectively, whereas underweight in the consumer non-cyclical and overweight in the basic industry sectors detracted 2 and 3 bps, respectively. Our underweight in ION Platform contributed 2 bps, as the software company suffered particularly from a general sell-off in the software space, due to risks of AI lowering entry barriers for several players. Our underweight in Altice International bonds detracted 2 bps, as bonds rebounded from the sharp drop of last month, which followed the news of bondholders being stripped of certain assets.

Market development

In January, euro high yield spreads tightened by 8 bps to 266, while YTW ticked 6 bps lower to 5.11%. The first month of 2026 saw Europe navigating renewed geopolitical and trade uncertainty after President Trump threatened tariffs of up to 25% on several European economies in an attempt to pressure Denmark over Greenland. In response, the EU accelerated efforts to diversify trade links, finalizing major agreements with India and the Mercosur bloc, while the UK stepped up attempts to rebuild economic ties with China. On the macro front, inflation in the Eurozone eased to 2.0% in December, reaching the ECB's target for the first time since the summer and reinforcing expectations that rates will remain on hold. Economic activity proved resilient into year-end, with Eurozone GDP growing 0.3% in Q4. In the UK, business activity surprised to the upside in January, rising at the fastest pace in nearly two years and pointing to improving momentum at the start of 2026. Euro HY printed EUR 17.2 bln worth of new bond issuance, and there was one default in January, affecting 270 mln of notional.

Expectation of fund manager

The fourth quarter of 2025 ended positively for credit investors, with high yield outperforming, though the lowest-rated credits lagged, underscoring the need for selectivity. Heading into 2026, Europe's outlook is constructive: rates support the economy, growth should remain modest but positive, and labor markets are healthy. Fiscal stimulus, especially in Germany, will further boost prospects, while inflation stays subdued, creating a stable credit environment. Technical factors are strong, with demand for fixed maturity products and pension derisking driving credit buying. The euro market has outperformed the US, but further gains may be limited as supply dynamics shift. The AI investment boom and increased M&A activity will drive new issuance, adding uncertainty. Tight valuations offer limited cushion, and the gap between high-quality and stressed credits persists. We remain conservative, focusing on quality, risk management, and a selective approach as technological shifts and evolving supply shape the year.

Top 10 largest positions

Our top ten holdings are concentrated in the automotive and telecommunications sectors. Within automotive, we hold sizable positions in ZF Industries, Renault and Forvia. In telecommunications, our largest exposures are Telefónica and Fibercom. Beyond these core sectors, we also maintain significant positions in Crown Holdings within packaging and Thames Water within utilities.

Sector allocation

The fund currently carries overweights in less cyclical industries such as basic industry and capital goods, with an emphasis on issuer selection within packaging, chemicals, and metals & mining. This is complemented by an off-benchmark allocation to financials. We also maintain overweights in several consumer-oriented segments, including consumer products, healthcare, automotive, and lodging. Conversely, our largest underweight remains in communications, alongside reduced exposure to more cyclical consumer areas such as supermarkets and transportation.

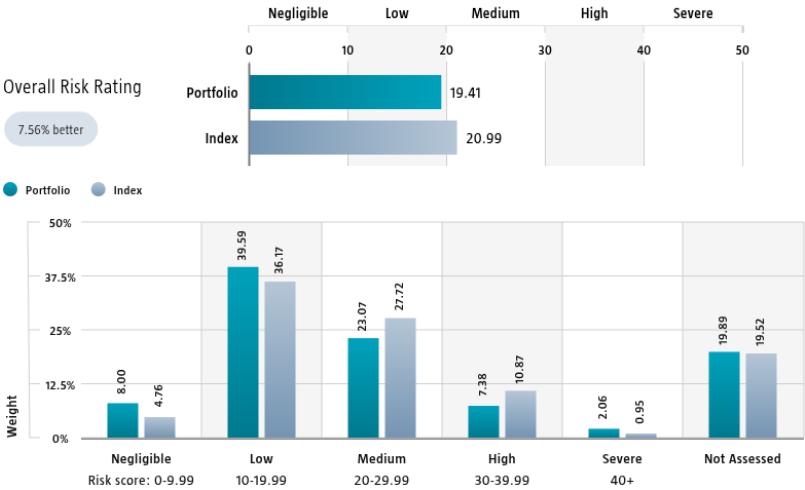

Sustainability

The fund incorporates sustainability in the investment process via exclusions, ESG integration, a minimum allocation to ESG-labeled bonds, and engagement. The fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. In the credit selection the fund limits exposure to issuers with an elevated sustainability risk profile. Furthermore, the fund invests at least 2% in green, social, sustainable, and/or sustainability-linked bonds. Lastly, where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Sustainalytics ESG Risk Rating

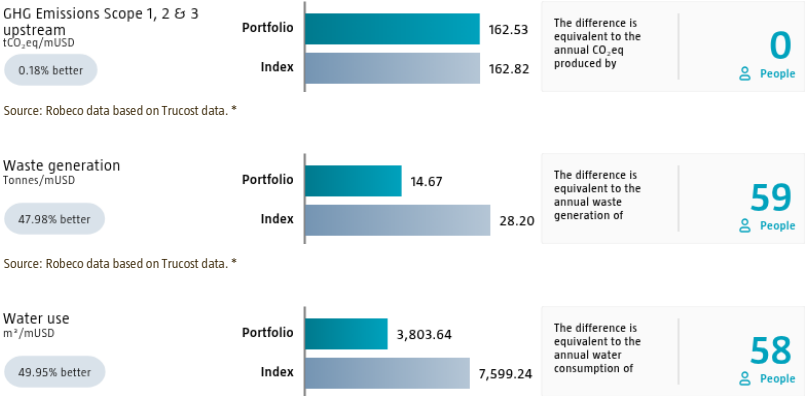

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. 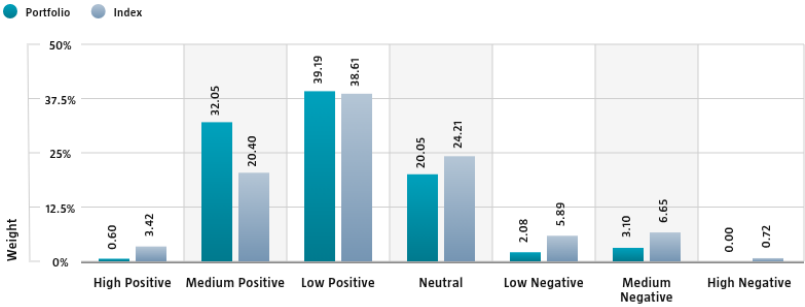

SDG Impact Alignment

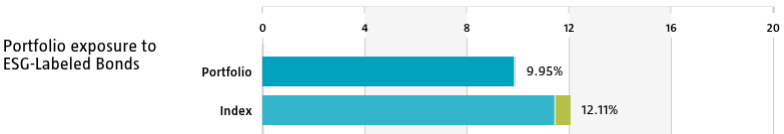

Engagement

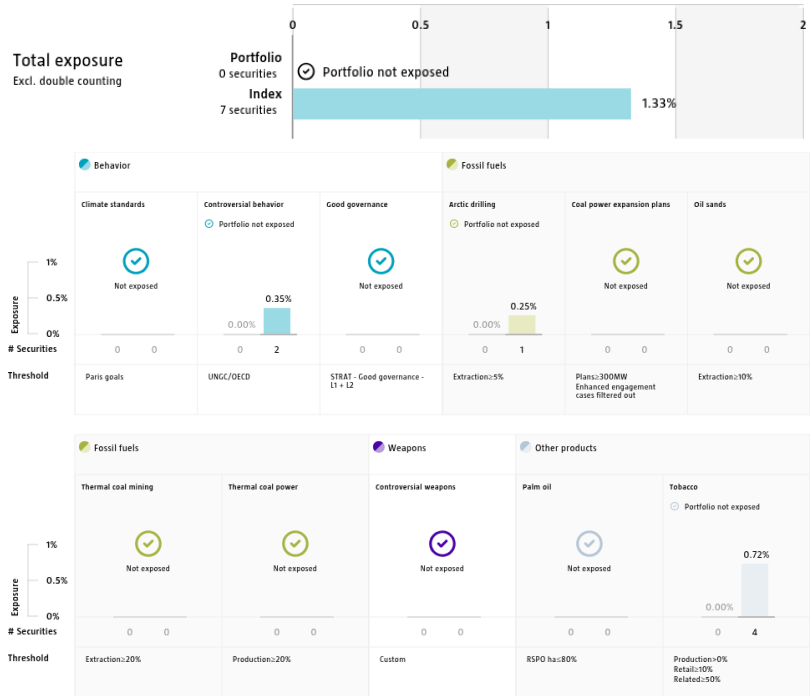
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The selection of these bonds is based on fundamental analysis. The fund's objective is to provide long-term capital growth. The portfolio is broadly diversified, with a structural bias towards the higher rated part in high yield (BB/B). Performance drivers are the top-down beta positioning as well as bottom-up issuer selection.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, and engagement.

Daniel de Koning is Portfolio Manager High Yield in the Credit team. Prior to joining Robeco in 2020, he was Portfolio Manager High Yield at NN Investment Partners. Daniel started his career in 2011 at APG Asset Management, where he held roles of Credit Analyst and Portfolio Manager High Yield. He holds a Master's in Business Economics from the University of Amsterdam and he is a CFA® and CAIA® charterholder. Sander Bus is CIO and Portfolio Manager High Yield Bonds in the Credit team. He has been dedicated to High Yield at Robeco since 1998. Previously, Sander worked for two years as a Fixed Income Analyst at Rabobank where he started his career in the industry in 1996. He holds a Master's in Financial Economics from Erasmus University Rotterdam and he is a CFA® charterholder. Roeland Moraal is Head of Leveraged Finance and Portfolio Manager High Yield in the Credit team. Before assuming this role, he was Portfolio Manager in the Robeco Duration team and worked as an Analyst with the Institute for Research and Investment Services. Roeland started his career in the industry in 1997. He holds a Master's in Applied Mathematics from the University of Twente and a Master's in Law from Erasmus University Rotterdam. Christiaan Lever is Portfolio Manager High Yield and Emerging Credits in the Credit team. Before assuming this role in 2016, he was Financial Risk Manager at Robeco, focusing on market risk, counterparty risk and liquidity risk within fixed income markets. Christiaan has been active in the industry since 2010. He holds a Master's in Quantitative Finance and in Econometrics from Erasmus University Rotterdam and he is a CFA® Charterholder.

Team info

The Robeco European High Yield fund is managed within Robeco's credit team, which consists of nine portfolio managers and twenty-three credit analysts. The portfolio managers are responsible for the construction and management of the credit portfolios, whereas the analysts cover the team's fundamental research. Our analysts have long term experience in their respective sectors which they cover globally. Each analyst covers both investment grade and high yield, providing them an information advantage and benefiting from inefficiencies that traditionally exist between the two segmented markets. Furthermore, the credit team is supported by three dedicated quantitative researchers and four fixed income traders. On average, the members of the credit team have an experience in the asset management industry of seventeen years, of which eight years with Robeco.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance. Any amount invested in the fund forms part of the investor's net assets.
