Performance commentary

Based on transaction prices, the fund's return was -1.17%.

The fund outperformed its benchmark by 26 bps on a gross basis, bringing the 1-year performance to +240 bps gross. The sovereign credit overweights in Angola, Laos and BOAD added to performance, as did the underweights in Bahrain, Indonesia and Saudi Arabia, and the overweights in TRY and EGP. In security selection, Uzbeki local and Moroccan OCP added the most. The USD duration overweight detracted from returns, which was partially offset by the EUR duration overweight, which contributed positively.

Market development

EM hard currency debt (-1.4%) gave back some performance in July, bringing down the YTD return to 1.8%. The monthly returns were driven by larger negative US Treasury (-1.2%) and smaller negative spread (-0.2%) contributions. Spreads added a total of 2.9% YTD and US Treasuries detracted 1%. Lebanon (+8.0%) was the top performer this month, erasing earlier losses, as the situation in the Middle East moved toward a resolution. Oil and gas exporters in Africa such as Mozambique (3.7%), Gabon (3.5%), Angola (1.2%) and Nigeria (0.9%) did well, as oil prices went up by 24% due to US-Iran deal uncertainty. Regionally, Africa and Europe outperformed Asia, Latin America and the Middle East. The worst performers were US Treasury sensitive IG-rated credits with limited cushions to offset the core rates rise such as Malaysia (-3.1%), Uruguay (-2.9%) and Chile (-2.9%).

Expectation of fund manager

Developments in the Middle East continue to leave uncertainty elevated across global financial markets, including EM hard currency bonds. The base case is now for a fragile truce to be in place for the medium term, although we cannot rule out further volatility in energy prices and headline inflation. Core interest rates have not corrected as inflationary risks linger, but balance of payments and fiscal pressures on EMs should be moderating. We would expect that global macro factors such as the outlook for US Treasuries, Fed policy, US equity market evolution as well as geopolitical risks remain important drivers for EM hard currency debt.

Sector allocation

The fund is predominantly allocated to sovereign debt, with an underweight in quasi-sovereign bonds. Selective non-sovereign positions include Pemex and Cemex (Mexico), Akbank, Garanti and Limak Cement (Turkey), and supranationals BOAD and Afreximbank, providing diversified African credit exposure at attractive spreads.

Country / Region allocation

The portfolio maintains a high conviction tilt toward higher yielding and improving-credit stories. Largest overweights: Romania, Ecuador, Ukraine, Ghana, and Mexico (Pemex). Our largest underweights are in Saudi Arabia, Indonesia, China and Malaysia, where valuations appear stretched. Off-benchmark positions include BOAD, Afreximbank, and Laos.

Currency denomination allocation

USD exposure stands at approximately 75% of the portfolio. The remainder consists primarily of EUR-denominated bonds (Brazil, Colombia, Morocco, Romania) with FX hedged to USD, plus select local currency positions in NGN, UZS, ARS.

Duration allocation

The fund is neutral in USD duration, but has a small overweight in EUR and local duration (5-year Mexican rates, and shorter dated Nigerian and Uzbeki bonds).

Rating allocation

We remain cautious on investment grade and are underweight in expensive IG names such as Saudi Arabia, China, Indonesia and Malaysia. In high yield, the portfolio is skewed toward BB (approximately 24%), B (approximately 24%) and CCC (approximately 15%). Key high yields overweights include Argentina, Ecuador, Angola, and Ghana.

Reference

1. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

2. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg.
