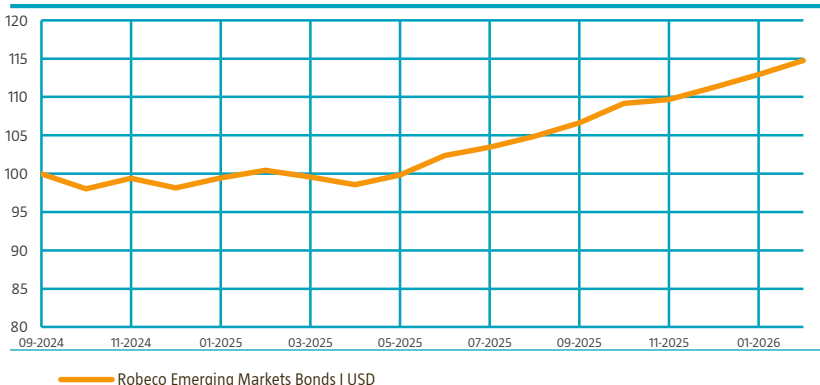

Performance

Based on transaction prices, the fund's return was 1.62%.

The fund outperformed its benchmark in February. Top-down positioning contributed mostly strongly to returns, followed by the contribution from local EM bonds. In country allocation, Senegal, positions in multilaterals, Brazil, and Romania contributed most. Overweights in Argentina and Ecuador detracted from performance. Carry versus benchmark in core rates and spreads contributed positively.

Market development

Emerging debt markets returned 1.39% in February. The return was mainly driven by positive returns in core rates, which added 2.10% to the total return. Spreads ended the month slightly wider, with high yield widening slightly more than investment grade on average (+20 and +8 bps, respectively). The top performers in February were Senegal (+8.36%), Venezuela (+4.83%), and Panama (+3.52%). The bottom three were Argentina (-1.93%), Ethiopia (-1.90%), and Gabon (-1.61%).

Expectation of fund manager

Developments in the Middle East have brought significant uncertainty into global financial markets, including EM hard currency bonds. The transmission to EM runs largely through three channels: direct involvement of some EM issuers, mainly those in the region, energy and commodity prices, and risk sentiment. The rise in commodity prices impairs US Treasuries' and German Bunds' function as safe heaven assets, as higher inflation expectations translate into higher interest rates. We substantially reduced exposure to risky assets, as the end of February neared, and the risk of war rose with the increasing US pressure on Iran. Regional exposure was brought down to zero, and reductions were made in high yield sovereigns such as Argentina, Ecuador, Benin, the Republic of Congo, Ivory Coast, Kenya, and Sri Lanka. Lastly, protection was bought through CDX EM and the fund continues to hold its CDS protection in Saudi Arabia. Although we have positive views on these issuers in the medium and long term, we expected risk to sell off indiscriminately when significant risk events occur, and hence have seen it as prudent to trim positions.

Sector allocation

The fund is mostly allocated to sovereign debt with an underweight in state-owned enterprises (SOEs) versus the benchmark. Relative valuations and the opportunity set offered by sovereigns vs SOEs at this juncture make sovereigns our preferred sector, but there are some opportunities in the non-sovereign sectors. We have positions in Pemex and Cemex in Mexico, and Ak Bank and Garanti in Turkey. The fund also has a position in the West-Africa Development Bank (Banque Ouest Africaine de Developpement), and the African Export-Import Bank.

Currency denomination allocation

The fund remains predominantly invested in USD bonds, which make up 100% of the benchmark. The share of EUR-denominated bonds is around 14%, mostly in Eastern Europe, and the fund had positions in EM local currency bonds in Egypt, Nigeria, Turkey, and Uzbekistan at the end of the month. EUR currency risk is hedged and EUR duration is partially hedged.

Duration allocation

The fund has a small overweight in duration in USD and EUR, and holds underweights in the long end of both curves versus an overweight in the front end. The fund has a modest BRL duration overweight as well.

Rating allocation

We continue to see the highest-rated segments, AA, A, and BBB, as trading expensive in absolute and relative terms and therefore have a cautious stance toward issuers such as Saudi Arabia, China, and Malaysia, where spreads offer limited potential. In Saudi Arabia we have bought CDS protection, adding to the underweight position, in light of geopolitical risks developing in the region. In the BBB space, the fund has positions in Romania, Bulgaria, and Hungary, but is underweight in the rest of this market segment. In the high yield space, we continue to see opportunities, particularly among select B and CCC-rated issuers, where spreads remain attractive and fundamentals are improving. Notable overweights are held in Ecuador, Turkey, Argentina, and Ghana.

Country allocation

The largest overweights in market value terms are in Ecuador, Hungary, and the off-benchmark position in African supra-national development banks. In DTS terms, the largest positions relative to the benchmark are in Romania, Ecuador, Senegal, and Hungary. The biggest underweights are in Saudi Arabia, Indonesia, and the United Arab Emirates.

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration and a minimum average country sustainability ranking score as well as a minimum allocation to ESG-labeled bonds. The fund complies with Robeco's exclusion policy for countries and does not invest in countries where serious violations of human rights or a collapse of the governance structure take place, or if countries are subject to UN, EU or US sanctions. In addition, the fund excludes the 15% worst ranked countries following the World Governance Indicator 'Control of Corruption'. ESG factors of countries are integrated in the bottom-up country analysis. In the portfolio construction the fund ensures a minimum weighted average score that is better than that of the index, following Robeco's proprietary Country Sustainability Ranking. The Country Sustainability Ranking scores countries on a scale from 1 (worst) to 10 (best) based on 40 environmental, social, and governance indicators. Lastly, the fund invests in a minimum of 5% in green, social, sustainable and/or sustainability-linked bonds. For more information please visit the sustainability-related disclosures. The index used for all sustainability visuals is based on J.P. Morgan GBI-EM Global Diversified.

Country Sustainability Ranking

The charts displays the portfolio's Total, Environmental, Social and Governance scores following Robeco's Country Sustainability Ranking methodology. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. 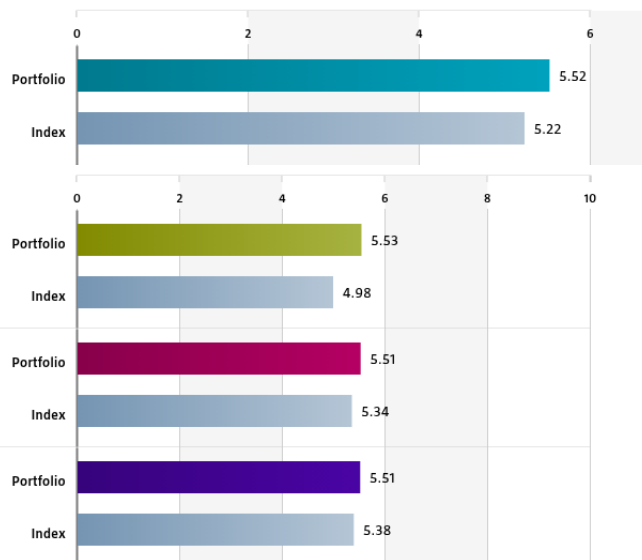

Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.

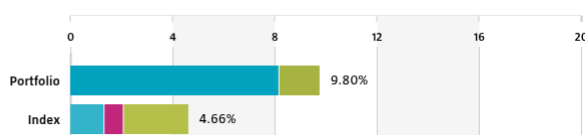

The selection of these assets is based on fundamental analysis. The fund's objective is to achieve a better return than the index and provide long-term capital growth.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.
