Market development

Emerging market local currency bonds navigated a mixed backdrop in July, as higher US Treasury yields and uncertainty around the timing of Federal Reserve easing weighed on global duration. EM central banks remained on divergent paths, with some continuing to ease policy as domestic inflation moderated, while others maintained restrictive settings amid persistent price pressures and currency considerations. EM currencies were broadly mixed against the US dollar, with country specific fundamentals, commodity prices and differing monetary policy expectations driving relative performance. Resilient domestic activity and improving inflation dynamics supported selected local bond markets, although higher global yields and intermittent risk aversion limited the broader rally. The JPM GBI-EM Global Diversified Index returned +0.30% in USD terms in July, with the bulk of that driven by currencies (+0.48%) rather than local rates (-0.18%).

Expectation of fund manager

Looking ahead, the global backdrop remains one of elevated uncertainty, with geopolitical risks and the potential for renewed inflationary pressures likely to keep volatility high across EM assets. Balance of payments and fiscal dynamics across emerging markets remain broadly supportive, providing an important buffer against external shocks. We continue to favor high-carry markets where credible policy frameworks and improving fundamentals provide attractive risk-adjusted opportunities. At the same time, we remain selective on duration and retain underweights in markets where valuations or external vulnerabilities leave limited room for policy disappointment. Overall, we see scope for attractive carry to remain a positive driver of returns while maintaining a disciplined approach to beta.

Sector allocation

The portfolio remained predominantly invested in local currency government bonds, complemented by meaningful allocations to sovereign-linked and agency instruments. Off-benchmark sovereign exposure and agency holdings continue to provide carry enhancement and portfolio diversification beyond the pure treasury-dominated benchmark. Supranational bonds serve a liquidity management and quality enhancement role. Local currency exposure remains the dominant driver of portfolio risk and return versus the benchmark.

Country / Region allocation

Country positioning reflects high-conviction overweights in Colombia (+7.7%), Turkey (+6.9%), Tunisia (+4.7%, off-benchmark), and Nigeria (+4.6%, off-benchmark). These positions reflect attractive real yields, policy credibility and carry. The portfolio is underweight in Indonesia (-5.1%), Malaysia (-6.0%), Poland (-4.2%) and South Africa (-4.1%), where rate sensitivity, external vulnerabilities or fiscal concerns warrant lower conviction.

Duration allocation

Duration ended the period modestly below benchmark. Duration was reduced during the month, as mixed signals on de-escalation in the Iran conflict, higher US yields and a relatively firm US dollar created a challenging external backdrop. Overweights ended the period concentrated in Colombia (+0.6yr), Brazil (+0.2yr) and Hungary (+0.2yr). The fund's underweights in Thai baht duration and broader Asian curves remain and reflect continued concern about duration exposure in markets facing persistent external pressures.

Rating allocation

The fund's overall credit rating at month-end stood at BAA3/BA1, reflecting the portfolio's broad exposure across investment grade EM sovereigns and selective positions in higher-yielding credits. The largest overweights versus the benchmark are in AA-rated (+10.0%) and CAA-rated (+10.8%) instruments, reflecting the portfolio's significant off-benchmark exposure to high-quality supranationals and select frontier positions, respectively. The fund retains meaningful underweights in the A-rated (-19.2%) and BAA-rated (-10.3%) segments, where valuations remain less compelling relative to the fund's opportunity set.

1. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

2. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.
