Robeco Transition Emerging Credits is an actively managed sub-fund that invests in bonds (which may include contingent convertible bonds (also "coco" bonds)), asset backed securities and similar fixed income securities issued by entities incorporated or exercising a preponderant part of their economic activities in Emerging Countries. The selection of these bonds is based on fundamental analysis. The fund has the flexibility to invest in value opportunities beyond the index universe, which means that the fund comprises both local currency and hard currency debt. The fund aims to make investments in assets with a sustainable objective as well as investments in assets that contribute to a transition. Transition pertains to activities that measurably and credibly contribute to the goals of the Paris Agreement and/or an environmental and/or social objective. This is achieved by investing in entities that have credible emission reduction targets, entities that provide solutions to enable climate change mitigation and bonds to finance sustainability transformation or refinancing, in part or in full, new and/or existing projects with an environmental and/or social objective. The fund's objective is to provide long-term capital growth.

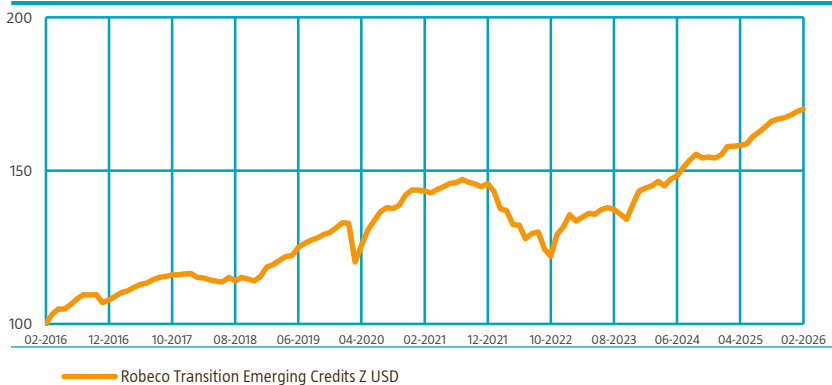

Performance

Based on transaction prices, the fund's return was 0.48%.

This month's beta contribution marginally added to performance. Issuer selection detracted from performance.

Positions in issuers such as CAF, Equinix and Helios Towers contributed to performance, while positions in Rumo, Alpek and Raizen detracted from performance.

Market development

EM corporate credit navigated February 2026 with strong technicals, but a sharp drop in primary supply. Following January's record, February issuance moderated to just USD 21 bln, partly driven by Asia's Lunar New Year holidays, and easily absorbed by robust EM bond fund inflows that reached USD 14.8 bln year-to-date. Strong demand kept CEMBI spreads tight within a 10 bps range, though spreads widened slightly late in the month on a reversal in risk sentiment, driven by escalating geopolitical tensions. On the final weekend of February 2026, the US and Israel launched coordinated military strikes on Iran, causing oil prices to spike and driving a broad flight-to-quality trade. Despite this, EM corporates delivered positive total returns, buffered by a decline in US Treasury yields as the 10-year fell below 4%. The US macroeconomic backdrop showed mixed signals, while EM central banks such as Thailand began leaning dovish. Broad EM corporate fundamentals remained resilient; however, the 2026 global default rate forecast could move higher due to idiosyncratic stress in Latin America, specifically from selective Brazilian issuers.

Expectation of fund manager

We expect corporate credit performance to be led by carry, with spreads broadly anchored but more likely to drift wider than tighten, as exceptionally strong technicals ebb (net supply marginally picks up and large AI-related investment grade issuance competes for USD demand) and are potentially coupled with persistent geopolitical tensions. Although lower tail-risks on tariffs, diverting supply chains and easier monetary policy delivered in 2025 are supportive, a prolonged escalation in the Middle East poses tail risks for oil prices if the Strait of Hormuz faces extended closure. Fundamentals start from a robust base (low leverage, positive rating migration and historically low default rates), but tight valuations limit cushion and make selectivity over beta essential. EM investment grade spreads still offer attractive pickup versus US IG when taking its lower net leverage into account. We favor BBB-BB rating buckets over the lower-rated segments, remain overweight in financials, stay cautious on cyclical sectors such as chemicals and energy, and expect higher dispersion across HY names. A modest EUR bias vs USD is reasonable where supply competition may be sharper.

Top 10 largest positions

In risk terms, our positions include names such as Corporacion Andina de Fomento (CAF), Orbia, El Puerto de Liverpool, Raizen and Longfor. The largest underweights are in Ecopetrol against which we hold Colombian sovereign bonds, Kosmos Energy, VLL and Indofood. The largest positions in weight terms are CAF, Alibaba and Standard Chartered.

Sector allocation

In our portfolio management, we not only factor in weights, but also spreads and durations (DTS). The largest underweights are in government-owned entities, consumer non-cyclical and energy. The largest overweights are in financial bonds issued by banks, as well as supra/sovereign issuers and capital goods (mainly cement producers). We have underweight risk positions in Hong Kong, Taiwan, the Philippines and the GCC driven by tight valuations. We remain selectively overweight in Latin America, where several issuers benefit from reduced tariff tail risks.

In the allocation to the capital structure, we favor the bonds with solid risk-adjusted performance potential while taking into account the beta, sector themes, and the credit cycle. We prefer shorter-dated senior bonds. Within subordinated bonds, we favor Tier-2 over Tier-1 bonds.

Sustainability

Sustainability is incorporated in the investment process by the means of a target universe, exclusions, ESG integration, and a minimum allocation to ESG-labeled bonds. The fund invests in credits issued by companies with a positive or neutral impact on the SDGs. The impact of issuers on the SDGs is determined by applying Robeco's internally developed three-step SDG Framework. The outcome is quantified with a proprietary SDG score methodology, considering both the contribution to the SDGs (positive, neutral or negative) and the extent of this contribution (high, medium or low). At least 50% of the fund is invested in Transition-related Investments contributing to the goals of the Paris Agreement and/or Transition-related Investments with an Environmental and/or Social objective. This is determined through Robeco's Paris Alignment Assessment, which evaluates companies using a Climate Traffic light. In addition, the fund does not invest in credit issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer's fundamental credit quality. Furthermore, the fund invests at least 15% in green, social, sustainable, and/or sustainability-linked bonds. The fund limits exposure to elevated sustainability risks. Lastly, where a credit issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion.

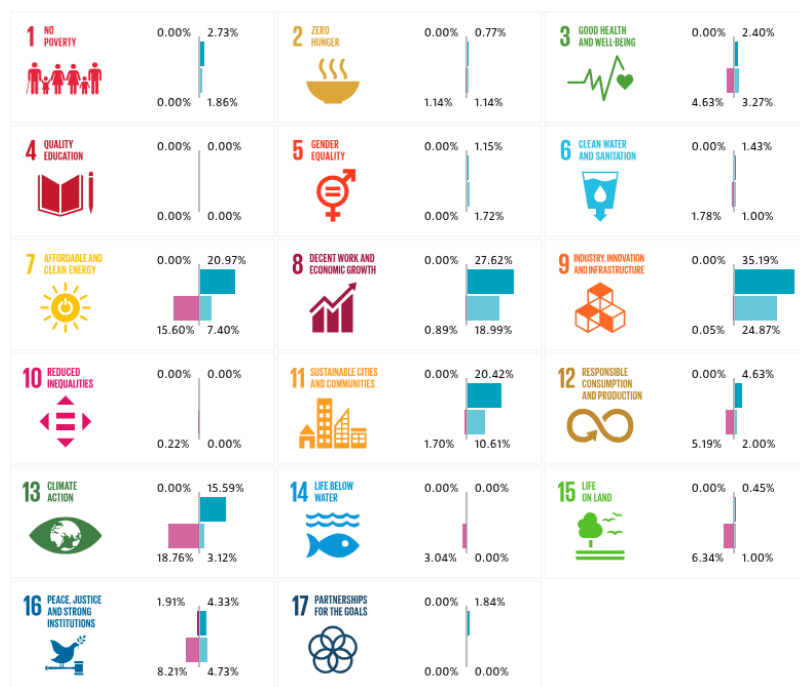
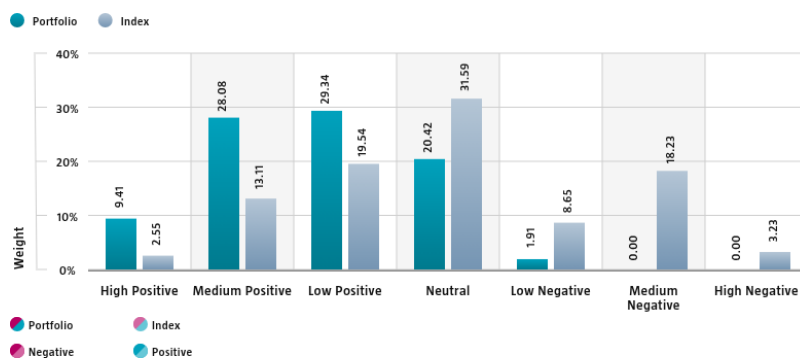

SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. 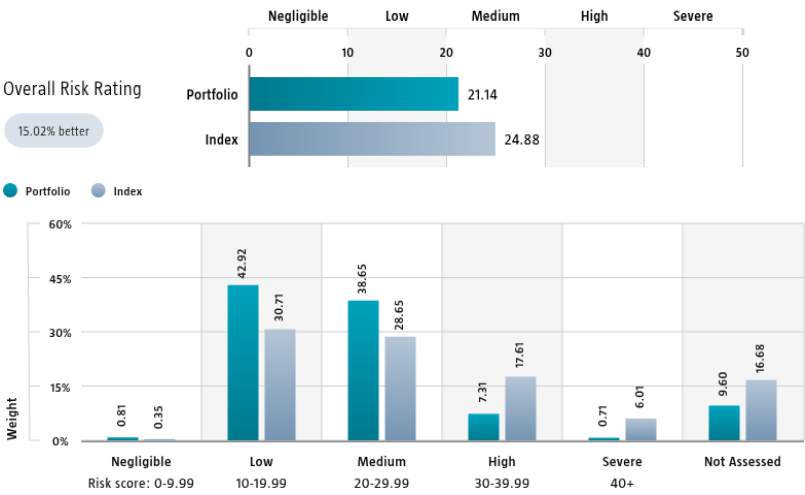

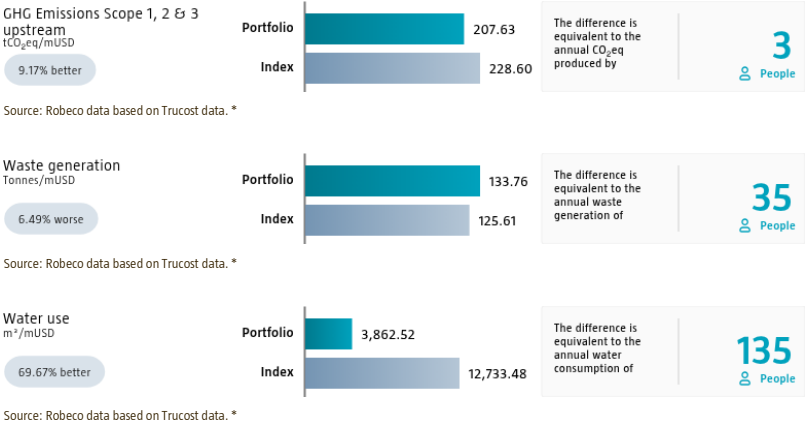

Environmental Footprint

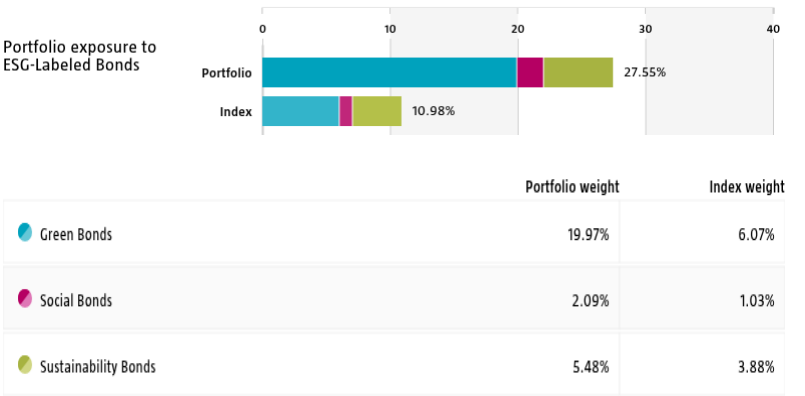
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

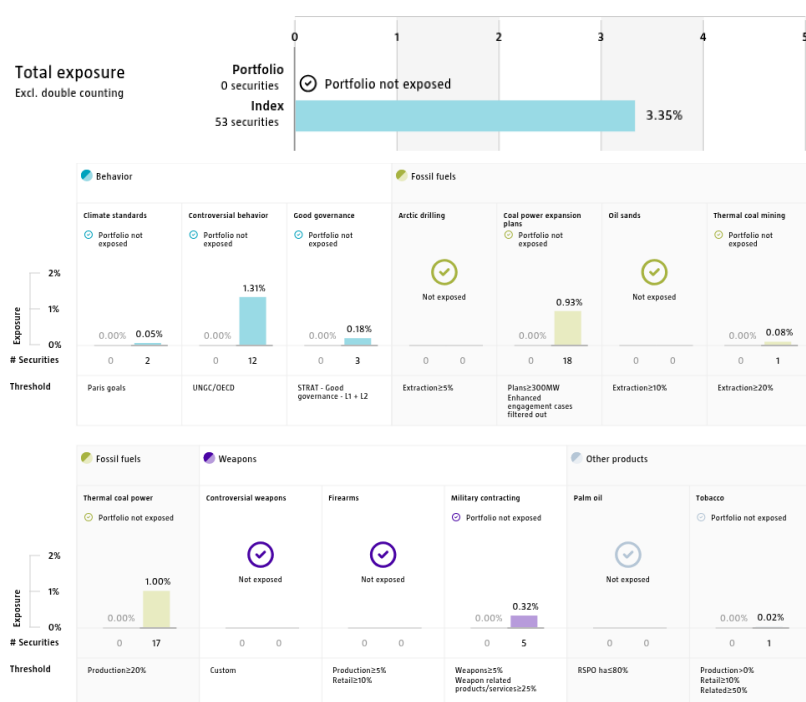
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Based in Singapore, Thu Ha Chow is Head of Fixed Income Asia and Portfolio Manager Emerging and Asian Credits. Prior to joining Robeco in 2022, she was Portfolio Manager and Asia Strategist at Loomis Sayles & Co and Head of Asian Credit at Aberdeen Asset Management, both in Singapore. Previously Thu Ha worked for 15 years in London where she held senior fixed income positions at Deutsche Asset Management and Threadneedle Asset Management in addition to 3 years in investment banking at Credit Suisse First Boston. She started her career in 1998 after obtaining a Master's in Economics and Philosophy from London School of Economics. Frank Reynaerts is Portfolio Manager Emerging and Asian Credits. Frank joined Robeco in 2011 as a Portfolio Manager Emerging Debt. Prior to that, he was Portfolio Manager Investment Grade Credits at Syntus Achmea, Portfolio Manager Emerging Debt at Lombard Odier and Portfolio Manager Fixed Income at Fortis. Frank started his career in 1997 at ASLK Bank as a Risk Analyst. He holds a Master's in Commercial and Financial Sciences from EHSAL Business School of Brussels and he is a CFA® Charterholder. Evert Giesen is Portfolio Manager Investment Grade in the Credit team. Previously, he was an Analyst, responsible for covering the Automotive sector within the Credit team. Prior to joining Robeco in 2001, Evert worked at AEGON Asset Management for four years as a Fixed Income Portfolio Manager. He has been active in the industry since 1997 and holds a Master's in Econometrics from Tilburg University.

Team info

The Robeco Transition Emerging Credits fund is managed within Robeco's credit team, which consists of eight portfolio managers and twelve credit analysts (of which four cover the financial sector). The portfolio managers are responsible for the construction and management of the credit portfolios, whereas the analysts cover the team's fundamental research. Our analysts have long term experience in their respective sectors which they cover globally. Each analyst covers both investment grade and high yield, providing them an information advantage and benefiting from inefficiencies that traditionally exist between the two segmented markets. Furthermore, the credit team is supported by three dedicated quantitative researchers and four fixed income traders. On average, the members of the credit team have an experience in the asset management industry of sixteen years, of which eight years with Robeco.
