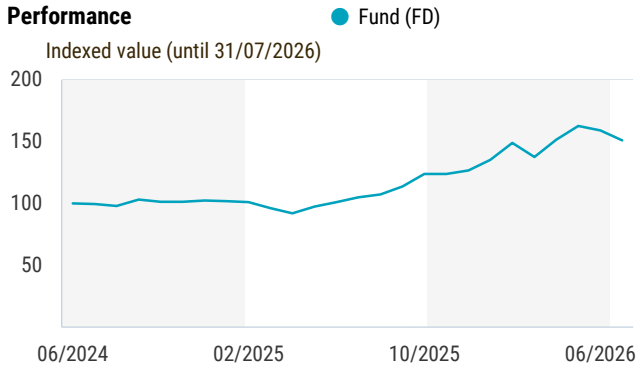

About the fund

Robeco Emerging Markets Climate Transition Equities is an actively managed sub-fund that invests in equities in emerging countries across the world. The Sub-fund will take exposure of at least two thirds of its total assets to equities of companies incorporated or exercising a preponderant part of their economic activities in Emerging Countries. The stock selection is based on fundamental analysis. The Sub-fund aims to make investments in assets that contribute to a climate transition. Climate transition pertains to the transitional efforts required to limit global temperature increase to well-below 2°C degrees, aligned with the goals of the Paris Agreement. This is achieved by investing in companies that are making the transition and companies are enabling the transition, as described in the Prospectus.

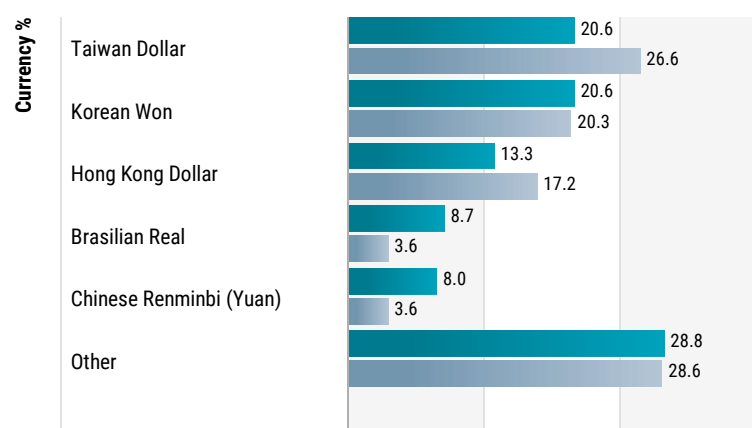
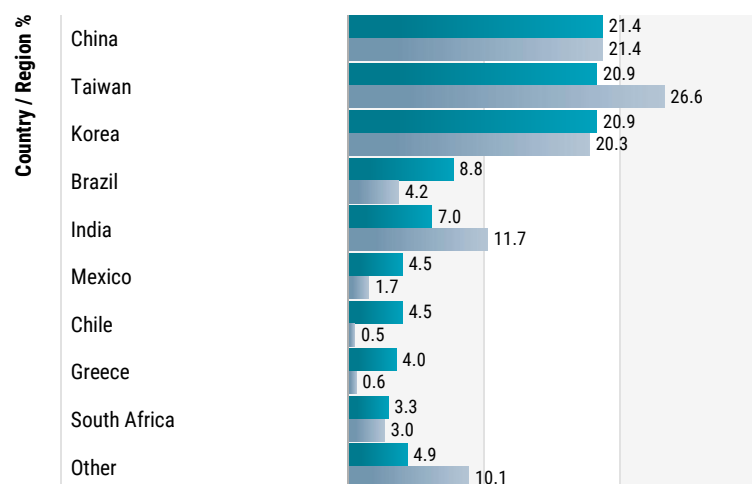
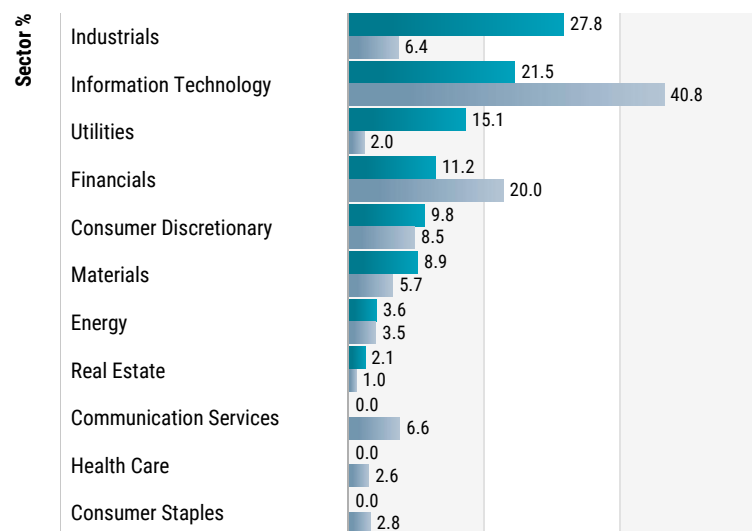

Performance commentary

Based on transaction prices, the fund's return was -5.03%.

The portfolio underperformed versus the MSCI EM Index in July, as positive country allocation was offset by weaker stock selection. Overweights in Brazil and Chile, alongside a preference for Chinese H-shares over A-shares, added value, while the overweight position in South Korea detracted. Top contributors included Wiwynn, supported by strong revenue growth and continued investment in AI infrastructure; Metlen Energy & Metals, which benefited from a strategic gallium supply agreement; Hon Hai, driven by better-than-expected results and a new AI server contract with SpaceX; Gerdau, aided by a positive rating outlook revision and strategic energy asset acquisition; and Kia, following strong earnings, rising vehicle volumes and market share gains. Key detractors were SK Square, reflecting volatility surrounding SK hynix's ADR listing and subsequent market sell-off; Sungrow, impacted by US restrictions on foreign inverter imports; Samsung C&T, which declined despite record earnings given the weakness in Samsung Electronics shares; Lundin, affected by weather-related production disruptions at the Caserones copper mine; and SQM, pressured by falling lithium prices.

Market development

Emerging markets declined 3.7% (EUR) in July, underperforming versus developed markets, which fell 0.1% (EUR). Performance was primarily affected by a correction in AI and technology-related stocks, particularly in South Korea and Taiwan, as investors reassessed AI spending, funding needs, commercialization prospects, and rising competition from Chinese companies. South Korea was further impacted by hedge fund de-risking and reduced leveraged ETF exposure. Market sentiment improved toward month-end as deleveraging pressures eased, supporting a strong rebound in South Korean equities. Geopolitical tensions in the Middle East also weighed on markets, with renewed hostilities and ongoing Red Sea shipping disruptions pushing oil prices higher and reducing risk appetite. Top-performing markets were Colombia, Indonesia, Poland, the Czech Republic, and Greece, while South Korea, Taiwan, and Turkey lagged.

Expectation of fund manager

The war in the Middle East is a significant shock with a big impact on the region and on global oil and gas prices. Even though the most likely scenario is that the war will be relatively short, risks do remain for a longer conflict and larger impact. Also economically, the US has become a source of more uncertainty on interest rate policy, import tariffs and policy making. Emerging markets are having to rely more on their own domestic policies and growth opportunities. We still expect higher structural economic growth compared to developed markets, while macroeconomic stability has significantly improved. Emerging equity markets' valuations have become attractive relative to developed markets, with discounts of more than 35% based on earnings multiples. Expected earnings growth is 46% for 2026 and 17% for 2027, both above developed markets.

Top 10 largest holdings

Our top holdings are very diversified across EM sectors and sustainability themes, whereas the weight is distributed through connectivity, transition financing, mobility and heavy sector leaders. In the technology sector, we have positions in Taiwan through TSMC, one of the largest semiconductors and supplier of chips globally, computer and electric components manufacturers Hon Hai Precision, and computer storage and network services developer Wiwynn. Also related to IT, we hold South Korean conglomerates SK Square, the controlling holding of memory chip manufacturer SK hynix, and Samsung C&T, the conglomerate owner of Samsung Electronics and Samsung Biologics. Regarding financials, we are positioned in three leading regional banks, Itaú in Brazil, ABSA in South Africa, and KB Financial in South Korea. On the mobility theme, we have relevant exposure via EV battery producer Contemporary Amperex and global automaker Geely Automobile.

Sector allocation

The main overweight sectors are industrials, utilities, and materials. In industrials, the portfolio holds companies active in EV battery manufacturing and its supply chain, electricity efficiency companies and rolling stock companies. Utilities companies include renewable integrated players, geothermal producers, district cooling as well as transition energy players. In IT, the fund invests in semiconductor manufacturing, solar panel production and IT services. Yet, IT is the largest underweight as some large IT caps fall out of the investment scope. Conversely, the fund is underweight in financials, communication services and consumer staples where climate transition is less material than other ESG themes.

Country / Region allocation

In Asia, the fund is overweight in Indonesia and South Korea, market weight in China, while underweight in the smaller ASEAN markets such as Malaysia, Thailand and the Philippines, where we hold no positions. Due to our restricted investment universe, we are underweight in Taiwan and India, although those countries have high absolute weight in our portfolio and host some of our largest investment ideas. We are overweight in Latin America, a commodity-producing region where there are many companies in the priority sectors which are advanced in their climate transition commitments. We are overweight in Brazil, Mexico and Chile, while underweight in Peru and Colombia. In EMEA, the fund holds overweight positions in Greece, while it is underweight in Eastern Europe, Turkey and Saudi Arabia.

Currency allocation

The currency allocation largely reflects the country allocation. Positions in EUR and USD are primarily because of ADR/GDR positions.

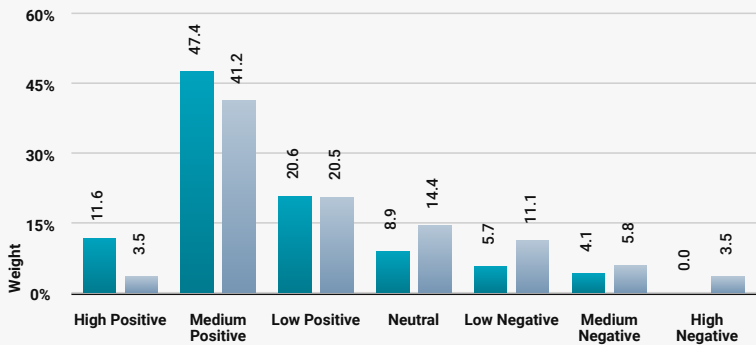

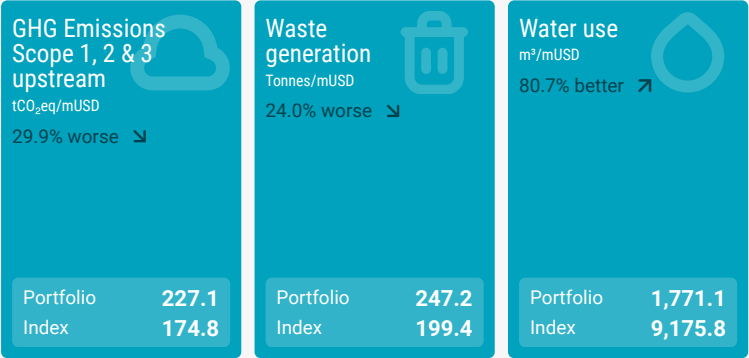
SDG Impact Alignment ¹

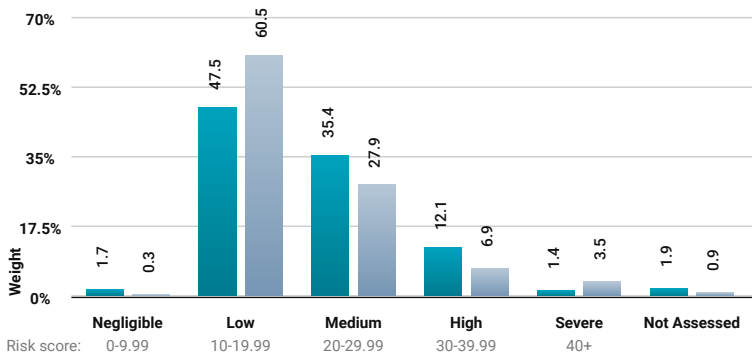

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
