Performance commentary

Based on transaction prices, the fund's return was 5.43%.

The fund slightly underperformed versus the benchmark (MSCI EM ex China) in August. Country allocation was slightly positive while stock selection was negative. Our underweight position in India contributed to the performance while our underweight in Taiwan detracted from performance. Stock selection was the main drag this month, more than offsetting a positive allocation contribution. On the positive side, gains were concentrated almost entirely in Taiwan's hardware supply chain: Wiwynn (server ODM) and Asustek (PC hardware) were overweight winners, while Tripod Technology (PCBs), Sunonwealth Electric (cooling fans/motors) and Macronix (memory chips) added value as non-benchmark positions we chose to own. On the negative side, the pain came mainly from names we avoided rather than names we owned: MediaTek (semiconductors, Taiwan), AngloGold Ashanti (gold miner, South Africa) and Samsung Electro-Mechanics (electronic components, South Korea) were all zero-weight calls that rallied against us. On the overweight side, Itaúsa (bank holding, Brazil) and Banco Macro (bank, Argentina) also detracted.

Market development

The MSCI EM ex China Index gained 3.96% in euro terms in August, beating the broader MSCI EM Index (2.38%) and MSCI World Index (1.6%). Improving sentiment toward the AI investment cycle and a rebound in North Asian technology shares outweighed persistent macroeconomic headwinds, including elevated bond yields and geopolitical tensions. Technology led performance, supported by resilient hyperscaler capital spending, solid earnings and guidance, and sizeable shareholder-return announcements from South Korean memory makers. Furthermore, the positioning unwind that pressured South Korean equities in July largely subsided, allowing underlying fundamentals to reassert themselves. Elsewhere, the global backdrop remained challenging. Middle East tensions fueled oil price volatility, while climbing yields drew investor focus. A hawkish Jackson Hole message from the Federal Reserve prompted markets to price in a higher probability of a September interest rate hike, though the US dollar ended slightly lower. August's top performers were South Africa, Turkey, Greece, Taiwan, and South Korea, while the Philippines, Colombia, Egypt, Brazil, and Thailand lagged behind.

Expectation of fund manager

The conflict in the Middle East remains a significant source of geopolitical risk, with potentially far-reaching implications for regional stability and global energy markets, particularly oil and gas prices. While tensions have moderated from their earlier peaks, the geopolitical backdrop remains fragile, with a meaningful risk of renewed escalation and associated disruption to energy supplies and trade flows. Emerging equity markets' valuations have become attractive relative to developed markets, with discounts of more than 40% based on earnings multiples. Expected earnings growth is 72% for 2026 and 23% for 2027, both above developed markets.

Top 10 largest holdings

From a geographic perspective, most of our top ten holdings are based in Asia, and comprise of technology, financial and industrial names. Taiwan is represented by Taiwan Semiconductor Manufacturing (TSMC), the world's leading contract chipmaker, Hon Hai Precision Industry (Foxconn), the electronics manufacturing giant and key AI server assembler, Wiwynn, a leading server ODM, and ASE Technology, the largest semiconductor assembly and testing provider. South Korea features prominently with Samsung Electronics, the memory and consumer electronics leader, appearing in the top ten through both its common and preferred shares. SK hynix, a global memory chip leader, and SK Square, the holding company with a major stake in SK hynix, also remain among our largest positions. Indian private sector banks ICICI Bank and HDFC Bank complete the top ten, reflecting our conviction in India's structural financial deepening story.

Sector allocation

The main overweight sectors are financials, consumer discretionary and real estate. In consumer discretionary, we own a broad spectrum of companies that are well positioned to benefit from the growing buying power of the emerging consumer. Information technology remains the largest absolute exposure in the portfolio, albeit modestly underweight versus the benchmark, and here we hold a number of attractively valued companies with good long-term prospects. Conversely, consumer staples, materials and healthcare are the largest underweight positions compared to the benchmark, alongside communication services, which contains several expensive internet companies.

Country / Region allocation

In Asia, the strategy is overweight in South Korea and underweight in India and Taiwan, as well as in the smaller markets such as Malaysia and the Philippines, where we hold no positions. The strategy also has overweight positions in Vietnam and Indonesia. Within India, we prefer domestic exposure over the export sectors. In Latin America, we are overweight in Mexico, Brazil, Peru and Argentina, underweight in Chile, and hold no position in Colombia. In EMEA, the fund holds overweight positions in the United Arab Emirates, Hungary, Poland, Greece, South Africa and Turkey. The fund has a neutral position in Qatar. It has no positions in the Czech Republic and Kuwait, and an underweight position in Saudi Arabia.

Currency allocation

The currency allocation largely reflects the country allocation. Positions in EUR and USD are primarily because of ADR/GDR positions.

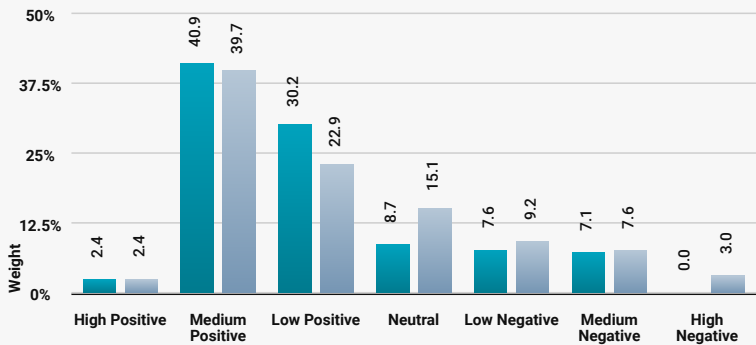

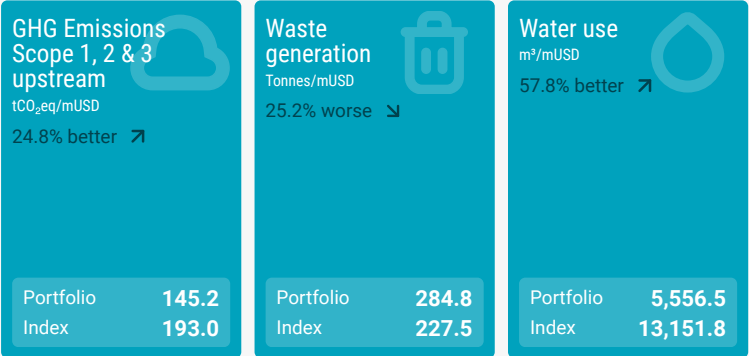
SDG Impact Alignment ¹

Environmental Footprint ²

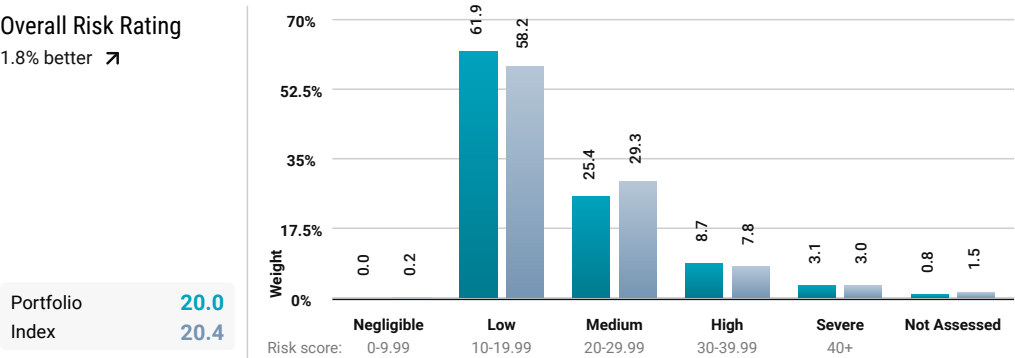

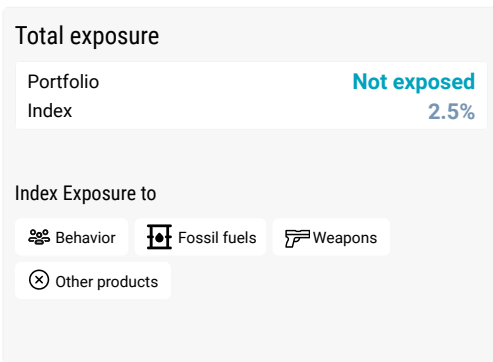

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund.
