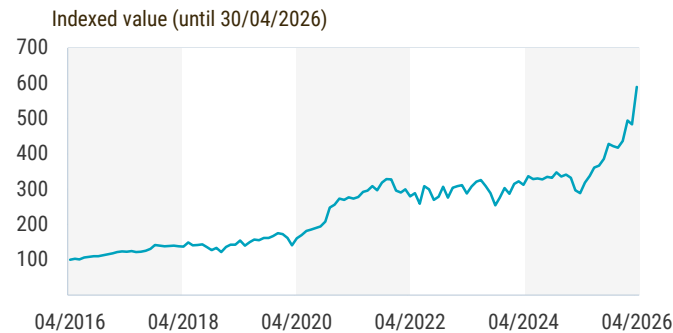

Robeco Smart Energy is an actively managed fund that invests globally in companies active in clean energy production, energy infrastructure and management, as well as solutions that improve energy efficiency for sectors such as industrials, buildings, transportation or data centers. The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The fund's objective is also to achieve a better return than the Benchmark. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. The assessment regarding relevant SDGs uses an internally developed framework, more information on which can be obtained at www.robeco.com/si.

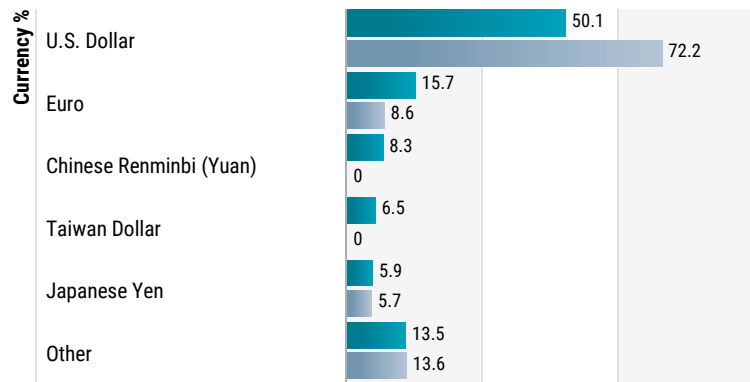
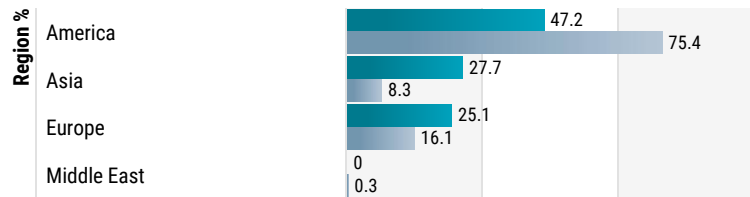
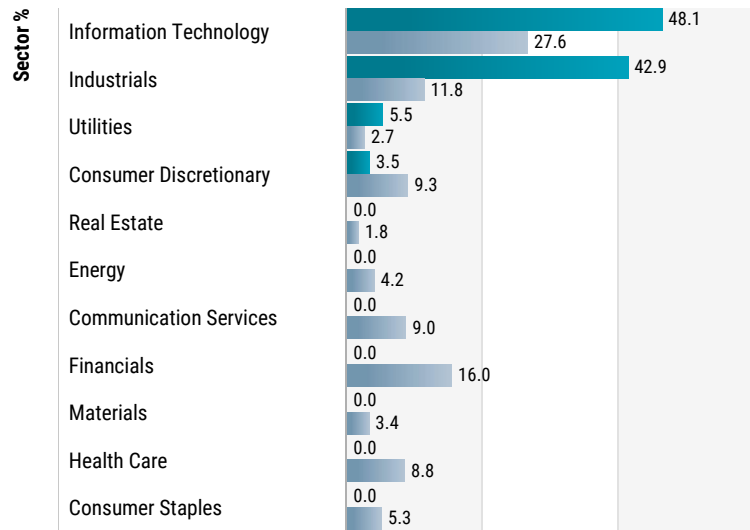

Performance commentary

Based on transaction prices, the fund's return was 22.05%.

The Energy Management cluster was the strongest performer, driven by a sharp rebound in Semiconductor Power Management as cyclical recovery expectations improved. Stabilizing automotive demand and renewed EV momentum, supported by higher fuel prices, underpinned sentiment, while structurally rising AI data center demand reinforced the medium-term outlook. Infineon and Onsemi led gains, reflecting high automotive exposure. Energy Storage delivered positive returns but lagged due to margin pressure at CATL from higher lithium prices. Energy Efficiency was the second-best performer, led by Big Data. Strong results and AI-driven demand supported Marvell, Zhongji Innolight, Vertiv and Delta Electronics. Energy Distribution contributed positively, driven by Equipment Suppliers, while Renewables lagged amid higher rates, though Nordex stood out on earnings strength and backlog growth.

Market development

Global equity markets rose strongly in April, supported by solid earnings and renewed enthusiasm around artificial intelligence. Despite ongoing geopolitical tensions and elevated energy prices, investors focused on corporate fundamentals, with a narrow group of large technology and semiconductor stocks driving much of the gains. AI-related results reinforced confidence in sustained capex, lifting US equities to their strongest monthly performance in years. Macro data were mixed, with persistent inflation pressures offset by resilient growth, keeping bond yields elevated. Regionally, the US outperformed Europe, while Asian markets rebounded, led by AI-exposed economies such as Japan, South Korea and Taiwan.

Expectation of fund manager

The escalation of tensions involving Iran has temporarily weighed on our expectations but does not alter our core base case scenario. We continue to expect inflation to resume its gradual downward path once the situation in the Middle East stabilizes. In the United States, interest rates are likely to move lower, albeit at a slower pace, which should support economic activity and improve investor sentiment – particularly in the construction sector in the second half of 2026, after a prolonged period of pressure from elevated financing costs. Meanwhile, the global manufacturing PMI is trending upward, signaling improving growth momentum, supported by reshoring initiatives and the rapid expansion of data center infrastructure. Against this backdrop, investment in clean energy, grid infrastructure and electrification is becoming increasingly urgent to ensure energy security and support structurally higher power demand.

Top 10 largest holdings

Infineon is the largest semiconductor company in Automotive and has a market-leading power semiconductor portfolio, part of the Semiconductor Power Management subcluster; Quanta Services is the largest and leading specialized US contractor in electric T&D and part of the Energy Distribution cluster; Delta Electronics is a global power-electronics and energy-efficiency solutions provider, part of the Energy Efficiency Industrial Processes subcluster; Onsemi is a power-focused semiconductor company enabling electrification and energy efficiency, part of the Semiconductor Power Management subcluster; Vertiv provides data center power management and cooling systems, part of Energy Efficiency Big Data.

Sector allocation

The fund invests in companies exposed to the structural growth trends of the Smart Energy theme. As a consequence, the portfolio is particularly invested in companies in the sector technology, followed by industrials and utilities.

Regional allocation

The fund invests globally. Most exposure is in North American stocks, followed by European and Asia-Pacific stocks.

Currency allocation

The portfolio itself does not use currency hedges. This means that for an unhedged share class, the currency allocation is a reflection of the investments of the portfolio. For a hedged share class, the currency allocation is the result of the currency hedge.

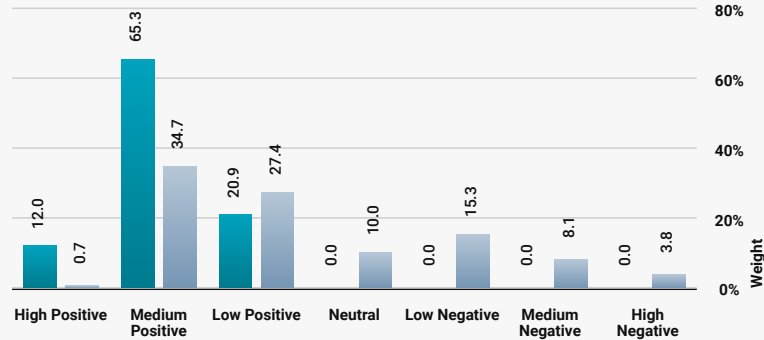

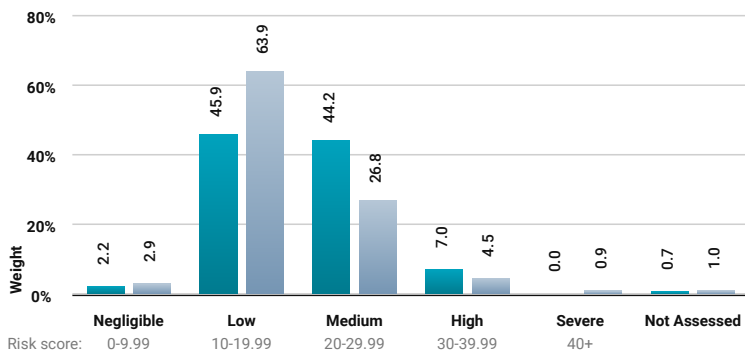

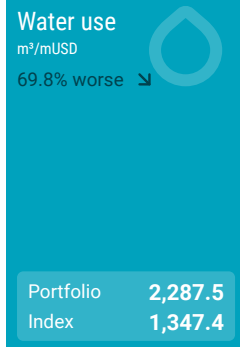

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
