The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The fund's objective is also to achieve a better return than the Benchmark. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 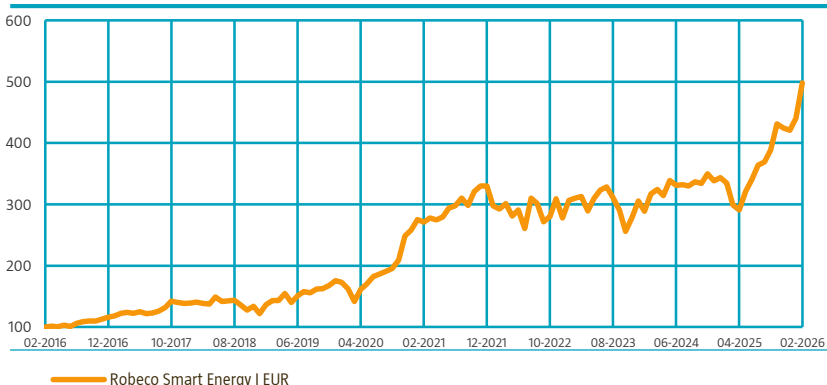

### Performance

Based on transaction prices, the fund's return was 13.21%.

The Energy Efficiency cluster was the strongest contributor, led by a rebound in the Big Data subcluster after January's consolidation. Lumentum surged on sharply better-than-expected results and upbeat guidance, reflecting accelerating AI-driven demand for optical networking, while Vertiv rallied on solid earnings, positive 2026 guidance and a record data-center-related order backlog. Zhongji Innolight lagged as investors paused after its strong 2025 performance. Industrial Processes ranked second, supported by Regal Rexnord on solid results and a large data center order, while Energy-Efficient Transport advanced on Maruwa's strong earnings. Energy Distribution also performed well, with equipment suppliers outperforming. By contrast, Energy Management was mixed and Renewables lagged, with dispersion high across wind and solar.

### Market development

Global equity markets posted mixed results in February, as resilient headline performance masked pronounced sector and style rotation. Investor sentiment increasingly shifted toward risk aversion, driven by concerns that rapid advances in generative AI could disrupt earnings across multiple industries. Heavy selling in software and large-cap technology weighed on US indices, while capital rotated toward cyclical, asset-heavy and defensive sectors, lifting volatility as markets became more narrative-driven than fundamentally anchored. Bond markets echoed this caution, with the 10-year US Treasury yield falling below 4% amid growth concerns and risk-off flows rather than clear disinflation signals. Regional equity performance diverged: US markets lagged amid mega-cap weakness, Europe reached new highs on value-oriented leadership, and Japan led gains in Asia on strong semiconductor momentum and improved political clarity.

### Expectation of fund manager

For 2026, we expect inflation to continue its gradual downward trajectory. In the United States, interest rates are projected to move lower, which should lend support to both economic activity and investor sentiment – particularly within the construction sector, which has been constrained by higher financing costs. At the same time, the global manufacturing PMI is trending upward, signaling accelerating growth. In the long term, we believe a new Industrial Revolution is transforming electricity grids/infrastructure across the US and Europe. After nearly two decades of stagnation, electricity demand is on the rise, fueled by energy-intensive data centers driven by the AI industry, electric vehicles and the heating and cooling of buildings. This, coupled with government incentives for clean energy infrastructure development, has spurred a surge of new construction projects to upgrade energy systems and modernize the grid.

Vertiv provides data center power management and cooling systems, part of the Energy Efficiency Big Data subcluster; Quanta Services is the largest and leading specialized US contractor in electric T&D and part of the Energy Distribution cluster; Lumentum provides optical components for data centers, part of the Big Data subcluster; Infineon is the largest semiconductor company in Automotive and has a market-leading power semiconductor portfolio, part of the Semiconductor Power Management subcluster; SSE is a UK-based electricity transmission operator and renewable power developer and part of the Electric Network subcluster.

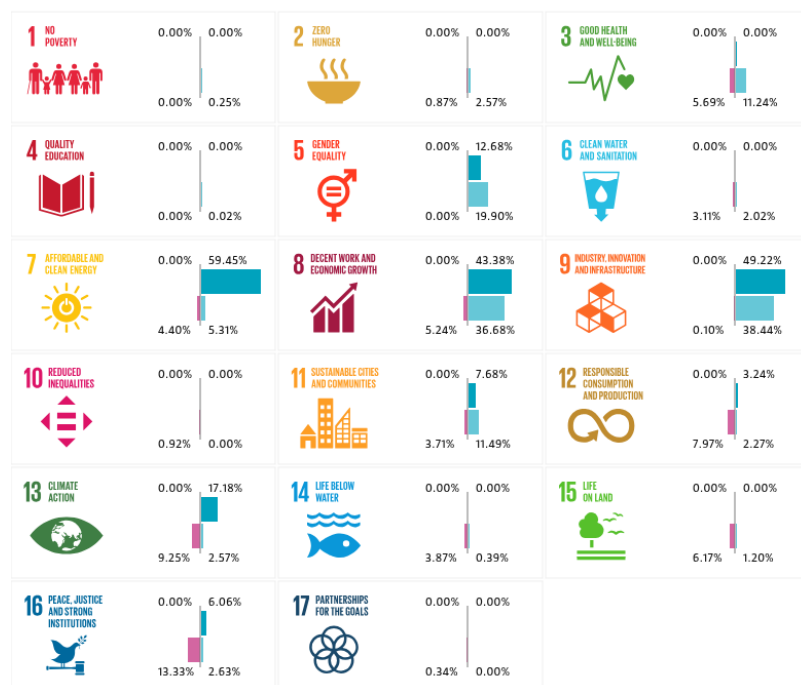
## Sustainability

The fund's sustainable investment objective is to further the transformation and decarbonization of the global energy sector. The transformation and decarbonization of the energy sector and sustainability considerations are incorporated in the investment process by the means of a target universe definition, exclusions, ESG integration, a carbon footprint target and voting. The fund only invests in companies that have a significant thematic fit as per Robeco's thematic universe methodology. Through screening on both Robeco's internally developed SDG Framework and Robeco's exclusion policy, the fund does not invest in issuers that have a negative impact on the SDGs, are in breach of international norms or where products have been deemed controversial. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. The fund's weighted carbon footprint will be equal to or better than that of its Climate Transition Benchmark. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy. For more information please visit the sustainability-related disclosures. ## SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. 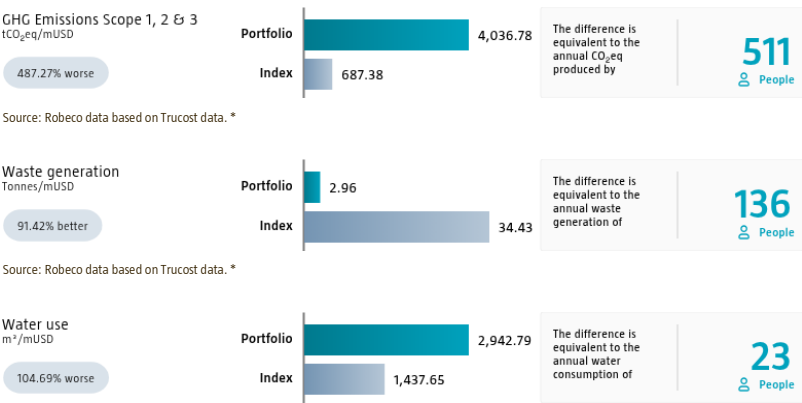

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. ## Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund furthers the decarbonization of the global energy sector through investments in clean energy sources, energy efficient products and infrastructure and by the electrification of the industrial, transportation and heating sectors. This is done by investing in companies that advance the following UN Sustainable Development Goals (UN SDGs): Affordable and Clean Energy goal, Decent work and economic growth, Industry, innovation and infrastructure, Sustainable cities and communities, and Climate action. The fund integrates ESG (Environmental, Social and Governance) factors in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to normative, activity-based and region-based exclusions, carbon reduction target and proxy voting.
