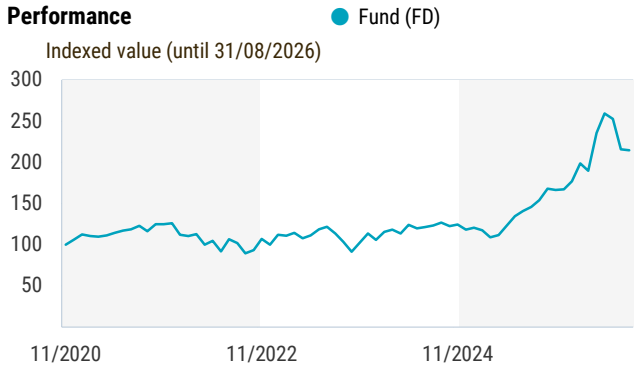

About the fund

Robeco Smart Energy is an actively managed fund that invests globally in companies active in clean energy production, energy infrastructure and management, as well as solutions that improve energy efficiency for sectors such as industrials, buildings, transportation or data centers. The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The fund's objective is also to achieve a better return than the Benchmark. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. The assessment regarding relevant SDGs uses an internally developed framework, more information on which can be obtained at www.robeco.com/si.

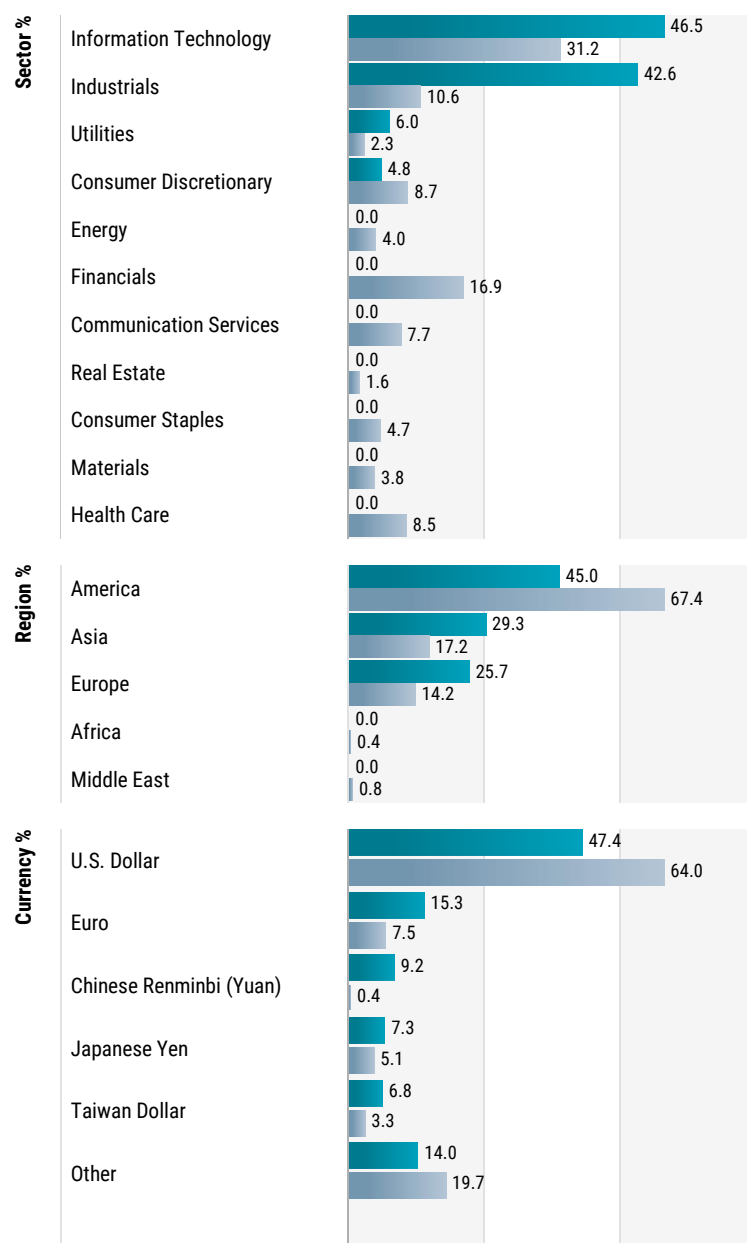
On the launch date, 29 October 2020, the fund absorbed Multipartner SICAV - Robeco Smart Energy Fund. Performance prior to the launch date has been simulated on the basis of the past performance of the absorbed fund that had similar investment policy and applied higher or comparable charges. With effect from 16 July 2026, the benchmark has been changed from MSCI World Index to MSCI All Country World Index.

Performance commentary

Based on transaction prices, the fund's return was -0.43%.

Outperformance in the Energy Efficiency cluster was led by Big Data, as AI-linked stocks regained market leadership. Asia Vital Components, Lumentum and Marvell benefited from continued strength in AI infrastructure spending, while Autodesk supported gains as demand for vertical software remained resilient. Transportation lagged, as weaker EV demand in China weighed on BYD and Shuanghuan Driveline. Energy Distribution also contributed positively, driven by equipment suppliers exposed to grid investment and data center power demand. HD Hyundai Electric and SWCC performed strongly on robust transformer and optical networking demand, while SSE benefited from investor preference for defensive, regulated growth businesses. Renewable Energies underperformed as rising bond yields pressured renewable power producers. Vestas was a bright spot following strong results and improving profitability, while Fervo Energy, Sunrun and Sungrow detracted. Energy Management was the weakest cluster. Power semiconductor stocks faced profit-taking despite generally solid earnings.

Market development

Global equities rebounded in August, recovering much of July's weakness as strong corporate earnings, particularly from AI-related companies, outweighed concerns over rising bond yields and geopolitical tensions. Long-term government bond yields moved higher across the US, Europe and Japan, as investors focused on fiscal deficits, growing financing needs and continued government debt issuance. The AI investment cycle remained a key market driver. NVIDIA's strong results reinforced confidence in sustained demand for data centers, computing power and energy infrastructure, supporting positive earnings momentum across the technology sector. Regionally, US equities led gains, driven by technology and AI beneficiaries. Asian markets recovered, supported by semiconductor demand and improved risk appetite, with Japan, South Korea and Taiwan outperforming.

Expectation of fund manager

Markets remain in a consolidation phase as investors balance geopolitical tensions, higher energy prices and rising bond yields against resilient corporate fundamentals. Attention is increasingly shifting toward AI monetization and the sustainability of elevated capital spending. Encouragingly, earnings continue to support our investment thesis, with robust demand for electric infrastructure, a broadening cyclical recovery and growing evidence that AI investments are creating tangible value. Improving manufacturing activity and a recovery in construction markets further strengthen the outlook. At the same time, rising power demand continues to reinforce the need for electrification, grid expansion and clean energy investment. While geopolitical and policy risks remain, we believe the long-term fundamentals supporting our investment theme remain firmly intact.

Top 10 largest holdings

Infineon is the largest semiconductor company in Automotive and has a market leading power semiconductor portfolio, part of the Semiconductor Power Management subcluster; Marvell is specialized in semi-customized networking, storage and data center solutions for power-efficient data processing, part of the Big Data subcluster; Asia Vital is a leader in liquid cooling for AI servers, part of the Big Data subcluster; Delta Electronics is a global power-electronics and energy-efficiency solutions provider, part of the Energy Efficiency Industrial Processes subcluster. Zhongji Innolight is a leading optical transceivers player, part of the Big Data subcluster.

Sector allocation

The fund invests in companies exposed to the structural growth trends of the Smart Energy theme. As a consequence, the portfolio is particularly invested in companies in the sector technology, followed by industrials and utilities.

Regional allocation

The fund invests globally. Most exposure is in North American stocks, followed by Asia-Pacific and European stocks.

Currency allocation

The portfolio itself does not use currency hedges. This means that for an unhedged share class, the currency allocation is a reflection of the investments of the portfolio. For a hedged share class, the currency allocation is the result of the currency hedge.

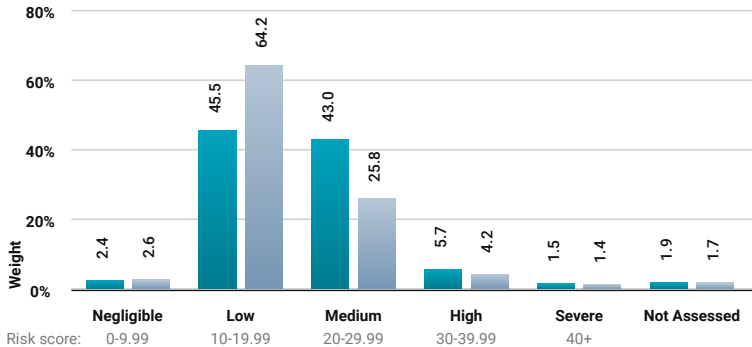

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. 4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance. Any amount invested in the fund forms part of the investor's net assets.
