Performance commentary

Based on transaction prices, the fund's return was -0.26%.

The fund's return (gross of fees) was higher than that of the benchmark in July. Although the duration overweight of the portfolio detracted from relative performance, most other segments contributed positively. The underweight position in French and Italian government bonds helped relative performance as spreads slowly widened in July. Short-dated corporates outperformed government bonds, also benefiting the overweight allocation to credit. Lastly, the overweights in euro-denominated bonds of Romania and Mexico as well as South Korea added to relative performance. The contributions of the covered bond and government-related bond positioning were roughly neutral for the month.

Market development

Government bond returns were negative across the globe in July. 10-year US Treasuries rose 27 basis points to 4.73% while the 30-year bond reached its highest yield since 2007. The German Bund yield even rose by 35 basis points to 3.21%. Oil prices rose sharply again, driven by a renewed escalation of the US-Iran conflict, which fueled concerns about inflation and increased expectations for further monetary policy tightening. As widely anticipated, the ECB left its deposit rate unchanged at 2.25%. President Lagarde highlighted the downside risks to growth stemming from higher energy prices, while reiterating the ECB's data-dependent approach. In the US, labor market data continued to point to a 'low-hire, low-fire' environment. Although the unemployment rate declined, this was driven by a lower participation rate rather than stronger job creation. The Fed left rates unchanged at its July meeting, despite markets assigning some probability to a rate hike ahead of the decision. Peripheral Eurozone spreads widened marginally versus Bunds, as investors demanded a higher risk premium amid weaker risk sentiment and heightened geopolitical uncertainty.

Expectation of fund manager

The renewed escalation of the US-Iran conflict has led to upside risks to inflation and increased the scope for further monetary tightening. In the US, this raises chances that the Federal Reserve might raise its policy rate later this year. That said, a meaningful deterioration in labor market conditions or a sharp decline in oil prices could prevent the Fed from acting. In our base scenario, we expect gradually moderating energy prices and a continued absence of second round effects on inflation, although the ECB is likely to hike rates by 25 bps at their September meeting if oil prices stay at current levels. Within European sovereign spreads, we expect further divergence across countries. French government bond spreads are likely to remain under widening pressure, as investor focus shifts toward upcoming presidential elections and fiscal developments.

Sector allocation

At the start of the month, the fund held an overweight position in corporate bonds and government-related bonds versus an underweight in government bonds and covered bonds. During the month, the fund slightly reduced the overweight in corporate bonds, taking profit on the recent outperformance of new issues. Within the government-related bond segment, the fund maintains an overweight in sovereign bonds (EM HC) versus an underweight in supnationals and local authorities.

Country / Region allocation

The fund maintains an overweight position in Dutch and Finnish government bonds and underweight positions in French, Spanish and Italian government bonds. Over the course of the month, the underweight exposure to Italian government bonds was reduced, taking profit on widening spreads. Moreover, the overweight position in euro-denominated Romanian and Mexican government bonds was also reduced, which outperformed in July. A small overweight was initiated in euro-denominated bonds from Chile.

Duration allocation

The overall duration of the fund is above that of the index. Over the month, we gradually added to the duration position, making use of the cheapening in front-end yields. Our base case remains a partial reopening of the Strait of Hormuz, providing some relief to energy prices and resulting in markets to price out excessive ECB tightening. At current levels, we see value in front-end yields in Europe.

Rating allocation

The fund has roughly 40% invested in AAA/AA bonds, mainly comprising government-related bonds and Dutch government bonds. The average rating of the fund is A1/A2, compared to an average rating of AA3/A1 for the index. The relative underweight in the A-rated segment is mainly driven by the underweight position in French government bonds, while the overweight in the AA-segment is driven by the position in Finnish government bonds.

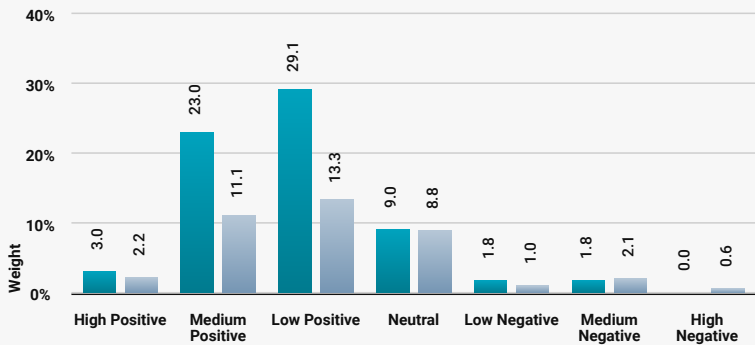

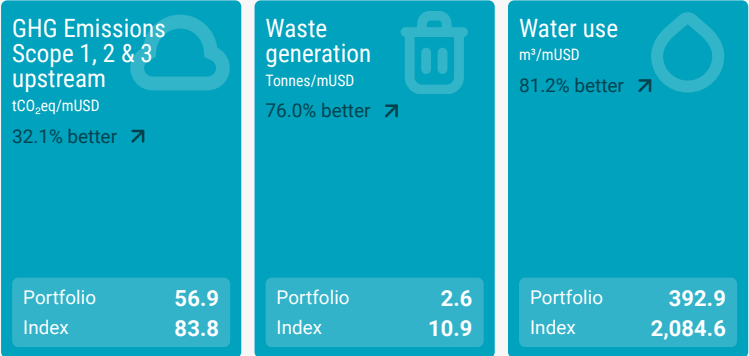

Environmental Footprint ²

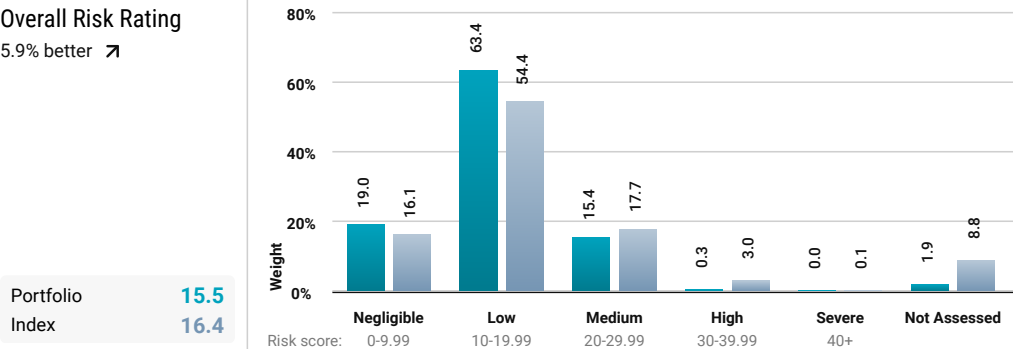

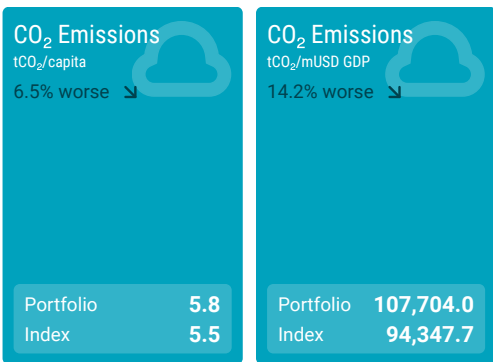

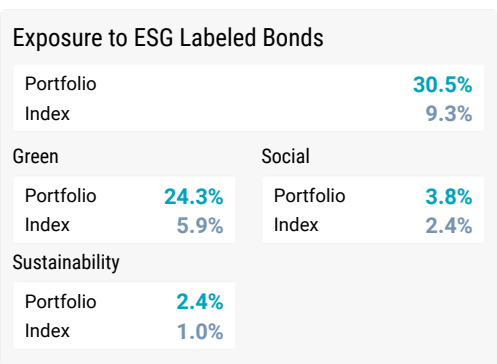

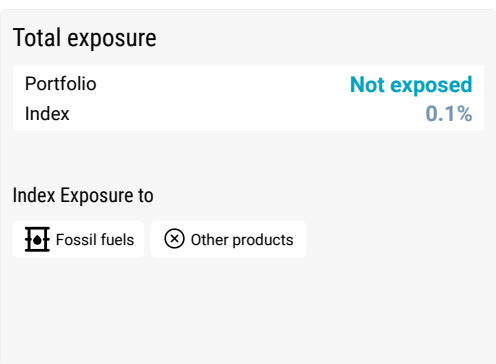
ESG Labeled Bonds ⁵

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

4. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Exclusions

7. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
