### Performance

Based on transaction prices, the fund's return was -2.41%.

In November, the fund performed slightly better than the MSCI Emerging Market Index, with a small positive result for country allocation and a small negative result for stock selection. For country allocation, the overweight position in South Korea and underweight in India contributed negatively, which was compensated for by the overweight in Brazil and South Africa, and the underweight in Taiwan and Saudi Arabia. The largest positive contributor was South Korean holding company SK Square. The company came out with an improved value-up plan, which included lowering the NAV discount target from 50% to 30%, and which resulted in better performance than its key holding SK hynix. Other well-performing stocks included Brazilian Itaú Unibanco, South Korean Hana Financial, and Chinese consumer companies Vipshop and Haier Smart Home. The largest negative contributor to stock selection was the South African holding company Naspers, which lagged its key holding Tencent following the confirmation of slightly lower buybacks. Other laggards were the South Korean defense company Hyundai Rotem, the South Korean auto companies Kia and Hyundai Motor, and the tech companies Samsung Electronics and Asustek.

### Market development

In November, the MSCI Emerging Markets Index declined by 2.9%, lagging the 0.3% decline for developed markets. The best-performing countries were Chile, Brazil and Colombia. In Brazil, inflation is moderating, which is leading to higher hope for interest rate cuts. Chile had the first round of the presidential elections, resulting in a run-off in December with conservative José Antonio Kast as the most likely winner. The worst-performing countries were Saudi Arabia, the UAE, South Korea and Taiwan. The Middle Eastern countries were impacted by a relatively weak US dollar and oil price. Within Taiwan and South Korea, the technology companies corrected in particular on global worries on the sustainability of the AI rally.

### Expectation of fund manager

The US remains a source of uncertainty in today's global economy with rising fiscal deficits, higher US import tariffs and erratic policy making. However, as the majority of earnings from emerging companies is domestically focused, we think the US itself will be most impacted. Global investors seem likely to diversify away from the US, which so far has resulted in a weaker US dollar. With the current America First focus, emerging markets are having to rely more on their own domestic policies and growth opportunities. We expect higher structural economic growth compared to developed markets, while macroeconomic stability has significantly improved. Emerging equity markets' valuations have become attractive relative to developed markets with discounts of more than 30% based on earnings multiples. Expected earnings growth is 12% for this year and 17% for next year, both above developed markets.

### Top 10 largest positions

TSMC and Samsung Electronics are two globally leading technology companies that combine good growth prospects with attractive valuations. Alibaba is China's leading e-commerce company, and is also one of the leaders in cloud services and AI development in China. Naspers is a South Africa-listed holding company for Tencent and several other internet companies across emerging markets, and is trading at a large discount to the underlying value. SK Square is a holding company for memory chip company SK hynix, and is also trading at a large discount, while the underlying business is performing very strongly. The other top ten holdings come from various industries; we see attractive valuations combined with high or better-than-expected growth opportunities for all.

### Sector allocation

In November, the fund added to the financials and materials sectors, as new positions were bought in Polish Bank Pekao and Peruvian mining company Buenaventura. Financials, consumer discretionary and information technology remain the largest sectors in the fund. In these sectors we find the best opportunities for companies that combine good growth prospects and attractive valuations.

### Country allocation

In November, the fund slightly increased weight in Brazil, Poland and Peru, and reduced weight in China, South Korea and Taiwan. In Poland, Bank Pekao was added as a new holding in the fund. We are positive on the outlook for Poland, and the bank trades at a low valuation with a high dividend yield and potential upside from a merger with insurance company PZU. And the fund entered a new position in Peru, as a position in copper, silver and gold miner Buenaventura was bought. The company is attractively valued, increasing its production in the coming years and there is a strong demand for its key metals. Finally, the positions in Chinese gas distribution companies Kunlun and ENN Energy were sold. These were relatively small positions with a lower structural growth outlook. South Korea, China and Taiwan remain the largest countries in the fund.

### Currency allocation

The fund has initiated a short USD forward contract versus the EUR in order to benefit from a further weakening of the USD going forward. Increasing political risks in the United States, along with a large current account deficit and a rising fiscal deficit driven by expansionary policies, are negative factors for the US dollar.

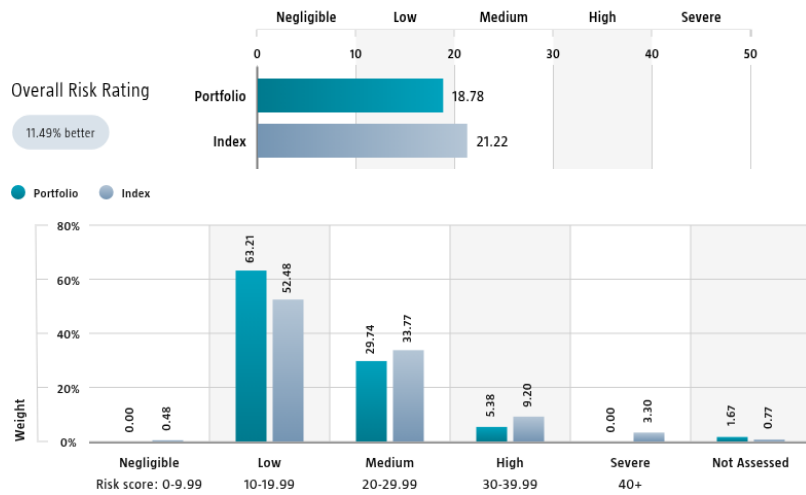
The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

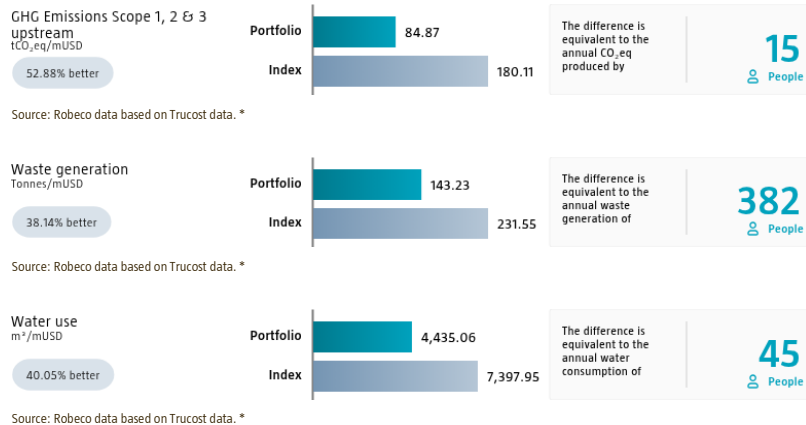

### Environmental Footprint

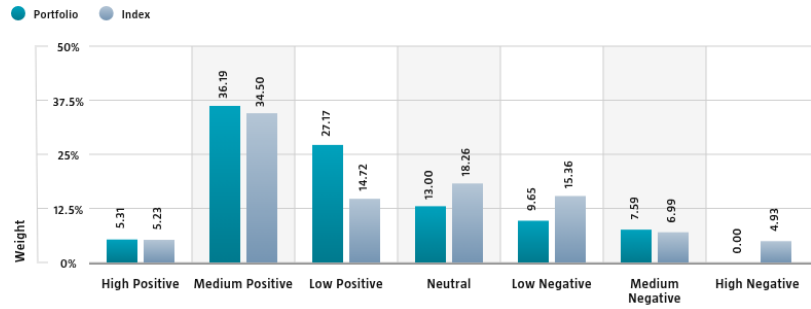
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. ### Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

We focus on companies that have both a healthy and solid business model growth prospects as a reasonable valuation. The fund has a focused, concentrated portfolio with a small number of larger bets.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, and proxy voting.

## Fund manager's CV

Jaap van der Hart is the Lead Portfolio Manager of Robeco's High Conviction Emerging Stars strategy. Over time, he has been responsible for the investments in South America, Eastern Europe, South Africa, Mexico, China and Taiwan. He also coordinates the country allocation process. He started his career in the investment industry in 1994 at Robeco's Quantitative Research department and moved to the Emerging Markets Equity team in 2000. Jaap holds a Master's in Econometrics from Erasmus University Rotterdam. He has published several academic articles on stock selection in emerging markets. Karnail Sangha is a Portfolio Manager within the Emerging Markets Equity team and provides analytical research coverage on India. He is Co-Portfolio Manager for the Emerging Stars and Sustainable Emerging Stars Equity strategies. Prior to joining Robeco in 2000, Karnail was a Risk Manager/Controller at Aegon Asset Management where he started his career in the industry in 1999. He holds a Master's in Economics from Erasmus University Rotterdam and is a CFA® charterholder. Karnail is also fluent in Hindi and Punjabi.
