An in-house Sustainability Investing (SI) research team integrates financially-material sector and company-specific sustainability analysis into investment cases.

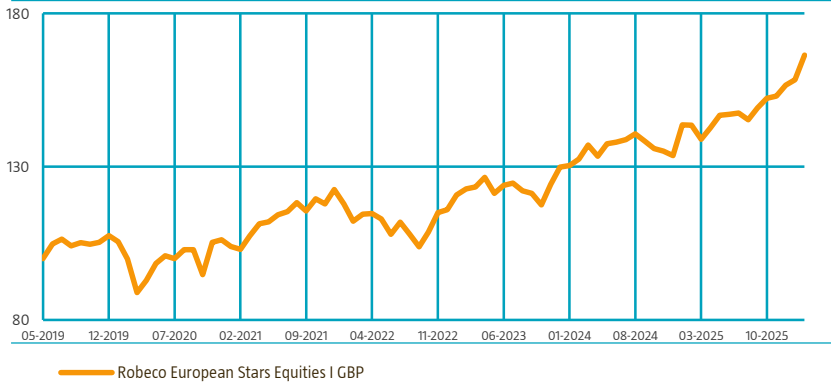

Performance

Based on transaction prices, the fund's return was 5.08%.

The fund performed very strongly in February, returning 3.8%, although performance did not fully match the exceptional return of +4.1% for the MSCI Europe. Good stock selection was more than offset by an overall negative allocation effect. Performance was strongest in healthcare, materials, and information technology, while industrials, financials, and consumer discretionary lagged the most. Positive performance in healthcare was driven by the pharmaceutical holdings AstraZeneca and Novartis, as well as by not holding Novo Nordisk. Besides two of the best-performing stocks, AstraZeneca and Novartis, the weakest performance contribution also came from a healthcare holding, namely EssilorLuxottica. Negative performance in financials was driven by the payment provider Adyen and the two bank holdings Erste Group and Barclays. Within the information technology sector, the fund's holding Halma rose by more than 15%, as the company is viewed as an AI beneficiary due to its exposure to data center capital expenditure, while its other segments are relatively well-protected from AI disruption.

Market development

In February, the MSCI Europe extended its strong rally, recording an eighth consecutive month of positive performance. With a robust gain of 4%, the European benchmark comfortably outpaced the S&P 500 index in the US, which traded flat in EUR terms during the month. The strong relative performance of European equities versus US equities was driven by continued asset flows from the richly valued US market into more favorably valued European markets. The best-performing sectors in Europe were real estate, communication services, and consumer staples. Asset-heavy sectors such as energy and materials trailed the top performers by only a small margin. Sectors that underperformed versus the MSCI Europe were financials, consumer discretionary, information technology, and healthcare. Within financials, payment companies and financial institutions with greater exposure to private markets were hit the hardest, while insurance companies and exchanges performed better.

Expectation of fund manager

The fund's strategy aims to make investments in high-quality companies with sustainable, differentiated business models taking a full-cycle view. Given that approach, we'd expect the fund to show its full strength when returns of individual stocks start to materially differ due to less overall market support. The fund's positions tend to be less driven by assumptions on general market trends, but much more by company-specific qualities that are likely to endure in both positive and negative environments. Driven by expected business resilience and comparably moderate valuations, our key convictions can give some comfort in volatile times.

Top 10 largest positions

We believe a robust, fundamental stock-picking approach that fully integrates a variety of material ESG information into the process helps to uncover underappreciated, long-term opportunities in the market. The research process leads to a diversified but highly focused portfolio consisting of shares of sustainable companies with attractive return potential over the full cycle. The top ten positions are composed of our highest conviction ideas.

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, ESG and environmental footprint targets, and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. In addition, a negative screen is used to exclude the 20% worst ESG scoring stocks from the investable universe. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. The fund also targets a better ESG score and at least 20% lower carbon footprint compared to the reference index. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy. For more information please visit the sustainability-related disclosures. Sustainalytics ESG Risk Rating

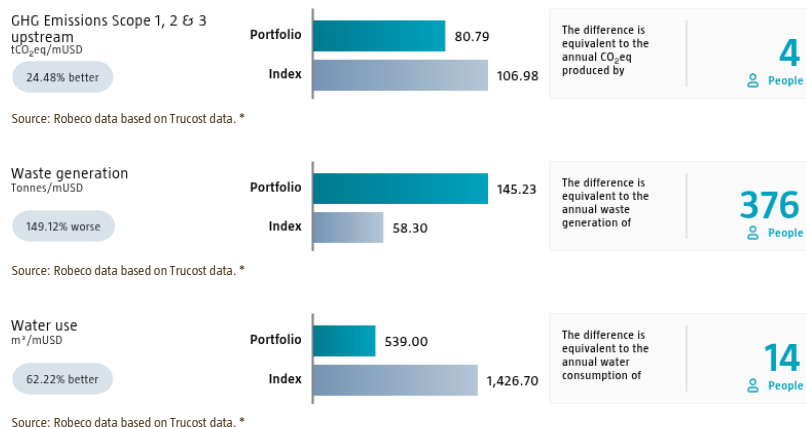

Environmental Footprint

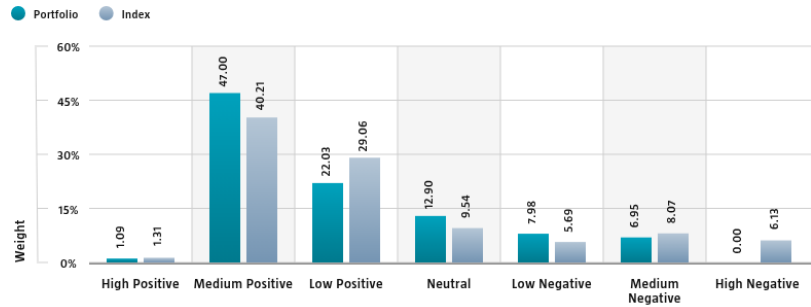

Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

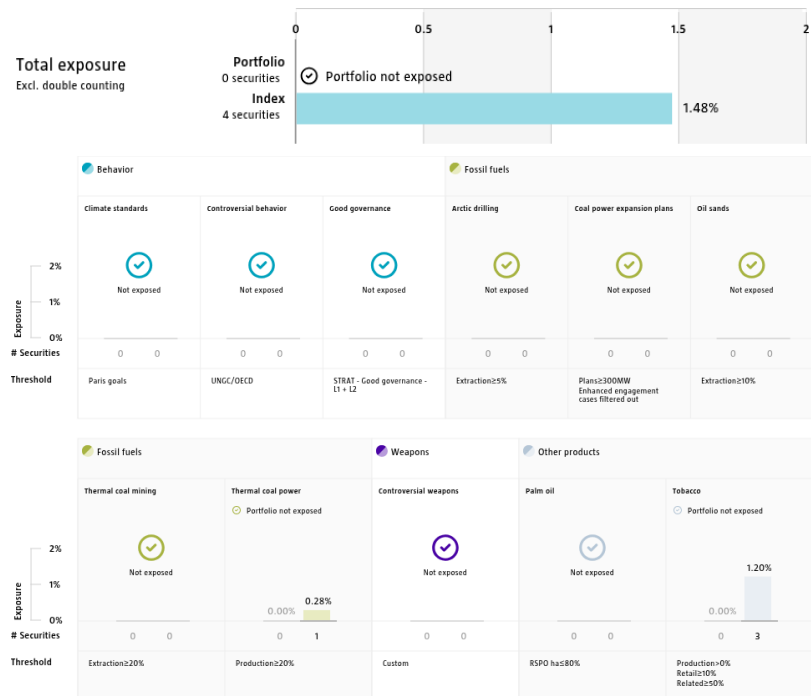
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
