An in-house Sustainability Investing (SI) research team integrates financially-material sector and company-specific sustainability analysis into investment cases.

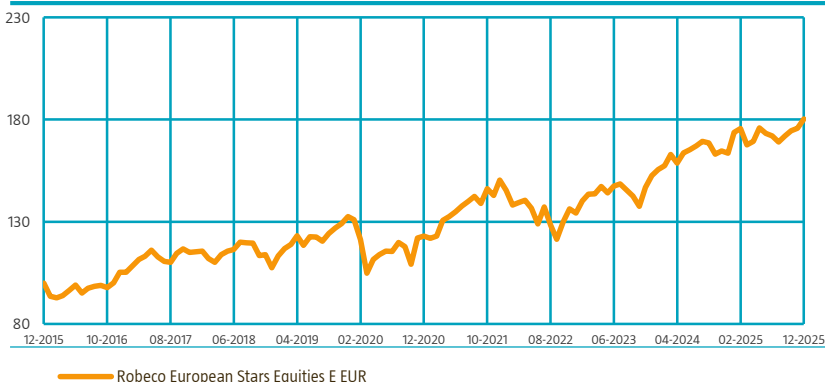

Performance

Based on transaction prices, the fund's return was 2.61%.

In December, the fund was up 2.75% versus the MSCI Europe's +2.67%. During the month, positive stock selection was offset by negative allocation. Stock selection was most positive in materials and consumer discretionary, and most negative in financials and communications services. In materials, our positions in Antofagasta (up +16.8% in absolute terms) and Rio Tinto (+10.8%) performed well. In consumer discretionary, our position in Inditex gained +16.7% and was the biggest positive contributor to relative returns in December. The strongest headwind came from our holding in Deutsche Boerse. The shares failed to keep up with strong absolute performance in financials, which was the best-performing sector in December (+6.5% in EUR, total return). In communication services, fears of AI disruption in the real estate classifieds market continued to weigh on shares of Scout24. However, there are currently no signs of a slowdown in business momentum, and management makes the case for a strong moat due to proprietary data and value-adding services.

Market development

Global equity markets extended their upward momentum in December, with the MSCI AC World Index gaining 0.7% in local currency terms. US equities modestly underperformed, as the S&P 500 declined 0.2%, while Europe staged a strong year-end rally. The MXEU Index rose 2.7% in local currencies, bringing its year-to-date performance to just over 20% – its strongest annual return since 2021. European equities were supported by a combination of declining interest rates, Germany's commitment to fiscal expansion, stabilizing bond yields, and growing optimism surrounding the 2026 outlook. In terms of sectors, the December rally was led by cyclicals, with financials (+6.5%) and materials (+3.9%) posting the strongest gains. Defensive sectors – particularly consumer staples – lagged amid the risk-on environment, while easing geopolitical tensions, including developments around potential Ukraine-Russia peace talks, helped reduce risk premiums in the energy sector.

Expectation of fund manager

The fund's strategy aims to make investments in high-quality companies with sustainable, differentiated business models taking a full-cycle view. Given that approach, we'd expect the fund to show its full strength when returns of individual stocks start to materially differ due to less overall market support. The fund's positions tend to be less driven by assumptions on general market trends, but much more by company-specific qualities that are likely to endure in both positive and negative environments. Driven by expected business resilience and comparably moderate valuations, our key convictions can give some comfort in volatile times.

Top 10 largest positions

We believe a robust, fundamental stock-picking approach that fully integrates a variety of material ESG information into the process helps to uncover underappreciated, long-term opportunities in the market. The research process leads to a diversified but highly focused portfolio consisting of shares of sustainable companies with attractive return potential over the full cycle. The top ten positions are composed of our highest conviction ideas.

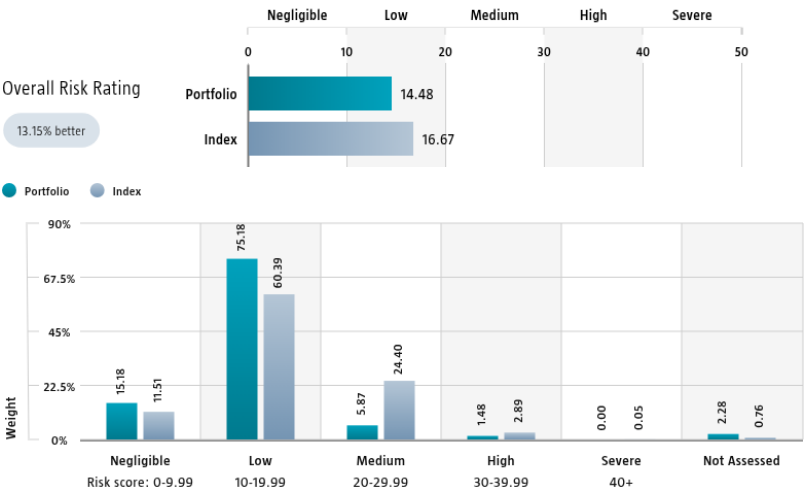

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, ESG and environmental footprint targets, and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. In addition, a negative screen is used to exclude the 20% worst ESG scoring stocks from the investable universe. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. The fund also targets a better ESG score and at least 20% lower carbon, water and waste footprints compared to the reference index. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

Sustainalytics ESG Risk Rating

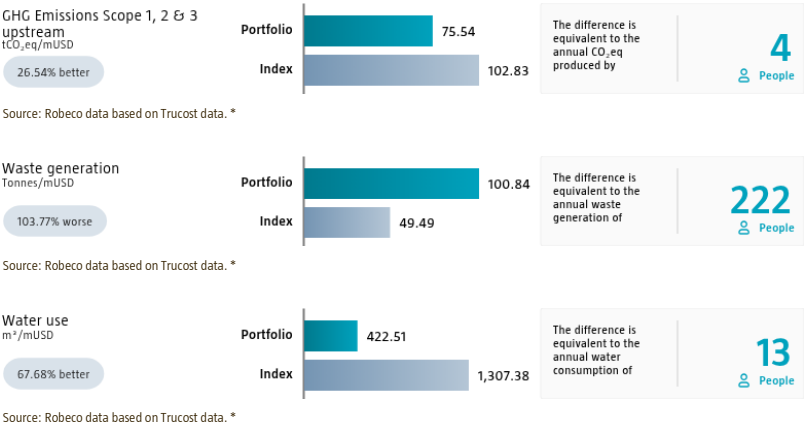
The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. Environmental Footprint

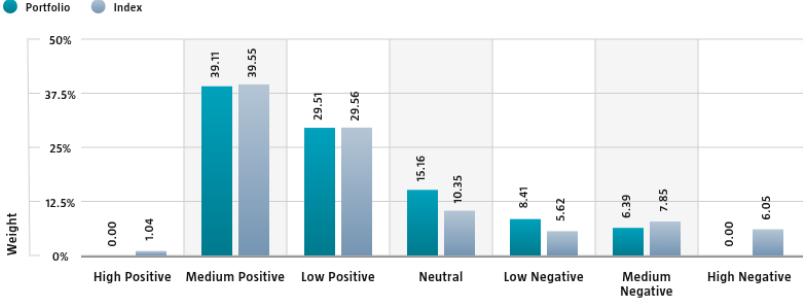

Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

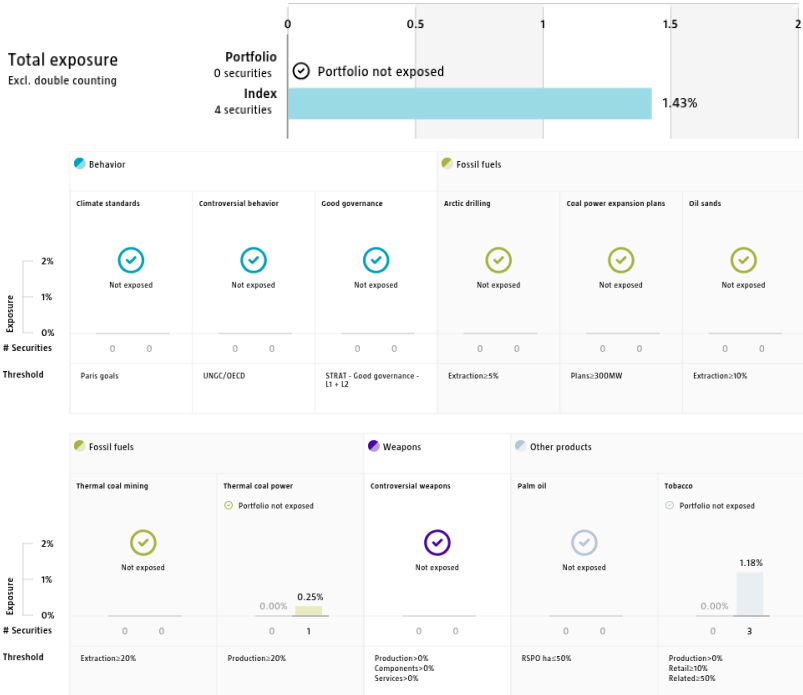
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund aims for a better sustainability profile compared to the Benchmark by promoting certain E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation and integrating ESG and sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, proxy voting, negative screening and aims for an improved environmental footprint.
