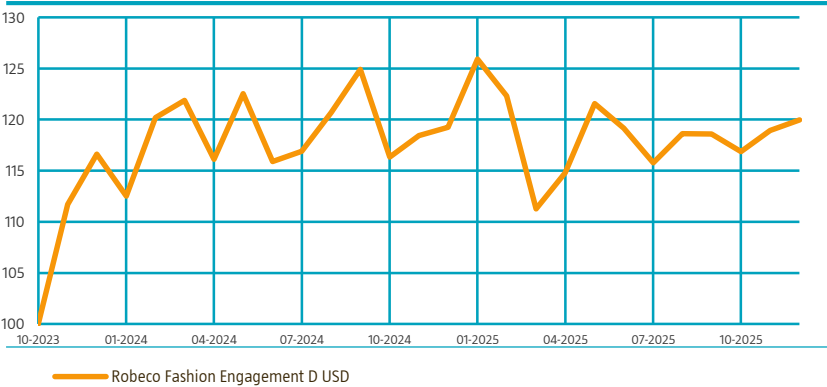

Performance

Based on transaction prices, the fund's return was 0.86%. The Fashion Engagement Fund underperformed versus the MSCI AC World Index, but outperformed its internal benchmark. Premiumization was the strongest cluster, driven by LVMH (+25%), Galderma (+18%), and Richemont (+14%), though Birkenstock, Kering, and Prada lagged. Casualization & Value (+4.1%) also rebounded, with strong gains from Inditex (+22%), Ross Stores (+19%), On Holdings (+10%), and TJX (+7%), while Proya, Bosideng, Levi's, and Nike disappointed. Automation & Digitalization declined sharply, with Shopify the only positive contributor. Weak performers included Zebra Technologies (-18%), Eclat Textile (-15%), MercadoLibre (-14%), and Cosmecca (-11%). Sustainability & Circularity (-5.4%) also struggled, with only Novonesis and Bureau Veritas posting gains, while Winmark and Cintas dragged performance.

Market development

The last quarter of 2025 in the fashion industry was marked by persistent uncertainty and cautious spending, as brands continued to grapple with inflationary pressures, inventory challenges, executive shake ups, and a rotation toward experiences over physical goods. While luxury outperformed mid-market players, even premium labels faced growth slowdowns, marking a tough year-end for the fashion industry.

Expectation of fund manager

The fashion industry is expected to navigate a complex environment marked by shifting consumer behaviors, evolving economic conditions, and accelerating technological change. Growth prospects remain uneven across regions, with mature markets facing slower demand while emerging economies offer pockets of opportunity. Consumer sentiment is likely to be influenced by macroeconomic uncertainty, requiring brands to balance affordability with aspirational value. Digital innovation will continue to reshape the industry, with advancements in AI, automation, and data-driven personalization becoming central to operational efficiency and customer engagement. Sustainability remains a critical priority, driven by regulatory pressures and heightened consumer awareness, prompting companies to invest in traceable supply chains. Overall, the industry outlook suggests cautious optimism: while challenges persist, opportunities exist for agile businesses that embrace innovation and align with evolving consumer values.

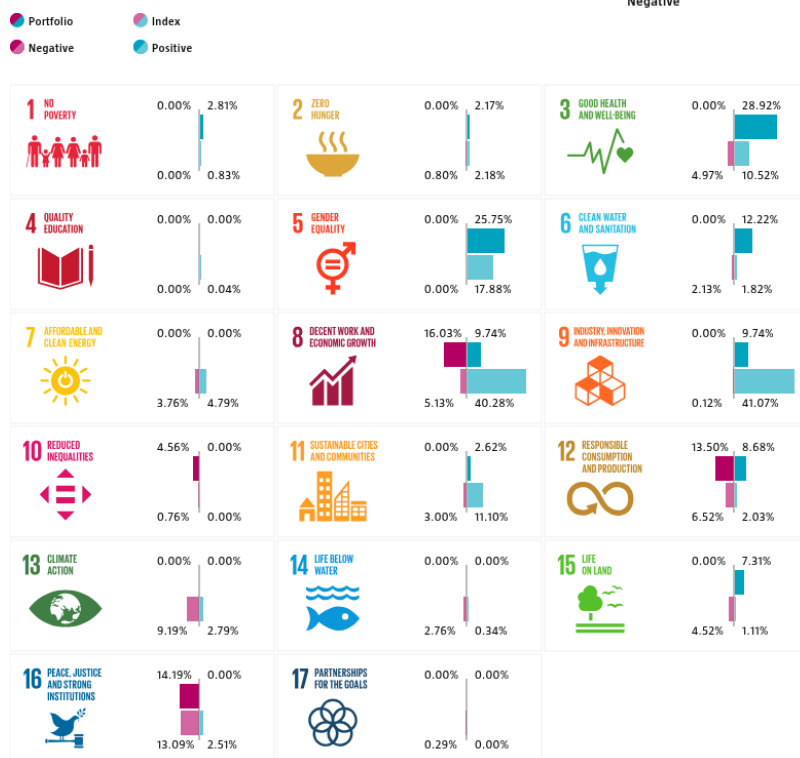
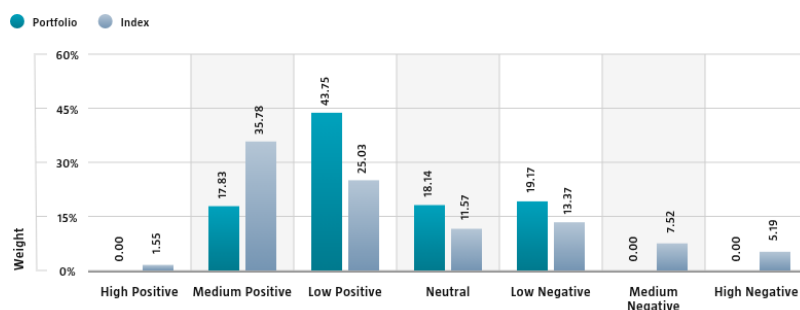
Sustainability

The Fund's sustainable investment objective is to promote structural changes in the fashion industry by engaging with companies on the industry's sustainability challenges. The companies are selected by showing potential and intention to address the industry's sustainability challenges and driving systemic change for the fashion industry. The fund actively engages with at least 80% of the corporate holdings typically for a period of three to five years. The fund does not invest in stock issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

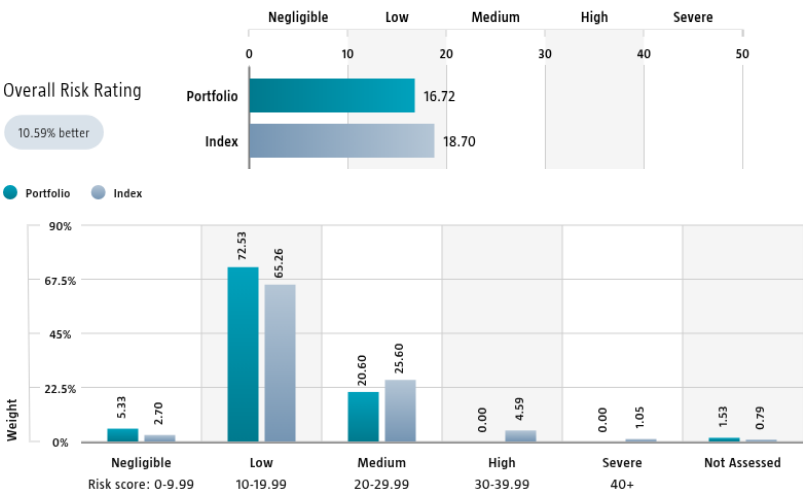

Sustainalytics ESG Risk Rating

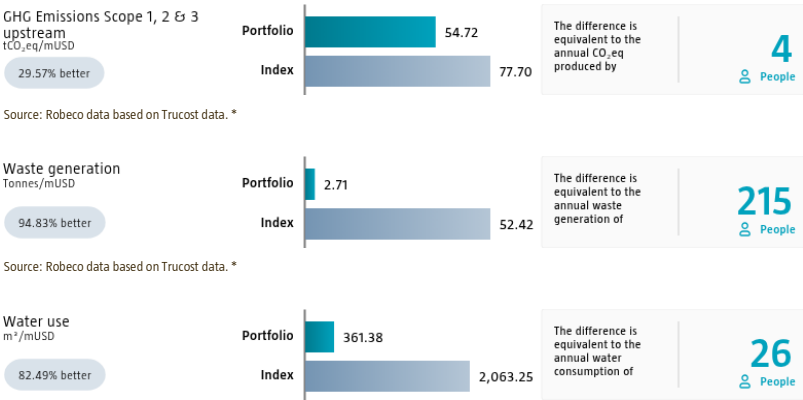

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

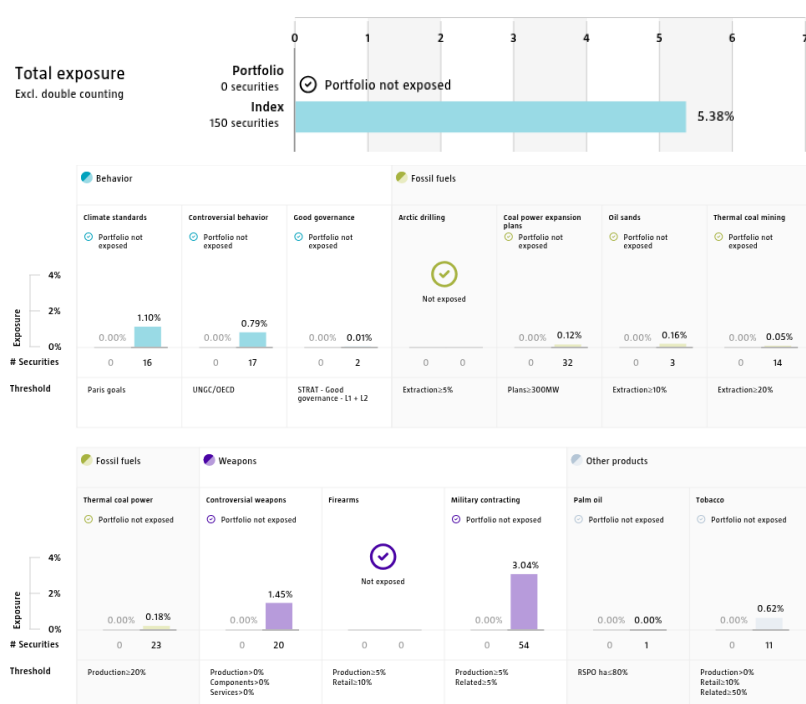
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
