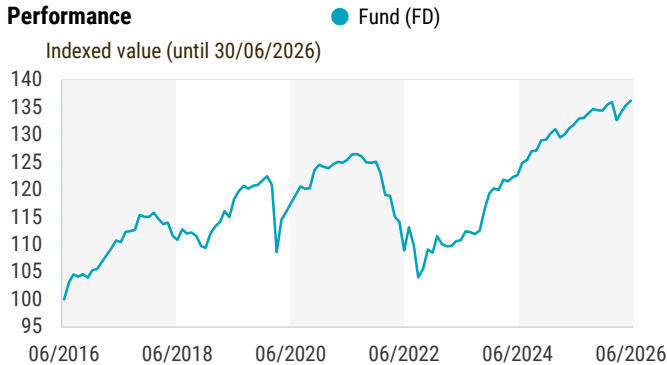

About the fund

Robeco Financial Institutions Bonds is an actively managed fund that mainly invests in subordinated debt issued by banks and insurance companies, primarily from Europe. The fund has a strong focus on Tier 2 debt, while having some flexibility to invest off-Benchmark in Contingent Convertible Bonds (also "coco" bonds), senior bonds and non-Euro denominated debt. The selection of these bonds is based on fundamental analysis. Performance drivers are the top-down beta positioning as well as bottom-up issuer selection. The fund's objective is to provide long-term capital growth.

Performance commentary

Based on transaction prices, the fund's return was 0.58%.

The fund generated a positive total return in June. Government bond yields ended the month largely lower, while credit spreads moved tighter. Spread performance was a positive 20 basis points, reflecting a tightening of average index spreads to 115 basis points, down from 116 basis points the previous month. The portfolio outperformed the index by 11 basis points. The portfolio was overweight in beta during the period, resulting in a positive contribution from market beta. Issuer selection contributed positively to performance. Key positive contributors included overweight positions in Deutsche Bank, mBank, Sampo and KBC Group. Negative contributions came from Banamex, Rabobank and Lloyds.

Market development

Credit spreads were fairly stable in June, though the second half of the month was a bit weaker than the first half. Throughout the month, oil prices trended lower as the US and Iran agreed on a memorandum of understanding and oil exports began to recover through the Strait of Hormuz. In the US, monthly labor market data showed a strong uptick in hiring, suggesting that the recent trend of labor market softening may be reversing. Credit markets were hardly impacted by the end-of-month weakness in technology shares. Government bond returns were positive in June. 10-year US Treasury yields rose 3 basis points to 4.47%. The US yield curve flattened significantly, as 2-year US Treasury yields increased by 17 basis points, while the 30-year US Treasury yield declined by 2 basis points. German Bund yields declined 8 basis points to 2.86%, and the curve also flattened, albeit to a lesser extent. A number of new deals was announced, including Tier 2's of names such as Nordea, KBC, Mapfre, BCP and PKO. In the Tier-1 market, names such as Crédit Agricole Assurances, Erste Bank and BNP Cardiff issued new CoCos. We participated selectively in some of these deals.

Expectation of fund manager

Credit spreads have reached cycle lows. At the same time, the financial sector is fundamentally doing well. Balance sheets look robust after years of deleveraging. Profitability has benefited from higher interest rates, strong cost control and healthy growth in fee income. Going forward, we expect profitability to plateau at a higher level than observed in the period between the great financial crisis and the Covid-19 crisis, as we do not expect central banks to move back to periods of zero interest rates, while at the same time banks have made strong progress in terms of improving their underlying profitability. A such, the resilience of banks to external shocks has greatly improved. Appetite for bonds with higher yields remains strong, as investors like to lock in attractive yield levels. We are becoming more selective in participating in new bond issues, as spreads have tightened. We target a neutral beta positioning in the fund, as despite strong fundamentals, we believe valuations are getting somewhat demanding. At the same time, we believe we can continue to add performance with our credit selection in primary and secondary markets.

Top 10 largest holdings

The fund has a benchmark that caps benchmark weights at 2%. Holdings typically consist of exposures to large and strong banks and insurance companies.

Sector allocation

The fund only invests in financials – excess cash may be invested in (German) government bonds. Government-owned banks like Belfius Bank, Permanent TSB and Bayerische Landesbank are classified under Agencies and Local Authorities. The exposure to industrials relates to Tier-2 bonds issued by Renault Bank.

Country / Region allocation

Country allocation is to a large extent bottom-up driven. We are underweight in France, as spreads are tight. The largest overweight can be found in Spanish banks.

Currency denomination allocation

The fund is allowed to invest in currencies other than euros. Approximately 9% of the fund is invested in bonds issued in pound sterling and US dollar. All foreign currency exposures are hedged.

Duration allocation

The fund mostly runs an interest rate position that is neutral versus the benchmark, but deviations from this neutral position are possible.

Rating allocation

The fund does not follow an active rating strategy – the current rating allocation is a result of bottom-up bond selection. The fund is allowed to invest in high yield to a maximum of 20%; the current exposure is circa 15%.

Subordination allocation

The largest part of the portfolio is invested in Tier-2 debt. About 80% of these bonds are issued by banks, while the remainder is issued by insurance companies. The categories hybrid and subordinated mostly contain subordinated debt issued by insurance companies. The exposure under Tier 1 primarily relates to bank CoCos. The exposure to senior bonds mainly consists of German Bunds, although we also hold senior bank bonds issued by institutions such as mBank and Banca Transilvania.

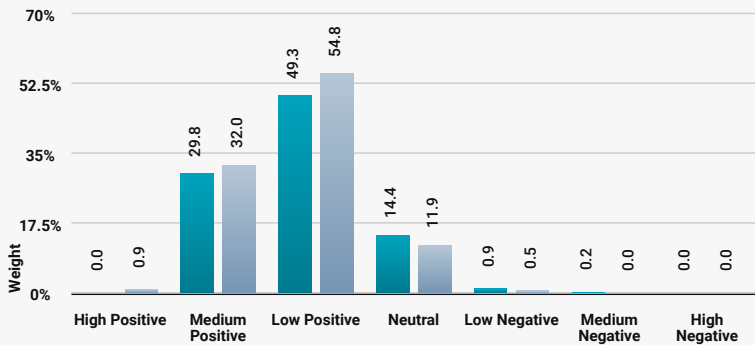

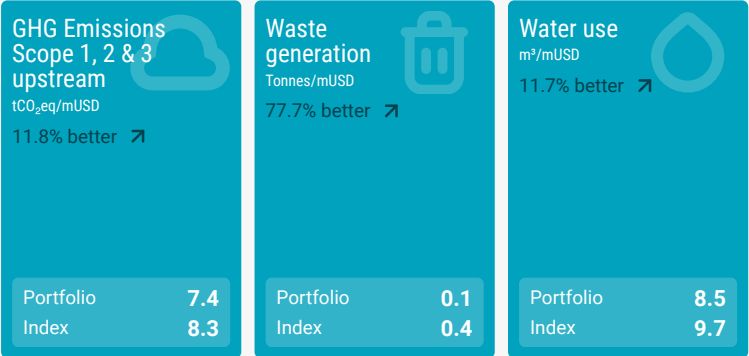
SDG Impact Alignment ¹

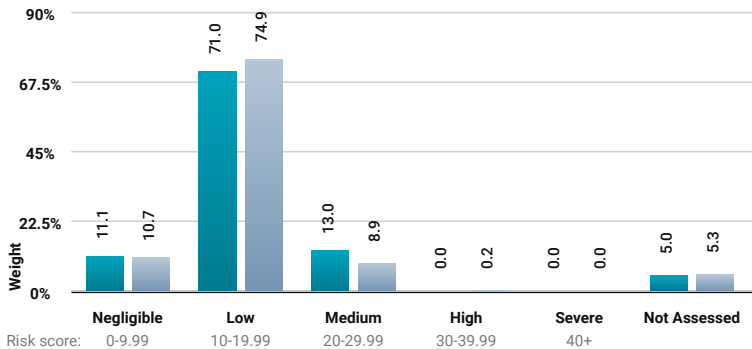

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 3. Sustainalytics ESG Risk Rating

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully embedded in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
