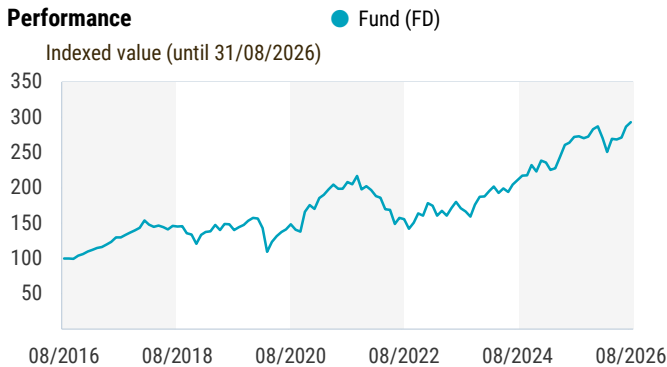

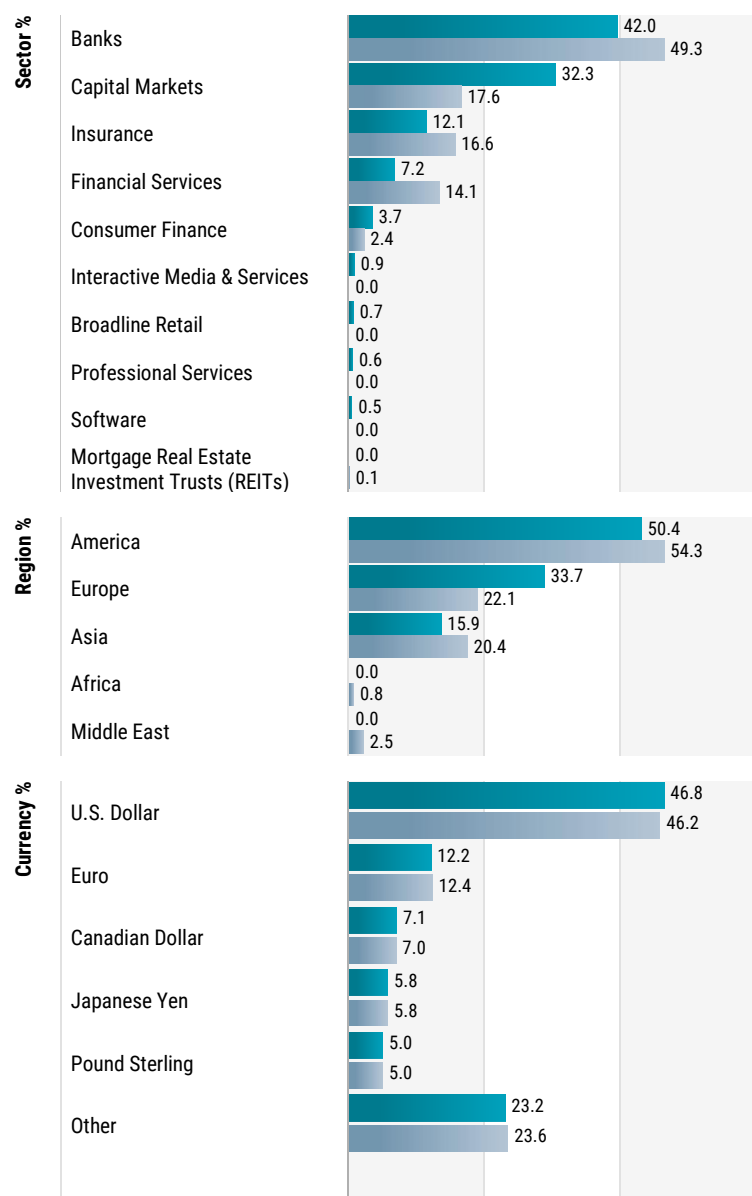

Performance commentary

Based on transaction prices, the fund's return was 2.19%.

Robeco New World Financials outperformed its benchmark in August, supported by positive contributions from both Digital Finance and Aging Finance, while Emerging Finance detracted from returns. Digital Finance was the strongest-performing theme, benefiting from the rebound in digital asset markets and strong performance from holdings such as Coinbase, Robinhood and Adyen. Within Aging Finance, Deutsche Bank, Nomura and Julius Baer contributed positively as investors continued to favor capital markets and wealth management-related businesses. Emerging Finance weighed on performance despite strength in selected holdings such as Vietnam Techcombank and Hana Financial. The main detractors were Itaú Unibanco, Prudential and Klarna, while BNP Paribas also underperformed. At the industry level, capital markets and financial services made the largest positive contributions, whereas banks detracted from performance.

Market development

Global equity markets advanced in August, led by renewed strength in technology and AI-related stocks, while financials slightly lagged after two months of strong outperformance. The dominant market theme was the continued rise in long-term interest rates, driven by resilient economic growth, persistent fiscal deficits and expectations that inflation may remain elevated. This reinforced a supportive environment for banks and other rate-sensitive financial companies. Another important development was the sharp rebound in digital asset markets. Rising cryptocurrency prices, stronger trading activity and increasing regulatory clarity in the United States boosted sentiment toward the sector. Despite some regional volatility related to European fiscal concerns and developments in Asian insurance markets, financial-sector fundamentals remained supported by solid earnings, with investors continuing to reassess the earnings power and valuations of banks, insurers and diversified financial companies.

Expectation of fund manager

The outlook for financials remains constructive, supported by strong earnings momentum, solid capital positions and a favorable interest rate environment. A steepening yield curve, easing regulatory pressures and robust capital markets activity are expected to benefit banks, insurers and diversified financials. The managers continue to see attractive opportunities outside the US, where valuations remain relatively compelling. Within Digital Finance, structural growth drivers such as digital payments, capital markets activity, AI adoption and blockchain technology remain intact. The increasing use of AI agents is expected to create opportunities for digitally native and data-rich financial businesses, while continued innovation in FinTech and digital assets supports a positive long-term outlook.

Top 10 largest holdings

Top overweights in August were Deutsche Bank, Coinbase, Capital One Financial, Ameriprise, and Citigroup.

Sector allocation

The three main trends in the fund are Emerging, Digital and Aging Finance. Emerging Finance is about emerging-market growth, but also includes innovative financials in developed markets. Digital Finance is about the increasing digitization of the sector. Aging Finance is about building up enough savings to enter retirement comfortably. As we look top-down at trends and bottom-up at stock selection, regional or sector spreads are merely the result of the investment process, though we do monitor limits.

Regional allocation

Robeco New World Financials selects the long-term trends that are expected to show the most powerful growth over the long term. Within the trends, the fund managers select the companies that will best capitalize on long-term trend growth. How much we invest depends on the stock valuation, where we look for growth at a reasonable price. As we look top-down at trends and bottom-up at stock selection, regional or sector spreads are merely the result of the investment process, though we do monitor limits.

Currency allocation

The fund takes small active currency positions, but generally hedges back to the benchmark. We do not hedge currency exposures in emerging markets, as this is costly. This leads to a small USD balance.

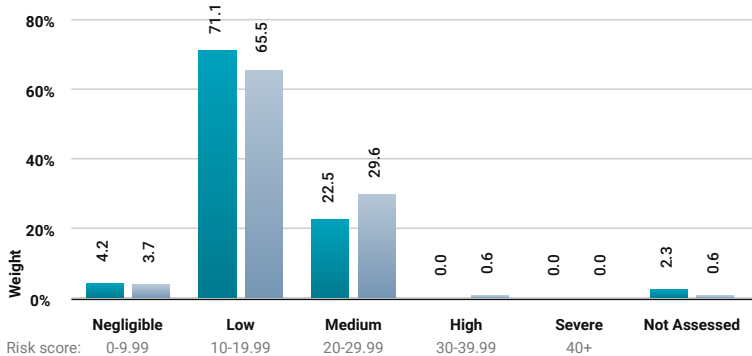

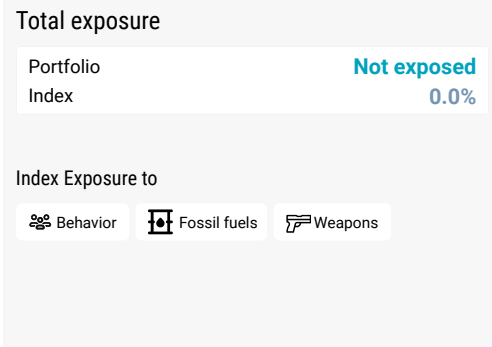

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment
