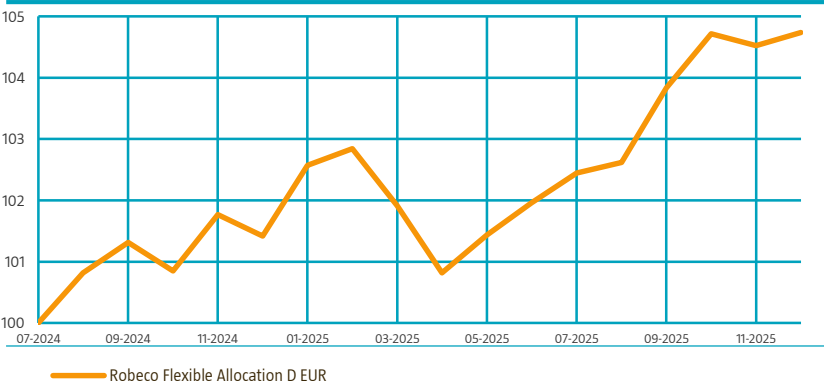

Performance

Based on transaction prices, the fund's return was 0.20%. The Robeco Flexible Allocation Fund delivered a positive return of 0.20% in December. Throughout the month, the fund's equity beta fluctuated between 30% and 34%, with additional equity exposure expressed through call spreads on the S&P 500. These were preferred over outright equity positions because they offer attractive pricing and meaningful upside. Exposure to German 2-year government bonds was increased as a hedge against potential equity market weakness, although the position detracted from performance as yields rose following hawkish comments from the Bundesbank president. We continue to view this position as an effective hedge and believe the ECB remains far from raising rates, leaving room to add opportunistically. In FX, the yen weakened further despite the BoJ's rate hike, as policymakers maintained a cautious tone. We are monitoring for signs to exit if conditions do not improve. AUD exposure was increased on expectations of a stable RBA policy and strong demand for industrial commodities. Gold holdings were maintained, and the USD hedge added value.

Market development

The global economy ended 2025 in a stable but decelerating growth environment. While no broad signs of systemic stress emerged, economic momentum remained uneven across regions, reinforcing a cautious and orderly late-cycle backdrop rather than a shift toward renewed acceleration or outright downturn. Central banks broadly met market expectations in December, anchoring sentiment into year-end. The Federal Reserve delivered a widely anticipated rate cut, the European Central Bank maintained its policy stance, and the Bank of Japan continued gradual normalization. These decisions underscored policy continuity and incremental adjustment rather than abrupt shifts. Market behavior reflected late-cycle dynamics, with narrow and selective leadership prevailing over broad risk-on participation. Selective cyclical performed reasonably, while US technology delivered mixed results. Volatility in longer-dated bond markets persisted but failed to trigger sustained risk-off moves. Equity markets closed the year with mixed outcomes. Across other asset classes, commodities diverged, with subdued energy prices offset by firmer industrial metals, while credit markets remained resilient overall.

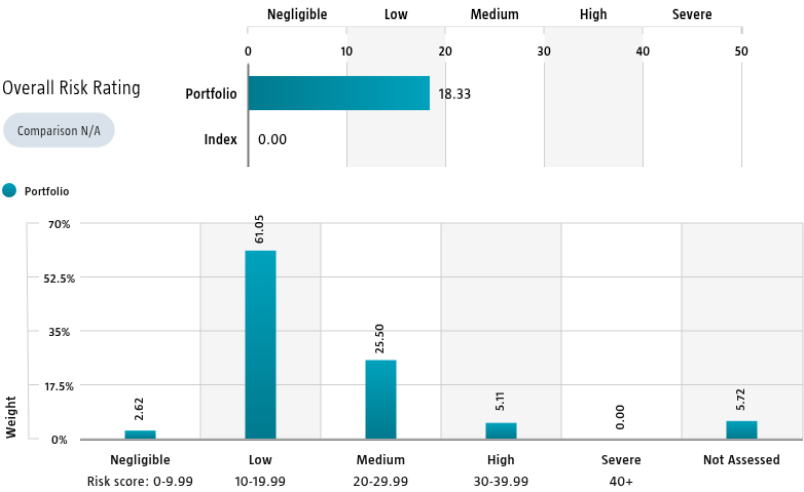

Sustainalytics ESG Risk Rating

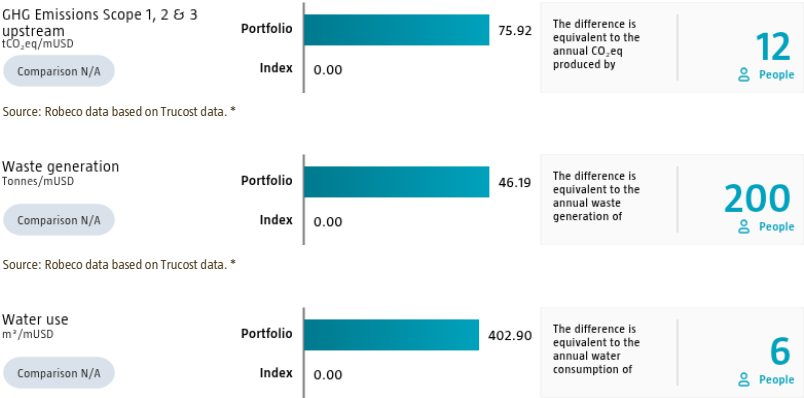

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

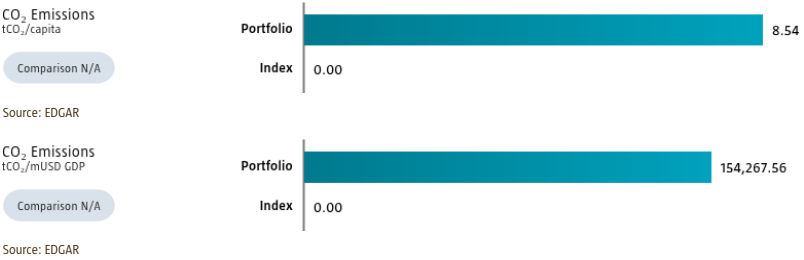

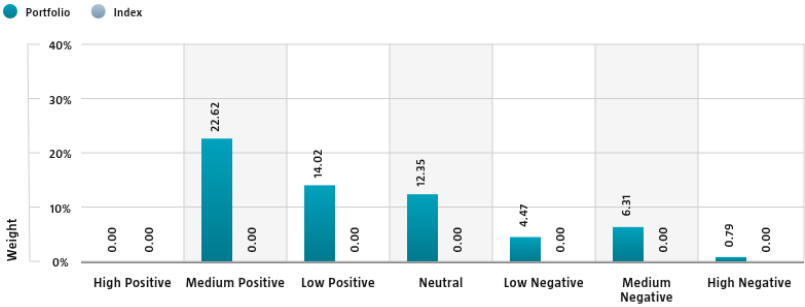
Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio's relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.



SDG Impact Alignment

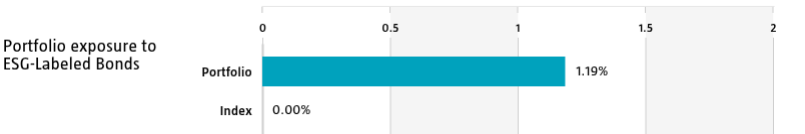
This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco’s SDG Framework. The framework utilizes a three-step approach to assess a company’s impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

ESG Labeled Bonds

The ESG-labeled bond chart displays the portfolio's exposure to ESG-labeled bonds. Specifically, green bonds, social bonds, sustainability bonds, and sustainability-linked bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

Engagement

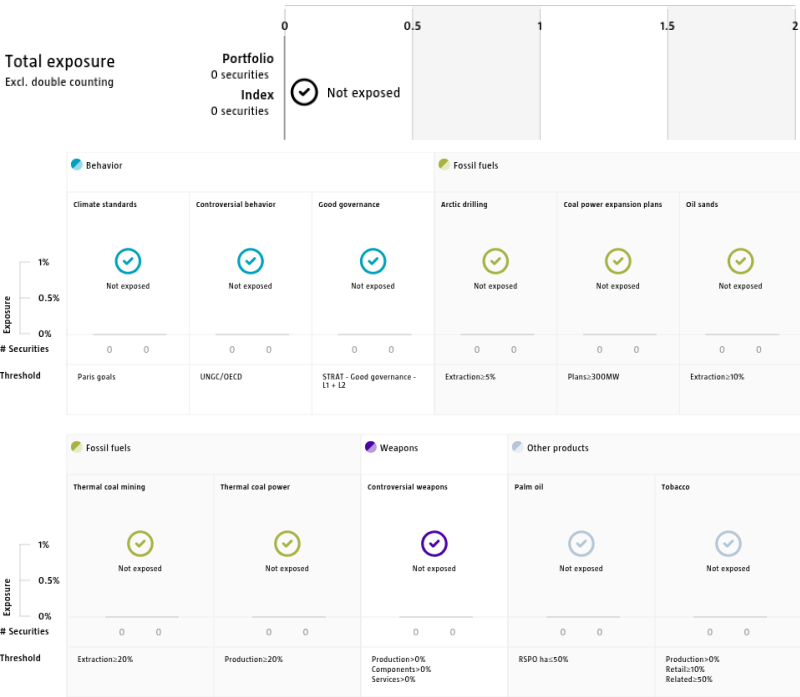
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.

Prior to joining Robeco in 2001, Ernesto worked at ING Barings as a Product controller at the cash equities and derivatives desk for three years. Ernesto started his career in the investment industry in 1998. He holds a Master's in Financial Economics from Erasmus University Rotterdam. Arnout van Rijn is Portfolio Manager and member of the Sustainable Multi Asset team. Previously, Arnout was CIO Asia Pacific, Co-Head of the Asia Pacific team and Lead Portfolio Manager of Robeco Asia Pacific Equities. Before that, he was Lead Portfolio Manager of Rolinco, one of Robeco's flagship global equity products. Before that, Arnout held several positions within the Robeco Equity department, covering European, Asian and American markets. From its inception in 1994 until 2000, he was Portfolio Manager of Robeco's Emerging Markets Equities fund. He started his career in the investment industry in 1990. Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
