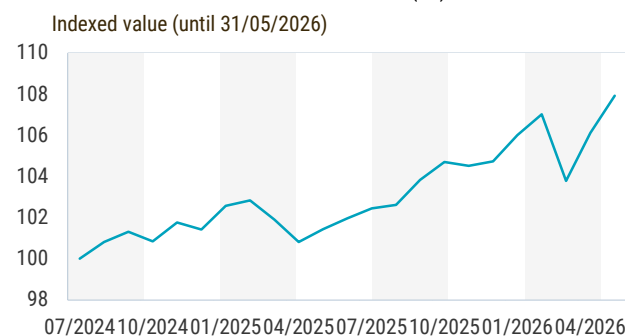

Performance commentary

Based on transaction prices, the fund's return was 1.70%.

It was another strong month for the Robeco Flexible Allocation Fund, which rose 1.8%. Performance was primarily driven by equity allocations. Despite unresolved tensions in the Middle East, equity markets remained constructive, supported by corporate earnings, particularly from companies linked to AI developments. Equities absorbed higher oil prices with limited disruption, while government bonds followed a more volatile path, with yields rising early in the month before stabilizing toward the end. The fund entered the month with an equity beta of around 29%, which was gradually increased to 36%. In fixed income, we added protection via CDX, which we view as a cheap tail risk hedge given its asymmetric risk reward versus equities. Positions in short-dated German and UK bonds contributed positively, as did a cross-regional trade in long UK 10-year versus short US 10-year rates, alongside emerging market local debt. Currency positioning detracted slightly, as gains from our long Norwegian krone were offset by losses on long Japanese yen and short Swiss franc positions.

Market development

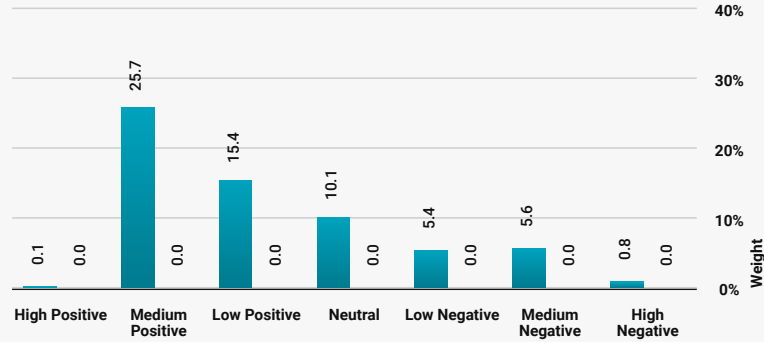
May 2026 was characterized by a striking disconnect: equity markets extending gains and credit spreads holding tight, even as oil prices swung violently and geopolitical risk remained elevated. US growth remained resilient, supported by firm labor markets and solid earnings, while the Eurozone softened. The escalating situation involving Iran and disruptions to the Strait of Hormuz drove significant oil price volatility, with bond markets proving more sensitive to the inflation implications than equities. The confirmation of Kevin Warsh as Federal Reserve Chair added a notable dynamic, with markets forming a view on whether the Fed's reaction function will change under his leadership. Both developed and emerging markets pushed ahead, powered by AI and semiconductor momentum, with the AI footprint increasingly visible across emerging markets. Overall, May served as a reminder that resilient growth and rising uncertainty can coexist, and that the distance between the two may be shorter than markets appear to believe.

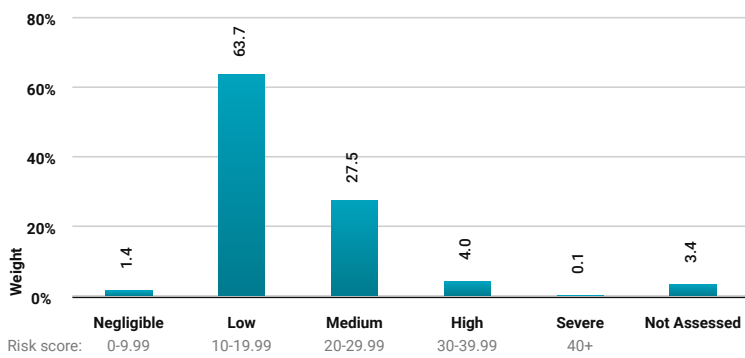

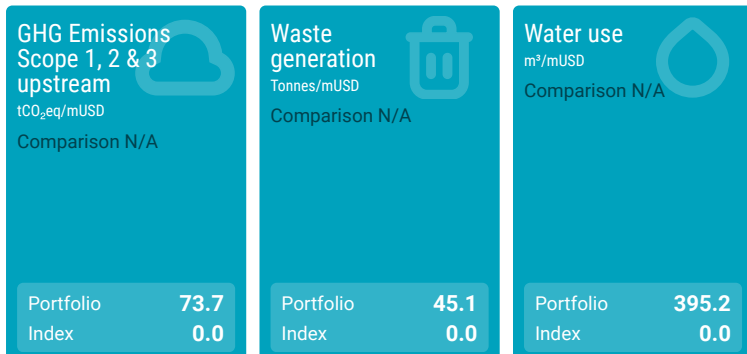

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels.

3. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

4. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

5. Exclusions

6. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

7. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully embedded in the investment process to ensure that the fund's positions remain within set limits at all times.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
