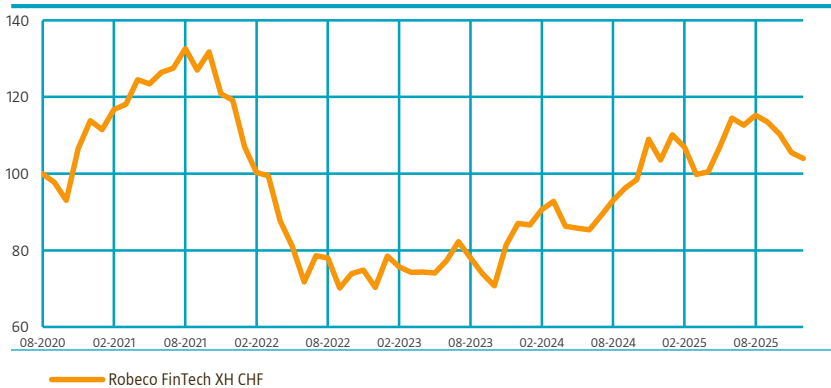

Performance

Based on transaction prices, the fund's return was -1.41%.

The fund underperformed versus the MSCI AC World Index in December. Data & Analytics (14%) was the only positive cluster, while Digital Assets (10%), Financial Management (25%), Payments (32%) and Financial Infrastructure (19%) all detracted from returns. Top performers were Capital One Financial, Charles Schwab, Intuit, S&P Global and EPAM. Major laggards included Coinbase, BitMine and XP. From an industry view, IT Services and consumer finance contributed positively, whereas capital markets, banks and software were the weakest contributors.

Market development

Stock markets had a muted December and within the FinTech universe, Digital Asset companies continued to correct, with Coinbase down 17% despite the SEC approving tokenization of equities, ETFs, and US Treasuries beginning in 2026. The US consumer appears resilient, whether it's in terms of payment volumes, loan growth, or delinquency rates. As a result, consumer finance stocks such as Capital One reached record highs, rising 11% in December. Although semiconductors drove markets to new highs in 2025, FinTech lagged despite strong revenue and earnings growth. Meanwhile, US consumer resilience supported strong performance in consumer finance names such as Capital One (+11%).

Expectation of fund manager

We enter 2026 with strong long-term momentum driven by three major forces: a resurgence in capital markets activity, rapid progress in agentic commerce, and accelerating tokenization across financial services. Our strategy continues to target 10–15% EPS growth supported by scalable digital business models. Capital markets activity is rebounding to 2021 levels, with a growing pipeline of IPOs, M&A, and strong private market valuations, suggesting a supportive environment for listed FinTech firms. Meanwhile, agentic commerce presents a multi-year opportunity as networks such as Visa and Mastercard and platforms such as Shopify and MercadoLibre integrate automated, AI-driven transactions. Digital Assets are approaching a major tipping point. Tokenized financial assets could expand from USD 600 billion today to nearly USD 19 trillion by 2033, supported by regulatory clarity and stablecoin adoption exceeding USD 300 billion. Overall, our structural growth drivers remain firmly in place for 2026.

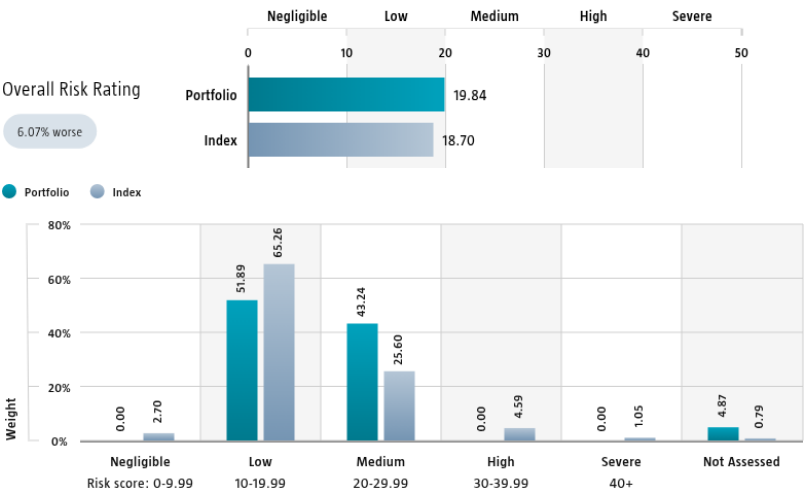

Sustainability

The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

Sustainalytics ESG Risk Rating

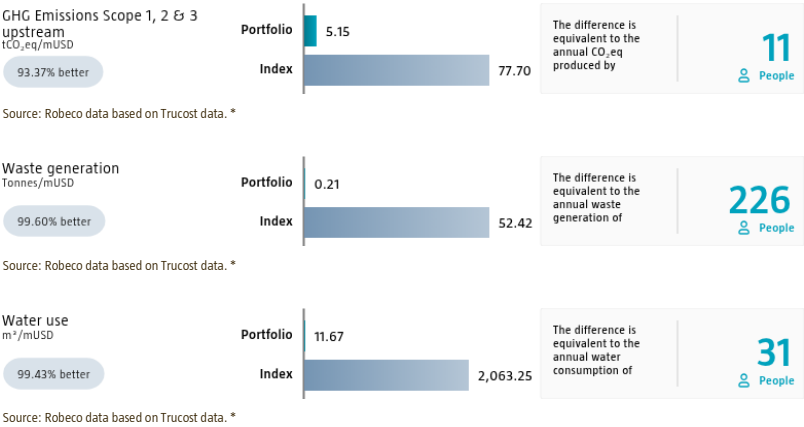

Environmental Footprint

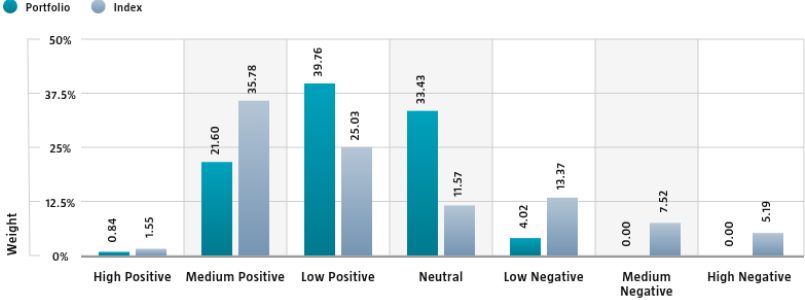

Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company’s SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Michiel van Voorst is Portfolio Manager and member of the Thematic Investing team. He has a focus on financials/fintech. In 2020, Michiel rejoined Robeco from Union Bancaire Privée in Hong Kong where he was CIO Asian Equities. Prior to that, Michiel spent 12 years at Robeco in several senior positions including portfolio manager Rolinco Global Growth fund and Robeco Asian Stars. Prior to joining Robeco in 2005, Michiel was Portfolio Manager US Equity at PGGM and Economist with Rabobank Netherlands. Michiel started his career in the investment industry in 1996. Michiel van Voorst holds a Master's in Economics from University of Utrecht and is a CFA® Charterholder. Koos Burema is Co-Portfolio Manager and member of the Thematic Investing team. He has a focus on financials/fintech. Koos was an Analyst with the Emerging Markets team covering Korea and technology in Taiwan and Mainland China. Besides this, he was responsible for the integration of ESG in the investment process. Before joining the team in January 2010, he worked as a Portfolio Manager for different sector teams within Robeco. He started his career in the industry in 2007. Koos holds a Master's in Business Administration from the University of Groningen and is a CFA® charterholder.

Fiscal product treatment

The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes.
