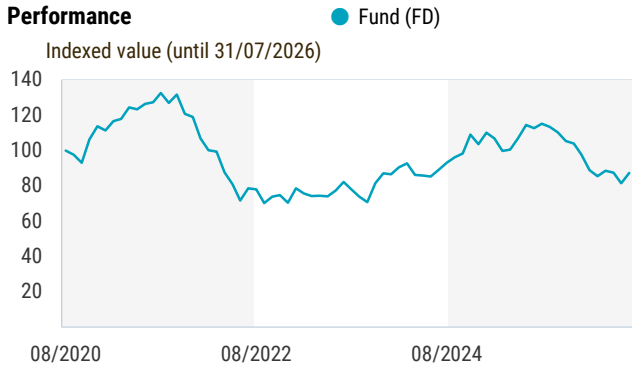

These are individually assessed on the basis of industry trend analysis, in-depth discussions with corporate management, analysts and industry experts. The fund's objective is to achieve a better return than the broad equity index.

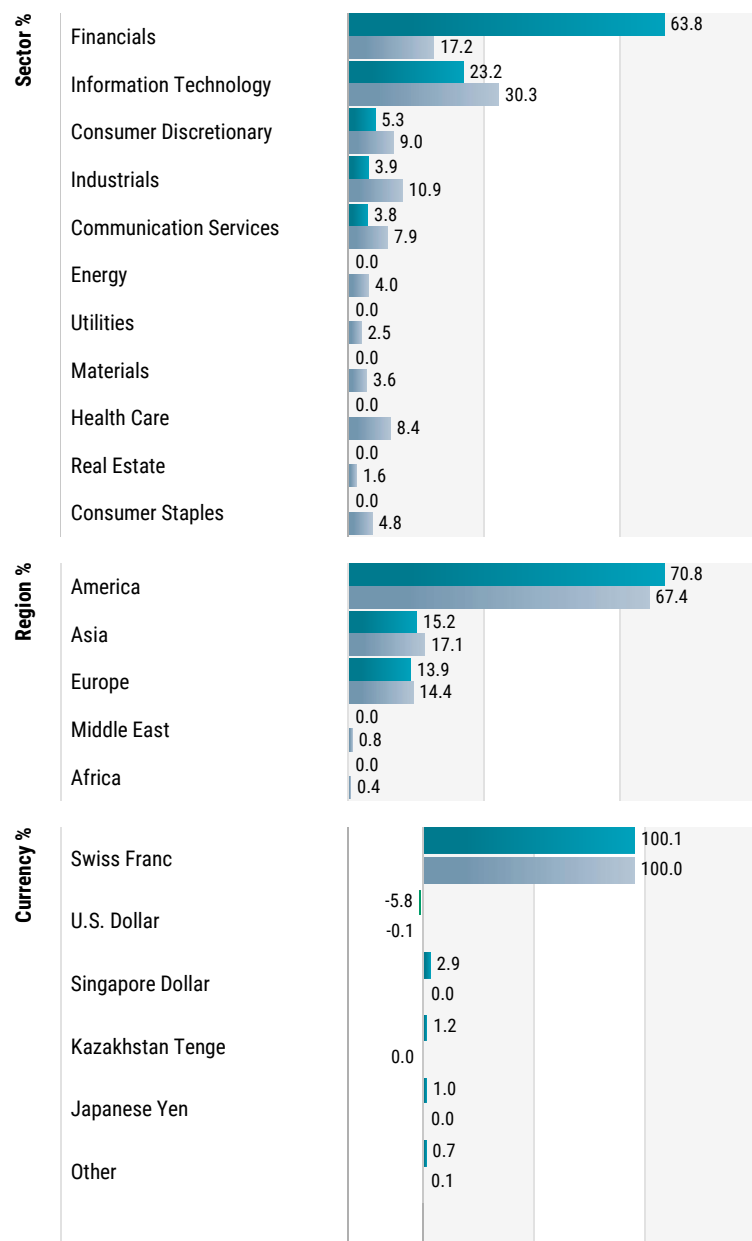

Performance commentary

Based on transaction prices, the fund's return was 7.10%.

The fund strongly outperformed the reference index, the MSCI AC World, during July. Performance was broad, with all segments of the FinTech investment universe contributing positively to returns. Financial Infrastructure was the largest contributor, followed by Payments, Financial Management, Data & Analytics and Digital Assets. At the stock level, BitMine, Intercontinental Exchange, Guidewire, SS&C, Cognizant, Q2 Holdings, Intuit and Qualys were among the strongest contributors. In contrast, Figure, Affirm, Robinhood Markets and Klarna detracted from performance. From an industry perspective, software, capital markets, IT services and professional services contributed most positively to returns. Financial services was the only area to detract from performance during the month.

Market development

Global equity markets were broadly unchanged in July, with investor sentiment affected by higher interest rate concerns, the fragile US-Iran ceasefire and doubts over the durability of parts of the AI theme. Market leadership broadened during the month, while semiconductor stocks experienced a sharp correction following exceptionally strong performance in the first half of the year. Within the FinTech segment, earnings results generally remained supportive. Payment companies reported resilient consumer spending trends and improving credit quality, while financial infrastructure software companies benefited from earnings upgrades and constructive commentary around AI monetization. Strategic activity across the sector also remained elevated, highlighted by continued merger and acquisition activity in financial markets infrastructure. Despite market volatility, underlying business fundamentals across many areas of the FinTech universe remained resilient.

Expectation of fund manager

The Robeco FinTech strategy invests in a universe composed of five segments: Payments, Financial Infrastructure, Financial Management, Data & Analytics and Digital Assets. This makes for a diverse portfolio benefiting from the ongoing digitization and tokenization of the financial sector. From the launch of the FinTech strategy, we targeted a portfolio with an average of 10-15% EPS CAGR, driven by strong topline growth in combination with operational leverage as business models scaled to full potential. We have seen plenty of changes in underlying FinTech trends, but the long-term growth profile of our strategy is still firmly intact. By focusing on key trends such as capital markets resurgence, agentic commerce and tokenization, we can identify and capitalize on the most promising opportunities within the FinTech landscape.

Top 10 largest holdings

The five largest positions in the fund are Block, Tencent, Coinbase, MSCI and BitMine.

Sector allocation

The fund does not have a sector allocation policy. The fund invests in companies that benefit from the digitization of the financial sector, and focuses on the FinTech long-term growth investment universe. It invests in five distinct segments, labelled as Payments, Financial Infrastructure, Data & Analytics, Financial Management and Digital Assets.

Regional allocation

The fund currently has over 60% of its investments in the US, which is the dominant country for listed FinTech equity investments, but we expect China, India and other emerging markets next to Europe to gain importance.

Currency allocation

The fund has no active currency positions.

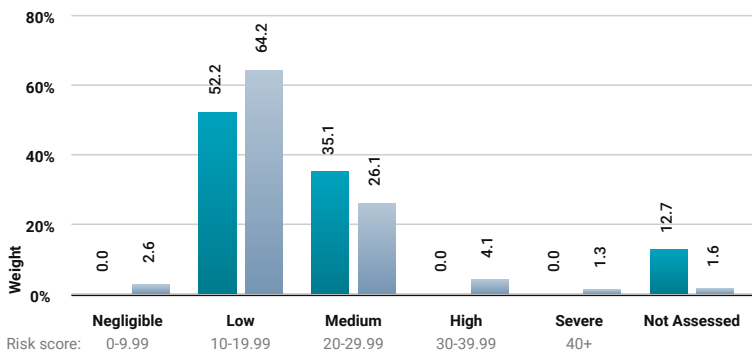

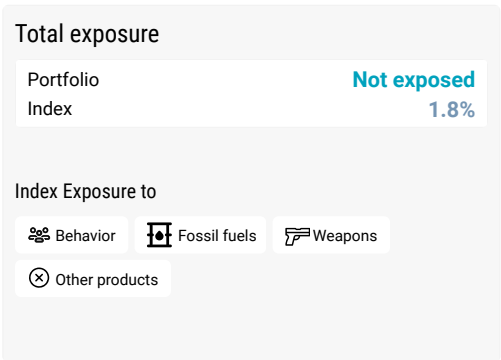

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
