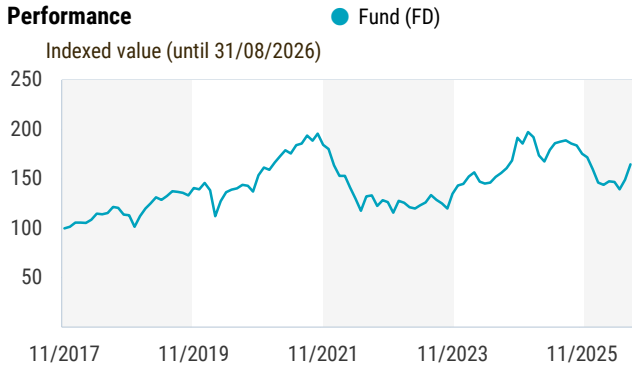

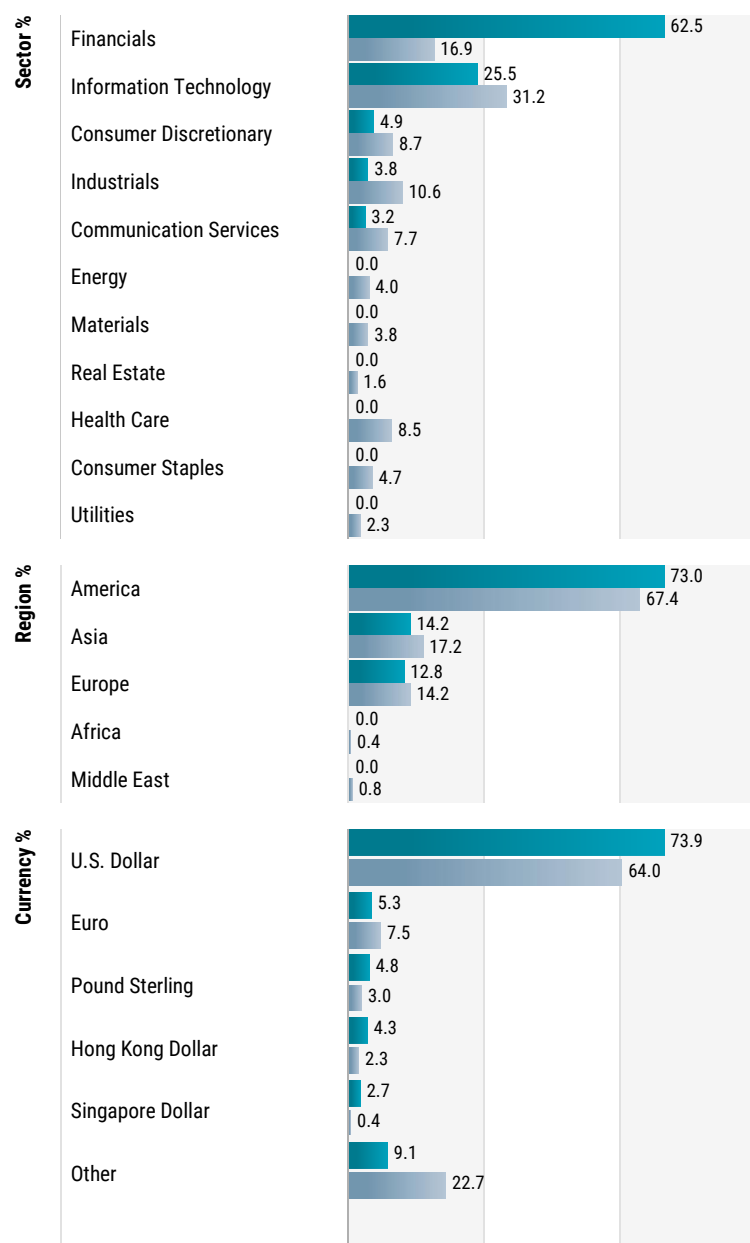

Performance commentary

Based on transaction prices, the fund's return was 10.47%.

The fund significantly outperformed the MSCI AC World Index in August, with all five FinTech clusters contributing positively to returns. Digital Assets was the largest contributor, followed by Financial Infrastructure, Payments, Data & Analytics and Financial Management. The strongest contributors were BitMine, Circle, Guidewire, Coinbase, Figure, Bullish, Shopify and Adyen. Detractors were limited, with Klarna, Tencent and Bajaj Finance weighing most on performance. At the industry level, Software, Capital Markets, Consumer Finance and IT Services made the largest positive contributions, supported by strong earnings and improving investor sentiment. Interactive Media & Services contributed positively as well, although to a lesser extent than the other sectors.

Market development

Global equity markets advanced in August, supported by renewed strength in technology stocks, particularly software companies. Financial markets continued to focus on higher long-term interest rates, reflecting resilient economic growth expectations and ongoing fiscal spending. Against this backdrop, financial technology and digital asset-related companies performed strongly as investor sentiment toward the sector improved. Cryptocurrency markets rebounded sharply amid increasing regulatory clarity in the United States and a recovery in trading activity, benefiting broader digital asset ecosystems. Meanwhile, payment and FinTech companies continued to report healthy transaction volumes and stable credit conditions, supported by resilient consumer spending. Software firms also regained momentum as investors reassessed the long-term impact of artificial intelligence, favoring companies with mission-critical platforms, proprietary data and resilient business models.

Expectation of fund manager

The Robeco FinTech strategy invests in a universe composed of five segments: Payments, Financial Infrastructure, Financial Management, Data & Analytics and Digital Assets. This makes for a diverse portfolio benefiting from the ongoing digitization and tokenization of the financial sector. From the launch of the FinTech strategy, we targeted a portfolio with an average of 10-15% EPS CAGR, driven by strong topline growth in combination with operational leverage as business models scaled to full potential. We have seen plenty of changes in underlying FinTech trends, but the long-term growth profile of our strategy is still firmly intact. By focusing on key trends such as capital markets resurgence, agentic commerce and tokenization, we can identify and capitalize on the most promising opportunities within the FinTech landscape.

Top 10 largest holdings

The five largest positions in the fund are BitMine, Coinbase, Block, Guidewire and Adyen.

Sector allocation

The fund does not have a sector allocation policy. The fund invests in companies that benefit from the digitization of the financial sector, and focuses on the FinTech long-term growth investment universe. It invests in five distinct segments, labelled as Payments, Financial Infrastructure, Data & Analytics, Financial Management and Digital Assets.

Regional allocation

The fund currently has over 60% of its investments in the US, which is the dominant country for listed FinTech equity investments, but we expect China, India and other emerging markets next to Europe to gain importance.

Currency allocation

The fund has no active currency positions.

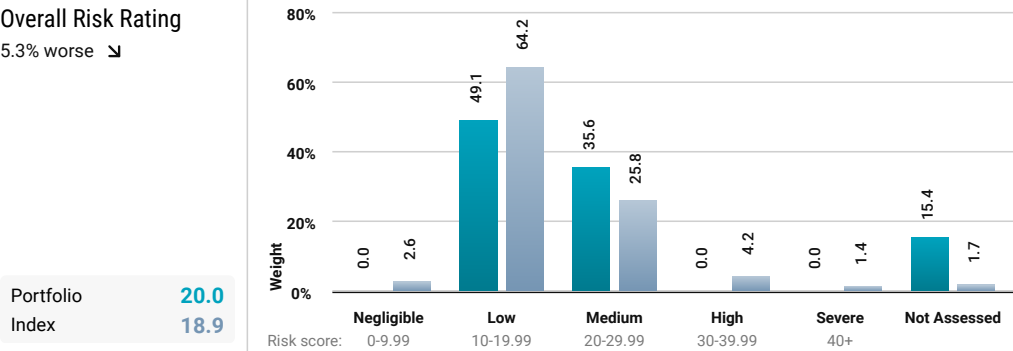

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg.
