Performance commentary

Based on transaction prices, the fund's return was -0.36%.

The strategy underperformed versus the MSCI AC World in May, with contributions varying across FinTech segments. Payments and Digital Assets delivered the most resilient performance, while Data & Analytics and Financial Management provided mixed contributions. Financial Infrastructure lagged, weighing most on overall returns. At the stock level, performance dispersion remained significant. Companies such as Circle, Qualys, Klarna, Robinhood, Affirm, and Guidewire supported results, while Nu Holdings, Wise, BitMine, and Tradeweb detracted. From an industry perspective, insurance contributed positively, while capital markets, software, and financial services segments weighed on performance, reflecting ongoing pressure in software and mixed sentiment within financial stocks.

Market development

As geopolitical concerns around Iran eased, equity markets regained momentum in May, supported by improving sentiment and strong fundamentals, despite increasingly narrow market leadership. Performance remained highly concentrated, with AI infrastructure and commodities driving returns, while other sectors lagged. This divergence is clearly reflected in the strong outperformance of semiconductors relative to software, underscoring investor preference for AI-exposed segments. Underlying fundamentals across financial services remained robust. Payments companies continued to deliver strong volume growth and solid credit metrics, while neobanks showed resilient operational performance despite macro pressures weighing on sentiment. In Digital Assets, ongoing progress toward regulatory clarity, particularly around the CLARITY Act, supports broader institutional adoption of blockchain technology and strengthens the long-term outlook for the ecosystem.

Expectation of fund manager

The Robeco FinTech strategy invests in a universe composed of five segments: Payments, Financial Infrastructure, Financial Management, Data & Analytics and Digital Assets. This makes for a diverse portfolio benefiting from the ongoing digitization and tokenization of the financial sector. From the launch of the FinTech strategy, we targeted a portfolio with an average of 10-15% EPS CAGR, driven by strong topline growth in combination with operational leverage as business models scaled to full potential. We have seen plenty of changes in underlying FinTech trends, but the long-term growth profile of our strategy is still firmly intact. By focusing on key trends such as capital markets resurgence, agentic commerce and tokenization, we can identify and capitalize on the most promising opportunities within the FinTech landscape.

Top 10 largest holdings

The five largest positions in the fund are MSCI, Coinbase, Circle Internet, Intercontinental Exchange and S&P Global.

Sector allocation

The fund does not have a sector allocation policy. The fund invests in companies that benefit from the digitization of the financial sector, and focuses on the FinTech long-term growth investment universe. It invests in five distinct segments, labelled as Payments, Financial Infrastructure, Data & Analytics, Financial Management and Digital Assets.

Regional allocation

The fund currently has over 60% of its investments in the US, which is the dominant country for listed FinTech equity investments, but we expect China, India and other emerging markets next to Europe to gain importance.

Currency allocation

The fund has no active currency positions.

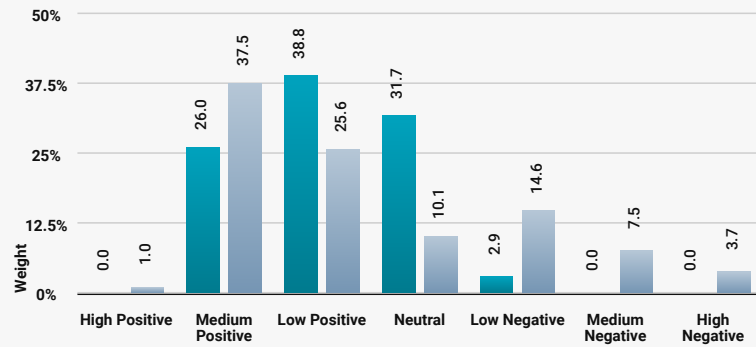

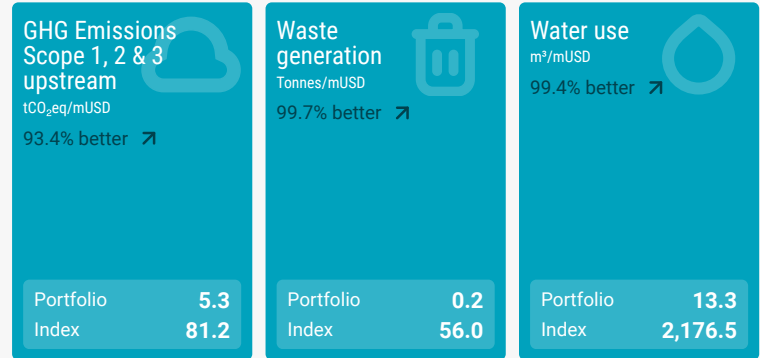

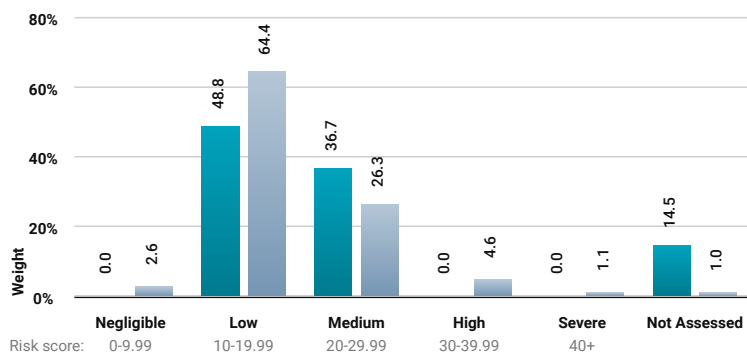

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
