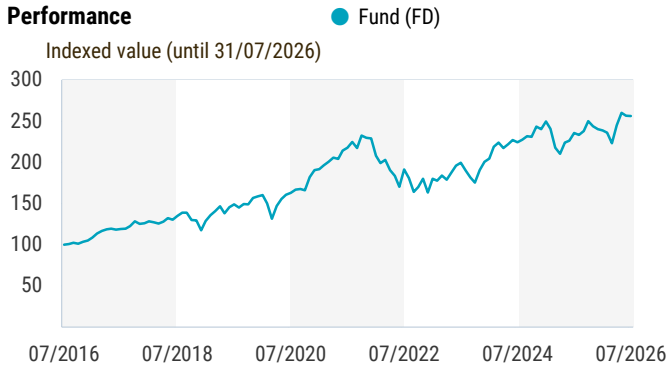

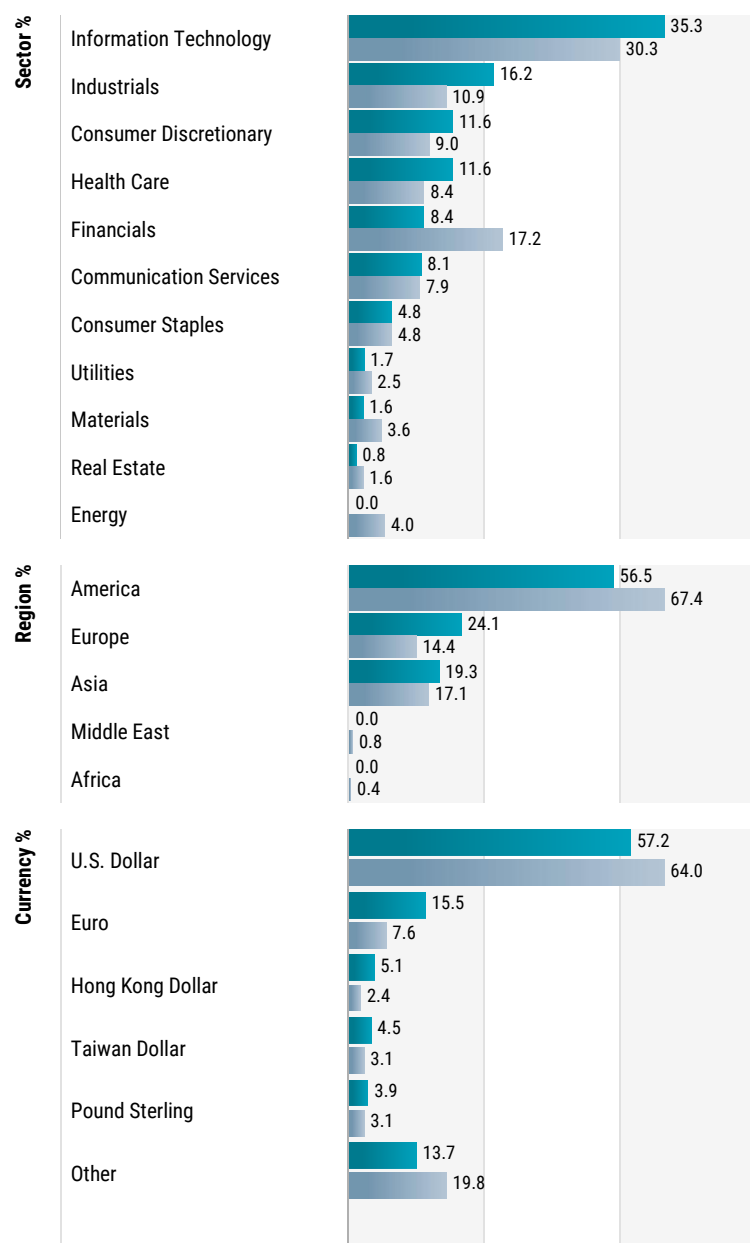
Effective as of May 27, 2024, the sub-fund previously known as Robeco MegaTrends shall henceforth be designated as Robeco Global Multi-Thematic.

Performance commentary

Based on transaction prices, the fund's return was -0.17%.

The Global Multi-Thematic strategy outperformed the MSCI ACWI in July. Stock selection was the primary driver of outperformance, while asset allocation and currency effects detracted from returns. Changing Sociodemographics was the strongest-performing theme, supported by positive contributions from healthcare, Chinese internet and emerging e-commerce holdings. Transforming Technologies declined modestly as a sharp rotation away from AI infrastructure weighed on semiconductor-related positions, although sentiment improved toward month-end following strong earnings from major technology companies. Preserving Earth was the weakest-performing theme, reflecting broad weakness in sustainability-related and industrial technology holdings despite positive stock selection. At the stock level, Microsoft, Amazon and IQVIA were the largest contributors to performance. In contrast, TSMC, Infineon Technologies and Prismsian were the main detractors during the month.

Market development

Global equity markets remained volatile in July, although broad indices proved relatively resilient. Market leadership shifted away from AI-infrastructure beneficiaries, while previously lagging areas of the market attracted renewed investor interest. Despite a pullback in technology shares, corporate earnings provided important support, with results generally exceeding expectations across both the US and Europe. Macro and market sentiment were increasingly driven by the second-quarter earnings season. Earnings growth was broad across sectors and regions, while the number of companies raising full-year profit guidance reached its highest level since 2021. These developments helped reinforce confidence in the underlying strength of corporate fundamentals, despite ongoing geopolitical tensions and elevated market volatility. Investor attention remained firmly focused on artificial intelligence. Better-than-expected cloud growth and continued AI spending helped improve sentiment toward the theme late in the month, after a period of weakness in AI-infrastructure-related stocks.

Expectation of fund manager

We remain positive on the long-term outlook, supported by powerful structural trends across Transforming Technologies, Changing Sociodemographics and Preserving Earth. Innovation in AI, automation, healthcare, digital infrastructure and clean energy continues to create attractive growth opportunities, while cybersecurity and supply-chain resilience are becoming increasingly important in a more uncertain geopolitical environment. Key areas of opportunity include digital payments and FinTech, AI-enabled productivity, healthcare innovation, data center infrastructure, industrial automation and resource efficiency. We believe companies with scalable business models, strong competitive positions and exposure to these secular growth drivers are well-placed to generate attractive long-term returns, despite potential periods of market volatility.

Top 10 largest holdings

The top five holdings of the fund are NVIDIA, TSMC, Microsoft, Alphabet and Amazon.

We have selected three independent top-down and long-term growth trends. The sector positioning is the outcome of our bottom-up stock selection process within these trends.

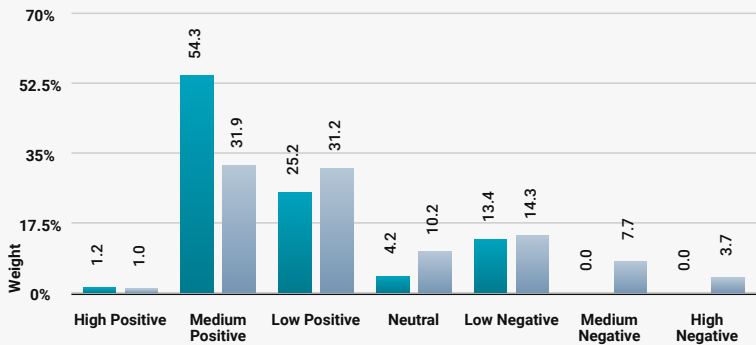

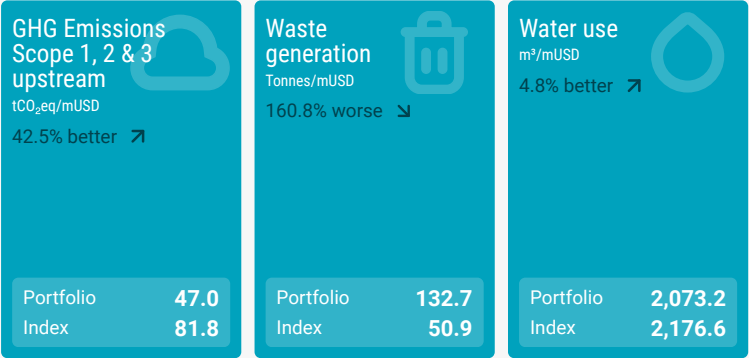
SDG Impact Alignment ¹

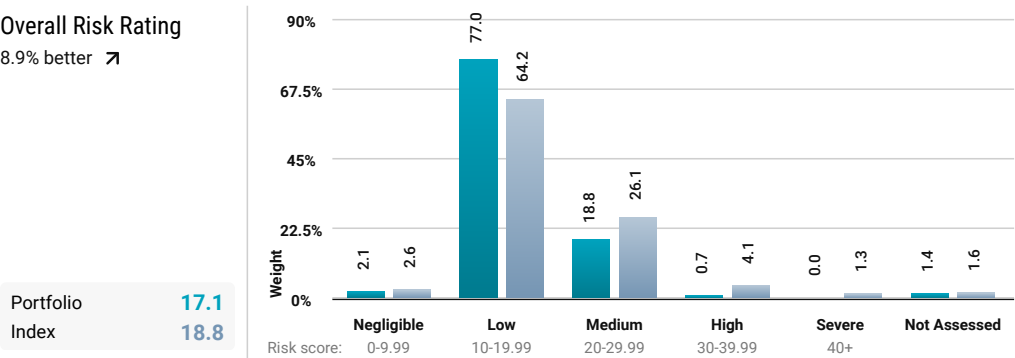

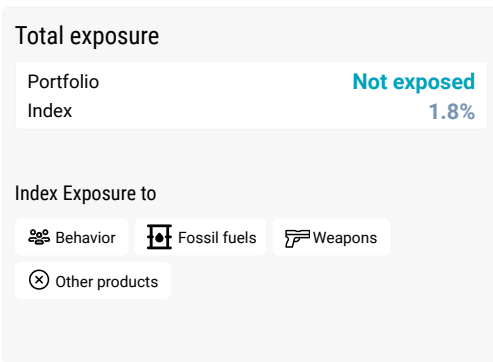

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes.
