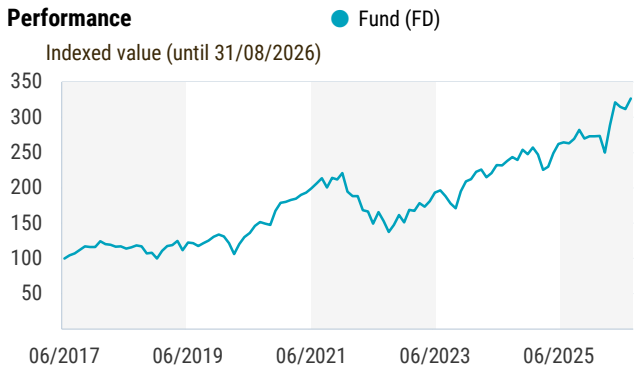

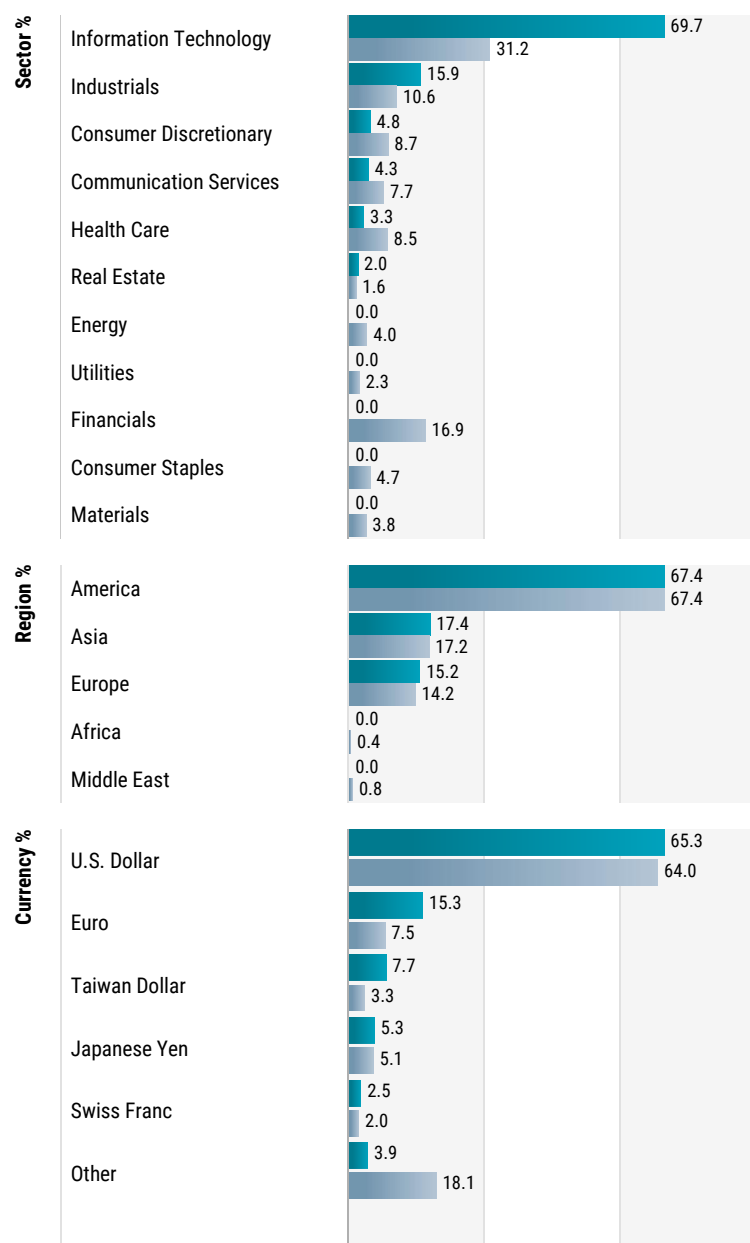

Performance commentary

Based on transaction prices, the fund's return was 4.79%.

Robeco Digital Innovations outperformed the MSCI AC World Index during August. Returns were driven by strong gains in Health Innovation (+16.2%), Security (+15.5%) and Software (+15.2%), reflecting continued investor appetite for innovative growth companies and a notable rotation toward software stocks. Health Innovation was the strongest-performing theme, supported by holdings such as Veeva Systems and Intuitive Surgical. Security also rebounded strongly, driven by Palo Alto Networks, CrowdStrike and Okta, while Software benefited from strong contributions from Salesforce, ServiceNow, Dynatrace and SAP. NVIDIA and Microsoft were among the largest individual contributors to performance. The main areas of weakness were Artificial Intelligence (-3.3%) and Robotics & Automation (-3.1%). Within AI, gains from NVIDIA and Microsoft were offset by weaker performance from several large-cap technology holdings. Robotics & Automation remained under pressure. At the stock level, the largest detractors were Fanuc, Rockwell Automation and Datadog.

Market development

Global equity markets continued to advance in August despite ongoing geopolitical tensions in the Middle East, higher inflation concerns and rising interest rates. Technology remained a market leader, with software stocks significantly outperforming semiconductors for a second consecutive month as investors increasingly favored businesses perceived to be more resilient beneficiaries of artificial intelligence adoption. In China, internet and technology stocks weakened following a strong prior month, reflecting a combination of company-specific disappointments, capital raising activity and softer revenue trends at several large platforms. At the same time, momentum around Chinese AI innovation remained strong, highlighted by significant investor interest in emerging AI and robotics companies. Overall, market performance continued to be driven by enthusiasm around AI-related opportunities, although leadership broadened from infrastructure and semiconductors toward software and application-layer beneficiaries.

Expectation of fund manager

Innovation continues to accelerate across artificial intelligence, drug discovery, nuclear fusion and quantum computing, reinforcing our conviction that technological progress remains a powerful long-term growth driver. While macroeconomic conditions may influence the pace of investment, the direction of innovation remains firmly positive. Artificial intelligence continues to be the primary engine of technology spending and earnings growth. Beyond digital applications, AI is increasingly being deployed in robotics and industrial automation, helping address labor shortages, production bottlenecks and the reshoring of manufacturing activity. At the same time, rising investment in domestic manufacturing is creating additional opportunities across the technology value chain. As digitalization expands, cybersecurity remains a critical area of focus as both organizations and threat actors increasingly adopt AI-driven capabilities. We remain confident that the strategy's themes are well-positioned to deliver attractive long-term growth, although elevated expectations following several years of strong performance may create periods of near-term volatility.

Top 10 largest holdings

The top five largest positions for the month are NVIDIA, TSMC, Microsoft, Palo Alto Networks and Alphabet.

We have selected seven innovations to segment the portfolio: AI, Robotics & Automation, Software, Security, Digital Infrastructure, Health Innovation and Frontier Technologies. The sector positioning is the outcome of our bottom-up stock selection process within these trends.

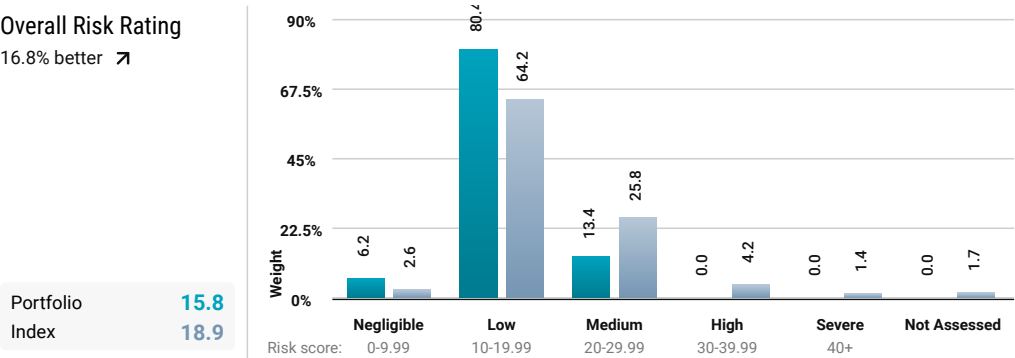

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
