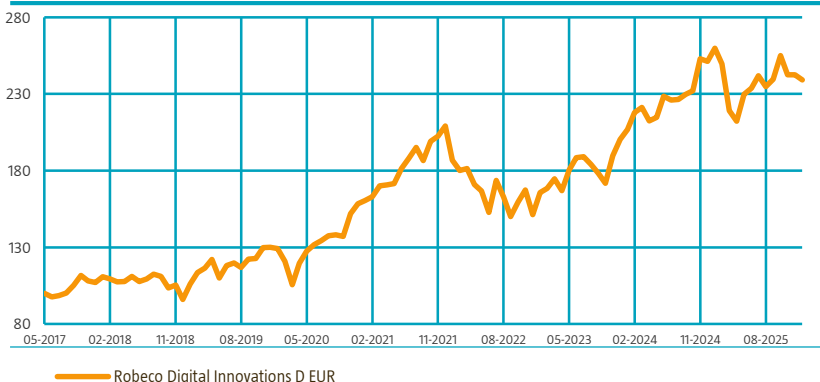

Performance

Based on transaction prices, the fund's return was -1.37%.

In January, Robeco Digital Innovations underperformed versus the MSCI ACWI. The artificial intelligence segment rose 4.3%, supported by strong results from TSMC and ASML, pointing to continued demand for high-performance computing, although Microsoft fell sharply despite beating expectations. Digital Infrastructure gained 6.0%, helped by ABB and SK hynix. Frontier & Other Technologies jumped 12.9%, driven by a strong rebound in Intel and solid results from IBM. Health Innovation declined 11.6% after Intuitive Surgical guided to slower growth, while Robotics & Automation delivered mixed returns. Security fell 6.2% amid broader software weakness. Software dropped 17.1% after disappointing market reactions to earnings, even though reported results exceeded expectations. Looking ahead, software growth is projected to accelerate, SaaS leaders are rapidly integrating AI, and valuations have become more attractive.

Market development

Global equity markets started the year positively amid AI-driven optimism, supportive monetary policy and generally strong earnings results from early reporting companies. Emerging markets outperformed, fueled by AI capex booms in China, Taiwan, and South Korea. Software and semiconductor stocks again diverged sharply: TSMC's results and capex surge forecast sparked a broader rally in semis. Software slumped into bear territory amid fears of AI disruption.

Expectation of fund manager

Innovation across AI, drug discovery, nuclear fusion, and quantum computing shows that the pace of technological change is accelerating, continuing a long historical pattern of human ingenuity driving progress. As economist Robert Solow noted, innovation is central to sustained economic growth, and while macro conditions can influence the timing of investment, the long-term direction remains forward. In 2025, for the third consecutive year, AI was the main engine of technology innovation and earnings growth, a trend expected to continue into 2026. Capital spending on high-performance semiconductors and supporting infrastructure should persist, but attention is increasingly shifting toward AI's ability to deliver real productivity gains. AI is also moving into the physical world through adaptive robotic systems, supporting a renewed push to reshore manufacturing amid labor shortages, supply constraints, and geopolitical concerns. In the US, manufacturing investment has surged sharply in recent years. Overall, these themes support strong long-term growth, though elevated expectations after several strong years pose a near-term risk.

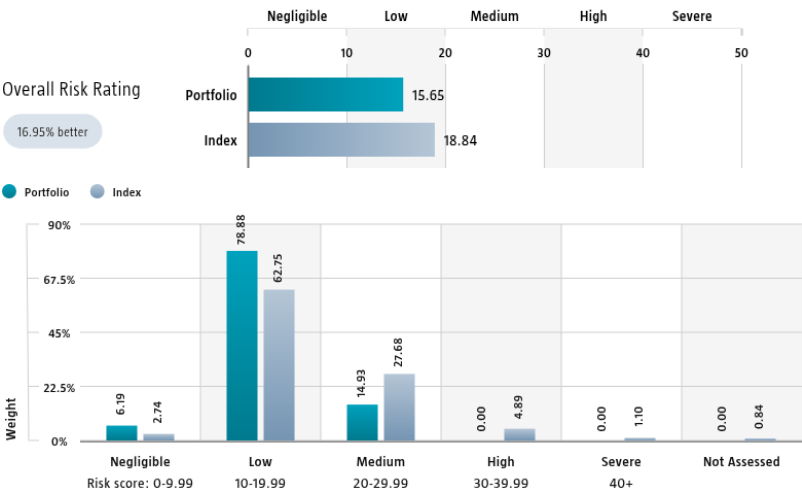

Sustainability

The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

Sustainalytics ESG Risk Rating

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The Distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Environmental Footprint

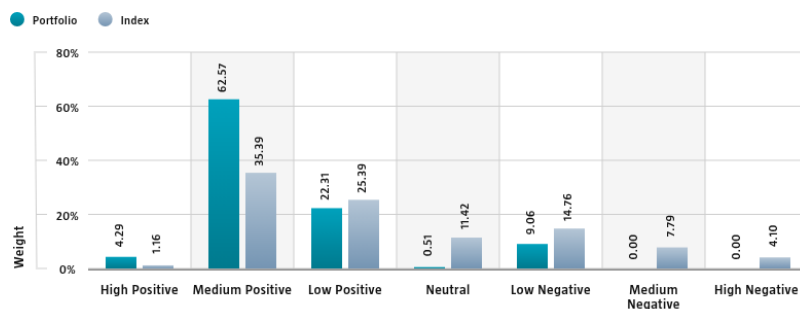

Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

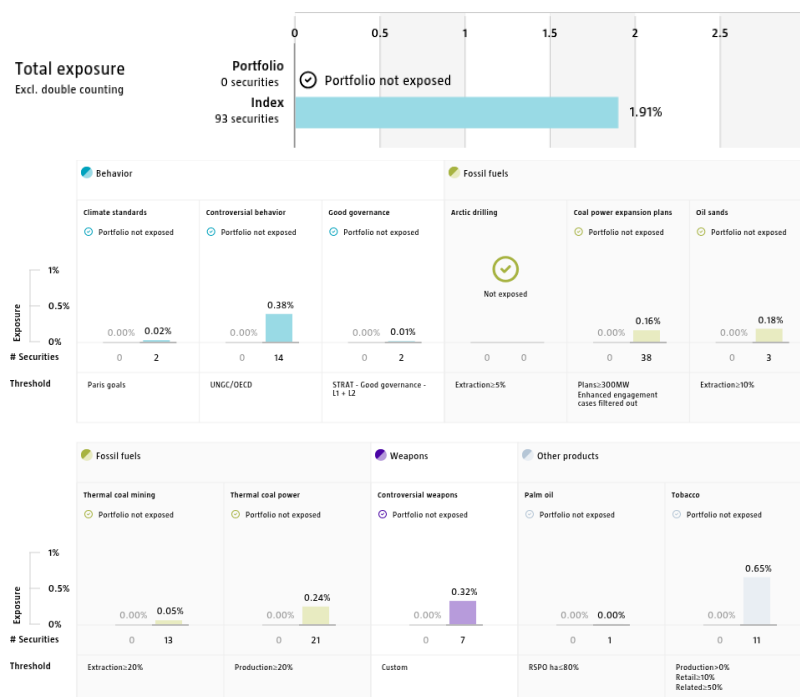
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
