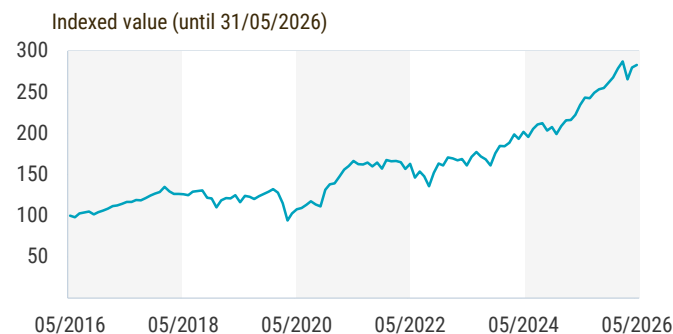

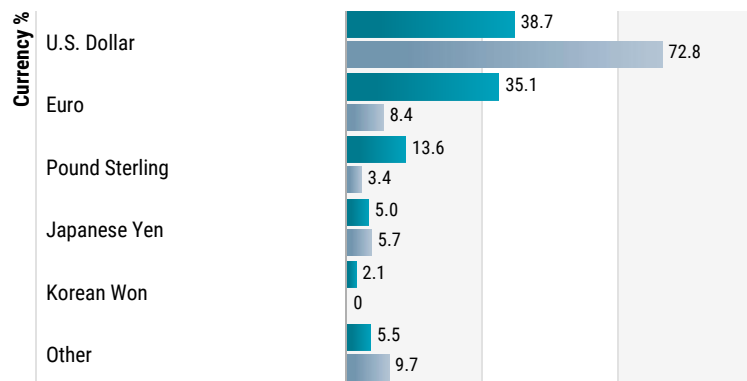

The fiscal consequences of investing in this fund depend on the investor's personal situation.
