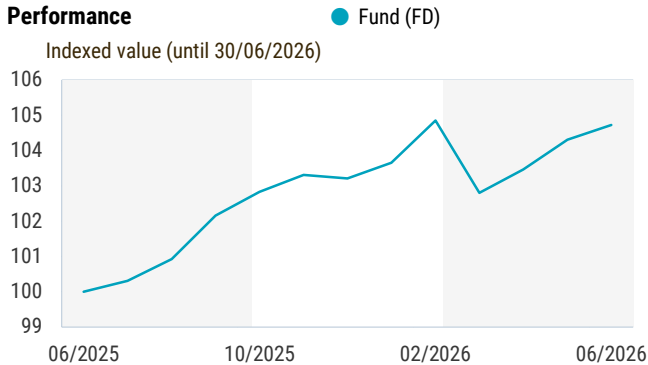

Robeco QI Global Multi-Factor Credits is an actively managed fund that invests systematically in predominantly investment grade credits. The selection of these bonds is based on a quantitative model. The fund's objective is to provide long-term capital growth. The fund offers balanced exposure to a number of quantitative factors by focusing on bonds with a low level of expected risk (low risk factor), an attractive valuation (value), a strong performance trend (momentum) and a small market value of debt (size). The investment universe includes bonds with at least a BB rating.

Performance commentary

Based on transaction prices, the fund's return was 0.40%.

Based on closing prices, the fund posted a relative return of +0.09% versus the benchmark. Issue(r) selection delivered a positive contribution and beta allocation slightly detracted. Duration hedging contributed positively. The low-risk/quality factor, driven by the underweight in longer-dated bonds, delivered the largest positive contribution, followed by smaller positive contributions from value and size. The momentum factor contributed neutrally. Sector allocation slightly detracted, largely from the overweight in the technology sector; the underweight in the communications sector contributed slightly positively. Currency allocation contributed slightly positively, driven by the overweight in EUR-denominated paper. Country allocation contributed slightly positively, mainly due to the overweight in Finland. The allocation to subordination groups slightly detracted, mostly due to the overweight in senior corporates. Rating allocation delivered a small positive contribution, driven by the off-benchmark position in BA-rated paper. SDG score allocation contributed slightly positively. ESG Risk Rating allocation contributed neutrally.

Market development

The Bloomberg Global Aggregate Corporates Index posted a credit return of -0.08% as credit spreads widened somewhat from 76 to 78 bps. The euro-hedged total return was 0.19%, as underlying government bond yields decreased. Corporate bond markets remained resilient in June, despite modest spread widening. Despite a cooling down of the rally in US mega-cap technology names, the overall stock market rose, with emerging market stocks outperforming on weaker dollar dynamics. Global sovereign yield curves flattened. In the US, yields increased, especially on the short-end of the curve, while German long-term yields ended the month lower. US labor market data was strong in June. Central bank policies diverged: the Federal Reserve held its benchmark rate steady in its first meeting under Chair Kevin Warsh, whereas the ECB raised its key rate by 25 basis points to 2.25%. Geopolitically, a US-Iran ceasefire agreement eased Middle East tensions, causing oil to drop by 20% and gold by 12%.

Expectation of fund manager

Robeco QI Global Multi-Factor Credits invests systematically in predominantly investment grade credits. It offers balanced exposure to a number of quantitative factors. In the long term, we expect the fund to outperform the market by systematically harvesting factor premiums with a risk profile that is similar to the reference index.

Sector allocation

Allocations to sectors are limited to a relative overweight or underweight of 10% and an outright restriction to REITs. They are otherwise non-tactical, and incidental to the bond selection, which is generated by the quantitative multi-factor ranking model. The portfolio exposures to the technology, consumer non-cyclical and banking sectors increased over the month, while the exposure to the communications sector decreased. The largest underweights are in the electric utility and communications sectors; the largest overweights are in the consumer non-cyclical and technology sectors.

Currency denomination allocation

Allocations to bond currency denominations differ from the benchmark by 10% at most, and are otherwise non-tactical, and incidental to the bond selection, which is generated by the quantitative multi-factor ranking model. Currency exposures are subsequently hedged to the currency of the fund class. Over the month, the exposures to EUR and AUD-denominated paper decreased, while the exposure to USD paper increased. The portfolio is underweight in USD and CAD-denominated bonds and overweight in EUR and GBP bonds.

Duration allocation

The duration position is non-tactical and incidental to the bond selection, which is generated by the quantitative multi-factor ranking model. Duration is subsequently hedged to that of the benchmark using interest rate derivatives.

Rating allocation

Allocations to rating buckets differ from the benchmark only by a permitted 10% fund exposure to BA, and are otherwise non-tactical, and incidental to the bond selection, which is generated by the quantitative multi-factor ranking model. The portfolio exposure to A-rated paper increased, while the exposure to AA paper decreased. The portfolio is underweight in BAA and AA-rated bonds and overweight in AAA and A bonds, and holds about 6% in off-benchmark BAs.

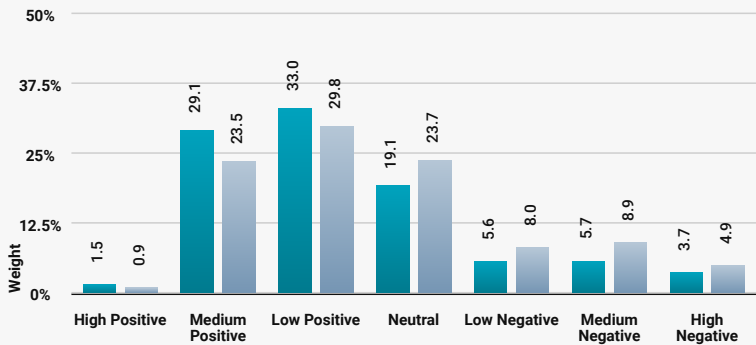

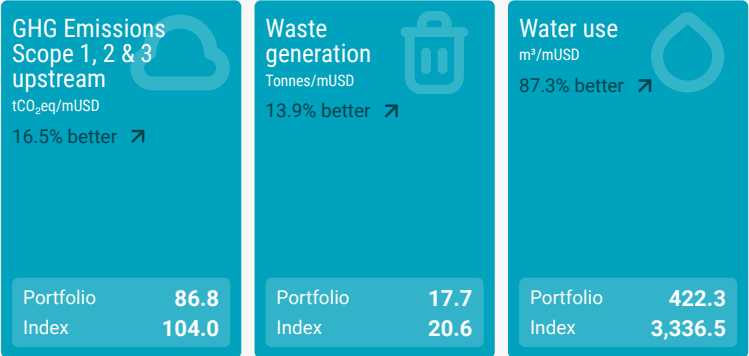

Environmental Footprint ²

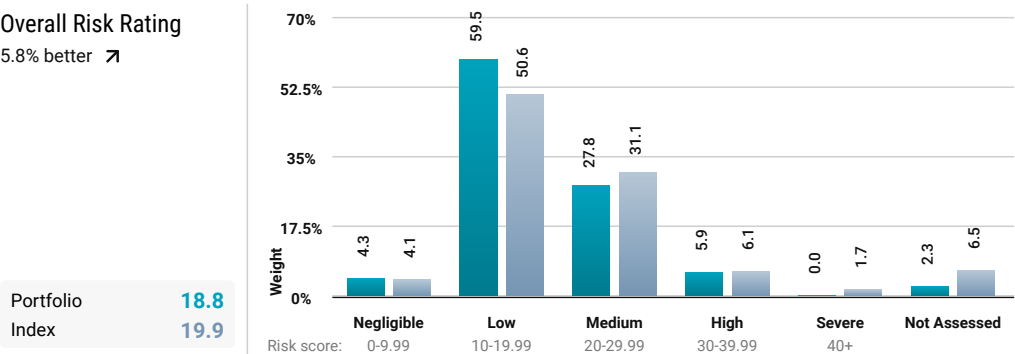

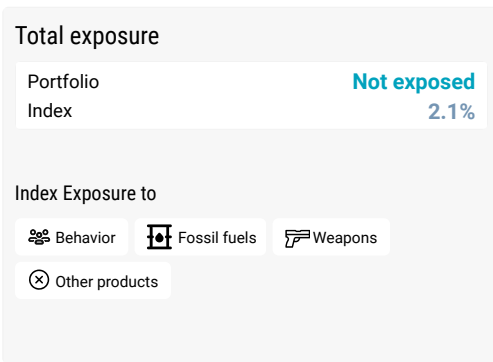

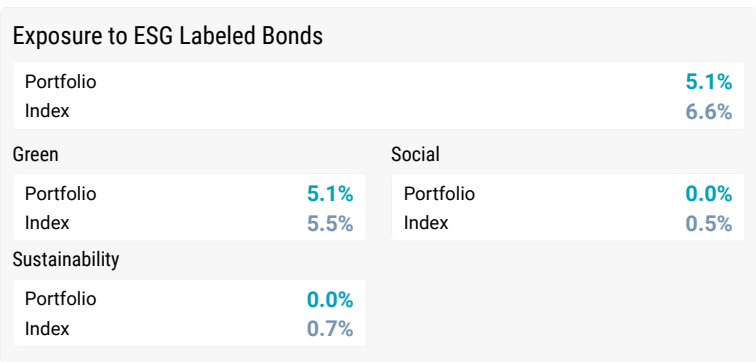

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. 5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

The fund will strive to create a risk profile, which is similar to the reference index. The duration and currency exposure of the portfolio will be hedged to the reference index. The strategy can have significant tracking error versus the reference index. The ratio of the portfolio volatility with respect to the volatility of the reference index is restricted by predefined guidelines. These guidelines also restrict the leverage exposure of derivatives on a fund level and the currency exposure as described in the prospectus.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.01% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

Investors who are not subject to (exempt from) Dutch corporate-income tax (e.g. pension funds) are not taxed on the achieved result. Investors who are subject to Dutch corporate-income tax can be taxed for the result achieved on their investment in the fund. Dutch bodies that are subject to corporate-income tax are obligated to declare interest and dividend income, as well as capital gains in their tax return.
