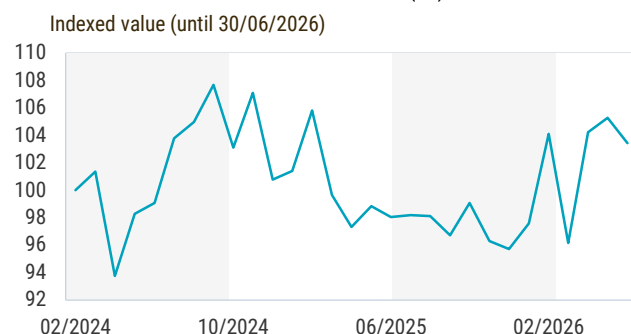

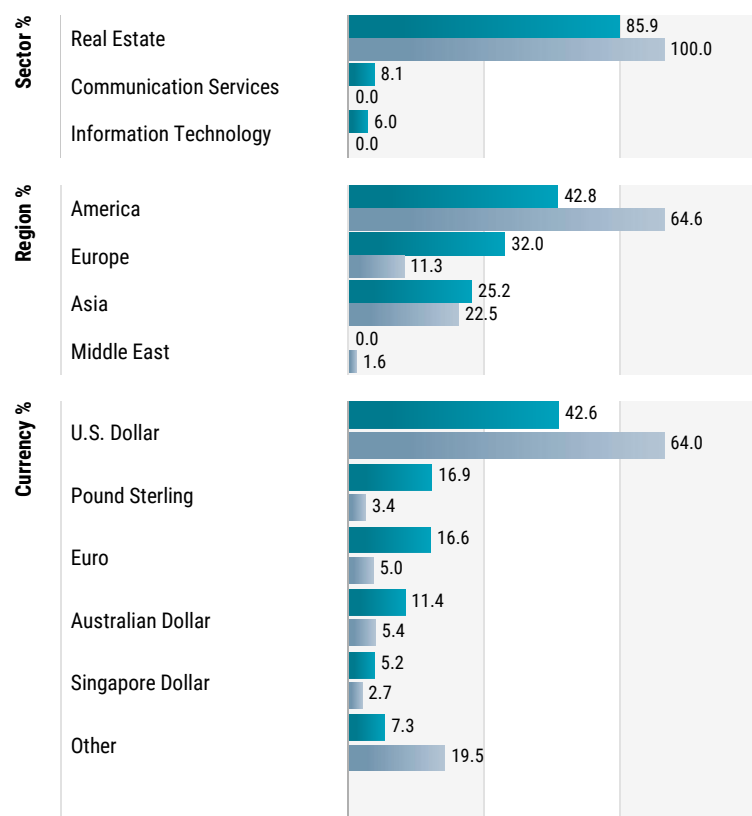

Performance commentary

Based on transaction prices, the fund's return was -1.75%.

Fund performance was negative in June, with a mixed performance across sectors. Networks and logistics delivered positive returns, while data centers and cell towers were down on the month. Europe delivered positive returns, while North America and Asia Pacific were negative.

Market development

Markets were mixed in June, with the Federal Reserve holding interest rates steady as updated projections caused markets to price a 25-basis point rate hike by October. In his first meeting as Fed chair, Kevin Warsh moved to scrap forward guidance and launched a series of task forces to reassess the Fed's policy framework. Meanwhile, oil markets dropped after the US and Iran signed a memorandum of understanding which reopened the Strait of Hormuz, though the truce proved fragile as the two sides exchanged strikes later in the month before agreeing to resume talks again. Despite positive signs from the US economy, with strong labor market data and a higher revision of Q1 GDP, inflation proved stubborn, with consumer prices climbing to their highest level since 2023.

Expectation of fund manager

The fund manager remains positive about the digital infrastructure sector due to the strong underlying performance of portfolio assets. During the month, Prologis, one of the largest REITs in the world, made an unsolicited all-share offer for SEGRO, the largest REIT in the UK. The offer was equivalent to SEGRO's latest NAV (925p), representing a 25% premium to SEGRO's undisturbed share price. SEGRO's board 'unanimously and unequivocally' rejected the 'opportunistically timed' offer, which 'falls a long way short of SEGRO's own views on value'. A week after the initial announcement, Prologis published a presentation to further explain the strategic rationale of the deal for both sets of shareholders. Prologis has until July 22nd to make a firm offer.

Top 10 largest holdings

The largest names in the portfolio represent companies that operate at the intersection of real estate and technology, and benefit from strong digital mega trends. These trends include 5G wireless communications, AI and e-commerce. The companies own physical infrastructure assets that are vital to the functioning of the digital economy: data centers, logistics warehouses, communication towers and fiber networks.

Sector allocation

The fund invests in companies that own and operate infrastructure assets which enable the successful operation of the modern digital economy. These include listed real estate companies (REITs) that own data centers and e-commerce fulfilment warehouses, as well as listed infrastructure companies that own telecom towers and fiber networks.

Regional allocation

The fund invests in companies that are listed in developed markets. The fund does not apply a regional allocation policy, as regional allocation is driven by security selection. This means that regional allocation reflects investments in the portfolio.

Currency allocation

The fund does not apply an active currency policy, currency exposure is driven by security selection. This means that currency allocation reflects investments in the portfolio.

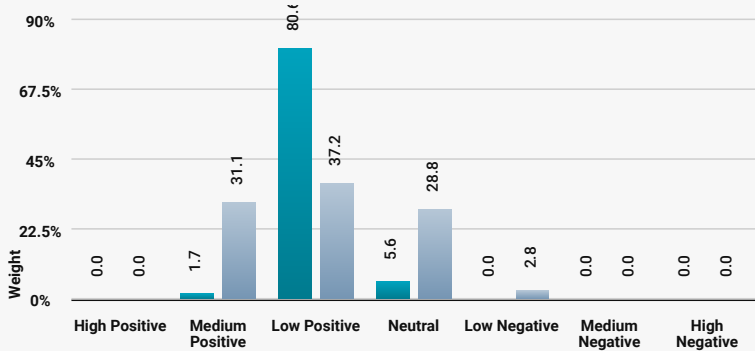

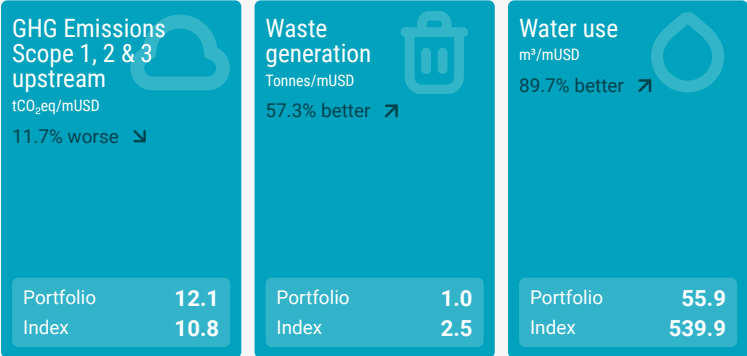
SDG Impact Alignment ¹

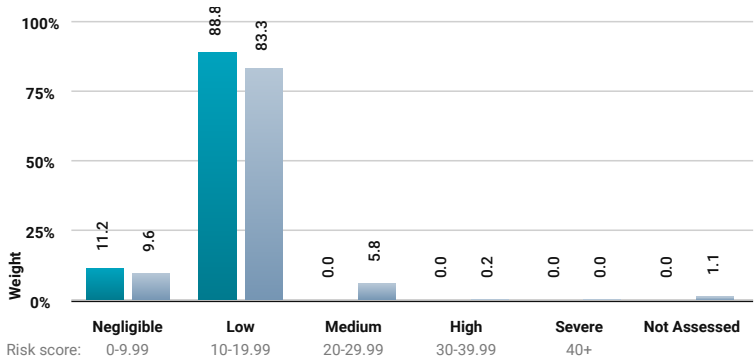

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
