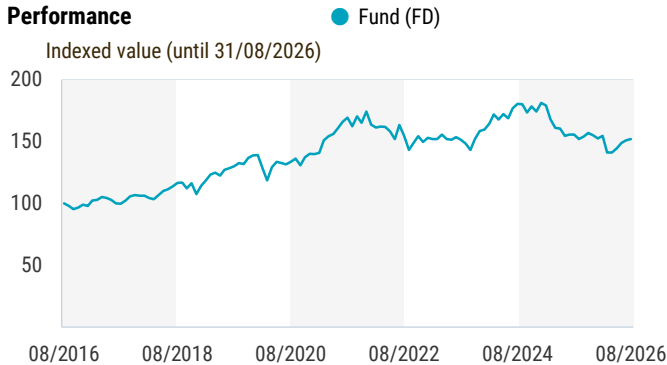

The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 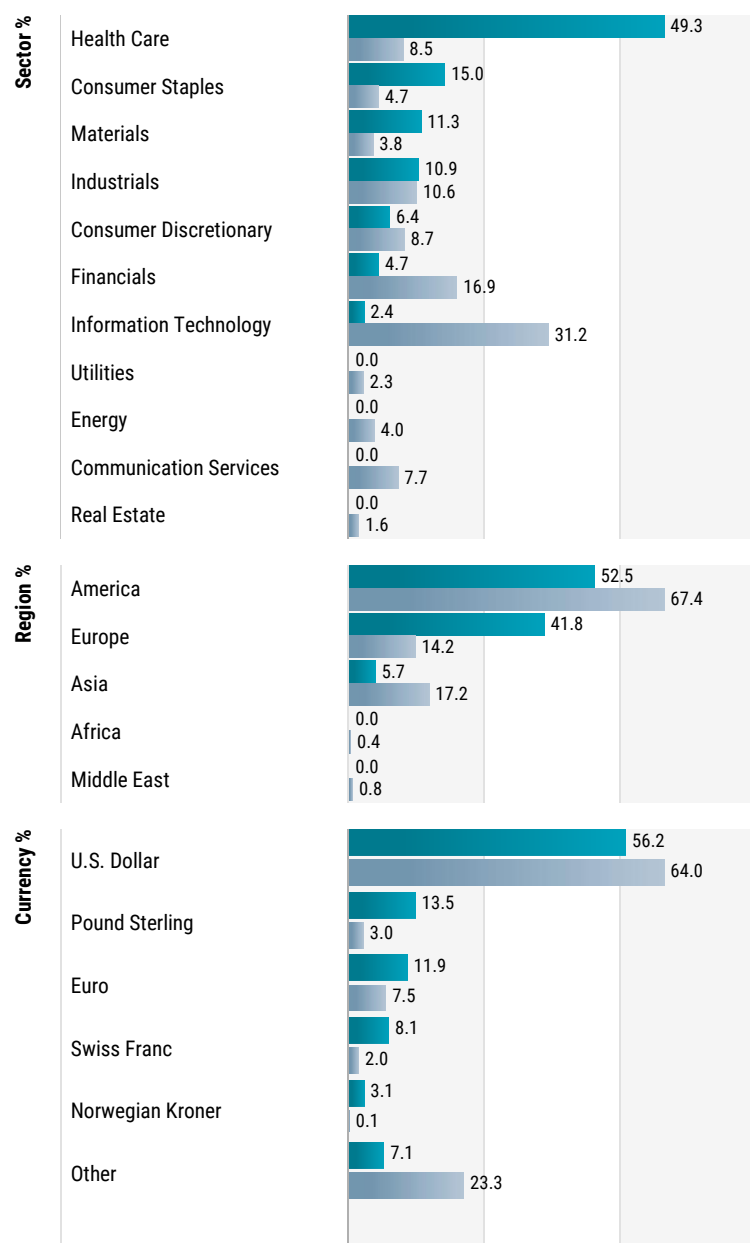
On the launch date, 29 October 2020, the fund absorbed Multipartner SICAV - Robeco Sustainable Healthy Living Fund. With effect from 16 July 2026, the benchmark has been changed from MSCI World Index to MSCI All Country World Index.

## Performance commentary

Based on transaction prices, the fund's return was 0.58%.

In August, the Healthy Living fund generated positive returns, but underperformed versus the global market and its internal benchmark. The Healthcare Innovation, Essential Systems and Resilient Society clusters generated positive returns during the month and were the primary contributors to performance, while the Longevity Lifestyles and Resilient Society clusters were negative. At subcluster level, the Health Tech subcluster generated the strongest returns, driven by the rebound in Olympus and a strong second quarter print by Veeva Systems. At the individual stock level, the biggest positive contributor was life sciences tools company Agilent Technologies. The company reported fiscal third-quarter results above market expectations and raised its full-year guidance at the end of August, reinforcing the view that conditions in analytical instruments are gradually improving. Similarly, the second largest contributor was Thermo Fisher Scientific. The largest negative contribution came from managed care company CVS. While the company once again delivered strong quarterly results and raised its 2026 guidance, investors focused on a more cautious profit outlook for 2027.

## Market development

In August, global equity markets returned a positive performance (in USD). The materials sector outperformed significantly, driven by mining companies, followed by the information technology sector, which drove the bulk of market returns, while the energy and healthcare sectors also outperformed the market. In contrast, the consumer staples and industrials sectors saw negative returns, while the consumer discretionary sector was flat. Healthcare Technology was the best-performing industry within the MSCI All Countries Index this month, while Biotech and Life Sciences Tools performed strongly. Healthcare Equipment was positive for the second consecutive month this year. On the consumer side, the Textiles, Apparel & Luxury Goods, which include sportswear companies, and Food Products industries materially underperformed versus the market, resulting in a bifurcated performance in industries relevant to our investment universe.

## Expectation of fund manager

Healthcare remains the core sector of the Healthy Living strategy. Following a prolonged period of underperformance relative to the global market, sector valuations have become more attractive, offering a compelling entry point for long-term investors. At the same time, key regulatory headwinds are easing, with increased clarity around issues such as Most Favored Nation / Medicare pricing proposals and managed-care reforms, improving visibility for earnings and capital allocation. Healthcare not taken into account, the consumer environment remains bifurcated, as inflation and tariffs have put pressure on disposable income. While discretionary spending is under pressure in parts of the market, structurally attractive, high-growth categories aligned with the Healthy Living theme continue to outpace broader consumer trends. Areas such as functional nutrition and performance apparel benefit from consumers' willingness to pay for tangible health, wellness, and performance outcomes, supporting resilient growth and pricing power.

## Sector allocation

The Healthy Living strategy invests in companies that enable healthier, longer and more productive lives. The investable universe includes companies providing innovative products and solutions across nutrition, personal care, physical activity, healthcare, environment, financial resilience and workforce productivity. As a result, the portfolio is invested mostly in the healthcare, consumer discretionary, consumer staples, materials, industrials, financials and information technology sectors.

## Regional allocation

The fund is currently 42% exposed to Europe, 52% to the Americas and 6% to Asia.

## Currency allocation

The fund does not engage in currency hedging transactions.

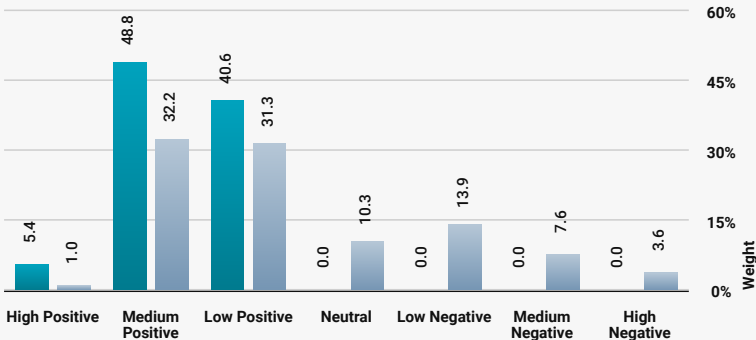

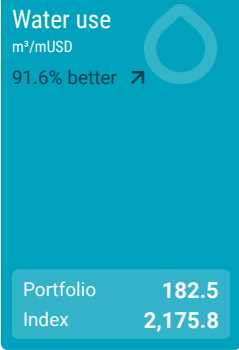

## Reference

### 1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

### 2. Sustainability ESG Risk Rating

The chart displays the portfolio's Sustainability ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainability ESG Risk Rating by its respective portfolio weight. The distribution across Sustainability ESG Risk levels chart shows the portfolio allocations broken into Sustainability's five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. ### 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
